THE CUSTODY OF LODGE FUNDS.

THE proposal of our correspondent last week, that Grand Lodge should undertake the custody of Lodge Funds, with a view of making a profit out of the standing balances, must, we fear, be dismissed because of its impracticability, but because it is so very unlikely Grand Lodge would move in the matter; there are some who would consider such a course undignified, others who would object to it as tending to create a supervision over Lodge finances, and others who would uphold "principle," and strenuously oppose what would seem to them a most radical innovation. For our part we think the subject is surrounded rather by sentimental obstacles, than anything which should really stand in the way of some such scheme as set out by our correspondent, but that does not make it any more likely that Grand Lodge will entertain the proposal, or that the representatives of the Craft would support it if it were

regularly brought forward.

But the same objections do not seem to exist when we turn to our correspondent's alternative schemethat the three Institutions should take up the matter, and, by united effort, seek to profit by assuming the custody of Lodge surpluses. There are so many influential brethren showing an active interest in thousands of pounds would be deposited immediately arrangements for their reception were completed, and there are many prominent workers in the good cause who would be ready to assist in supervising and managing the Fund, in such a way as to ensure the largest amount of profit for it, and the smallest outlay for working expenses. It is too early yet to discuss the arrangements that would be necessary to conduct the affairs of the fund, they could well be left for settlement by the brethren who took the lead in its inauguration, but it is none too early to endorse the opinion of our correspondent, that something might be done in the direction he points out. The movement must necessarily be a voluntary one, and the first step would seem to be for any brethren in favour of the scheme to show their approval by some thousands of pounds of deposits, and the bulk future receipts would be ample to meet the likely outgoings.

If Grand Lodge moved in the matter Private Lodges would probably regard support of the Fund as compulsory, which is by no means desirable, and would most likely defeat the very end it proposed to serve, but with the Institutions of the Craft at the head of affairs the same objection would not existthere would be no compulsion, but in time we should to be able to give a decisive answer. expect the majority of our Lodges to fall in with the

idea, and lend their support to the scheme, in which case the estimate of our correspondent as to the floating balance in hand would probably be below, rather than over the mark. In any case, to discuss the scheme will cost nothing, to carry it through might result in a handsome profit for our Charity from the programme of future possibilities, not Funds, and such being the case we have no hesitation in putting it thus prominently before our readers, although, at the same time, we acknowledge, as the author of the scheme, our correspondent of last week.

MASONIC PUBLICATIONS.

MASONIC magazine, properly conducted, is a fountain of instruction. It enlightens the brethren on points which it is impossible to obtain at Lodge meetings, which present no time for such discussions. But it is singular that Massachusetts, proverbial for teaching pure Masonry, should take so little interest in the support of Masonic publications. If Masonic principles are anything, and if Masonic teachings are valuable, then it is our duty to help disseminate them. The duties of Masons to the brotherhood, their duties as citizens, their domestic duties, in their family, cannot always be a subject for the Lodge, the time is taken up by work and other business, and there is seldom any time to lecture upon the duties of the brethren, our three Institutions that it seems to us some and often the Master is incompetent, if he had the time. It is, therefore, of great importance that we should seek the desired information from the true fountain, which is a well-conducted magazine; and the brethren should see that such a publication is well supported by bestowing their mite towards it. Masonry, properly understood, embraces a system of duties and obligations which are indispensable for the rule and guide of our lives as good men and citizens.

But we are too apt to be satisfied with performing our duties to our brethren in the Lodge without carrying out its principles into our every day life, which it is equally incumbent upon us to do. These instructions can be disseminated by a properly conducted magazine, which should be appreciated and patronised by the brethren who have any interest in spreading the knowledge of our Craft, not only among the brethren, but among those who are ignorant of its motives and teachings, and who view it as merely an association for the benefit only of those who promising their co-operation. By this means, as we belong to it, and are entirely ignorant that its teachings have said, we should expect an immediate promise of are brotherly love and charity to all, whether connected with the institution or not. In this as well as in other of the amount could be permanently invested, as respects, it is incumbent upon all who take any interest in the Order, and are earnestly seeking for more light, to patronise a well conducted Masonic magazine. It gives information to all upon what our institution is founded. If brethren would act on these suggestions much valuable information would be obtained. The Grand Master is often applied to, to settle questions of which those who make the inquiries could readily inform themselves if they subscribed for a Masonic magazine. And, then, it is not every Grand Master who is himself posted in these matters

It is expected of Freemasons that they should live up to

their solemn covenant in all their private and social relations, and if we would continue our institution to posterity, and preserve it in its original aim and purposes, its memhers must live up to its highest teachings, and cause the light of their example to shine forth, and convince the world of its beneficent and divine principles. Now, a publication which labours for the dissemination of Masonic principles, and the denunciation of all that tends to make Masonry appear in a false garb, should be supported by the Fraternity. Our Masonic magazines are channels through which the brethren are admonished of their duties and reminded of their obligations, and the public are informed on some points concerning the order on which they seem to be in perfect ignorance. For instance: they state that we are tempted to do wrong in the interest of a brother, because of our obligations, which impose the duty of mutual assistance. On the contrary, every Mason knows that no obligation he has taken requires him to do wrong in behalf of a brother. All the teachings of our Order are opposed to any such idea; he may be called upon, under certain circumstances, to risk his own life for the protection of a brother, but he is not obliged to sacrifice his honour, or commit a breach of trust in order to protect a brother. No Masonic obligation justifies a wrong act, even in behalf of a brother. To do right, at all times, and under all circumstances, is the maxim of Freemasonry. The brother who appeals to another to do wrong in his behalf is guilty of un-Masonic conduct in making the request, and not only justifies a prompt refusal, but also the suspicion that he is unworthy of confidence.

Through our Masonic magazines the public are enlightened in regard to what is required of those belonging to the Order, if they really wish to be, but there are those whose stubbornness will not allow them to be enlightened, and will denounce the Order if one of its members proves that his bad heart has been too powerful against the good influences by which he had been surrounded. But they have not a word to say against religion because one who professes it has turned out to be a scoundrel. Is it too much to ask for Freemasonry the same consideration? The small band of twelve whom the Great Teacher gathered around Him had one among them whose sordid nature was not influenced by these benign teachings. We cannot claim for Freeemasonry, moral as are its teachings, a higher power over the human heart than these lessons of our Great Teacher possessed.

I have heard it remarked more than once, that if a Mason was arraigned for any crime it would be impossible to convict him if the judge was a Mason, or if there was a Mason on the jury. Now, every Mason knows that this is the very opposite of what would occur, for the brother is obligated to obey the laws of his country, and if he transgresses, he has forfeited the obligations of his brethren to him, as well as his own to the Fraternity, and the Masonic brother, whether upon the bench or on the jury, would be the first to convict him, as he has not only forfeited his obligation as a citizen, but also his obligation to the Fraternity, by this disobedience to the laws under which he lives, and those who make such assertions should know more about the Order before they make them.

Now a Masonic periodical is the right channel through which they may gain a better knowledge of the Institution, and the members be more constantly reminded of their duties, and every brother is in duty bound to support such a publication by his subscription. The publisher works hard to disseminate the beautiful teachings of our Order, and we are bound to "help, aid, and assist" a worthy brother. Therefore, I say to my brethren who profess to be interested in the Order, patronise some Masonic magazine.—Masonic Review

THE COHESIVENESS OF FREE-MASONRY.

THE widespread influence of Freemasonry has for a long time been the wonder of all people. Those who are comparatively ignorant of its real intent, or the doctrines it inculcates, look upon it as an Institution of almost unlimited power and extent. They venerate it without knowing why, except a vague sense of respect for its reputed antiquity, and a feeling of indefinable awe for there. On the same tessellated floor meet the Christian

apparent mystery that surrounds its history. That it is the most powerful of human societies is acknowledged on all sides. That it has the loyal support of its members in all countries is well known within its precincts. There must be some reason for this universal respect, this worldwide influence and this firm adherence to its principles, aside from its mere antiquity and its mysterious history.

There is a cohesiveness in Freemasonry that is found nowhere else, and the question is pertinent, Why is it? In the church there are storms and schisms; divisions and strife. Brother is arrayed against brother, and where should be found a spirit of forbearance and brotherly love, is the bitterest hatred. The fierce fires of hell are not hotter than the fire of religious persecution. Among those who only a short while ago there seemed to be the sweetest harmony, there now exists an antagonism that threatens the peace of the whole religious world. The spirit of determined opposition to fancied heresy in some marked and prominent leaders of Christian thought, has brought out the very worst weaknesses of the human heart. In their zeal to "defend the faith," to "maintain the dignity of the church," they resort to the basest means known in the world, and the hard feelings engendered makes those who were fast friends the bitterest foes, and scenes of disgraceful riot are not infrequent.

Rivers of human blood have been spilled in religious warfare, and the very worst impulses of the human heart have been aroused. The knife of the assassin has been used as a defence of pretended Christian belief. The creed! the creed! has been the cry, and any who dared oppose the dictum of the church, whether it was in harmony with the convictions of conscience or not, suffered the rack or the

thumbscrew or the faggot.

In the State the same spirit of strife and contest is seen. Parties war with each other, and those of a man's own household are often found arrayed against him. If that difference in opinion were confined to mere matters of conviction, and were not allowed to change a man's very nature, and cause him to raise his hand against his best friend, and even in fratricidal strife to curse his nearest kin, it would not be so dreadful in its consequences.

In society, jealousies and ambitions cause the widest preparations. Pride, with its haughty dangers, estranges those who should be in closest friendship. There are "castes" and "sets" so seclusive and exclusive that hearts are made to bleed from the slights and neglects that are daily heaped upon them. There is no protection in society. A shrug of the shoulder, a knowing wink, or an inuendo soon takes shape in a rumour that grows with every repetition until the purest angel from heaven would be made to appear blacker than the demons of hell. Society destroys friendships. Pride tramples upon the heartstrings and causes distress where there should be peace and joy.

There are many elements in Freemasonry that bind together its members. Underlying them all is the greatest of all doctrines of church or school—the fatherhood of God. Masonry teaches in terms so plain that the humblest may understand, that there is one God, the maker and preserver of all things. To Him, the Wisdom, Strength and Beauty of the universe, all should pay homage, from the king upon his ivory throne to the peasant in the hovel. Masonry does not tell a man that he must worship God according to any particular creed, it does not attempt to define the doctrine of regeneration or election. It leaves all such questions to the man's own decision, after exercising his reason and enlightening his conscience by study. It simply teaches that man has one Father, to whom he owes his heart's best devotion.

Allied closely, indeed, inseparably connected with the doctrine of the fatherhood of God, is that broad fundamental principle of Freemasonry, the brotherhood of man. Every man is a brother to every other man. These two doctrines are, perhaps, the strongest elements of cohesiveness in the institution. All men are equal in the eyes of God. All men are equal in Masonry. Not in the sense of social or intellectual attainment, but in being the creatures of one Supreme Being. Therefore in the Lodge-room all ranks are levelled, all distinctions are done away with, and the prince and peasant, the rich man and the poor, the learned and the unlearned meet upon one common level, and strike hands as brothers. There is a golden chain of sincere affection that binds heart to heart in the mystic circle. Political strife finds no place in the Lodge-room. Religious creeds and theological dogmas are unheard of there. On the same tessellated floor meet the Christian

from his church, the Mohammedan from his mosque, and the Jew from his synagogue. Outside their religious beliefs keep them wide apart, and each goes in divergent ways, but in the Lodge-room there is a common altar erected to the one All-Father, to which all can come and about which all may gather as brothers. This is a strong element of cohesiveness.

We are bound together in ceremonies that teach principles that appeal to the heart of every man, of whatever nation or creed. Virtue and the virtuous are what we seek. Here Truth, Honesty, Temperance, Brotherly Love, Charity, Fortitude, and every good doctrine is inculcated. These principles, so ennobling to the human heart, are the "hooks of steel" that binds us together in a band that circles the globe; and as long as the God of Truth smiles upon our labours, the beneficient influence of this Fraternity must spread, and its beauty and cohesiveness becomes more and more apparent.

We learn in the Lodge-room that the Creator has implanted in man a part that will survive the grave, and never die. In our ceremonies we are taught, "how frail is man," how soon does the body waste away; but born out of this human chrysalis is the undying spirit, that immortal part that came from the lips of God himself, when he breathed into man the breath of life, and he became a living soul. There is a wonderful cohesiveness in the doctrine of immortality. We cannot look upon onr fellow man and realise that he too possesses an immortal spirit, that must return to God who gave it, without being drawn indistinctively toward him as our equal in eternal existence. Side by side we must go through the undying cycles of eternity. Its vastness bewilders thought, but it binds together the whole race of mankind under the Fatherhood of God, and elevates the great binding doctrines of our Fraternity.—The Dispatch.

Ovituary.

BRO. G. GUNSON.

The funeral of the late Bro. George Moore Gunson, whose death occurred with appalling suddenness on Saturday morning, the 23rd ult., took place on Tuesday afternoon, the 26th ult. The relatives intended the obsequies to be of a private nature, but the brethren of the Loyal Cambrian Lodge, No. 110, with whom the deceased was formerly in association, quietly repaired to the Masonic Hall, Merthyr, at half-past one, and then walked up the Courtland Terrace to head the cortège, and they were immediately followed by a company of deceased's fellow members of the Merthyr Chamber of Trade, who had previously assembled at the Bush Hotel. Hence the cortège assumed an imposing appearance. The interment was at Cefn Cemetery, and the burial service was conducted with deep impressiveness by the Rev. J. G. James, who, in his address at the mortuary chapel, touched upon the solemn lesson of the call which had taken the deceased from their midst, and recalled in a consolatory manner several of the appreciatory traits which distinguished the character of the deceased. At the close of the service at the grave side, a short Masonic address was given by Bro. E. B. Nash W.M. of the Loyal Cambrian Lodge.

BRO. WILLIAM THOMPSON.

WE have to announce the death of an honoured member of the Craft, who will be much missed as a befriender of the Masonic orphans, namely Bro. William Thompson, of Rathmines. His illness was of short duration, he being in his usual health until quite recently, but he passed away on the 27th ult., at the advanced age of 89. Bro. Thompson was a member for over fifty years of the Harold's Cross congregation, and during his long connection with that Church he subscribed liberally to its various funds. Bro. Thompson was for many years a retired member of the staff of the Bank of Ireland, and his former colleagues and friends belonging to that establishment will greatly regret his disappearance.

THE funeral of Bro. C. Milsom took place, on the 27th ult., at Bathwick Cemetery, the body being brought into the city, from Claudown, in an open hearse. So that, in my case, the "independent banking account" does not "cost a Lodge money," but "earns some for it." To make myself quite clear, there is no charge whatever for keeping it made by the bank.

The Provincial Grand Mark Lodge of Cornwall is to assemble at the Masonic Hall, Public Rooms, Truro, on Tuesday next, 9th August, at 2 p.m., under the wing of the Fortitude Lodge, No. 78, of that city. Sir Charles B. Graves Sawle, Bart., is the Provincial Grand Master, and Bro. Thomas Chirgwin, J.P., Deputy Provincial Grand Master. The Mark degree has flourished in Cornwall for about 27 years, and was never more popular than now, the Province being well managed, with a popular ruler and a most courteous Provincial Grand Secretary.

The Candour Lodge, Uppermill, held their annual pic-nic on Monday, the 18th ult., to Ripon, and were favoured with beautiful weather. The company of about 60, who left Saddleworth by the 9.30 train in two saloon carriages, had a most pleasant time of it. On arriving at Ripon, lunch was partaken of at the Unicorn Hotel. and after the Cathedral had been visited the company drove in carriages to Fountains Abbey and Studley Royal, returning to the Unicorn at 6.30, when a sumptuous dinner was served. The party left for Saddleworth, arriving by the last train.

Other members of the Hamilton family are distinguished members of the Craft, Lord George himself being a Past Senior Grand Warden of the United Grand Lodge of Freemasons, and a generous supporter of the noble charities connected with the Order. Doubtless, the large and influential Province, inaugurated and so successfully ruled by its last honoured chief, will, under its new master, continue its important Masonic work.—West Middlesex Standard.

PROVINCIAL GRAND LODGE OF NORTH AND EAST YORKSHIRE.

N the 27th ult., the Provincial Grand Lodge and General Communication of Masons of the Province of the North and East Ridings of Yorkshire was held, on the invitation of the North York Lodge, No. 602, in the Town Hall, Middlesbrough, and was attended with great success. Every possible preparation had been made by the brethren of the North York Lodge to secure the comfort and convenience of the visiting brethren, and the Town Hall in which the Provincial Grand Lodge was held was well adapted for the purpose, there being plenty of room. The large hall in which the Lodge was held was splendidly decorated for the occasion with palms, evergreens, and flowers, while national and other flags and floral emblems were neatly interspersed over the hall. Prior to the Lodge the Board of Benevolence met in the ante-room at the east-end, and voted £95 for the relief of aged and distressed Masons of the Province. There was a very large gathering of brethren, all the Lodges in the Province being well represented. The brethren having donned Masonic clothing and signed their names were directed to their seats by the Stewards in the Lodge-room, where they awaited the approach of the Provincial Grand Officers. Owing to Viceregal duties in Ireland, his Excellency the Earl of Zetland, G.M. of the M.I. Order of St. Patrick and Provincial Grand Master, was unable to be present, but the business of the Lodge was ably conducted by Lieut.-Col. the Hon. W. Orde-Powlett P.G.W. of England and Deputy Provincial Grand Master.

On the approach of the acting Prov. Grand Master, the brethren rose and remained standing until the Provincial G. Lodge was opened, when they greeted the acting Prov. Grand Master and his Deputy with grand honours. On the motion of Bro. J. W. Woodall, the minutes of the last Grand Lodge, held at Thirsk, and of the special Provincial Grand Lodge were unanimously confirmed.

The accounts of the Prov. Grand Lodge for the past year were read, and showed a goodly balance in hand. They were unanimously adopted, on the motion of Bro. Woodall.

The result of the Board of Benevolence meeting was read by Bro. Peck, as was a statement showing the condition of the Board of Education fund, which was read by Bro. W. Reynolds, the Provincial Grand Treasurer. Bro. Woodall moved that the report be received and adopted. They had all heard that their funds were in a fairly prosperous and profitable condition, and he was glad to think that their income from the charity fund was sufficient from the subscriptions of the various Lodges without any special appeal being made to them. At the same time he pointed out that this good work was particularly worthy of their support, and he trusted that many who knew the great advantages of a good education would see that the work which was going on was one which they could conscientiously place before their brethren.

Brother Todd, seconded the adoption of the report, and congratulated the members of the Lodge upon its satisfactory nature. There was also cause for congratulation on the fact that the subscriptions had come in so well from the different Lodges.

The report was put and carried unanimously.

Bro. W. H. Cowper then presented the report of the Charities and alluded to the fact that during the past year their Province had been successful in getting two boys admitted into their Masonic School. He had had to borrow a large number of votes to carry the election, but he hoped at the end of the present year to be able to repay them. He referred to the fact that the Province had given £696 9s 10d in contributions to the Charity Schools. He moved the adoption of the report, which Bro. Falkinbridge seconded, and it was carried.

Bro. Todd moved the re-election of Bro. Walter Reynolds as Provincial Grand Treasurer. Bro. W. H.

Cowper seconded, and it was carried.

On the motion of Bro. Geo. J. Robinson, seconded by Bro. Beavers, Bros. Woodall and Tessyman were re-elected the representatives of the Provincial Grand Lodge; while, on the motion of Bro. Foley, Brothers Fullerton and Whiteside were re-elected auditors. Brothers Woodall, Whitehead, Watson, Sykes, Rymer, and Tozes were then reelected a Committee of General Purposes.

Boys, addressed the brethren, and pointed out that during the past two years the generosity of the Craft had been exemplified in a most remarkable way, and he hoped that increased support would be given to the School to enable the children of Freemasons to receive a good education.

The reports were then handed in from the various Lodges in the Province, and showed that Freemasonry was largely on the increase in the North and East Ridings.

The Deputy Provincial Grand Master appointed and invested the Provincial Grand Officers for the ensuing year, as follows:-

Bro. Todd said that the late Bro. Holland, who was Prov. Grand Treasurer of the Lodge, had left the old Treasurer's book with the York Lodge, and they had passed a resolution that it should be handed over to the Provincial Grand Lodge, to whom it belonged. The W.M. of the York Lodge said he intended to have handed the book over, but he had come and forgotten it, but would do

so at an early date.

The Deputy Provincial Grand Master said he only wished the Provincial Grand Master had been present to have seen the hearty welcome the Provincial Grand Lodge had received from the brethren of the North York Lodge. Middlesbrough. He read both a letter and a telegram from his Excellency the Earl of Zetland, expressive of the regret that nobleman felt at being unable to be present. He (the Hon. W. T. Orde-Powlett) believed that since Lord Zetland had been in Ireland that occasion was the first time he had been unable to be present with them and preside over their meetings. Since the Provincial Grand Lodge had visited Middlesbrough, nine years ago, he noticed that Freemasonry had steadily increased until now they had three flourishing Lodges in the Borough. He then feelingly alluded to the death of H.R.H. Bro. the Duke of Clarence, and to the decease of Bros. W. J. Taylor, A. T. Rogers, and other prominent Freemasons, after which he said that although they had had no festival this year, yet he was pleased to see that their charities had been well supported. In conclusion he said that invitations had been received from the Old Globe, Scarborough, the Constitutional Lodge, Beverley, and the St. Germaine Lodge, for the next Provincial Lodge meeting to be held. He would take the earliest opportunity of handing them over to Lord Zetland, who would decide where it was to be held. He thanked the brethren for having listened to him, and also the North York Lodge for the magnificent arrangements they had

A vote of congratulation having been passed to the Earl of Zetland on the marriage of his daughter, Lady Hilda Dundas, to Lord Southampton, the vote was, on the motion of Bro. Woodall, ordered to be illuminated.

The hymn "Hail Masonry Divine" was sung, Bro. Shepherd singing the solo in splendid style, after which the Lodge was closed in due form and with solemn prayer.

A banquet was held in the Crypt beneath the Town Hall, which was attended by over 120 of the brethren. The Deputy Provincial Grand Master presided, and gave the toast of the Queen and the Craft. A special setting of the National Anthem by Bro. Peck was sung, Bro. Lansdale singing the solo. The Chairman then gave the Prince of Wales Most Worshipful Grand Master, which was loyally honoured, and a new ode, "God bless our future Monarch," was heartily sung. The other toasts were the Right Hon. the Earl of Lathom, the Bro. McLeod, from the Royal Masonic Institution for Right Hon. the Earl of Mount Edgeumbe, and His

Excellency the Earl of Zetland. Bro. W. J. Watson submitted the health of the Hon. W. S. Orde-Powlett Deputy Provincial Grand Master, which was given with cheers. Colonel Sadler submitted the newly appointed Officers, and Bro. Theo. Ward and others responded. Bro. W. H. Cowper gave the Masonic Charities, and Bro. McLeod replied. The Deputy Provincial Grand Master proposed the W.M. of the North York Lodge, and paid a high compliment to Bro. W. J. Watson P.M. for the excellent arrangements. Bro. W. J. Bruce W.M. replied. After Bro. Woodall had proposed the Visiting Brothren, to which Bro. McLeod responded, the proceedings, which were enlivened with capital songs and music, terminated.

PROV. GRAND LODGE OF MONMOUTH.

LARGE gathering of Freemasons assembled, on the 28th ult., at the annual meeting of the Provincial Grand Lodge of Monmouth, which was held in the afternoon at the Masonic Hall, Newport, under the banner of the Albert Edward Prince of Wales Lodge, No. 1429. The proceedings excited more than ordinary interest, inasmuch as advantage was taken of the meeting to present to the Provincial Grand Master and Deputy Provincial Grand Master addresses, and also to each of them a handsome table ornament, consisting of a silver centrepiece, in commemoration of their twenty-one years' rule over the Province.

Provincial Grand Lodge was opened by the Provincial Grand Master, who was supported by the Deputy Provincial Grand Master and Officers of Grand Lodge.

Excuses for the absence of members having been read, a roll call of the Lodges took place, after which the Provincial Grand Registrar presented the returns of each Lodge, showing a total of 582 members, of whom 61 were new members. The Provincial Grand Treasurer presented the annual report, which showed a balance to the credit of £201.

The charity report was presented by the Deputy Provincial Grand Master, who announced that Edith M. Morgan was elected to the Girls' School from Philanthropic Lodge, No. 818, at a cost of 3,189 votes, and that a brother of the Loyal Monmouth Lodge had been elected to the Benevolent Fund by 3,395 votes. These successes could not have been obtained without the aid of the Western Provinces Charity Association, of which he (the Deputy Provincial Grand Master) continued to act as Chairman, but it had entailed a heavy debt on the Province—3,353 votes-and an appeal was made to the brethren to repay this by subscribing liberally, so as to increase the voting power. Thanks were given to the brethren of the four Lodges who acted as Stewards, in conjunction with Brother Wm. Pickford Provincial Grand Treasurer, for the sum of £256 collected for the Girls' School Festival in May 1891. It was suggested that a Steward should be appointed from the Province for the Benevolent Festival in February next, and that the sum of 30 guineas should be voted towards the same. The report was adopted.

Bro. Colonel Perkins, on behalf of the brethren of the Province, then presented the addresses to the P.G.M. and D.P.G.M. In so doing, he dwelt on the gre t progress that had been made by the Province of Monmouth during the time that those brethren had ruled over it. Twenty-one years ago, he said, the Province was and increased numerically and influentially by leaps and bounds, and now no Province was better known for the excellence of its work, for its harmonious proceeding, and for its Masonic charity than that of Monmouth.

Bro. William Watkins P.G.S.W., honorary Secretary of the Testimonial Committee, then read the address. That to Colonel Lyne was as follows:-

To the Right Worshipful Brother Colonel CHARLES LYNE, D.L., J.P., Provincial Grand Master, 28th July 1892.

We, the Members of the Provincial Grand Lodge, and Brethren of the Province, congratulate you on having attained the twenty-first year of your rule over this Province. We are proud of being governed by a chief who has done so much honour to Freemasonry, and who so well knows what Freemasonry means. It is impossible to overestimate the esteem and regard entertained for you, and it is most gratifying indeed to us to have the privilege of assembling this day to offer you some tangible proof of the respect we have for one who has endeared himself not only by his Masonio virtues, but as a dear friend, I

a good neighbour, a devoted public man, and an officer in Her Majesty's service.

May it please the Great Architect of the Universe to spare you for many years, to continue to be a shining light in Freemasonry, ruling over this Province with the same zeal and assiduity you have shown for the last twenty-one years, and when summoned from your labours here, may you be found worthy to receive the reward promised to those who will work diligently in His Holy Temple So mote it be.

The address to Captain Homfray was inscribed on the title page as follows :

To the Worshipful Brother Samuel George Homfray, J.P., Past Assistant Grand Director of Coromonies England, Deputy Provincial Grand Master, 28th July 1892.

Following on in the succeeding pages the address was exactly similar to that presented to the Provincial Grand Master.

The addresses were on vellum, beautifully written, and prepared by Messrs. Waterlow and Sons, Limited, London. A neat border surrounded each page. The title page of each address was illuminated in ornate style, the coat of arms and crest of the two gentlemen being in the centre of the page, with a representation of the seal of the Province above, and of their jewel of office below. The addresses were enclosed in handsome Russian leather cases, stamped in gold.

Colonel Perkins having handed the addresses to the presentees,

Colonel Lyne expressed to the brethren his deep gratitude for their recognition of the services he had rendered to the Province. He felt sure that one and all felt deeply for him at that moment, but they could not feel as he did. Nothing was more difficult than to fittingly acknowledge such kindness as theirs. Their fellowship and friendship were formed long ago and had continued unabated until the present. He had made many kind friends and few enemies, and they had been a happy and united family, for within that threshold they knew no differences. His gratitude was due to the Deputy Provincial Grand Master for his services; and to a large extent they were indebted to Captain Homfray for the great advance Monmouthshire had made in its support to. the Masonic Charities and also for the assistance it had

been able to obtain from them. Deputy Provincial Grand Master feelingly acknowledged the presentation, remarking that it was a source of the greatest pleasure to have worked for the last 21 years with Colonel Lyne, under whose rule the Province had made great progress. Indeed, in the present time there was no Province more successful or which received greater respect than that of Monmouth.

After the presentation of the addresses Bro. Tennant Deputy Provincial Grand Master of the Eastern Division of South Wales was announced and admitted. various offices of Provincial Grand Lodge were declared small in numbers, and was comparatively unknown, but, vacant, after which Bro. W. Pickford was unanimously reunder the benign rule of Colonel Lyne and his Deputy, it elected Provincial Grand Treasurer, and Bro. H. Richards was elected Provincial Grand Tyler. The Provincial Grand Master then appointed and invested the Provincial Grand Officers for the ensuing year, as follow:

A vote of condolence was passed to Mrs. C. P. Evans on the death of her husband, who was Provincial Grand Senior Warden for the year. A formal vote of thanks was given the visitors for their attendance, and Grand Lodge

A large number of the brethren who had been present at Provincial Grand Lodge afterwards attended a banquet at the King's Head Hotel. It had been arranged that Bro. John Allan Rolls P.G.S.W. should make the presentation of the centrepieces to the Provincial Grand Master and Deputy Provincial Grand Master, but he telegraphed stating that he was unable to attend. The duty was, however, performed by Sir George Elliot, who is Provincial Grand Master of the Eastern Division of South Wales, and who, having travelled from London during the day, arrived during dinner.

The toast list opened with the Queen and the Craft, which was followed by that of the Most Worshipful the Grand Master of England H.R.H. the Prince of Wales. In proposing this, the Provincial Grand Master said there was no one more deservedly popular, especially among Freemasons, than the Prince of Wales. The Order was deeply indebted to His Royal Highness, who came to its rescue when it was, in a sense, rather proscribed, and for the position they now held they were more indebted to

their Grand Master than to any one else.

Bro. C. Lyne jun. gave the toast of the Pro Grand Master the Earl of Lathom, the Deputy Grand Master and Officers of the Grand Lodge, to which the Rev.

W. J. L. D. Stradling replied.

Sir George Elliot, in proposing the toast of the Provincial Grand Master, Colonel Lyne, and Deputy Provincial Grand Master Captain Homfray, made the presentation of the centrepieces. He said he was sure his presence there that evening was a pleasure to his friend Colonel Lyne, and to Colonel Lyne's friends. They knew no politics there. They were all friends. Good friends, he continued were a kind of real property which he urged his hearers never to lose. He presented the handsome ornaments on the table with the sincere expression of their good wishes and esteem for the recipients. In conclusion he dwelt on the objects of Freemasonry, and asserted that its religion was as pure and its morality as high as they could get in ? any institution, ecclesiastical or otherwise.

The centrepieces are splendid examples of the silversmith's art. Within a portal formed by three exact representations of columns in the Corinthian, Doric, and Ionic examples of architecture stands a charmingly modelled figure of Wisdom, at one side of her being a beehive, emblematic of industry. There are three branches and one centre dish for holding fruit or flowers. At the base of each column are faithful representations of Masonic working tools, and round the top are shields bearing representations of the various jewels, the ones in front being those denoting the offices of the recipients of the valuable and massive, yet graceful 'ornaments. Each centrepiece has on it an inscription. The one to Colonel Lyne is as

follows:-

Presented to the Right Worshipful Brother Colonel Charles Lyne, D.L., J.P., Provincial Grand Master, by the Freemasons of Monmouthshire, in commemoration of his 21 years' rule over the Province, 28th July 1892.

The inscription on the centrepiece presented to Captain Homfray reads:-

Presented to the Worshipful Brother Captain S. George Homfray, J.P., by the Freemasons of Monmouthshire, in commemoration of his 21 years' rule as Deputy Provincial Grand Master, 28th July 1892.

The centrepieces are of bold, yet graceful and chaste design, being quite unique in their way, and reflect the greatest credit on Messrs. Rainforth and Son, Newport, who were entrusted with their design and manufacture.

Colonel Lyne, in acknowledging the gift, spoke of his twenty-one years' rule of the Province as a period of unalloyed pleasure. He had never regretted for one single day or hour his connection with the Province. Although his appointment came from the highest authority in the Order, it was upon the unanimous requisition of the Address, The Secretary, I Fitzalian Square, Sheffield.

brethren of the Province that he was appointed to the office, and he had retained it up to the present by their wish and at their request. The responsibility attaching was very great. He had never met anything but kindness at their hands, and the handsome gift they had made to him he would hand down to those who were dearer to him than he was to himself, as a memento of kindness which he was sure they, like himself, would never forget. Shakespeare had said :-

> The friends thou hast, and their adoption tried, Grapple them to thy soul with hooks of steel.

And he for his part would wish to do so. He did not think there was a more happy family in Freemasonry than there was in that Province. He went on to speak of the benevolent objects of the Order, and referred to the indebtedness under which he laboured, and the Province also laboured, to his good worthy and lear Bro. Homfray, whose services in promoting the Masonic Charities and in getting a fair share of their benefits for Monmouthshire he highly prized. In conclusion, he urged upon the Worshipful Masters of Lodges not to care so much for numbers as the merit of their members. He said they should obtain good and true men whom they could respect, and with whom they could associate in good fellowship, and reminded that one black sheep would ruin a whole flock.

Captain Homfray also returned thanks, and, on his part, bore testimony to the amicable relations which had always existed between himself and the Provincial Grand Masters. The token of the esteem and regard of the brethren was almost too much for him to fittingly acknowledge. He appreciated very highly the good will and good fellowship

of the Province.

Colonel Perkins proposed in a felicitous speech the Masonic Charities, to which Bro. Mason, of the Royal Masonic Benevolent Institution, replied, and in the course of his remarks bore very high testimony to the liberality of the Province of Monmouth to the Charities of the

The toast of the Visitors was next given by the Prov. Grand Master, and acknowledged by Bro. Stradling, and the Worshipful Master of the Albert Edward Lodge, Bro. George Hazell, and the Lodges of the Province, and the Tyler's toast concluded the list.



Bell Grand Master of Manitoba presided, and after the removal of the cloth toasts were proposed, the first being the Queen and the Craft, which was duly honoured, Bro. Rigg leading in the National Anthem.


