### THE PARLIAMENT OF THE CRAFT.

at the Quarterly Communication of Grand Lodge on Wednesday next, in view of the large and varied amount of interesting business on the Agenda, some of which is intended to influence the future working of the Craft by the introduction of changes that may be set down as radical and far-reaching.

Not the least in importance, althought not the first in order, is the notice of motion given by Bro. W. F. Lamonby, who seeks to make Canvassing by or for a Candidate for any elective office in Freemasonry stamped as unconstitutional, and prohibitive under pain of punishment by the Board of General Purposes, or its District or Provincial counterpart.

We may at once say we do not imagine Bro. Lamonby has the smallest possibility of carrying his suggestion, at least not in its present form, the course he suggests being far too severe, even if the evil he proposes to deal with were much more acute than is actually the case; while the difficulty of carrying such a law into force seems to us to be so great as to virtually nullify it, as the law would either have to remain a dead letter, or ninety-nine of every hundred elective appointments would be brought within its scope, as the mere suggestion that such and such a Brother was qualified for a particular post might be construed into an act of canvassing on his behalf.

We may conclude that the position of Grand Treasurer of England is the one which of all others has lately led to the extension of the work of active canvassing, and it is probable it is the action of Brethren in regard to that office which has led to Bro. Lamonby's proposition. We will not say we regard active canvassing for this appointment as either necessary or the reverse, but may review the facts of the case and leave Brethren to form their own opinion, even if they have not already done so in regard to this point. First we may ask, how is a deserving Brother to secure the coveted honour if he and his friends allow his light to remain hidden? and how are they to announce it to the world without laying themselves open to the charge of canvassing on his behalf?

The evil of the system is, perhaps, the excess to which it has been carried in recent years, but if we analyse these apparent excesses we find they arise from the greater popularity of the candidates themselves. An energetic Brother who is known far and near is more likely to secure a small army of energetic workers on his behalf when he aspires to an elective office than the Brother who is virtually unknown outside his particular circle, so that it may really be argued that the popularity of a man is the true cause of the excitement that attaches to his election, and the tactics deemed necessary to secure it.

The question of the continuance or otherwise of the Colonial Board will also require consideration at the coming meeting, but this subject seems to be best summed up in the opinion expressed by the District Grand Lodge of Bombay,

to the effect that it appears "a matter of perfect indifference whether the affairs of Lodges abroad are administered by a Colonial Board, the Board of General Purposes, or a Sub-Committee of the latter." What is really wanted is a Board that will work harmoniously with the Lodges beyond the seas, and use every effort to secure and maintain perfect unanimity. One of the reasons urged in favour of the abolition of the Colonial Board was the friction it apparently maintained with many of its subordinates. It may not be the Board was wholly to blame for the disagreements to be met with in various parts, but we believe much of the trouble was the immediate outcome of the unbending position it took up—to outsiders there was often more appearance of might in its actions than right.

A very unusual event at this season of the Masonic year is the prospect of a contested election for the chief positions on the Board of Benevolence, two candidates being nominated for the post of Senior Vice-President, and two for that of Junior, and we anticipate the decision of the relative claims of the different Brethren will lead to some lively proceedings. These positions, it seems to us, hardly lend themselves to a contested election, yet how otherwise is a decision to be arrived at? It must be recognised there are many others, beyond the four whose names are now before the Craft, who are amply qualified for the appointments, and fully deserving of some tangible recognition at the hands of their fellows in the Craft. Why not make these Offices yearly ones, just as is now the case with the Grand Treasurership?

We are pleased to see substantial recognition is proposed for the Scholarship Fund for the Royal Masonic Institution for Boys, and we hope Sir John Monckton's motion to vote two hundred guineas for this purpose will be carried, as by securing the early approval of Grand Lodge for the scheme its future success may really be set down as assured, although we think sufficient has already been done on its behalf to carry it beyond the realms of mere suggestion.

The annual supper of the Walthamstow Lodge of Instruction, No. 2472, was held on Monday, 18th inst. We regret we are compelled to hold over our report until next week.

### SUSSEX.

LOYAL and hearty welcome was given by the people of Eastbourne on Wednesday of last week, to his Royal Highness the Duke of Connaught, who visited the town for the purpose of attending the annual meeting of the Provincial Grand Lodge of Sussex, which was held at the Queen's Hotel. Admirable arrangements had been made at the railway station, under the direction of the Station Superintendent, Mr. T. W. Dean. The arrival platform for a distance of about thirty yards was carpeted with red baize, and the columns supporting the roof were trimmed with evergreens and surrounded with chrysanthemum plants in flower. Shortly after half-past two a hundred men of the 2nd Sussex Artillery Volunteers, under the command of Captain Kelsey, and accompanied by the band of the corps, arrived and were drawn up two deep in the roadway facing the arrival platform. In a row behind the Volunteers were stationed 18 of the West Kent (Queen's Own) Yeomanry, under the command of the Marquis of Camden, Captain and Adjutant Landale being also on parade. The Royal train, which was in the charge of Mr. Richardson, Traffic Superintendent, and was drawn by the engine "Albany," was timed to arrive from Victoria at three o'clock. As a matter of fact it ran alongside the platform a minute in advance of time. As the Duke stepped from his saloon, the guard of honour presented arms and the band played the National Anthem.

The Mayor was introduced to his Royal Highness by Sir William Marriott, and his Royal Highness having intimated his compliance with the Mayor's request to hear the Address, the

Town Clerk read it.

The Mayor having duly presented the Address, his Royal Highness replied in the following terms:

Mr. Mayor and Gentlemen,—I am very sensible of the very kind remarks in the address you have just presented. It is now, I am sorry to say, eighteen years ago since I was last in this town. I carried away with me the most pleasant recollections. It was on a rather sad occasion when I was here. I came to see my dear sister, who was already then in very bad health, and who, as you remember, died a few months afterwards. But we all in my family remember with gratitude the kind reception you gave her at all times, and I am sure her family still remember with pleasure their stay here at Eastbourne. May I ask you to express to the inhabitants my gratitude for the words you have expressed to me?

A move was then made for the carriages in waiting, and a procession was formed, members of the Masonic body, the Councillors and Aldermen occupying a dozen carriages, preceding the Mayor's carriage, which contained the Duke, the Mayor, Sir William Marriott, and Colonel Egerton (the Duke's equerry).

The Gildredge Hotel was tastefully adorned, the sentiment "Welcome to our Prov.G.M." being writ large on the balcony

facing the station.

At four o'clock the Provincial Grand Lodge was opened at the Queen's Hotel, under the presidency of the Duke of Connaught Provincial Grand Master, who was supported by Sir W. T. Marriott, Q.C., S.G.D. Deputy Provincial Grand Master, and many other distinguished Craftsmen.

The minutes having been confirmed, highly satisfactory reports of the Board of Finance and the Charities Committee

were adopted.

The Provincial Grand Secretary read statistics showing the present strength of each Lodge, the entire Province numbering

1,389 members.

The Provincial Grand Master next addressed the Brethren as follows:--" Once more Brethren I am pleased to greet you all after another year of quiet progress and steady prosperity. I find the number of initiations is up to a fair average, but there are a great many resignations, leaving the actual increase in numbers only five; as far as I known nothing has occurred to interrupt the harmony of our Masonic proceedings. I have much pleasure in holding the annual meeting of Provincial Grand Lodge in this beautiful town of Eastbourne—a town in whose progress and rapid growth I take a sincere interest. My desire is that the annual meeting of our Provincial Grand Lodge should be held at different times in the different towns of importance in the Province, and I intend that next year it shall be held at the ancient and historic Borough of Hastings, the Brethren of whose Lodges, I have been informed, are anxious to receive Provincial Grand Lodge. I have received a petition for a new Lodge at Shoreham, and considering the circumstances under which the Burrell Lodge was removed to Brighton, I certainly did not, at first sight, think it either desirable or expedient to recommend the petition. I found, however, upon enquiry that the removal was purely a local matter, and, when the first Master, who is an old and respected member of the Provincial Grand Lodge, gave his assurance that there were several persons in the town of Shoreham who were willing to become Masons, that the Town Hall was available for the meetings, with every prospect of a permanency, that the necessary funds had been provided, and that there was no doubt of a successful future, I could not refuse to recommend the petition, and have this day signed it, and hope the result will prove that I have done right, and that the Lodge

will progress without drawing members from neighbouring towns in which there are other Lodges. I understand also that another petition will shortly be presented to me for a Lodge at Bexhill; when I receive it I shall certainly severely scrutinise the signatures, as although a rising town like Bexhill may fairly be expected to provide a Lodge, I should be very sorry to see one established if likely to do harm to any of the existing Lodges in the neighbourhood. I regret very much the serious indisposition of my Provincial Senior Grand Warden Bro. Morrison; he is so universally esteemed, and his services to Masonry have been so great, that I trust the Great Architect of the Universe will spare him to us for some time longer. I should like the Secretary to write to him and say how much we missed him, and how sincerely we sympathise with him in his affliction, and look forward to his further presence amongst us. You are kind enough to send me many invitations to attend your installation meetings, but you will quite understand that my time is so taken up by my profession and other engagements I can seldom spare a day to attend a meeting in Sussex, but whenever it is possible I will come and visit you, and even to-day I was forced to interfere with one of four Lodge meetings, but I could not help it. Rest assured I take the deepest interest in all that concerns Masonry in the Province, but am obliged to leave the greater part of the business in the hands of my Deputy Provincial Grand Master, who I am glad to find restored to health after his recent indisposition, and I congratulate him on his appointment as Senior Grand Deacon of England. I am pleased to hear that the Masonic Club established at Brighton has proved a success, and that many Brethren from London have joined it, thus giving an opportunity of exchanging Masonic votes and receiving and giving information without bringing Masonry to the front in presence of those who do not belong to the Craft. I cannot conclude without expressing extreme satisfaction at the numerous attendance to-day, and with the cordial reception I have received both from my Brethren in the Craft and the local authorities. I can only repeat that my services are, so far as lies in my power, at the disposition of Masonry, and rest assured that if I do not visit you as often as I should wish, your affairs have my earnest attention.

Bro. J. M. Reed was re-elected Provincial Grand Treasurer, and was warmly congratulated by the Provincial Grand Master upon the honourable and successful manner in which he carried out his duties.

The Provincial Grand Master then appointed his Officers for the ensuing year, and invested those present with the insignia of their respective offices, as follow:—

The Provincial Grand Lodge having closed, the Brethren sat down to a banquet, under the presidency of the Duke of Connaught, who opened the toast list by briefly proposing the Queen and the Craft.

In submitting the M.W. Grand Master His Royal Highness the Prince of Wales, the Duke said he was sure the toast would be received with greater cordiality than usual, for all would heartily congratulate the Prince upon the recent engagement of his daughter.

The Provincial Grand Master next proposed the Officers of Grand Lodge Present and Past. His Royal Highness said it was highly satisfactory to see the great interest taken in the welfare of the various Provinces by the Officers of Grand Lodge, and it gave him great pleasure to see Bro. Sir W. T. Marriott, Bro. Col. Egerton, Bro. the Very Rev. E. R. Currie, and other Grand Officers present. On the other hand the Officers of Grand Lodge fully appreciated the manner in which they were supported by the Provinces.

The Very Rev. Bro. E. R. Currie (Dean of Battle) P.G. Chaplain, in acknowledging the toast, said the Provinces owed

much to Grand Lodge, and the latter were indebted to the Provinces, inasmuch as it was made up of Masons from the various Provinces. Sussex, he said, was the only Province presided over by a Royal Duke, and so long as the Province had such a Grand Master the Brethren need have no fear of

Freemasonry in the county.

The Deputy Provincial Grand Master next proposed the M.W. Provincial Grand Master H.R.H. the Duke of Connaught. The Brethren in Sussex were always delighted, he said, to have their Provincial Grand Master with them. They all knew the many duties his Royal Highness had to perform, and they were therefore the more grateful to him for visiting them that day. In many countries Freemasons, he said, were suspected by those in power, but here there was no more loyal body of men than Freemasons, who were united by a bond of Brotherly love. Masonry united all classes, and at their head was the Royal

Family.

The Provincial Grand Master, on rising to respond, was received with enthusiasm. He said he was extremely grateful for the kind reception given to the toast, and he felt happy in being able to be with them. In the Lodge he had spoken, he said, of his many engagements of a military and social character, and though those duties prevented him from being a frequent visitor amongst them he could assure them that he took the deepest interest in the welfare of the Province. The resumé given in the Lodge of the work of the past year he regarded as satisfactory. He was pleased to see so large an attendance of the Brethren, and thanked Bro. Alderman Skinner (Mayor of Eastbourne), and those who had assisted his Worship in giving him such a hearty welcome to the town. Alluding to the bond of Brotherly love uniting all classes, he said his relative, Prince Leopold of Prussia, had been much struck by the loyalty and union which characterised English Freemasons, and wished to see the English and German Freemasons in closer union. The Prince of Wales had conferred upon Prince Leopold the honour of Past Grand Master.

Before sitting down the Duke wished to propose the Deputy Prov. Grand Master Bro. the Right Hon. Sir W. T. Marriott, Q.C., Senior Grand Deacon, and the Officers of Provincial Grand Lodge Present and Past. His excellent friend Sir William Marriott had worthily occupied his place during his absence on many occasions, and had ably carried out the great work imposed upon him. He was sure Sir William took great interest in the Province, and warmly congratulated him upon his appointment

in Grand Lodge as Senior Grand Deacon.

The Deputy Provincial Grand Master, who was warmly received, said he could not plead one-tenth of the engagements of H.R.H. the Duke of Connaught as an excuse for his absence from the Province, but he regretted that recently he had been in the hands of that despot, the doctor, who, at one time, had absolutely forbidden him from attending to his Masonic duties. Loyalty had, however, characterised the Brethren of Sussex, and, in the hands of Bro. Freeman, the Province had been perfectly safe. Indeed, no Province, he said, had a better Secretary than Sussex had in Bro. Freeman. He hoped, with renewed health, to be able to attend the various Lodges as usual. He then submitted the Visitors, to which Bro. Col. Fitzgerald responded.

In proposing the Royal Masonic Institutions, Bro. Joseph Farncombe embraced the opportunity of making sympathetic allusion to the severe illness of Bro. Morrison—a Brother who was beloved throughout the Province. Sussex, he said, had done well in the past in the support of the Masonic Institutions, and he hoped the Brethren would rally round the Duke of Devonshire, who intended acting as the President of one of the Masonic

festivals next year.

Bro. J. Terry, in responding, said Sussex had done nobly in the past with regard to the Masonic Charities, and had a splendid representative in Bro. J. M. Reed. During the past year the Province had subscribed nearly £1,300, and he hoped the Sussex Brethren, whom he heartly thanked, would continue their excellent support of the Benevolent Institutions.

At this stage of the proceedings the Provincial Grand Master left to catch his train, and the vacated chair was taken by the Deputy Provincial Grand Master, who proposed the Masters of the Lodges in the Province, to which Bro. Lloyd responded.

Bro. E. R. Currie gave the Stewards, eulogising them for the admirable arrangements they had made for the meeting and banquet.

Bros. J. H. Whatford and W. A. Raper acknowledged the toast, and the Tyler's toast brought the gathering to a close.

An especial word of praise is due to the Stewards, Bros. J. W. Masters, J. H. Whatford, W. A. Raper, J. Wood and R. P. Clowes, who did all that was possible to ensure the comfort of those present. During the evening a pleasing programme of vocal music was sustained by the Lewes Orpheus Glee Union, who rendered several glees in good style, while Messrs. W. N. Barnard, and E. T. Hall also contributed songs. The duties of director and accompanist were in the able hands of Mr. Percy Starnes.

The Duke left the Queen's Hotel at a quarter to nine, and reached the station five minutes later. Several thousand people had assembled to witness His Royal Highness's departure, and, on the arrival of the carriage, in which were also seated the Mayor and Colonel Egerton, hearty cheers were given. As the Duke alighted from the carriage the band of the 2nd Sussex Artillery Volunteers played the National Anthem, and, when the train steamed out of the station, they struck up "Auld Lang Syne." The train left at five minutes to nine o'clock.—"Sussex Daily News."

### EAST LANCASHIRE.

THE half-yearly meeting of the Provincial Grand Lodge of the Eastern Division of Lancashire was held in the Hulme Town Hall, on Friday of last week, Colonel Le Gendre N. Starkie Provincial Grand Master occupying the chair, supported by many P.G. Officers.

The roll of Lodges of the Province was called, all but three

being represented.

The minutes of the annual meeting held at Denton, in May, were taken as read and discussed. On the subject of a resolution affecting the procedure of the Finance Committee, Brother Heelis moved the appointment of a Committee to examine the books and accounts, and consider the most convenient day for the annual closing up of the receipts and expenditure of P.G.L., and report thereon to the May meeting, it being explained that the Committee was not to be permanent.

The motion was seconded, and a number of names submitted for election. Ultimately, however, it was decided that the selection should be left in the hands of the P.G.M., who submitted the following, which were accepted, viz.:—Bros. J. H. Sillitoe P.G.St.B., R. T. Sutcliffe P.G.D.Reg., S. F. Butcher P.G.S., J. B. Goulbourne P.J.G.D., and W. Allitt P.G.

Three Auditors having been elected, the report of the proceedings of the Charity Committee was read and adopted, and a vote of thanks passed to the Committee for their services.

Bro. Heelis moved, and Bro. J. Andrew seconded, and it was unanimously resolved, "That 50 guineas be given to the Fund for Aged Freemasons, 50 guineas to the Widows' Fund, 50 guineas to the Royal Masonic Institution for Boys, and 50 guineas to the Royal Masonic Institution for Girls.

Bro. F. R. W. Hedges, the Secretary of the last-named

Institution, thanked P.G.L. for its generous gifts.

Invitations were received from Brethren at Darwen and Rawtenstall to hold the next annual meeting of P.G.L. at those places. It will be 21 years in 1896 since P.G.L. held its annual meeting at Darwen. There was no other business of importance. -" Manchester Courier."

### MASONIC HOMES IN VICTORIA.

COUPLE of cottage homes, recently added to those already established by the Freemasons on their ground bordering Punt Road, Prahran, for the purpose of sheltering and maintaining aged members of the Craft unable to provide for themselves, were formally opened by Sir W. J. Clarke M. W.G.M., on Saturday, 12th October, in the presence of a large gathering of Masons. The cottages, now six in number, stand on five acres of land adjacent to the Alfred Hospital. Mr. B. D. Smith, on behalf of the Committee, tendered a hearty welcome to Sir William and Lady Clarke, and stated that the foundation stone of the first cottage was laid on 7th March 1867. There was room on the ground for twenty-eight cottages. At present it

cost between £150 and £200 per annum to maintain the inmates. Sir William Clarke said he considered it a great honour to have been asked to declare the cottages open, more especially as Lady Clarke's name was associated with his in the ceremony. Lady Clarke had been delighted to devote the afternoon for the purpose. No other pleasure could tempt her away, not even the races, although she had a horse running and expected Sir William then unveiled a tablet on the wall, to commemorate the connection of the United Grand Lodge of England with Freemasonry in Victoria; also two others in memory of the late John T. Smith Provincial Grand Master, and James Moray Henry P.M. After a vote of thanks to Sir William and Lady Clarke, Visitors were invited to partake of refreshments before finally separating.—" Melbourne Age."

### CEREMONY AT KINGSBRIDGE.

THE Church of St. Thomas of Canterbury, Dodbrooke, Kingsbridge, was well filled on the afternoon of the 21st, on the occasion of the re-opening, with Masonic ceremony, of the Tower Arch.

The arch is of granite, Gothic in design, with moulded capitals, corresponding to those of the pillars in the nave. When the work is completed a much-needed improvement will have been effected, and the tower will be much safer than it has been for many years, as the work is being carried out in a thoroughly satisfactory manner.

Previous to the dedication ceremony the members of the Craft were the guests of the Rev. Mr. Lewis. After tea they marched in procession to the church, where the Deputy Provincial Grand Mark Master (Bro. Strode Lowe) expressed the pleasure he felt in accepting the invitation to be present at the ceremony. In the course of his remarks, he said perhaps there were some present who wondered what Freemasons had to do with such a ceremony. So he thought a few words on the subject would not be out of place. Turning to the Old Testament history, they found great interest was taken by King Solomona Grand Master of the Order-in the building of that magnificent temple which he caused to be erected at Jerusalem. Hiram, another Grand Master, was employed there, too, and he was a skilful designer and cunning workman in brass, in silver, and other things. It was very evident that in England at one time the Freemasons were the skilled workers employed at all buildings. They were not allowed to work with the labourers except under urgent circumstances. They obeyed their master cheerfully, took their wages thankfully, and were not allowed to leave their master until their work was completed. The churches and cathedrals of England are, or were, the work of their Brethren, an many an eminent architect had been Grand Master. But, in later years, what, they might ask, had Freemasons done? He would not go far to look for a striking example of their work. It was in that church, and was a very handsome window which they placed there some eleven years ago. At present they were there to assist in the dedication of the arch, and though it was not erected by the Freemasons entirely, he thought he might claim that they, at least, had enabled the keystone to be fitted in the arch, without which none of the superstructure could have been added.

The D.P.G.M.M. then called upon the Rev. J. Henning to read the dedication prayers. This having been done, the usual service followed, the lessons being read by Dr. Webb and the Rev. Canon Houghton, Rural Dean, and vicar of West

The Rev. A. J. Hamlyn P.P.G.C., vicar of St. Paul's, Devonport, preached an eloquent and impressive sermon from Proverbs xviii, 10: "The name of the Lord is a strong tower: the righteous runneth into it, and is safe." Mr. C. Jeffery, the organist, presided at the organ, and rendered suitable music during the service .- "Western Mercury."

### ENGLISH MASONS IN DUBLIN.

N Monday morning about thirty Brethren, including Alderman R. H. Holmes, J.P., Deputy Provincial Grand Master Northumberland, and other Members of the Lodges in Newcastle-on-Tyne, arrived in Dublin, and were received as the guests of the W.M. and members of Lodge of Israel, No. 126. They arrived by the mail boat at Kingstown, says the "Irish Times," and when they reached Westland Row Station they entered carriages in waiting, and were driven to that fine establishment in Dawson Street, the Hibernian Hotel.

A large number of members of the Lodge of Israel attended at the station and received their friends with a hearty Irish welcome. A hospitable reception was accorded to them by Mr. Lurring, proprietor of the Hibernian, who placed them in comfortable rooms. The majority of the visitors, strangers to Ireland, were impatient to see the capital, and they quickly sallied out and took an exterior view of the splendid Museum Buildings in Kildare Street, from which they proceeded to that fine metropolitan park, Stephen's Green, whose attractive features they thoroughly appreciated. They returned to the Hotel, from which, after an excellent breakfast, they proceeded on pneumatic-tyred Irish jaunting cars, and drove through the city.

At the Royal Hospital they were received by Major Streatfield, Military Secretary to Lord Roberts, and by Captain Fielding, the courteous Adjutant of the Hospital. While the visitors were engaged inspecting the armour and weapons of war with which the fine Hall of the Hospital is ornamented, Lord Roberts arrived, and bade them a hearty welcome. His lordship expressed the pleasure which it afforded him to receive so large and representative a body. Alderman Holmes and Lord Roberts spoke of the occasion when his lordship was presented with the freedom of the city of Newcastle-on-Tyne, and of another on which the Field-Marshal was installed as Grand Junior Warden of England. On both occasions Alderman Holmes acted in an official capacity. After some further conversation Lord Roberts retired, amid applause.

The visitors, after enjoying a splendid day, receiving, as they said, information and instruction of the highest interest in connection with Irish history, returned to the Hibernian Hotel, where, with their hosts, they dined. A handsome little guidebook, containing a detailed programme of the visit, was presented to the visitors. On one of its pages there is a life-like portrait of his Grace the Duke of Abercorn Grand Master of Ireland, and on another page there is an address of welcome, signed on behalf of the Brethren of the Lodge of Israel, No. 126, by Bro. Thomas W. Donaldson W.M. The book also contains photographs of the principal public buildings of Dublin, and brief historical sketches of them. It gives a history of the Lodge of Israel, No. 126. The Warrant of the Lodge bears date 8th December 1865. It was signed by Augustus Frederick Duke of Leinster, who was Grand Master for Ireland from 1813 to 1874. A facsimile of his letter of the 24th January to Brother Morris Harris, one of the founders of the Lodge, is presented on one of its pages, and is as follows:—

WORSHIPFUL SIR AND BROTHER,—I have received your letter of the 23rd January, and am much gratified at the Lodge of Israel, No. 126, wishing to elect me an honorary member, and will with pleasure join their Lodge.

The festivities connected with the visit were brought to a close on Wednesday, the 20th, by a reception and Cinderella dance in the Round Room, Rotunda, which was beautifully decorated for the occasion, the entertainment being in every respect a brilliant success, and a fitting sequel to the grand banquet given in the Masonic Hall on the previous evening, in honour of the distinguished Brethren from across the water. The W.M. of the Lodge (Bro. 

### CENTENARY: HOPE AND UNITY LODGE,

TOR some time past the members of the Hope and Unity Lodge, No. 214, Brentwood, have been looking forward to the Centenary of the constitution of their Lodge. As long ago as last August a Committee was formed to make arrangements for a due celebration of the event; and their labours were consummated on Saturday, 16th inst., when there was a large and representative gathering of Masons from all parts of the county at the Royal Forest Hotel, Chingford, a dispensation to meet there for the occasion having been granted by the Prov.G.M. the Earl of Warwick. It had been hoped that the noble Earl would have been present, but at the last moment he was prevented, and the Deputy Prov.G.M. Bro. F. A. Philbrick, Q.C., Recorder of Colchester, was also unable to attend.

In the absence of these distinguished Brethren, Colonel Lockwood, M.P., Prov.S.G.W., in a few cordial and appropriate words, formally presented to the W.M. Bro. A. R. Meggy the Centenary Warrant granted by the Grand Lodge of England, on proof of the uninterrupted existence of the Lodge for 100 years.

The W.M. then handed to each member of the Lodge a jewel commemorative of the event; while the I.P.M. Bro. John Ramsey presented a handsome silver case in which the Warrant is to be deposited when not exhibited in the Lodge. Hearty greetings were then given by the Visitors present to the W.M. and Brethren of the Lodge, and the business part of the proceedings closed.

Between 70 and 80 Brethren afterwards partook of an elegantly served banquet in the handsome dining hall of the Hotel. The W.M. presided, and was supported by the Grand Treasurer of England Bro. W. Mason Stiles, Bro. Matthew Clark P.G.D. (for some time D.P.G.M. of Essex), Bro. T. J. Ralling P.A.G.D.C. Prov.G.Sec., Bro. James Terry P.G.Sw.B. Sec. R.M.B.I., Bro. Richard Clowes P.G.St.B., Bro. A. Lucking P.G.P. Prov.G.D.C., the Ven. the Archdeacon of Essex (Bro. the Rev. Thomas Stevens), Colonel Lockwood, M.P., Prov.S.G.W., the Rev. F. Haslock Prov.G.Chap., the Rev. Thomas Lloyd P.P.G.Chap., and others.

The toasts included one to the prosperity of the Lodge, and the health of the W.M., which was given in felicitous terms by Bro. James Terry, who contrasted the condition of Freemasonry at the time the Lodge was constituted with what it is now. He also mentioned the names of some of the distinguished Masons who had served as Masters of the Lodge, including Bros. Peter Gilkes, F. B. Alston (now Sir Francis Alston), the Rev. Spencer Wigram, and George Cooper. As to the latter Brother, Bro. Terry spoke with particular regret of his comparatively recent decease, and said no one would have taken a deeper interest than he in the celebration of the Centenary that day.

The handsome silver loving cup of the Lodge having been passed round, the W.M. suitably replied, remarking that it was a matter of special pride to himself that he should have had the honour of presiding over the Lodge during its Centenary year.

It may be interesting to mention that the Hope and Unity Lodge was constituted at the Ship Inn, Bridge Yard, Tooley Street, on the 22nd January 1796, the Warrant for the same having been granted by the Duke of Atholl, 3rd November 1795. The Lodge was removed to several places in London till early in the present century, when it was taken to Romford, where it remained till 1877, when it migrated to its present quarters at the White Hart, Brentwood.

8. REPORT OF THE BOARD OF GENERAL PURPOSES.

To the United Grand Lodge of Free and Accepted Masons of England.

The Board beg to report that in compliance with the resolution of Grand Lodge on the 6th March last, viz., "That the Board of General Purposes be requested to submit to Grand Lodge proposals for the purpose of bringing the jurisdiction of the Colonial Board under that of the General Board, and unifying the affairs of the general Craft, as was the case before 1838"; and in compliance with the resolution of Grand Lodge on the 5th June last, that the consideration of the proposals of the Board of General Purposes at that meeting submitted to Grand Lodge be deferred until the meeting of Grand Lodge in December, in order to give the Colonies an opportunity of considering the questions, they recommend the following alterations in the Book of Constitutions :-

- (1) That rule 254 Book of Constitutions be altered to read as follows:— The Board shall consist of the Grand Master, Pro Grand Master, Deputy Grand Master, the Grand Wardens of the year, the Grand Treasurer, the Grand Registrar, the Deputy Grand Registrar, a President, Past Presidents, the President of the Board of Benevolence, the Grand Director of Ceremonies, and twenty-four other members.
- (2) That rule 255 be altered to read as follows:-

The President and six of such other members shall be annually appointed by the Grand Master at the Quarterly Grand Lodge in June, and the Grand Lodge shall on the same day elect the remaining eighteen members from among the actual Masters and Past Masters of Lodges. A Master and Past Master, or more than one Past Master of the same Lodge, shall not be elected on the same Board. but this shall not disqualify any Past Master being a subscribing member and Master of another Lodge from being elected for and representing such other Lodge as Master.

- That the word "elected" be inserted before the word "members" in rule 256.
- (4) That rule 271 be altered to read as follows:—

The Board shall appoint, from amongst its members, a Committee of seven to consider all Colonial, Indian and Foreign matters that may be referred to it, whose duty it shall be to report their proceedings to the Board at its next meeting. Such Committee to be composed as far as can be of Masters or Past Masters of Colonial, Indian or Foreign Lodges under the English Constitution.

The Board may also appoint Committees for specific purposes who shall report to the Board in like manner.

(5) That rules 282 to 287 be repealed.

The Board have further to report that copies of the Reports of the proceedings of Grand Lodge at its meetings on the 6th March and the 5th June were, in due course, sent to every District Grand Master, Deputy District Grand Master, and District Grand Secretary of the 28 District Grand Lodges, and also to the Worshipful Masters of all Lodges in India, the Colonies, and foreign parts, numbering about 450, and that the only communications in reference to the above proposals received from any of the District Grand Lodges or Lodges in foreign parts have been-

- (1) From the District Grand Secretary of South Africa (Western Division), pointing out the desirability of having Brethren with Colonial experience on the newly-constituted Board
- (2) From the District Grand Lodge of Queensland, expressing an opinion that the abolition of the Colonial Board was undesirable, and recommending that in the event of the proposed change being carried the Board should contain five Past Masters having Colonial experience.
- (3) From the District Grand Lodge of Bombay, stating that it appeared to it to be a matter of perfect indifference whether the affairs of Lodges abroad are administered by a Colonial Board, the Board of General Purposes, or a Sub-Committee of the latter.
- From the District Grand Lodge of the Eastern Archipeligo, expressing its approval of the proposed alteration.
- From the Cambrian Lodge, N.S. Wales, expressing an opinion that the Colonial Board should be continued.




