THE BOYS SCHOOL PROPERTY.

A TTENTION is being locally drawn to the suitability of the buildings of the Royal Masonic Institution for Boys at Wood Green for the purposes of a Public Hall, Library, or other public uses, and it is not improbable that at a no very distant date a movement will be started there, with the object of acquiring the property for this purpose.

No doubt the executive of the Institution would do their best to co-operate in such a course, as it would lead to the speedy realisation of the estate. It would certainly be a great pity if the fine buildings already on the ground should have to be pulled down and sold as mere waste material, and we should think the inhabitants of the district would do well to take the matter into their serious consideration, while the opportunity is available, as at a moderate cost the existing structures could be adapted for the purposes contemplated.

ESSEX.

HE annual meeting of the Provincial Grand Lodge was held at Colchester, on Tuesday, 13th inst., and passed off most successfully.

The arrangements were in the charge of a Committee of the two Lodges at Colchester, the Angel. No. 51, and the United, No. 697. The Committee were fortunate in obtaining permission from Bro. Claude E. Egerton-Green for the entire use of the charming grounds of East Hill House, and the weather being fine the attendance was unusually large. Both before and after the business meeting the Brethren wandered amongst the shady walks or reclined under the trees.

The Provincial Grand Master the Earl of Warwick, accompanied by Bro. Robert Woodhouse, travelled by rail from London to Colchester, and drove direct to East Hill House, where his Lordship was received by Bros. Egerton-Green W.M. 51, H. E. Baker W.M. 697, T. J. Ralling Prov.G. Sec., A. Lucking Prov. G.D.C., Richard Clowes P.G. Stand.Br., and J. M. McLeod Sec. R.M.I.B. The party having been entertained to luncheon by Bro. and Mrs. Egerton-Green, an adjournment was made to the grounds.

The masonic proceedings took place in a large marquee erected in the paddock, some 250 Brethren being present, and when the Earl of Warwick entered, accompanied by his Officers, he received quite an ovation.

The minutes of the last annual Lodge, at Maldon, having been read and confirmed, the Provincial Grand Secretary said that letters, expressing regret at their inability to attend, had been received from several distinguished Masons.

The roll of Lodges was called over, and all were found to be

represented.

The Earl of Warwick said, before the recommendations of the Board of General Purposes for certain grants were put, he had a suggestion to make. They were all aware that a fund was being raised in the county and by the Lord Mayor with a view to assist the sufferers by the dreadful hailstorm that visited the county a week or two ago. This was a matter that he thought would appeal to them as Essex men, but particularly as Essex Masons. Whilst liberally supporting the charities of their Order, his experience of Masons was that they were as ready to open out their hearts to a cry of distress outside the Craft. Coming down in the train Bro. Woodhouse had kindly volunteered to give

£26 5s, he himself would give £31 10s, and he should like to propose that they vote the sum of £21 from their Lodge Funds,

and take a voluntary collection in the room.

Bro. George Corble P.M. 453 P.P.G.J.W. said he had been looking at the balance-sheet, and he really thought for such an exceptional occasion as this they might afford fifty guineas. He would venture to suggest that if his Lordship would amend his

motion to that amount it would be heartily endorsed by Provincial Grand Lodge.

The Earl of Warwick said he would be delighted to fall in with Bro. Corble's suggestion if the funds of Provincial Grand Lodge would allow. His Lordship then put the amended proposition, and it was carried amidst great applause.

Boulton £2 2s; Angel Lodge, No. 51, £5 5s; Lodge of Good Fellowship, No. 276, £2 2s; Chigwell Lodge, No. 453, £5 5s; United Lodge, No. 697, £5 5s; Liberty of Havering Lodge, No. 1437, £5 5s; Brooke Lodge, No. 2005, £5 5s; Tilbury Lodge, No. 2006, £5 5s; Shurmur Lodge, No. 2374, £10 10s; Colne Lodge, No. 2477, £3 3s; Ixion Lodge, No. 2501, £5 5s; making a grand total of £230 9s.

The next business on the agenda was the Board of General Purposes report, a copy of which having been sent to each member of P.G.L., was taken as read. The report stated that the accounts for the year had been audited, and that after payment of all expenses there was a balance in hand on the General Account of £160 12s 5d, and on the Charity Account of £32 12s 5d. The returns from the Lodges showed the strength of the Province to be 2,001 against 1,939 last year. The Board recommended the payment of the following grants:—From the General Fund—A donation of one hundred guineas to the Royal Masonic Institution for Boys, £10 10s to the Essex and Colchester Hospital, and £10 10s to the Eastern Counties Asylum for Idiots; and from the Charity Fund £10 10s to the Royal Masonic Institution for Girls, and a like sum to the Royal Masonic Benevolent Institution. The Board recommended that the portrait in next year's calendar be that of Bro. Andrew Durrant P.M. 276 P.P.S.G.W. P.P.G. Treas., one of the oldest Masons in the Province.

The report was adopted; as was also that of the Charity Committee, which stated that at the Girls election the Committee received 836 votes, exchanging 317 for 79 boys, and lending 519. The election was very flat, and there was no demand for votes at all. At the Boys election they received 788 votes from the Province, and 79 in exchange for Girls votes, enabling them to poll 277 for Oldham, raising his number of votes to 1,217. This election was a very exciting one, and the demand for votes was almost without precedent. A division of votes acted disastrously,

neither of the candidates being successful.

The Provincial Grand Master, on rising to address the Brethren, was heartly received. He said it was a great gratification to him to find himself once more in the good old town of Colchester, with which he had so many pleasant memories. It was in Colchester that he was installed as Provincial Grand Master, and for some years he had the pleasure to be connected with the town as its member, during which time he made many, and he trusted they would be lasting, friendships. As to their meeting that day, he felt they might congratulate themselves on their charming surroundings, and they were much indebted to Bro. Claude Egerton-Green for placing his beautiful grounds at the disposal of the Brethren. Referring to the recent national celebration of the sixtieth anniversary of the reign of their Gracious Queen, his Lordship said they, as Freemasons, might well be proud of the part they had taken in the celebration. All those who were present at that wonderful meeting at the Albert Hall must have been greatly impressed with it, whilst it must be a satisfaction to every Brother that as a result of that meeting more than £7,000 had been distributed in charity. This had been supplemented by a grant of £8,000 from the funds of the Grand Lodge, so that the total sum presented by the Freemasons of England in commemoration of the Queen's Jubilee amounted to a little over £15,000. His lordship congratulated Bros. William Shurmur and W. J. Crump on the honours conferred upon them by H.R.H. the Grand Master, at the Albert Hall, and although these two Brethren appeared to have been grouped with London Brethren the work they had done in Essex entitled them to the congratulations of the Province. Masonry continued to prosper in a wonderful way in Essex. When he commenced his career as Provincial Grand Master their membership was 900, now they would see by the report of their Board of General Purposes it had reached 2,000, whilst as regarded charity, the Brethren were always most liberal, and what had been done that afternoon for the hailstorm fund would be a proof to outsiders, as he had already said, that they were equally open-handed in relieving distress outside their ranks.

On the motion of Bro. William Shurmur P.G.Std.Br.,

William Gower W.M. 2501 was unanimously elected Provincial Grand Treasurer for the ensuing year.

The Earl of Warwick said he had an announcement to make which he was sure would be received with great regret. He had received within the last few hours a letter from his excellent Deputy, Bro. Philbrick, regretting that his judicial duties prevented his coming amongst them that day, and adding his feeling that this only too clearly showed that as he was always liable to these mischances he ought no longer to hold the office of Deputy. His interest was as fully as ever with Freemasonry in the Province, but he felt they were entitled to more than that, his bodily presence. This letter, Lord Warwick continued, had come to him, as to all of them, as a great surprise, and he had not had time to consider what was best to be done. He should write to Bro. Philbrick, and if he decided to resign he thought he should be able to nominate a Brother for the post who would be acceptable to the whole Province.

On the motion of Bro. F. H. Bright P.P.S.G.W., seconded by Bro. F. A. White P.P.G.R., Bro. Claude Egerton-Green Prov.S.G.W. was elected a member of the Charity Committee in the place of Bro. Hoddinott, who retired by rotation.

A hearty vote of thanks was passed to the Brethren of the Colchester Lodges for the excellent arrangements they had made for the meeting; and the Provincial Grand Master having announced that he had decided to hold next year's meeting at Brentwood, the Lodge was closed.

The banquet took place in a spacious marquee in the grounds,

catering of Messrs. Wright and Son giving unbounded

satisfaction.

At the close of the repast the Provincial Grand Master gave the toast of the Queen, referring to Her Majesty's practical sympathy for their county of Essex, by her donation to the "Devastation Fund."

His Lordship next submitted the toast of H.R.H. the Prince of Wales M.W.G.M., followed by the Pro Grand Master, the Deputy Grand Master, and the Grand Officers present and past.

Deputy Grand Master, and the Grand Officers present and past. He coupled with the latter toast the name of Bro. Shurmur.

Bro. Shurmur, in reply, referring to the Jubilee Masonic honour conferred upon him, said he trusted he should prove worthy of it. At the great demonstration of Masonic loyalty at Albert Hall, when it pleased the Grand Master to extend the right hand of good fellowship, when conferring the honour of appointing him an Officer of the Grand Lodge of England, the first to congratulate him upon his preferment was their beloved first to congratulate him upon his preferment was their beloved Provincial Grand Master the Earl of Warwick, and immediately afterwards the Ven. Archdeacon of Essex. He would always remember with Masonic pride the happy quarter of an hour in which he enjoyed the privilege of shaking hands with the Prince, the Peer, and the Prelate. It was a convincing proof of the levelling influence of Freemasonry. That afternoon they had gone a little out of the circle in contributing over 200 guineas to the Essex Storm Fund, but relieving the distressed was one of the characteristics of the Order, and therefore truly Masonic

Bro. Claude E. Egerton-Green W.M. 51 proposed the toast of the Right Hon. the Earl of Warwick Right Worshipful Grand Master for Essex. He asked indulgence in having been called upon to stand in the shoes of so distinguished and eloquent a Brother as Deputy Provincial Grand Master Philbrick, and propose the toast of the day. The Earl of Warwick, he said, had many titles; but he was sure he valued no title more highly than that of Provincial Grand Master of Essex, and he was also sure that in the various positions in which he was placed there were none in

which he was valued more highly and in which his qualities were

more fully recognised than by the Masons of Essex.

The Provincial Grand Master, who was enthusiastically received on rising, thanked the brethren most heartily for the manner in which his health had been proposed and received. He had in Lodge expressed the very great satisfaction which it gave him to meet them again in the old town of Colchester. As he then told them, it carried him back to about one interest. ago, when he was a much younger man-much more ignorant, perhaps, in Masonry, and ignorant in many ways-when he first came before them. He believed the Masons of Essex had done a great deal for him—and from what he could hear from the Senior Warden, his fellow-townsmen in Colchester did a great deal for him on a celebrated occasion. One thing had always been most pleasing to him; he was not called the always been most pleasing to him; he was not only on the friendliest terms with Masons, but also with all parties in the town, whether Radical or Conservative. He though Freemasonry, perhaps, gave one larger views, and it was not a bad thing sometimes to see both sides of a question, although he did not think vacillation was a thing to admire or uphold. One thing he was proud of that day. They had shown that there was something real and genuine in Freemasonry—something beyond the pleasure of meeting together and the pleasure of banqueting. They had in the Lodge that day subscribed the handsome sum of over 200 guineas towards the fund in relief of the great disaster which had befallen a part of their county. They had decided to keep the fund open for a fortnight, so that any Lodges or brethren who desired to contribute might send their money to the Provincial Grand Secretary.

The Provincial Grand Master next proposed the toast of His Honour Judge Philbrick, Q.C., G.Reg. Deputy Provincial Grand Master for Essex, repeating the regret they all felt at the absence of His Honour. He coupled with the toast the name of Bro. T. J. Ralling Prov. Grand Secretary, to whose devotion to Masonic interests he paid a high tribute, and expressed gratitude to him for his exertions on behalf of the Province.

Bro. Ralling, in the course of a happy reply, assured the Brethren that his interest in Masonry was as warm as ever. Speaking from a considerable experience, he asserted that at no time was Masonry so flourishing in Essex as at the present time, and the present gathering was the finest they had ever had, which he could only compare with the gathering they had at Easton Lodge—a repetition of which he hoped some day to see.

The name of Bro. McLeod Secretary of the Royal Masonic Institution for Boys was coupled with the visitors, also proposed by the noble Earl. Brother McLeod said a visit to the Essex Provincial Grand Lodge was such a pleasure that he gladly embraced the opportunity of being with them that day. The harmony with which all the business was carried out and the genuine ring of charity which pervaded the Lodge had been most pleasing to the visitors. As regarded his special charity, he said the Province was most fortunate in having so good a represent-ative on the Board of Management as Bro. George Corble, who was most assiduous in looking after the interests of the School.

The Province had shown their appreciation of Bro. Corble's services by re-nominating him to the position.

The toast of the Worshipful Masters of the Lodges in the

Province was responded to by Bro. Harry E. Baker W.M. United Lodge, No. 697, and Bro. Claude Egerton-Green W.M. 51. The former claimed for his Lodge that his Lordship had no more loyal and hardworking a body of Brethren; whilst the latter, referring to the harmonious working of the two Lodges together, facetiously remarked that if they were not all "Angels" they were certainly

" United."

The day's proceedings concluded with a very pleasant garden party, a large number of Ladies visiting the grounds by invitation of the Brethren. The popular band of the York and Lancaster Regiment, under Bro. Bandmaster Wood, which had played selections during the dinner, continued to discourse sweet music till the shades of evening brought a most successful meeting to a close.—" Essex Standard."

NORTH AND EAST YORKS.

ORE than usual interest was attached to the annual meeting of the Provincial Country meeting of the Provincial Grand Lodge of North and East Yorks which was held on the 15th, at Whitby. This was mainly owing to two reasons-first, that the Lion Lodge, No. 312, at whose invitation the brethren assembled, was celebrating its 100th anniversary festival, and, secondly, that Whitby is always considered one of the most pleasant outings afforded the members of the Craft. Although, of course, not able to accompany the Brethren within the sacred precincts of the Lodge, many of the fair sex took the journey to Whitby, and spent a most enjoyable time at the old historic abbey, and in visiting many other points of interest with which the famous jet town abounds.

The Provincial Grand Lodge was opened at two o'clock in

the Lodge-room at the Grand Saloon. The Marquis of Zetland Provincial Grand Master presided, and was supported by Lord Bolton D.P.G.M.

The minutes of the last meeting, held at Hull, were confirmed. The annual report of the Board of Benevolence was adopted. This recorded several grants to widows of deceased brethren, as also to members of the Craft, who, through calamity and misfortune, had been placed in reduced circumstances. The balance of the Fund at the end of the financial year was stated to be £1,046 15s 7d.

The Treasurer's balance sheet was of a very satisfactory

character.

On the motion of Bro. T. B. Whytehead it was resolved "That in future the official duties of the Provincial Grand Treasurer be undertaken by the Provincial Grand Secretary, and that an annual honorarium of ten pounds be voted to the P.G. Secretary in recognition of the additional work entailed by the change of arrangements." Several minor alterations in the byelaws were agreed to.

The Rev. Fox-Thomas P.P.G.C. read a most amusing and interesting paper on the History of Freemasonry in Whitby, tracing the same from 1616 to 1897.

The Marquis of Zetland feelingly referred to the lamented death of Bro. Joseph Todd P.G. Treasurer, and then presented the Centenary Warrant to the W.M. of the Lion Lodge. Reviewing the Masonic events during the past twelve months, his lordship said the assembly last month at the Albert Hall was the largest ever known, the Masonic charities benefiting to the extent of £3,000. Locally, the celebration of the fifth festival of the North and East Yorkshire Educational Fund held in May was a great success, as upwards of £1,036 was realised. Next year the Centenary of the Royal Masonic Institution for Boys would be held, on which occasion the Prince of Wales G.M. would preside.

Subsequently the annual banquet was purveyed at the Crown Hotel, the Marquis of Zetland presiding. During the evening a grand ball was held in the saloon, in celebration of the centenary

of the Lion Lodge.

The Centenary commemoration of this Lodge may be said to have commenced on Sunday, 11th inst., when the brethren attended the Congregational Church in full Masonic costume, and an appropriate sermon was preached by the Rev. E. Fox-Thomas P.M. Chaplain of the Lodge and Past Provincial Grand Chaplain.

Yorkshire takes almost a premier position in connection with English Freemasonry, as the first head-quarters of the mystic Craft are said to have been established at York, says the "Leeds Mercury." Whitby also has a prominent place in the history of Yorkshire Masonry, for according to ancient documents and records there were two "Free Maisons" in Whitby as far back as 1616 and 1639. The first Lodge constituted in Whitby was the Golden Lion, warranted in 1764, and which met at the Golden Lion Inn, a licensed house, which dates back to the days of the Stuart dynasty. Now, this Lodge is believed to have continued in existence until about the year 1772, when it was erased for not making its orthodox returns to Grand Lodge, and the Britannia Lodge was established that year in its stead and warranted by the Grand Lodge. Its assemblies were first at the Buck Inn, and later at the Plough Inn, Church street. Although this Lodge is said to have been most popular and prosperous for some time, for some unexplained reason it seems to have declined, and to have been dissolved. Some of its members evidently desired a new constitution, and were really the founders of the present Lion Lodge, to which the jewels belonging to the old Lodge were presented. The formation of the Lion Lodge took place in 1797. Its original members were unquestionably in many instances some of the most influential inhabitants of Whitby and its vicinity, and the high respectability of this timehonoured Lodge has been fully maintained ever since. Its first place of meeting was at the Golden Lion Inn, then at the Freemasons' Tavern, later on at the Angel Inn, and lastly at the Masonic Hall since 1859. All the minute books since 1797 are extant, and in good preservation.

The Lodge at present numbers 100 brethren, and the W.M., is Bro. J. H. Harrowing, C.C. In connection with the Lodge there is also the Britannia Chapter of Royal Arch Masons, and a Mark Lodge, and they, like the Mother Lodge, are flourishing. There are several Jubilee brethren connected with the Lodge still surviving, and the oldest of these were initiated in 1838, 1839, and 1840. A number of these venerable brethren paid a visit to the Zetland Lodge at Leeds only last year, at the installation of the W.M. of that Lodge, and received a cordial welcome from

Leeds Craftsmen.

The Prov. Grand Master having appointed the next annual communication of the Provincial Grand Lodge to be held at Market Drayton, votes of thanks were unanimously passed to the Ven. Archdeacon Maude for kindly allowing the commemoration service to take place at St. Chad's Church, and to Brothe Rev. Cooper Smith, D.D., for his visit to the Province in order to preach the special sermon, and he replied.

A vote of thanks was also passed to Messrs. Eyre and Spottiswoode, H.M. printers, for kindly allowing the Province to reprint the Bishop of Wakefield's Jubilee hymn, "Oh, King of Kings," in the programme of the day's proceedings. The Provincial Grand Lodge was closed in ancient form.

The Brethren then assembled in a tent specially erected in the Quarry, from which, attired in full Masonic regalia, they marched to St. Chad's Church for Divine worship. A very large crowd assembled to watch the procession, which elicited considerable interest. The congregation was a large one.

A special form of service was gone through, which included the singing of the Bishop of Wakefield's Jubilee Hymn, "O King of Kings," "The Hallelujah Chorus," and the National Anthem, and the entire service was characterised by great heartiness. The first lesson was read by the Provincial Grand Chaplain Bro. the Rev. J. Lewis Williams, the second by P.P.G.C. Bro. the Rev. J. B. Meredith.

The sermon was preached by Bro. the Rev. H. R. Cooper-Smith, D.D., Past Grand Chaplain, who took as his text the words "Sirs, ye are Brethren" (Acts vii, 26). In the course of an appropriate discourse the preacher alluded to the position of Freemasonry from a religious point of view, and maintained that it was in no sense inconsistent with the principles of Christianity, and no unbeliever could be admitted within its pale. Masons were loyal to the Crown and Queen, and Her Majesty was their Patron. At such a time as the present Masons desired to emphasise the relations in which they stood to the Queen and to each other, and whatever might have been the action of those in other countries or in other times, the loyalty of the English Masons was undoubted, and the service that day was an expression of their feeling of love towards the Queen, and of gratitude to Almighty God for the happy and prosperous years during which Victoria's reign has lasted.

At the close of the sermon a collection was made on behalf of the Queen Victoria Diamond Jubilee Fund of the Shropshire Masonic Charitable Association. After the service the Brethren returned to the Quarry, and subsequently sat down to lunch in the Music Hall. There were in all about 150 members of the Craft in attendance at the festival, under the presidency of Sir

CHURCH SERVICE.

N Sunday, 11th inst., a very interesting service was held at St. Mary Abbots, Kensington. The new Vicar, the Rev. Canon Pennefather holds the rank of P.P.G.C., and as a kind of welcome many Brethren attended, wearing Masonic clothing, when a special service was used, consisting of a shortened form of the Evening Service, special Psalms, lessons, and hymns. All who officiated were Masons, and wore their clothing over their

surplices. The Vicar preached a very able and practical sermon from Galatians vi., 5 and 2, "For ever man shall bear his own burden," and "Bear ye one another's burdens, and so fulfil the law of Christ." He remarked the appeared to be some difference between the two texts. They were told not only to bear their own burdens, but they must help bear another's burdens. Although this appeared somewhat contradictory, yet it was perfectly true. Every one had his own burden, one which was particularly his own, and which no one else could bear for him. These were more particularly felt when friend sympathised with friend, and at times when they stole away from busy scenes, and were alone with God. Even when walking through the most crowded thoroughfares they realised they were alone bearing their own responsibility. They might see a man or bearing their own responsibility. They might see a man or woman at dinner with a careworn look on their face—the sign of sorrow could be read there. What was the meaning? It was that the individual was realising his own individuality. Sorrows might have entered their home, and friends speak kindly and write letters of sympathy, but still there was that aching in the heart when they realised they were alone, comparatively speaking, with God, and bearing their own burden. But they must remember that it was the burden God had made for them. It might be with respect to the responsi-bilities of life. He hoped they realised the meaning of such responsibilities. Why had God sent them into the world and endowed them with such powers as they had? Was it that they should live for their own interest; simply to acquire wealth and get on in the world, as some had done so well? If they did so, they did not understand. God had sent them not to live a selfish life, but to live for others, to spend their time in the Master's service. Did they realise that the most blessed days in life were those in which they carried out the will of the Father, doing good to others? Did they understand the responsibility—that one day they would have to give an account of their work? Every man bore his own burden when he realised his individuality. The memory of sin which fell on everyone seemed to come as a black hideous spectre in the night. They tried, but could not banish it, but a voice said unto them, "Cast your burden on the Lord." That was the only way. He loved them as brothers loved, and died on Calvary's cross to take away their sins. They had also to endeavour to live for others, and to bear, as far as God gave them strength, one another's burdens. "All ye that are weary and heavy laden draw near unto God," said the Apostle. They had to help those who were striving to fight the good fight of faith. Some at times felt weary, and wished to give up the struggle, but as even one of the principles of their great

and noble society was to help one another, so they must hold out the hand of sympathy to those in sorrow, and if they grasped each others hands and went forward shoulder to shoulder, helping each other, then by the grace of God they would conquer. Kind words of sympathy helped to shake off the dark shadow of sorrow in the same manner as Brethren of their Craft held out a helping hand to those who in the struggle and battle of life were almost giving way, and to help remove the grinding crush of poverty. That was one of the ways in which they fulfilled the poverty. That was one of the ways in which they fulfilled the law of Christ and helped to bear one another's burdens. He considered it a great privilege to welcome them in that church. What a magnificent power they would be if only they were true to their own Craft, and in their daily life remembered the principles on which the Craft was founded and the high standard of Christian love and charity to follow. The world would be much better for their lives, and they would be much happier themselves if they only tried to make the lives of others happier. Let them be good Masons, and strive to do their duty to their Brethren, and the higher view they took of their Craft and the more they remembered its principles, the better and more useful men they would be—prepared to go forward and build up the Church of Christ. He was asking that day on behalf of the Kensington Dispensary. They had particularly requested it should not be for a Masonic charity, but for the dispensary which was doing such noble and good work in the whole of the parish of Kensington, and as bearing the burden of others was fulfilling the law of Christ. He knew they would make an offertory worthy of them-selves, worthy of their Craft, and worthy of the cause for which he pleaded.

A collection having been made, amounting to over £40, the Brethren returned to the Town Hall and disrobed.—" Kensington

BOARD OF BENEVOLENCE.

THE July meeting of the Board of Benevolence was held on Wednesday evening, at Freemasons' Hall, the three chairs being occupied by Bro. James H. Matthews President, D. D. Mercer Senior Vice-President, and C. A. Cottebrune Junior Vice-President. The Grand Secretary and Bros. W. Dodd, G. S. Recknell and H. Sadler G.T. represented the Grand Secretary's office, and many other Brethren attended.

A list of twenty cases was before the Brethren for consideration, and in the course of the evening £465 was voted to seventeen of these, the remainder being deferred for noncompliance with rules. Grand Lodge was recommended to give £60 in one case, and the Grand Master was asked to sanction £40 being given in four cases, £30 in four cases, and £25 in another case. The sum of £20 was voted in two instances, £15 in two, and £10 in three. This concluded the meeting's business.

CANTERBURY CATHEDRAL.

ON Friday, 16th inst., a special meeting of the Provincial Grand Lodge of Kent was held in the Chapter House, Canterbury, for the purpose of formally handing over to the Dean and Chapter the new east window, presented by the Freemasons of Kent. The Provincial Grand Master Earl Amherst presided, supported by the Deputy Prov.G.M. Bro. J. S. Eastes, and several Grand and Provincial Grand Officers, altogether between 300 and 400 Brethren being present.

Provincial Grand Lodge having been opened, it was adjourned while the Dean was sent for. On entering the Chapter House, he was met by the Provincial Grand Officers and escorted to a seat on the right hand of the Provincial Grand Master, who then explained to the Dean the object of the gathering, and handed him an envelope in which was a cheque for £1,000, the cost of the window. The Dean, in an eloquent speech, expressed his deep gratitude to the Freemasons of Kent for their munificence. He said that it was, perhaps, rather his misfortune than his fault that he was not was, perhaps, rather his misfortune than his fault that he was not a Mason, but two of his sons were holding Office in the Craft, and he would not say what might happen to himself in the future. Speaking on behalf of the Chapter, as well as for himself, he assured the Masons that if they should require the Chapter House at any time for meetings, &c., it would be at their service. In again thanking the Masons of Kent for their splendid gift to the Cathedral, the Dean referred to the suggestion which he made to H.R. H. the Prince of Wales, that the companion window at the H.R.H. the Prince of Wales, that the companion window at the western end of the building should be filled with stained glass by the Masons of England, and he hoped this might be done. Provincial Grand Lodge was afterwards closed and many of the Brethren attended the afternoon service in the Cathedral, where Bro. Dr. Longhurst presided at the organ.

Previous to the ceremony, about 100 Brethren lunched together at the Foresters' Hall, under the presidency of the Provincial Grand Master.

HOW TO SECURE WORK.

N every Masonic Lodge there is a desire that there should be frequent work. This is proposed. frequent work. This is proper—nay more, the absence of such a prevalent desire on the part of the members is evidence not only that the Lodge is in an unhealthy condition, but that the members are pleased to have it so. The work of the Lodge is the life of the Lodge. It is to it what the circulation of the blood is to the individual man—the absence of circulation brings with it paralysis and invites death. We need not now discuss why this is so, but we take it for granted for the purpose of this article, which is to discover the most proper and praiseworthy methods for securing continual work for a Lodge. If idleness be death and industry life, it is important that it should be determined how a Lodge may be in the best sense of the term industrious.

For more purposes than one the Officers are the Lodge. Given the possession of attentive, earnest, skillful Officers, and the prosperity of the Lodge ordinarily must follow. They compel success. Their punctuality, energy, ability, and devotion to rendering the work correctly and forcibly are infectious. Like Master, like members. The Officers are the leaders, and where they go many others follow, what they do is copied generally by the body of the Craft over which they preside. They are the great luminaries—especially the W.M.—around whom all the others revolve. Given a thoroughly competent Master, and a live Lodge is almost inevitably the result. Moral: Select your Master, and do not let him select himself. In elevating him you are either elevating or lowering yourselves, since what he is that you will probably become. He, far more than any other Brother, determines the condition and character of the Lodge. Another moral: Masters, recognise the responsibilities you are under, and do everything in your power for the highest advancement of the Masonic body over which you have the honour to preside. Master the work in every part of its details. Be not slouchy about anything. Take a pride in saying the right thing in the right way. When you get your intellectual team into action, do not put the cart before the horse. Be sure you are right and then go ahead, with everything to hope for and nothing to fear. Having mastered the ritual, render it audibly, intelligently, earnestly. Show that you mean what you say, and manifest your sincerity by vigour of utterance, by propriety of intonation, and by downright earnestness. Throw yourself into the work. The result will be, every one will be instructed. It will get abroad that excellent work is done in your Lodge, your membership will be largely drawn out, and you will also have numerous visitors. It does not require that you should be a Demosthenes or a Cicero to fill your role with distinction; it only requires that you should be sincere in

manner, articulate your words clearly, and speak in tones so as to be heard by all in the Lodge.

But the members have duties to perform as well as the Officers. The Lodge is your Lodge. It made you, and you may make it—or mar it. If your Officers are model Officers, of course you are attracted to attend regularly, but if they be not, still attend regularly, and endeavour to give them such Fraternal aid and advice as will tend to improve them. They are your Officers, and you owe them your presence, your sympathy and your assistance. Especially is this true of Past Masters. These should never be past Masons! Never can a Brother who has been accorded the highest honours in the gift of his Lodge do too much for its advancement and prosperity. If it droops, it is in part his fault; if it prospers, he should be proud to be in part at least the cause of it. Where a healthy spirit of emulation exists among the members as to who can best work and best agree, that Lodge is on the high road to prosperity. It is a live Lodge, an active Lodge, a busy Lodge. Its work is ably performed, its charities are liberally dispensed, and its meetings are attractive and instructive. It properly unites labour and refreshment, and when the toil of the evening is over, the Brethren assemble

when the toll of the evening is over, the Brethren assemble around the fraternal board, and there enjoy those felicities of speech, anecdote and song which are only known in their perfection to Brethren of the Mystic Tie.

In no instance where the Officers and members of a Lodge conscientiously perform their several duties, can it be said that there is no Labour, no Refreshment, no harmony, and no attractiveness in the Lodge meetings. Just as surely as the work is correctly and impressively performed go surely the work is correctly and impressively performed, so surely the members will be drawn together in increased numbers, and their presence will secure the frequent presentation of material for moulding into perfect ashlars, so that the spiritual Temple shall have constantly added to it living stones of value and beauty.— " Keystone."

PIC-NIC OF THE MINNEHAHA MINSTREL LODGE, No. 2363.

THE most successful pic-nic held in connection with this Lodge took place on Monday, the 19th inst, the place selected with this Lodge took place on Monday, the 12th inst., the place selected being Worksop, Nottinghamshire, which the Domesday Book of William the Conqueror mentions as having been owned by Elsi, a Saxon, the manor then being styled Werchesope. The party, which consisted of over fifty Brethren and friends, left Manchester by saloon carriages at 8-32 a.m., arriving at the Golden Ball Hotel after a journey of about two hours. Having partaken of a capital lunch provided by the host (Bro. W. Wheeler, Peiham Lodge, No. 939), a number of carriages provided for the party were soon filled, and a long drive of twenty-five miles commenced through the estates of Clumber, Thoresby, and Welbeck, owned respectively by the Duke of Newcastle, Earl Manvers, and the Duke of Pottland, and popularly known by the collective name of the "Dukeries," a title adopted to imply in one word the nature of its charming features. None of these places are near a railway station, but carriages may always be obtained at the hotels to convey visitors through the various lovely drives to any of the numerous places of interest. And we may add that for those who desire to spend a few days in the neighbourhood, there is Worksop Manor, once the seat of the Dukes of Norfolk; the fine old lace-making town of Nottingham, with its castle and ancient streets, whose quaint names are suggestive of Saxon times; and Belvoir Castle, the seat of the Duke of Rutland, a building somewhat in the style of its rival at Windsor. It is situated on a hill which is thickly dotted with wood, its lovely gardens on a steep declivity delighting the eye of any horticulturist. And there is Newstead Abbey, the home of the Byrons; Bestwood Lodge, the property of the Duke of St. Albans; and Rufford Abbey, the seat of Sir Lumley Saville; together with Wollaton Hall, the seat of Lord Middleton, besides other mansions perhaps little known outside the locality, yet many of them of very great beauty.

The three estates first mentioned are within the ancient and historical forest of Sherwood, known to every schoolboy as the home of the notorious outlaw Robin Hood, and his merry men, of Little John, Will Scarlett, Friar Tuck, Allan-a-Dale, and the lovely Maid Marion, thus described in language of the day:—

"Sich utlauz an' his men Vil England never see agen."

Vil England never see agen."

The forest is not of very great extent, and although there are now left but few of the most ancient trees that formerly abounded in its glades when Robin Hood and his merry men hunted, and prosaically pillaged, yet those which do stand exposed to storm and tempest, are very good specimens of the woodland where our predatory ancestors roamed.

The present mansion of Clumber, built by the second Duke of Newcastle (circa 1770), is about four miles from Worksop, and for magnificence is said to be second to none in England; its great central hall, ninety feet by forty-five feet, its marble columns, floor of mosaic and tesselated work, its magnificent works of art, its beautiful gardens, and fine extensive lake, all combine to raise an envious feeling in the breast of the visitor. Clumber Park comprises 4,000 acres, and in circumference measures nearly eleven miles. The waters of the lake cover eighty-seven acres, the lake costing £7,000 in construction. construction.

construction.

The handsome mansion of Thoresby, situated in a park which has a circumference of twelve miles, was built by its present owner, in place of the former structure of red brick, erected by the second and last Duke of Kingston, which in its turn had risen phenix-like from the ashes of its predecessor—a victim to the ravages of fire in 1745. Lovers of literature will associate with the name of Thoresby House that of a brilliant and witty celebrity—the British epistolary rival of that "spirituelle" Frenchwoman, Madame de Sévigné, we mean Lady Mary Wortley Montague, who was born here in 1690, and who flourished during the first half of the eighteenth century. In the library of Thoresby is an elaborately carved chimney piece of oak, fourteen feet high and ten feet wide, which represents a scene in Sherwood Forest, introducing the "Major Oak," a herd of deer, Robin Hood and Little John, with other details.

About midway on the drive through the "Dukeries" is the pretty Saxon village of Edwinstowe, where a long halt is usually made for the purpose of

About midway on the drive through the "Dikeries" is the preuty saxon village of Edwinstowe, where a long halt is usually made for the purpose of feeding and resting the horses. A welcome cup of tea had been provided for the ladies, which they partook of. The village is said to derive its name from Edwin, King of Northumbria, who was killed about the year 633 A.D. According to tradition he was buried here.

With regard to the tree which Shakespeare calls the "unwedgeable and gnarled oak," the ancient Gaelic proverb says:—"Thrice the age of a dog is that of a horse; thrice the age of a horse is that of a man; thrice the age of a man is that of a deer; thrice the age of a deer is that of an eagle; thrice the age of an eagle is that of an oak." On the Welbeck demesne there are some very wonderful specimens, one of which is estimated to be about sixteen hundred years old. This is the "Greendale Oak," sometimes called the "Methuselah" of trees. In 1724, as the outcome of a bet, an opening was cut through the trunk of this tree wide enough to admit the passage of a carriage, or three horsemen abreast. The most remarkable tree, however, belongs to the Thoresby estate; it is that monarch of Sherwood known as the "Major Oak," sometimes called the "Queen Oak," said to be over a thousand years old. Viewed in the distance, its magnificent foliage, which covers a space of 240 feet in diameter, would hardly induce a stranger to suppose that in its trunk is a fissure which leads to a great hollow fifteen feet high, easily capable of holding a dozen full-grown people. Indeed, it is asserted that sixteen persons have actually squeezed themselves into the boll.

Shortly after entering the Welbeck estate, and in the vicinity of "Robin Hood's larder," is the "Russian Log Cottage," used as a hunting box. It is said that it was purchased at the Manchester Exhibition, and is not only picturesque, but decidedly novel, inasmuch as it is dovetailed together, and fastened without the aid of a single nail. Close to the Abbey is a block of modern-built houses, called "Winnings," their origin being sufficiently attested by an inscription upon them:—"These houses were erected by the sixth Duke of Portland at the request of his wife, for the benefit of the poor, and to commemorate the success of his racehorses in the years 1888, 18

Welbeck Abbey (although for some inscrutable reason its portals seem ever jealously closed to visitors) is brimful of old historical associations, but as space will not allow us to touch upon them, we will merely mention some of its modern wonders, which cost the late Duke of Portland between two and three millions sterling—called by a writer in London "Society" fads, but to which local tradition assigns a more potent reason. Besides a subterranean carriage-way, the grounds are literally perforated by miles of tunnelling, through which three people can walk abreast; then there is the underground picture gallery, lighted by 1,100 gas burners; the glass-roofed tan gallop 1,270 feet in length, containing upwards of 64,000 feet of glass; and the riding school, said to be the finest in the kingdom, being 385 feet in ength, 104 feet in width, and lighted by 8,000 gas jets. From the time of

the first Duke of Newcastle, lord of Welbeck in the 17th century, until now, the Abbey has been famous for its riding room.

Many apochrypal stories have crystallised around a great name, but we believe we are correct in stating that the famous letters of Junius, which created such a stir in literary circles during the latter half of last century, were universally attributed to William Henry Cavendish Bentinck, third Duke of Portland. According to the Nullum Tempus Bill ("nullum tempus occurit regi") the Crown had power to revive a claim for lands held without a legal title, in spite of any length of possession. By this Bill, the estate of Inglewood, in the honour of Penrith, together with the castle and manor of Carlisle, which had been in the possession of the Portland family for sixty-five years, were reclaimed (circa 1767), as never having been included in the Royal grant. The letters of Junius were mainly directed to the restoration of the Forest of Inglewood, granted away from the Duke of Portland to Sir James Lowther, son-in-law to Lord Bute. It has been computed that in fifty-eight of the letters in question, the name or interest of the Duke is mentioned, twenty times directly and specifically, and thirty-eight times indirectly or by allusion, and a natural conclusion was arrived at that the Duke must have been the writer. As, however, he never divulged the secret, the authorship remains to this day an unsolved problem.

But, as before hinted, it would take more space than we have at our command to describe the wonders of Welbeck, its extensive lake and magnificent gardens, where bounteous nature, aided by the improving hand of man, has bestowed flowers and plants in argustic overtorned. It was a lovely day

Without fear of contradiction we may say of this locality, there is so much that is beautiful and attractive, there are so many lovely falls and chasms, such as the Pecca, Thornton, Foss, Beasley, Cauldron Hole, Boggarts' Roaring Hole, L-Hole (so named from its outline resembling that letter of the alphabet) and so many natural caverns, all worth a visit, that it is difficult to know where to commence and where to end, or how to describe one without invidiously cold-shouldering the other.

The susurration of the waters flowing along stony beds in silver streams, the embankments almost smothered in fern and trees, changed in character entirely as one advanced towards the cascades, where, in some instances, the

waters leaped and sported over the rocks with a noise like artillery. The scene was often quite tropical in its boundless loveliness, and the delicious softness and warm languor of a beautiful day, added to the fact that the view of water was often lost in dense foliage and could only be heard, and the sky overhead almost shut in by an impervious screen of leaves and branches, added salience to every changing feature, and induced a feeling that this was real pastoral happiness.
