## THE GIRLS SCHOOL FESTIVAL.

ONE of the greatest events of the year in Masonic Charity affairs takes place on Wednesday next, when the 110th Anniversary Festival of the Royal Masonic Institution for Girls will be held at Freemasons' Tavern, London, under the presidency of Sir Reginald Hanson, Bart., M.P., Past Grand Warden of England Patron and Treasurer of the Institution.

It is well known to the Craft that the result of this appeal is looked forward to with considerable concern, as a very small return is anticipated, in consequence of the strong counter attractions offered by the Centenary celebration of the Boys School, but we sincerely hope the total subscribed will be greater than is generally anticipated, and that the management of the Institution will have a feeling of relief after the announcement is made, in the knowledge that there is no real cause for anxiety as to the immediate future of the Institution-but such a relief can only be afforded by a more liberal response to the Chairman's appeal than at present seems probable.

The annual visit of the Stewards and distribution of prizes to the pupils of the School takes place on Monday, when Lady Hanson has promised to attend, and will, we hope, be supported by a large number of those interested in this most deserving Fund of Masonic Benevolence.

## THE OLD PEOPLE.

NOTHER important event which will take place next week is the annual meeting of the Royal Masonic Benevolent Institution, to be held on Friday, at Freemasons' Tavern, London.

The business includes the election of a Treasurer and Auditors, and the consideration of two notices of motion.

The first, on the recommendation of the Committee of Management, is intended to give official recognition to Masonic Charitable Associations, and allow them to acquire votes for their Executive Officers in return for amounts

The second proposition stands in the name of Bro. W. C. Parsons P.M. 180, who proposes an addition to Rule 13 of the Laws of the Institution, so as to give two annuities each year on each fund to the two Candidates who have been the longest on the list, if deemed worthy of the same; failing the passing of which he proposes that any Candidate failing to obtain election after six years shall be removed from the list, but may be again re-nominated if considered worthy.

These suggestions of Bro. Parsons must be rejected. Under the first proposal it would be only necessary to get on the list to secure an annuity—if one lived long enough. Under the second proposal a manifest injustice would be done, as votes recorded on behalf of a candidate during his or her six years candidature would be forfeited, simply because the applicant's friends might not be strong enough to secure the annuity in the ordinary way. This would be manifestly unfair, and we cannot understand how anyone of Bro. Parsons's known sympathetic nature could have suggested such harsh treatment.

The usual election of annuitants for the two funds will next be proceeded with.

## WEST LANGASHIRE.

SATURDAY will rank as a red-letter day in the annals of Blackpool. inasmuch as the first line annals of Blackpool, inasmuch as the first public function attended with Masonic ceremonies took place. The proceedings commenced at one o'clock in the Poulton-le-Fylde Parish Church, when the Right Hon. Lord Skelmersdale P.G.W. Past Prov.G.W., by command of Earl Lathom, unveiled a handsome stained glass window which had been erected to the memory of Dr. John Winn P.Prov.G.D.C. His Lordship was attended by the Provincial Grand Chaplain Rev. R. S. Y. Bradshaw, of Blackpool, who delivered a short and appropriate address.

At the conclusion of the service the Brethren travelled by special train to Blackpool, and attended Provincial Grand Lodge, which was opened in Christ Church Schools, after which they were marshalled into procession, and, headed by the 1st Volunteer Battalion, North Lancashire Band, they proceeded to the site of St. Paul's Church on North Shore. At St. Paul's Lord Skelmersdale laid the north-east corner foundation stone with the accustomed Masonic ceremonies.

The foundation stone of the new Masonic Hall, to be erected in Upper Adelaide Street, was next laid by his Lordship. Lord Skelmersdale was the recipient of two handsome silver trowels with ivory handles, and two magnificent mallets made of oak from Nelson's flagship, the Foudroyant, that was wrecked at Blackpool in June of last year, all of which bore suitable inscriptions, those on the mallets being engraved on copper bands, also obtained from the Foudroyant. In the evening a banquet was held at the Lane Ends Hotel.

## STAFFORDSHIRE.

ON the occasion of the annual meeting of this Provincial Grand Lodge, reported in our last issue, the Earl of Dartmouth Provincial Grand Master, addressing the members of the Province, said: At the annual gathering they had opportunities of considering what events of interest had taken place in the Province during the past year, and of forming opinions as to the future. One great cause of regret was that owing to the state of his health the Deputy Provincial Grand Meeter had found it necessary to recipile the Provincial Grand Master had found it necessary to resign the post which he had held with so much acceptance during the last nine years. He felt that he was voicing the feeling of every Brother in the Province when he said that it was a matter of extreme regret that Col. Bindley felt called upon to resign the position which he held in the Provincial Grand In a great Province like theirs there were matters Lodge. continually arising which required both ability and tact in dealing with them, and in such matters the services of Col. Bindley had been invaluable. They would all join in the hope that, though he was severing his official connection with the Provincial Grand Lodge, he had still many years of life before him. There was no one to whom he owed more than to Bro. Bindley for advice and guidance, and the word in season which was officers as reliable. He wished word in season which was oftimes so valuable. He wished to express his sincere thanks for the great assistance which he had given to him. He hoped that for many years they would be able to welcome Bro. Bindley either at Provincial Grand Lodge or in any Lodge of the Province which he might attend. Wherever he went he would have a most hearty and fraternal greeting. After congratulating the Province on the new Masonic calendar which had been issued for its special behoof, Lord Dartmouth urged the great importance of a liberal contribution from the Lodges to the Boys School Centenary Festival. They had had a visit from the Grand Master the Prince of Wales in the Province, and ought to show that they appreciated his Province, and ought to show that they appreciated his kindness in coming among them, by doing what they could to ensure him a bumper reception at the Festival at which his Royal Highness was to preside. He mentioned that on account of the Centenary subscribers of ten guineas would have five life votes instead of three as on other occasions. That would increase their voting power if it was taken full advantage of, but if other Provinces were more generous in their response they might find themselves out-voted in the future. Referring to the recent consecration of the Foster Gough Lodge, he said the Grand Officers of England who were present were highly pleased with the whole proceedings, with the arrangements made for the occasion. would ask that it might be recorded on the minutes that the Provincial Grand Lodge recognised most cordially the efficiency of the arrangements which were made for the consecration, so that those who were responsible for the arrangements might feel that their efforts were appreciated to an extent that would be some compensation for the trouble they had undergone. He congratulated the Province upon the continued increase in the number of Brethren, and expressed his acknowledgments for the hearty greetings accorded to him whenever he was able to visit the different Lodges. He moved a vote of thanks to Col. Bindley for the great services which he had rendered to the Province during

the last nine years. The vote was carried by acclamation. Col. Bindley, in a few remarks, expressed his thanks for the kindly recognition which had at all times been given to his endeavours to further the interests of Masonry in the Province. He though that Staffordshire might be proud of being really to the fore in Masonic work, and of the genuine unanimity and Brotherly love which characterised all their proceedings. If he could be of any use to them in the future his services would be most willingly and most cordially at their disposal. He congratulated the Province on the good fortune of having Lieut.-Col. Walker for his successor. His duties of Provincial Grand Secretary had been admirably performed, and he moved that a vote of thanks be accorded to him and entered upon the minutes.

Bro. Bodenham seconded the motion, which was carried unanimously, and Colonel Walker briefly replied.

Bro. Dunbar Steen read the patent of Col. Walker's

appointment as Deputy Provincial Grand Master, in reference to which Lord Dartmouth remarked that he thought they would not be surprised that he had appointed Col. Walker to the office. They could not but feel sure, from the experience they had had of him in Masonic work, that there was no one who would better carry out their requirements.

Bro. Bodenham proposed that the Board of Management of the Royal Masonic Institution for Boys be requested to register the life presentation belonging to this Province in their books as "The Earl of Shrewsbury Memorial," the title under which it was subscribed and by which it is known in the Province, instead of "The Duke of Connaught," the designation which has been given in their reports through a misunderstanding. He explained that 500 guineas was subscribed as a memorial to the late Lord Shrewsbury. The mistake had arisen from the fact that the presentation was made on the life of the Duke of Connaught, and this vote was necessary to have the error rectified in the reports of the Boys School. The motion was carried unanimously.

On the motion of the Provincial Grand Treasurer, the payment of a sum of £21 to the fund raised in the county in commemoration of her Majesty's Jubilee, instead of £10 10s. voted at the last meeting of Provincial Grand Lodge, was sentiment and confirmed

sanctioned and confirmed.

Lord Dartmouth proposed that the sum of £105 be voted from the funds of the Provincial Grand Lodge to the Centenary Festival of the Royal Masonic Institution for

Boys.

Taylor President of the Masonic Charitable Association seconded the motion. He mentioned that there were about 120 Brethren who had been fortunate in the ballot, with others who had paid up their five guineas, and these Brethren by adding five guineas to the amount already subscribed might become Stewards, as it was not yet too late to pay the other half of the required ten guineas, for a Stewardship at the Centenary Festival next month. It was most desirable that the Province should send as many Stewards as possible. It might be well for the Brethren generally to know that in the last twenty-five years, reckoning the number of boys they had succeeded in electing to the Institution and the expense of their education, they had had more money out of the School than they had paid in. Therefore, as a financial speculation, the Boys and Girls Schools were a very good thing for Staffordshire. He urged that it was the duty of all Masons in the Province to support the Festival as far as they could, not only for the part which was being taken by his Royal Highness the Grand Master, but having regard also to the fact that their Prov. Grand Master was the chairman of the Board of Stewards in that Province.

Bro. Newnham proposed that a small Committee be formed for the purpose of giving substantial recognition to the services of Col. Bindley, for whom all Stafforshire Masons

had the very warmest regard.

Brother H. Payton P.P.G.R. seconded the motion, remarking that anything they could do would but very inadequately represent the feeling with which the Masons of the Province regarded Col. Bindley, who had found a place in all their hearts.

The Provincial Grand Master, the Deputy Provincial Grand Master, Bros. Newnham, Pepper, and Dunbar Steen were appointed a Committee, with power to add to their

number.

The P.G. Lodge was resumed after service, and, on the motion of the Provincial Grand Master, votes of thanks were passed to the Mayor and Corporation of Stafford for the use of the Borough Hall, to the County Council for the use of the Shire Hall, to the Rector of Statford, and to the Prov. Grand Chaplain for his excellent discourse.

After the closing of the Lodge, a banquet was held at the Shire Hall, and was attended by nearly 100 members. The Earl of Dartmouth presided, supported by his principal Officers. The dinner, provided from the Swan Hotel, and the arrangements of the Prov. Grand Stewards, gave every

The usual Loyal and Masonic toasts were honoured. Lord Dartmouth's health was drunk with musical honours, and the new D.P.G.M. and the Officers of P.G. Lodge were toasted with the greatest cordiality.

A feature in the post prandial proceedings was the engagement of the Lichfield Masonic Glee Party, whose contributions to the enjoyment of the evening were warmly appreciated. A clever recitation was given by Bro. Dunbar Steen the new Provincial Grand Secretary.—"Staffordshire Advertiser."

## WEST YORKSHIRE.

THE annual convocation of this Provincial Grand Chapter was held on Wednesday afternoon, under the auspices of the Sincerity Chapter, No. 1019, in the Mechanics' Institute, Wakefield. In the absence of the Right Hon. W. L. Jackson, M.P., Prov. Grand Superintendent the chair was occupied by Comp. Ensor Drury P.G.Soj. P.Z., of Sheffield. Eight Chapters were Chapters better.

Comp. Drury said that two Chapters had been added to the roll of the Province since their last annual meeting—the Milton, No. 1239, at Sheffield, and the Colne Valley, No. 1645, at Slaithwaite. There had been a considerable increase in the number of members during the past year. They now had nine Chapters in the Province which were

founded over 100 years ago.

The Provincial Grand Treasurer presented the balancesheet, which showed that the year commenced with a balance in hand of £280, and concluded with one of

Another fifty guineas was voted out of the Prov. Grand Chapter to further endow the Grand Superintendent's chair, Royal Masonic Institution for Boys, in commemoration of the Centenary of that Institution. It was pointed out that the Prov. Grand Lodge had contributed 200 guineas to the Boys Institution. The hope was expressed that the Province of West Yorkshire would send up 5,000 guineas to the Festival on behalf of the Boys School, and already £4,603 had been subscribed, so that they only required £397 to complete the sum.

## GRAND LODGE OF SCOTLAND.

QUARTERLY COMMUNICATION was held in the Freemasons' Hall, Edinburgh, on Thursday, 5th inst., the Grand Master Lord Saltoun presiding.

Charters were ordered to be issued to the following new Lodges: "Blue Fields," at Blue Fields, Nicaragua; and "Gwelo," at Gwelo, Rodesia.

It was agreed that special collections in aid of the annuity fund be taken up in all Lodges under the Scottish Constitution in December 1898 and December 1899.

A vidimus of the accounts for the quarter ending 26th April showed that the income had been £1,888, being £756 more than the expenditure. Grants of £180 had been given from the Benevolence Fund to distressed Masons or widows of Masons.

The Grand Master unveiled a white marble bust of Past Grand Master Sir Charles Dalrymple, of New Hailes, Bart., M.P., the work of Brother W. Grant Stevenson, R.S.A., and

a replica of the bust lately presented to Sir Charles and his family. It is a splendid likeness, and will, along with the busts of other Past Grand Masters, remain in the Great Hall.

The Grand Master before calling on Bro. Stevenson to

unveil the bust, made a graceful reference to Sir Charles's work on behalf of Masonry and the Grand Lodge.

The Past Grand Master, writing from the House of Commons Library, said that while thanking the Grand Lodge most heartily for this additional mark of their favour he regarded it as no ordinary event that his bust should he regarded it as no ordinary event that his bust should be set beside similar memorials of his predecessors in the chair of the Grand Lodge, whom he regarded with respect and veneration.

The Grand Master next moved the adoption of a recommendation by the Grand Committee that on the occasion of the completion of twenty-one years service as Grand Secretary 100 guineas should be presented to Brother D. Murray Lyon as a mark of the respect of the Grand Lodge of the way in which he had carried out the work of that office. Bro. Lyon, he said, had gained the confidence of every Grand Master and of the vast majority of Masons. A portion of the sum would be devoted to the purchase of a permanent souvenir which could be handed down from father to son, and be a memorial of his work for a long period of years. The whole of the Grand Masters under whom Bro. Murray Lyon had served were alive except, alas, one, and as a mark of respect they were to make him a present which he would very greatly regard. The motion was at once unanimously adopted.

The other business was routine.

## "A SPRIG OF ACACIA."

THE funeral of the unfortunate lad, whose tragic death at the Royal Masonic Institution for Boys we recorded last week, took place on Saturday, amid every evidence of respect and regard. The interment took place at Tottenham Cemetery, the service being conducted by the Head Master of the School, Bro. Rev. Harry Hebb, while the choir of the Institution also took a prominent part. The first part of the proceedings took place in the Tottenham Parish Church proceedings took place in the Tottenham Parish Church, where were congregated the boys of the Institution, numbering upwards of 200, together with the relatives of the deceased lad, the various masters and others connected with the Institution, making in all a large and devout congregation. During the period of waiting, several voluntaries were played. The funeral cortege left Suffolk Lodge, Lordship Lane, shortly after half-past two. Reaching the Church, the solemn procession wended its way up the nave, headed by the Rev. H. Hebb, intoning the opening sentences of the Burial Service. Following him was borne the coffin, covered with a purple pall, behind which immediately came the deceased lad's mother, brothers and sisters, and others. After the lesson the procession was re-formed, the choir leading the The two foremost boys carried baskets of choice flowers, which were afterwards strewn over the coffin. At the graveside all the boys were drawn up in a circle, inside of which were the relations and friends, the assistant-masters, and the officiating clergyman. Bros. J. M. McLeod Sec., Stanley J. Attenborough Hon. Solicitor, and others officially represented the Institution.

THE funeral of Bro. Captain M. P. S. Tozer, who died on Sunday morning, 1st inst., took place at Shire-hampton churchyard. The service was conducted by the vicar, Rev. A. J. Harvey. The mourners who followed were several sons and relatives, and in addition there was a large number present, including several Freemasons, the deceased having been a prominent member of the Craft in the district for some time past.

THE Provincial Grand Master of Nottinghamshire, his Grace the Duke of St. Albans died on Tuesday, 10th inst., after having suffered for a considerable time from an incurable malady. The late Duke was appointed to the charge of the Province in 1877, and has been very popular among the Brethren of the Craft under his rule.

## "MAINE" LODGE OF SORROW.

WE learn, per Bro. T. S. Parvin Grand Secretary and Librarian of Iowa, that the "Mexican Herald' March records the proceedings of a Lodge of Sorrow held by the seven Lodges in the city of Mexico, working under the Gran

Dieto of the Republic, as follows:

Last night in obedience to a joint call issued by the Spanish Lodge Riego, No. 4, and the Mexican Benito Juarez Lodge, No. 3, a Lodge of Sorrow was held at the Lodge rooms on Puerta Falsa de San Andres, No. 14. The object of the meeting was in commemoration of the death of the eighty-three Masons who were victims in the "Maine" catastrophe. The two officers who were killed, Lieutenant Jenkins and Engineer Merritt, being respectively the Senior and Junior Wardens of the Lodge which held its regular meetings on board the unfortunate battle-ship.

The Lodge of Sorrow was attended by full representations of all the Lodges working under the Gran Dieta Simbolica de Mexico, and included the following: Riego, Benito Juarez, Germania, Grand Lodge, Toltec, Cuauhtemoc, and Anahuac. The hall was fittingly draped in deepest black, and the Grand Master and other Officers, who assisted in the ceremony, were also emblematic of

the sorrowful occasion.

In Memoriam speeches were made by representatives from each of the Lodges present, and by the grand representative of the State of New York Hon. D. Whittemore. At the request of the Cuauhtemoc Lodge G. M. Ermilo Canton, of the Grand the Cuauhtemoc Lodge G. M. Ermilo Canton, of the Grand Lodge, spoke. He made a most moving speech, and his tributes to the deceased Brothers were most beautiful and eloquent. Riego Lodge was spoken for by Lic. Diodoro Batalla and Sir Villada. The Benito Juarez Lodge orator was Lic. Maldonado. Lodge Germania, August Pfeffer. Grand Secretary F. Iglesias spoke for the Grand Lodge. The Toltec Lodge orator was F. E. Young J.W. The Anahuac Lodge was spoken for by W. M. Morgan. After the speeches the funeral ceremony of the Order was performed with all its impressive solemnity.

## NEW TEMPLE AT TORQUAY.

THE Brethren of the Jordan Lodge, No. 1402, at Torquay, are building a home of their own. Hitherto they have been tenants of St. John's Lodge, but not content with that arrangement they have commenced the erection of a "Temple" on the Tor Hill Estate, one of the most central sites in the town. On Wednesday, 4th inst., the corner stone was laid with full Masonic ceremony by Bro. G. C. Davie P.A.G.D.C. Eng. Deputy Provincial Grand Master of Devon. The building will be Gothic in style, and mainly of red sandstone with bath stone dressings. On the ground floor will be a dining hall 38ft. by 23ft., an entrance hall 9ft. by 15ft., a kitchen 18ft. by 14ft., pantry and offices. Above will be the main hall 24ft. by 23ft., a reception room 18ft. by 14ft., a small ante room, steward's store, &c. Messrs. Bridgman are the architects, and Mr. S. Hawkins the builder the price being between 1900 and £1 000 builder, the price being between £900 and £1,000.

Prior to laying the corner-stone in the north-east corner of the building, the D.Prov.G.M. said it was a great pleasure to him to accept the invitation of the Brethren of Lodge Jordan to come to Torquay to lay the corner-stone of their new building. It was now a quarter of a century since the Lodge was founded, and they all congratulated it upon the progress it had made, and upon its now obtaining for itself a habitation of its own. During the quarter of a century Freemasonry had made great progress in England, and especially in the Province of Devon, and no healthier sign of that progress could be had than the number of Lodges which had provided for themselves suitable buildings for their own use. As they were aware, in the earlier days of their own use. As they were aware, in the earner usys of Freemasonry, and up to quite a recent date, the usual place of meeting was in some hotel. Without in any way meaning to utter a word of disparagement to hotels, and whilst fully recognising their great usefulness, he could not help saying he did not think them suitable places for Lodge meetings. The accommodation in them did not allow of that secrecy and privacy which was the gist of their proceedings, and whatever might have

been the case in past days it was now against the spirit of the times to meet on licensed premises. Therefore, claiming as he did to have the good of Freemasonry at heart, he was glad indeed to hear when a Lodge left the hotel and occupied premises of its His remarks respecting hotels were not applicable to the Jordan Lodge, as the Freemasons of Torquay had for many years had a meeting place of their own. It was not sufficient, however, to only build a hall, for that was merely a means to an end. There was use of the hall and the spirit in which it was used to be considered. If they looked at the elements of consecration they would point out the spirit in which it should be used. The corn signified abundance, not only of material blessings, but of the higher blessings of virtue and honour arising to the Brethren in increased degree. All who attended the hall should come with the determination of carrying away with him and putting into practice the precepts he heard inculcated, and those who used it should as far as possible take care that no member was admitted to the hall who was not worthy of it, remembering that the lapse of a Brother from the paths of rectitude not only injured him, but almost infallibly inflicted discredit and produced dishonour upon the Society to which he belonged. Especially was this the case with Freemasonry. The wine was emblematic of joy and cheerfulness. He was quite sure the meetings in that hall would be bright and happy, and that friendships formed there would last for ever. He hoped the Brethren would never despise cheerfulness. He thoroughly believed in the full enjoyment of the pleasures of life, but not in their abuse. Then there was the oil, the symbol of peace and unanimity. He trusted the calming influence would act on the passions and prejudices of all. There would always be differenced of opinion or religious and political would always be differences of opinion on religious and political matters, and a good thing to, for to those differences the progress of the great Empire was due, but within that hall there would be no differences. There they would all be equal, the only Brother who stood above his Brethren being the W.M., in execution of his office, and he would be placed there by his own merit and the free vote of the members. In conclusion he trusted that plenty and abundance, joy and cheerfulness, and peace and unanimity might rest upon that building as long as it stood.

The Deputy Provincial Grand Master was presented with a parchment recording the proceedings, and it, with Masonic papers, was placed in a cavity beneath the stone, and after the block of limestone had been lowered into place he declared the stone truly squared, levelled, and plumbed, and properly laid according to the custom of the Craft. Corn, oil, and wine were scattered over the stone. The plans were handed by the architect (Mr. Bridgman) to the D.Prov.G.M., who remarked that he felt sure the building would be worthy of the Craft and worthy of the builder. A second prayer by Rev. E. Windle P.P.G.C. followed, and the Benediction concluded the ceremony.

The Brethren subsequently marched in procession to the Pavilion Hotel, where a banquet was served .-- "Western Morning News."

## A DUTY.

REEMASONRY has been in existence for generations. In all these ages it has been essentially the same organisation. Its principles and its characteristics have never changed. Its traditions, the source of so much Masonic knowledge remain unchallenged. The regulations, laws and landmarks that have constituted its identity from the earliest of days are yet as obligatory and authoritative as at the beginning. Freemasons now are the inheritors of these characteristics which to-day mark what is the only true Masonry

Therefore a most solemn duty is imposed on every Mason to protect Freemasonry from any and all attempts to impair, weaken or destroy the integrity of the Institution. When the profane seeks to obtain the rights and privileges of Masonry he is required to do certain things before he can receive admission into the Fraternity. These are all fully explained to him. He voluntarily agrees to all that is required. The duty therefore devolved on him is by his own consent. If he understands it in its true character there can be no excuse for a neglect to obey the dictates of this duty. To plead ignorance is to charge the Lodge with improperly instructing him. Every Lodge tries to be free from any such imputation, for its existence depends on its fidelity to the duties imposed on it, else it would be deprived of its functions. So, then, the excuse of ignorance cannot be accepted.

But there are a very, very large number of Brethren who are not ignorant of the duty to which a member is called. They know what that duty means; more than this, they also know

how to perform it

Hence if any persons are engaged in efforts, or plans, or pretences, to set up a clandestine association of men as Masonic, it is not difficult for any of this large number of well-informed, well-trained, well-instructed Brethren to detect such a scheme,

which if carried out would impair or weaken the integrity of the

character of Freemasonry.

Those Brethren who can surely protect Freemasonry from Those Brethren who can surely protect Freemasonry from the subtle or open efforts to organise a clandestine body on the pretence that it is Masonic, are bound by the solemn duty placed on them when they become Masons, to use their knowledge to detect and expose such an attack on the Craft to which they are attached. The very life of Freemasonry depends on the ability of its members to protect it, and this duty is so interwoven into all the obligations of every Mason that it is an ever-existing, imperative, and solemn self-asserting command on the conscience and courage of all Masons.

It is now well known that there are associations of persons

It is now well known that there are associations of persons which by implication pretend to be "Masonic." This word is used as though it was the common property of anybody or everybody who seeks notoriety, or to call the attention of the thoughtless and curious multitude to the society they seek to set

up for purposes not explained.

When it is found that here and there meetings are held by individuals, who, without any right to use the word Masonic, do use it, then the duty of the Freemason is to discover what is meant by the use of this word. If inquiry is made which proves the thing is a counterfeit, or an abuse, or a pretence of true Masonry, and those engaged in the proceedings are not Masons, then prompt exposure of the affair is demanded. Every true Mason is interested in the discovery and the exposure of the fraud. Thus the integrity of the ancient and honourable Fraternity of Freemasons is protected.—" Keystone."

## A MASON'S RESPONSIBILITY.

REEMASONRY, like a Chinese house, was built from the roof down. There was a Grand Master before there was a Lodge, and Masters and overseers before there was a Grand Lodge, and Masters and overseers before there were Lodges. Freemasonry was the gift from the one to the many. It is not a constituent body. The Grand Master is subordinate to no higher authority. He is amenable to no one.

The symbolism through which Freemasonry communicates its lessons shows this fact conclusively. King Solomon's Temple and the teaming includents connected with its projection, building

and the teeming incidents connected with its projection, building, destruction and rebuilding furnish the central idea. That a secret word and sign should be bestowed upon the faithful Craftsman was a conception of the man of Tyre, when he was considering how to disperse the workmen at the completion of the Temple. He was the first Grand Master. Freemasonry was his gift, in that he consolidated isolated toilers into Lodges and rewarded the worthy with a means of recognition and a certificate of honourable discharge. Freemasonry, therefore, owes nothing to its votaries. They come into its fellowship unsolicited and voluntarily assume the obligations it imposes.

"There are duties owing by every Mason to his Brethren," says Mackey, and this thought cannot be too strongly pressed

upon the attention of the Fraternity.

When, as a novice, you asked a part in the rites and privileges of the particular Lodge with which you determined to affiliate, you were to be a recipient only in so far as the ceremonies of initiation made you a Mason. Your obligation, the traditions and esoteric teachings of Freemasonry all made plain to you that

you assumed responsibilities.

To be a member of a Lodge, to attend regularly its meetings, to witness the ceremonies of initiation and to partake of its refreshment, is not all that is required to make a Mason, in the highest sense of that title. The dissatisfied Mason and the nonaffiliate are those who expected to be recipients of some unknown good, and who are disappointed to learn that they are offered only the incentive to do good to others. Labour is expected of them. They have been taught to bestow, not to expect to receive benefits. That this is the highest good finds no echo in their selfish natures.

If all of Freemasonry lay in its forms and ceremonies, what a hollow mockery it would be! To witness, not that noble contention as to who can best work and best agree, but greed for self and greed for place, helped on by scheming plots and unfraternal strife, might lead the onlooker to exclaim, "There is

none that doeth good, no, not one!'

But some seed falls upon good ground. The bickerings of the selfish and ambitious sink into insignificance and fade in the golden glow of a true humanity. Distinctions of rank or wealth are obliterated on the level of a common manhood. The wealth are obliterated on the level of a common mannood. The great pulsating heart of a catholic charity beats warmly for the suffering and impoverished. The ready right hand of fellowship is extended to support the weak and raise the fallen. An humble and devout dependence on the One Great Law Giver reveals a faithful search rewarded by the recovery of the Lost Word. Truth glistens with an imperishable lustre. On every side Masons are going about doing good. Their word re-establishes the wavering. That they go hand in hand in the accomplishment of any good work establishes the contention that they have learned to be workers, giving of their powers and expecting nothing in return .- "Keystone.

## DUTIES AND OBLIGATIONS OF THE MASTER.

THERE is none too humble in the Craft to become the Master of a Lodge, and, indeed, it is a laudable ambition so to do. None should sit idly in the Lodge room with no desire to reach the higher rank of the Craft. All should be inspired with ambition to secure official degrees and none is more laudable to labour for than that of the rank of Past Master. With such a desire should be coupled a clear perception and comprehension of the character and duties of the Master of the Lodge. Its scope is not confined to the repetition of certain phrases and direction of the "work," but comprises vastly more of the understanding and service to be performed. A Master should be able to fully instruct the Craftsmen, not only in the meaning and origin of the ceremonies, but also to fully and intelligently explain to them the philosophy which is veiled in its allegories and illustrated by its ancient symbols.

its ancient symbols.

He should be able to convince his Brethren that all science and all art, legitimately directed, are but the lines which run toward the great and benign work and teaching of the Craft. By art and science we are led to fully appreciate the wonderful works of the Great Architect of the Universe, and by them are made better and nobler followers of the compass and square, and more clearly to comprehend the wonderful glories of our Almighty Father, who created us. The Master of a Lodge should set an example to his fellow-Craftsmen, by exemplary conduct and good citizenship, and his conversation in and out of Lodge be a model for the Brethren to admire and imitate, and should always practice those great moral doctrines and virtues which he inculcates within the walls of a Lodge room. He must be methodical and punctual in all things connected with his duties as executive of the Lodge, make all decisions without fear or favour, using his best judgment, and act in all things with justice and impartiality, so that he may command the respect of all fair-minded Freemasons. These are a few of the requirements necessary for a successful Master. Constant study and strict attention to the duties incumbent upon him will remove all obstacles and render his official life comparatively smooth.—Ex.


