### ROME AND FREEMASONRY.

POR some time past a number of letters have appeared in the columns of the "Catholic Times, in regard to Freemasonry and the ban placed upon it by the Romish Church. We have reprinted many of these letters, and we think those of our readers who have perused them must be struck, as we have been, with the almost general tendency of the writers to favour our Craft. It is true a few of the letters have been written in the fanatic intolerant spirit we had come to be accustomed to expect among Romish writers when dealing with the subject of Freemasonry, but the majority of them most certainly display a more rational sentiment, and would seem to call for friendly and courteous consideration at the hands of members of the Craft, who, almost for the first time in the history of the opposition of Rome to our doings, appear to be regarded more as fellow subjects, than as murderous infidels intent on the overthrow of religion, and every form of legal authority throughout the world.

The old fashioned arguments of Roman Catholic writers—that Freemasonry is bad, because it is bad, and that it is terribly wicked because the heads of their Church have said so-have, for the first time in our experience, been challenged by Catholics who appear to have an opinion of their own, and do not hesitate to express it; and we can but acknowledge a feeling of satisfaction that it is so-for we are firmly convinced that once Roman Catholics have the pluck, or secure the necessary permission, to examine Freemasonry for themselves, they will soon find it is by no means the "bogey" they have always been taught to consider it, and a better understanding all round must necessarily result.

This correspondence has brought to the front members of the Romish Church who boldly ask why they are prohibited from joining an Institution which has the support and patronage of the highest in the land, and which professes and practices the best principles of their religion; and more than one of the writers has evinced a determination to over-ride priestly interference in this particular, and go straight to the head of their Church for an explanation of the prohibition, and, it may almost be expected, a thorough enquiry into the whole matter under the admitted altered conditions of the age.

It seems to us so absurd that two great organisations, both professing to work for virtually the same objects, should be so widely separated as Freemasonry and the Church of Rome have so long been, and it is only on the principle that religion has been the cause of the most bitter and the most terrible disputes in the history of the world, that one can even excuse the gulf which exists at the present day between them. Are we on the verge of a reconciliation? We sincerely hope so, but if it does not come just yet we can but regard the candid expressions of opinion on the part of many of our contemporary's correspondents as a most gratifying step in the right direction. We only ask for a fair and free consideration of our position—as opposed to the fanciful picture conjured up in the minds of our rabid opponents in the Romish Church.

### BOARD OF BENEVOLENCE.

THE July meeting of the Board of Benevolence was held on the 19th inst., at Freemasons' Hall, the President's and Vice-Presidents' chairs being occupied respectively by Bros. D. D. Mercer, Henry Garrod, C. J. R. Tijou, and George Graveley.

The Grand Master having approved of grants to the amount of £200 recommended at the June meeting for his

sanction, they were confirmed. Thirty petitions were on the new list, but two of these

were withdrawn by the petitioners after presentation. # CHARLES DICKENS LODGE.

THE association of the respected name of our great novelist with Freemasonry is at first sight not quite apparent. Dickens was not a member of the Craft, and his references in the few isolated instances quoted in his works tend rather to the convivial than to the sublime work of our Order. Still, as Bro. the Rev. Canon Quennell observed in a most interesting address, the writings of Dickens contain evidence of the principles of Freemasonry, and even his severe castigations of cant and humbug prove that at least he was a Mason at heart. The idea of naming this Lodge after Charles Dickens doubtless originated in the fact that the meetings will be held at the ancient hostelry referred to in "Barnaby Rudge."

A Warrant having been granted by the Grand Master for the establishment of the Charles Dickens Lodge further speculation is unnecessary, and hence it happened that on Tuesday of last week a large number of Brethren journeyed by a well appointed train of the Great Eastern Railway to Buckhurst Hill, where carriages were in waiting to convey the visitors to the King's Head, at Chigwell, to meet the Provincial Grand Master of Essex, the Earl of Warwick, who had kindly undertaken to perform the consecration.

Upon arrival the Brethren assembled in the Lodge room, when Bro. Thomas J. Ralling P.G.A.D.C. Prov. Grand Sec., happily recovered from his recent indisposition, opened the Lodge in the three degrees, after which the Provincial Grand

Master entered, and was saluted according to ancient custom.

Lord Warwick requested the following Brethren to assist him: Robert Woodhouse Prov. S.G.W. as S.W., Colonel Landon Prov. J.G.W. as J.W., Rev. Canon Quennell as Chaplain, Albert Lucking P.G.P. as D.C., and John J.C. Turner P.P.S.G.W. as I.G. The opening hymn was then

sung, after which the Chaplain offered prayer.

Lord Warwick addressed the Brethren, saying they were assembled together in that ancient and historic room for the purpose of organising another Lodge in the Province, and he had been authorised by the Grand Master to act as his Deputy, and perform the consecration ceremony.

A very interesting and appropriate adddess was given by the Chaplain Bro. the Rev. Canon Quennell P.M. 214 P.P.G. Chap. (Rector of Shenfield). He said:—The duty devolves upon me, in obedience to command, to speak of the nature and principles of our Institution. It is a theme familiar to us all: we endeavour to study and practise them. Yet there are occasions when we recite them: as in a certain solemn service the Ten Words are recited—the Commandments of the Sacred Law, which we all know by heart, and acknowledge ourselves bound to know and to do them. difficult when all are familiar with the theme to present it with any air of freshness. But to-day, meeting as we do in this house—I may say in this room—which has become historic, and under a banner which bears the name and effigy of him who made it so-I may be forgiven if I wander a little from the beaten track, and ask you to accompany me

into those realms of fancy, observing, as we linger there, how the principles of the Craft—those social, moral, and religious foundations on which it rests, are represented in the delineations of life and character that we have as a possession of the English tongue from the brilliant imagination and facile pen of Charles Dickens. Was he then a Mason? There is no evidence that he was; and that in itself is presumptive evidence to the contrary. Some have thought that the grotesque scene in which he describes the Apprentice's initiation into the Secret Society of the 'Prentice Knights, under the command of the Valourous Master Simon Tappertit, was intended as a travesty of our solemp proceedings and was intended as a travesty of our solemn proceedings, and therefore implies some acquaintance with them; but the scene appears to me rather to smack of those fanciful imaginings which the uninstructed world conjures up about our mysteries and secrets; and, moreover, I feel quite sure that though Charles Dickens could hold up the foibles and weaknesses of life to keen ridicule, and lash with the bitterest invective its meannesses and wrongdoings, he was of far too generous a disposition wantonly to attack a noble institution, or by misrepresentation to wound the feelings of any of his fellow-men.

There are some of us who can remember the delight of those charming stories coming into our hands fresh from the author, and the eager expectation waiting from month to month for the new part. And while we may now think there is in his style a certain exaggeration—a rather strong flavour to the dish with which he serves us, when compared with the delicacy of some other of his contemporaries, or more recent popular authors—though he may appear to us to present rather caricatures than portraits, comparable with the drawings by which Browne and Cruickshank embellish his first editions rather than with the finished photographic picture of the modern illustration, yet (and here is the point to which I have been coming) in his writings there are always the great realities of the Masonic Charter—the laudation of benevolence, the denunciation of wrongdoing, the relief of suffering merit, the unmasking of hypocrisy and selfish greed,

the ultimate happiness of deserving loving hearts.

To take an illustration: The exuberant charity of the Brothers Cheeryble may move a smile, as we acknowledge that, notwithstanding the statement that they were drawn from life, no men exactly like them could have ever lived; but the principles of good feeling and beneficent action which they exemplify find an echo in every good man's heart, and are particularly consonant to the character of the ideal Mason, and the conduct which he is bidden to pursue. Only in passing will I refer to the convivial side of the Dickens' story, the ample provisions, the mingled viands, the (sometimes unmingled) liquids, which his scenes set before us. too, is the exaggeration I referred to; who can read without laughing at the contents of Dick Swiveller's hamper, or without a shudder the unlimited capacity of Mr. Pickwick for milk punch. Our author does not always depict the most comfortable and enjoyable form of social intercourse, such as quiet, sober Masons delight in, but the social side is always to the fore, and when the more serious parts of Masonic work have been well and worthily performed, the true Mason is always found to be a sociable man, and the virtues of goodfellowship are rightly fostered by the enjoyment of a common meal and the agreeable conversation that accompanies it. We have almost a spice of our author's exaggeration about us, when we invariably call it a banquet! Brethren, I have tried, I hope I have not exhausted your patience, by this excursion into the regions of fiction, yielding to the genus loci. Can we wish better for the Charles Dickens Lodge than that it may long prosper, and illustrate the great Masonic virtues of Brotherly Love, Relief, and Truth, with all the richness of expression, with all the steadiness of purpose, with all the zeal for the triumph of good over evil, and with all the graces of fancy, wit, and bonhommie which characterises the genius of him whose name

The Petition and Warrant were then read by Bro. Ralling, and the founders expressed their approval of the Officers named therein. The ceremony proceeded upon the usual lines, and the Lodge was duly constituted, and

dedicated to the service of God and the good of man.

Lord Warwick expressed regret at the absence of Col.

Lockwood Deputy Prov.G.M., who was detained by his duties at the House of Commons, but in his absence requested Bro. Lucking to undertake the installation of the first Master of the Lodge. Bro. J. T. Dormer was thereupon presented, and formally placed in the chair, in the presence of a very large Board of Installed Masters. Having been proclaimed, and saluted, the Warrant was entrusted to his keeping.

The whole of the ceremonies were carried out in an admirable, expeditious, and altogether business-like manner, all those taking part being thoroughly well acquainted with their duties, so that no time was wasted, yet everything was conducted with proper dignity and solemnity. The Earl of Warwick returned thanks for himself and the other Brethren who had assisted him in the ceremony. who readily consented to become connected with the Lodge as Honorary Members.

Bro. Johnson gave notice that at the next meeting he would propose a vote of ten guineas from the Lodge funds, to head the Master's list as Steward for the Royal Masonic

Letters of apology for absence were read from several distinguished Brethren who were unable to be present, and the W.M. having received the hearty good wishes of the Visitors the Lodge was closed, and the company adjourned

to the banquet room.

We may here state that the ancient hostelry of the King's Head has been recently thoroughly restored, and is now a comfortable and commodious Hotel, with suitable accommodation for summer outings and other gatherings, and is managed by Bro. William Lewis, of the Leyton Lodge. If the manner in which the dinner was served on this occasion may be taken as a criterion of Bro. Lewis' usual methods, we may congratulate him upon a successful career.

At the termination of the dinner the health of the Queen, and the usual Masonic toasts, were submitted by the W.M., and cordially received by the Brethren. Bro. W. H.

Bailey P.G.T. responded for the Officers of Grand Lodge.

The Earl of Warwick was received with great enthusiasm when he rose to acknowledge the toast of the Provincial Grand Master. He thanked the Brethren for the cordial and kindly reception extended to him that day, and expressed his gratification at the progress that was being made in the Province. When he was appointed, in 1882, there were only eighteen Lodges, and now they had constituted the forty-fifth, showing an excellent advance. He was pleased to find that Essex was generally near the top of the lists of the Masonic Charities, proving that the Brethren were sensible of their obligation in this respect. He also referred to the great object lesson in Freemasonry afforded by the speech of the Sultan Mohammed Khan at Brighton (as reported in our issue of the 1st inst.), who found in the teachings of the Craft a bond of union between the peoples of all nations. Finally he wished prosperity to the Charles Dickens Lodge, and he hoped he might be permitted to visit them

again at some future date.

Bros. Robert Woodhouse and Thos. J. Ralling responded for the Provincial Grand Officers.

The Earl of Warwick proposed the health of the Master, and in doing so his lordship remarked that he was greatly struck by the admirable manner in which Bro. Dormer had carried out his duties in the Lodge, and also at the banquet table. He was sure they could not have been more hospitably or courteously received. Bro. Dormer was well known in Freemasonry, and he hoped he would enjoy a happy and prosperous year of office.

The W.M. returned thanks for the compliment, and said

that the Lodge started under the most auspicious circumstances. All the furniture, even down to the slightest detail, had been paid for, and even the expenses attending the constitution of the Lodge had been defrayed. Still they had sufficient funds in hand to dispense relief to the distressed, and he was sure they would have a career of

prosperity

At this late hour we were obliged reluctantly to quit the meeting, to return to town, but the Visitors and the Officers of the Lodge received the customary compliment.

### "A SPRIG OF ACACIA."

PRO. DAVID HASLETT, of Golden Square, W., died on the 11th inst. and was buried at Hanvall on the on the 11th inst., and was buried at Hanwell on the 14th. He was alive and well on the 10th inst., but had a paralytic stroke on the afternoon of that day, and died the following morning about 6 a.m. Bro. Haslett was well known by West-end Masons, he having been Preceptor of the St. James Union and Athelstan Lodges of Instruction, and on the Committee of the Queen's Westminster Lodge of Instruction, also for many years on the Committee of the Domatic Chapter of Improvement. He learned Craft Masonry from the late Bro. Watson, in the Robert Burns Lodge of Instruction, and Bro. Cottebrune, of the Faith Lodge of Instruction, and belonged to nearly every one of the West End and City Lodges of Instruction; his R.A. Masonry was principally gained from the late Comp. Boyd. His knowledge was always at the disposal of all who knew him, and his services as installing Z, were in very frequent request. Bro. Haslett was in his 70th year, and was initiated in the Lodge of Prudent Brethren, in 1872, he was W.M. in 1878, and up to the time of his death Secretary of that Lodge. He was exalted in the Prudent Brethren Chapter, in 1878, was Z. in 1881, and Scribe E. till his death. He was a Life Governor of the Girls and Old Peoples' Institution, and Life Subscriber of the Boys.

NIVERSAL regret has been expressed by all classes at Bath, at the death of the Mayor, Bro. John Ricketts, J.P., which occurred on Thursday, 13th inst. Our deceased Brother was highly respected in the city, where he was born on 5th December 1837, and where he has long occupied a prominent position. He was initiated a member of the Royal Cumberland Lodge, No. 41, on 20th March 1861, and he passed the chair in 1867, serving the office of Provincial Grand Registrar of Somerset the same year. Bro. Ricketts was also recognised by the Grand Lodge of England, in consequence of his industry in the cause of Masonic Charity.

### LODGE TERCENTENARY AT EDINBURGH.

THE Tercentenary of the Lodge of Edinburgh (Mary's Chapel) was celebrated by a banquet on Wednesday, 5th inst., in the presence of a very large gathering of Brethren from the locality and outside parts. Originally it had been hoped that the Prince of Wales, who is affiliated to the Lodge, would have been present, but the numerous engagements of His Royal Highness made it impossible for him to accept the invitation. Such an interesting Masonic event, however, brought out a large company, and covers were laid for about two hundred.

The W.M. of the Lodge Bro. Peter L. Henderson presided, and was supported by Sir Charles Dalrymple, of Newhailes, Bart., M.P. and Lord Haddington Past Grand Masters of Scotland, with many other distinguished Brethren.

After the toast of the Queen, the Chairman proposed that of the Prince of Wales, Prince and Great Steward of Scotland. He considered it an honour to propose the toast of one who worthily holds the most exalted position in the realm, except only that of Her Most Gracious Majesty. The event which they were celebrating that night was one of peculiar interest, and furnished much food for reflection. But the dignity of the Prince of Wales was of older date than their minute-book. It had been borne by many distinguished and beloved sons of England, but by none with greater acceptance than by the popular Prince whose health he now proposed. As a Mason he occupied the highest position in the Empire, that of Most Worshipful Grand Master Mason of England, and many of them would remember that in 1870, with great pomp and ceremonial, he was installed by Lord Dalhousie, the then Grand Master Mason of Scotland, as Patron of the Scottish Brotherhood-a position held by Kings, both by George the IV. and William the IV. Immediately after this event His Royal Highness affiliated to the Lodge of Edinburgh, and they now claimed him as a royal Brother. all the later events of his life his royal spouse, the Princess of Wales, had been a constant and able support, and whether as a woman, a wife, or a mother, she was esteemed and beloved by all. He added her name to the toast and gave them: The Grand Master Mason of England, the Patron of Scottish Masonry, the Duke and Duchess of Rothesay, the Prince and Princess of Wales.

A long list of apologies and congratulations were then intimated from all parts of the world. The following letter from Dalkeith Palace was read:

"I am desired by His Royal Highness the Prince of Wales to express his regret that his engagements to-day will prevent him from being able to be present at the festival of the Masons of Scotland, but it is impossible for him to do so. I regret also to say that I am in the same position, and cannot leave His Royal Highness. Be kind enough to express to the Brethren how deeply I feel the honour conferred upon me in asking me to be present.—Abercorn."

A telegram was also read and enthusiastically received from the Prince of Wales. It read as follows:—

"The Grand Master of England regrets his inability to be present this afternoon at the tercentenary festival of Freemasons of Scotland, but he sends them his fraternal greeting."

Among others were apologies from Lord Saltoun the Grand Master of Scotland, the Duke of Abercorn Grand Master of Ireland, and Lord Provost Mitchell-Thomson.

Sir Charles Dalrymple, M.P., proposed the Navy and Army, Admiral Fletcher Campbell replying for the former, and Major the Hon. Dalrymple Hamilton for the latter.

The toast of the Three Grand Lodges and Three Grand Masters was given by Bro. J. Dalrymple Duncan, in the absence of the Hon. James Hozier, M.P. It was, he said, unnecessary for him to say anything of the Grand Lodge of England. They all knew its long and honourable history, and they all knew what services it had rendered to the cause of Masonry and Charity. They could not doubt that the Grand Lodge of England owed much of its prosperity to its present Grand Master the Prince of Wales, who had long presided over it. The Grand Lodge of Ireland was also in a most satisfactory and prosperous condition, and that, too, despite the fact that it had many difficulties to contend with in the shape of religious differences. It was most worthily presided over by the Duke of Abercorn. There was no Grand Lodge in the world which had made greater strides in the same period than their own Grand Lodge. Only some twenty years ago it was plunged up to the neck in debt, and surrounded by all forms of difficulty, and now they saw it absolutely free from debt, and possessed of large and increasing funds for distribution among necessitous members of the Craft. They had every reason to be proud of the position occupied by the Grand Lodge of Scotland, and they owed a great deal to their Grand Master and their Grand Secretary.

Bro. Henry Lovegrove Past Grand Sword Bearer of England, in responding, urged that the Craft in Scotland should do something more on the lines of charity, and told how in England they did so much to provide for a large number of Brethren who had been crushed in the battle of life, and to furnish pensions for necessitous widows.

Sir Charles Dalrymple also replied, and proposed the toast of the evening, the Lodge of Edinburgh (Mary's Chapel), No. 1. This, he said, was no ordinary gathering. It represented an enormous amount of forethought and of strenuous exertion on the part of those who were responsible for the Lodge. Those who were not immediately connected with the Lodge might well congratulate the Master, Officebearers, and members of the Lodge upon that splendid gathering, but it was also no ordinary Masonic occasion. When they saw upon the toast list "the oldest Masonic minute in existence," it gave them some idea of the antiquity of the Lodge. They knew how ancient was their Masonic Order, and an event such as they celebrated that night helped them to realise the antiquity of the Order. The tercentenary took them some way back to the time of King Solomon. But in all frankness he wished to say that there was one thought more especially in his mind that night. He liked to think that a Lodge that was so old was flourishing still. He was the last man to disparage antiquity for its own sake, but the institution that was young as well as old, an institution which was at once old and new with a present activity, commanded their warmest interest. The Lodge dated back to 1599, but what was more important after all was that the Lodge was kept up in a flourishing condition, and could command the devoted services of Brethren of high repute and of skill with the Masonic Craft, and that there never were wanting able and fit men to supply vacancies among members. He concluded by expressing the hope that the Lodge whose tercentenary they were celebrating would long continue to flourish.

The Chairman, in responding, expressed his thanks on behalf of the Lodge of Edinburgh (Mary's Chapel), No. 1, for the manner in which the toast had been proposed. He had also to thank the large gathering of Freemasons who had congregated there for the hearty response they had given. It was gratifying, indeed, to see such a gathering, and to feel that Masonic principles were so widely acknowledged and respected. They had present representatives from all parts of Scotland and England, the Channel Islands, and even from Egypt; there were Brethren from London, Newcastle, South Shields, Wolverhampton, and Bolton, to join with them in celebrating the tercentenery of the englist recorded them in celebrating the tercentenary of the earliest recorded minutes of a Masonic function. Masonry was believed by some to date back to many years before the Christian era, but certain it was that in mediæval times guilds and brotherhoods arose in connection with various trades, and that Masonry, then called Operative Masonry, became specially useful and prominently successful. Owing to the necessary migratory habits of skilled Masons in search of work among the great Cathedrals and other large works in progress at that time, symbols and signs to enable the skilled Craftsman to be recognised came into use. Each Mason also had his own mark to enable the Warden to recognise his The guilds elected a Master, and every tenth man was a Warden, and the Masonic Brotherhood enjoyed special advantages from several Papal bulls, which exempted them from the ordinary laws regulating common labourers. This gave rise to the name "Free Masons." At a very early period these Free Masons visited Scotland in the ordinary course of events, and tradition indicates that the Guild of Free Masons who came to Edinburgh in the beginning of the twelfth century started the Lodge of Edinburgh; these would be the men, then, who built Holyrood Abbey Church, in 1128. Among other Guilds possibly started under somewhat similar auspices were the Wrights of Edinburgh; but at any rate, it was known that they existed previous to 1475, for in that year the Wrights and Masons of Edinburgh were incorporated by Seal of Cause, and were known as the "Incorporation of Wrights and Masons of Edinburgh." In 1618 this Incorporation bought Mary's Chapel, and were henceforth associated with that name, as at the present day. The present day Freemasonry, however, which had been termed speculative, to distinguish it from operative, gradually began to assert itself, and in 1769 the operative body separated itself from the Lodge. From this it would be seen that this Lodge was a very ancient institution, probably over eight hundred years old. It was not, however, to celebrate the age of the Lodge in such a vague way that they were met there that day, but to celebrate an ascertained and

established fact, the three hundredth anniversary of the first written minute, which now remained. It would be forty-three years before another Scottish Lodge could celebrate such an event, and 126 years before an English Lodge could follow. follow. Whatever doubts might be cast on the age of the Lodge to which he had referred, or the manner in which it Lodge to which he had referred, or the manner in which it was arrived at, there could be no doubt whatever about the age of the first minute, the tercentenary of which they were celebrating that day; for there was the Minute Book to speak for itself, all duly dated and signed, and the gradual change of handwriting from the old Court-hand to the present day style might be clearly traced. The first item in the Minute Book was an order to elect Wardens and Commissioners (proxies) at St. John's Day yearly. The second was the Schaw Statutes of 1598 applied to the whole Craft of Scotland. Then followed the first, the oldest Masonic minute known, dated 31st July 1599, and signed by G. Paton. Since that date the minutes had been continuous down to the present day. To do honour to this marvellous down to the present day. To do honour to this marvellous record was what had brought them together that day.

The Chairman at this stage called upon Sir Lewis M'Iver, M.P., to present the Tercentenary Golf Trophy presented by him for competition among the Lodges of Scotland, to the successful team, the Lodge of Edinburgh (Mary's Chapel), No. 1. Sir Lewis, said the Chairman, took a great interest in all sports that tended to make Great Britain manly, and this trophy had been presented in honour of this memorable occasion. Sir Lewis, in handing the trophy over to the Chairman, said that although his Mother Lodge held this trophy this year he hoped she would not show her maternal greediness in holding it too long. It was his desire that Mary's Chapel team would have to do hard battle to hold it another year. The Earl of Haddington then presented the badges to the four members of the team, and the Chairman, in accepting custody of the trophy, said Sir Lewis M'Iver had always shown himself to be a devoted and loyal member of the Lodge. Led by the band, the company, upstanding, heartily sang "He's a Jolly Good Fellow," and round after round of ringing cheers were afterwards raised for the donor of the trophy and Lady

The Earl of Haddington gave the Provincial Grand Lodges. In any competition betwixt Grand Lodge and the Provincial Lodges there need be nothing, he said, antagonistic; there need be only that healthful spirit of rivalry which made each Provincial Lodge strive to produce men who were able to take their part in the highest offices in Grand Lodge. When Grand Master he had had, along with Grand Secretary, the opportunity of visiting all the Provincial Lodges in Scotland, from Stranraer to Orkney, and they had hardly found a fault with any of them, so admirably conducted were they all, owing in a great measure to their having good Provincial Grand Masters at their head. The Prince of Wales had said that if they were to be a lasting, a good, a permanent, and a useful institution, they must be religious, and as long as Freemasonry continued a charitable and religious body so long would Freemasonry not only exist, but flourish in the land. With reference to what Brother Lovegrove had said about charity, he would like to point out that there was bordly a Provincial Lodge in Sactland that that there was hardly a Provincial Lodge in Scotland that did not have its Benevolent Fund, and in one week the sum of £25,000 had been contributed as an addition to their already established benevolent funds. He hoped that those Lodges which had not such funds would have them before

Colonel Johnstone of Lesmurdie, Elgin, replied.
Sir Lewis M'Iver proposed the toast of the City of Edinburgh, and Bailie Pollard replied.

The toast of the Chairman was given by Bro. Sheriff Campbell, and was followed by that of the Secretary, the Past Masters, the Press, and the Croupiers, the very successful gathering ending with the singing of "Auld Lang Syne."—"Scotsman."

### A NEW CHAPTER.

A N event of considerable importance and interest took place last month at Colwyn Bay, when Comp. the Hon. Alan de Tatton Egerton, M.P., Grand Superintendent of the Province consecrated the Conovium Chapter, No. 2569, in connection with the flourishing Lodge of St. Trillo. Tindal, who is S.D. of the Etruscan Lodge, and has also filled the office of Secretary, has on several occasions been of signal service to the Lodge, and his fellow members, to mark their appreciation, took the occasion to present him with a case of cutlery and silver table-plate, enclosed in a handsome walnut case, with suitable inscription. The presentation was made at an informal meeting of the Lodge on Monday evening, 10th inst., by the Worshipful Master Bro. T. I. Cope, in the presence of a large assembly of members, which included sixteen Past Masters.

With picturesque ceremonial the freedom of the City was conferred on Bro. J. Henniker Heaton, M.P., at the Guildhall, on Thursday, in the presence of the Lord Mayor. The Chamberlain, having spoken in eloquent torms of Bro. Happiler Heaton's labourg in the cause of terms of Bro. Henniker Heaton's labours in the cause of Imperial penny postage, offered him the right hand of fellowship, and at the same time presented him with a handsome casket, which contained the scroll of the Freedom. In acknowledging the honour, Bro. Henniker Heaton said if all who had laboured with him were to be rewarded, it would, to use Lord Macaulay's phrase, rain gold boxes, as all the editors in the Kingdom, the Colonies, and India, numbering many thousands of gentlemen, would have to be summoned to Guildhall to sign the roll.

N reference to a request for a dispensation to confer the three degrees in one evening upon a candidate about to leave for China, the Grand Master of Quebec remarked: "It sometimes occurs to me that those who have contrived to live all their past lives among us without indulging any extraordinary desire for a knowledge of our science, or any special wish to be serviceable to those who have surrounded them here, can well afford, when about to leave us for pastures new, to wait just a little longer for a knowledge of our mysteries."

Commenting on the above, Bro. Birn F. Price, in the "Memphis Appeal," says: "These are our sentiments exactly, and remind us very much of a life-long sinner who has given the best energies of his life to the devil, but, when broken in health and run down by age, and knows that he must soon pass away, concludes that he will give the 'huskings of his life,' as it were, to his God. His life has burned to the socket, and, like a tallow dip that is spluttering and spitting in its last throes of existence, he concludes to offer the flickering embers as a ransom for his soul. So also with him who never sees any beauty in Masonry until he is about to depart for foreign countries, or take on some hazardous enterprise; then, suddenly, he is reminded that Masonry might help him over rough places, and forthwith petitions, 'provided he can get the degrees instanter.' We have as little faith in this kind of Masonry as we have in tail-end religion, and we do not think that any Grand Master should ever use the and we do not think that any Grand Master should ever use the prerogative of a dispensation to make this kind of Mason.—"Masonic Sun."

### THE STAR AND GARTER, KEW BRIDGE.

Form the water; but the curve is too high, the side walks not wide enough, and the approaches are much too steep. It is doomed, for they are progressing rapidly with a temporary wooden structure which is to span the river and do duty whilst the present bridge is to be replaced. The original Kew Bridge was built about the year 1757, at the corner being the famous Star and Garter Hotel, a house long associated with Masonic doings, and at present occupied by Bro. Capt. W. T. There is our host seated yonder in conversation with one of his customers. Yes, that jevial-looking, ruddy faced, stout gentleman, with white moustache and whiskers. Looks like a fine specimen of an old English squire, eh? Yes, with a touch of the military about his appearance, not unlike the Duke of Cambridge. Well, you are not far out, for my old friend has been a most ardent supporter of the Volunteers, and served his full time (twenty-one years) in the City of London Artillery Volunteers, entering as a lieutenant and retiring as a captain. He has received the Victoria decoration presented by the Queen for his long and attentive service. He must show it to you before you leave, for he is justly proud of the medal, and I'll get him to tell you some of his experiences during the time that he was in the corps.

But the gallant captain is disengaged, so let me introduce you. With a hearty grip of the hand, our host's face beams with delight as we evidently recall many a jolly day that is past, and now, seated in the comfortable saloon, we chat over those old times.

But we have come down to have a look at the Star and Garter, and not

to dwell upon old times, although such is irresistible when my old friend and

to dwell upon old times, although such is irresistible when my old friend and I meet.

Captain Purkiss will be our guide then, so let us proceed. On the right from the saloon bar is a spacious and very comfortable coffee-room with bar attached, the latter opened only on Sundays and upon busy occasions; through the coffee-room there is a snug little dining-room, and at the far end, down a flight of stairs, we enter one of the best appointed club skittle saloons I have ever seen, built by our host since he has been here.

Making our way back to the bar, we pass through the grotto and descend to the cellars. Finer cellars it would be difficult to find anywhere. To the left are the various departments in which the wines and spirits are kept, the first devoted to the sparkling champagn of every high-class brand and a very large stock, besides some exceedingly old and choice ports and sherries—for there is on occasions a great demand for these wines when the big banquets are held in the halls attached to this popular hotel. In an inner cellar are the large vats for the various spirits. Returning, we survey the bottle spirit bins and wines all systematically arranged and numbered, so that everything is to hand. The bottle beer cellar is also a great feature here, and the beer cellars are enormous, lofty, and splendidly cool, which, as already said, give Messrs. Fuller such fair play with their excellent beer.

Our guide takes us out into the grounds. There is a bowling green, beautifully turfed, 60ft by 100ft, surrounded by beds of flowers and fine old poplar trees—a very pleasant place to spend an evening. On the left is one of the entrances to the Princes Theatre, through which we proceed. Attached, I must inform you, to the Star and Garter is a fully-licensed theatre, which will seat seven or eight hundred, and with a fine stage 49ft by 30ft, built by Captain Purkiss, dressing-rooms, bars, and everything necessary for theatrical representations. In the winter months this is much patronised by amateur dramatic clubs

Sin,—I am in a position to confirm Father Clemente's statement in the "Catholic Times" that Continental Freemasonry is assisted not only morally, but materially and financially, by English Freemasons in its designs against the Church. On the establishment of the Volunteer movement in England about forty years ago, I was one of the first volunteers enrolled to defend our country against the threatened invasion of Napoleon III. The captain of our company was a Freemason. Very soon after the revolution in Italy was organised by the Italian Freemasons, which culminated in the bombardment of Rome, and the seizure of the Papal possessions under the leadership of Garibaldi, our captain, who was an enthusiastic admirer of Garibaldi, informed us that he and others were about to form an "English legion" to assist Garibaldi in his designs against Rome, and asked those of us who felt inclined to volunteer for that purpose to do so, stating that Freemasons were prepared to supply the means necessary to equip and send us out, and described in glowing language the glory that awaited us when Italy was united and free, with Rome as its capital. Being at that time a bitter opponent of the Catholic Church, I entered into the scheme with enthusiasm; but, thank God, the better counsel of my friends prevailed, and my comrades departed without me. The sad end of that vaunted "English legion" is now a matter of history. Very few came back again. On the conclusion of this disastrous and painful attack on the Church by the united forces of Freemasonry I had a conversation with a very intimate friend of mine, who had held the highest position in one of the Essex Lodges. He candidly acknowledged that English Freemasonry had been in personal communication with Mazzini, and had entrusted him with money for the purpose of carrying out the campaign. He added: "Catholicity is our most deadly enemy, and if we can overthrow that the rest would be easy." I said: "You will never succeed in that, for it is a Divine institution." He said: "Time will
