SUFFOLK.

A NUMEROUS company of Brethren, representative of every portion of the Masonic Province of Suffolk, assembled in the Library of Ipswich Town Hall, on Friday, 13th inst., to take part in the annual Provincial Grand Lodge, which was held under the presidency of the Provincial Grand Master the Right Hon. Lord Henniker P.G.W.Eng., who is also the Prov.G.M. of the Isle of Man.

This being the first occasion that his Lordship had presided over the Provincial Lodge of Suffolk since Her Majesty called him to the onerous post of Lieutenant-Governor of the Isle of Man, and also since his recovery from a long and dangerous illness, it is almost needless to state that his Lordship met with an enthusiastic reception on his entry into the Lodge—a reception the more cordial as the Brethren had evidence of the completeness of Lord Henniker's restoration to health. Indeed, it was generally admitted that his Lordship had not looked more robust for a number of years.

The Prov.G.M. was supported by his Deputy Rev. C. J. Martyn P.G.C., the Prov.G.Sec. Bro. N. Tracy P.G.Std.B., and a large assembly of other Provincial Officers and mem-

bers of local Lodges.

Provincial Grand Lodge having been opened in due form, the minutes of the last meeting, held at Woodbridge, were read and confirmed, after which the roll of Provincial Officers, as well as that of the several Lodges was called.

Regret was expressed at the absence, in consequence of an accident, of the Prov.G.D.C. Bro. J. M. Franks 376, but his duties were ably discharged by his Assistant Bro. George

Booth jun. 81.

Bro. Philip J. Jolly having been unanimously elected Provincial Grand Treasurer, and Bros. C. E. Tempest, T. E. Mayhew, and A. A. Bennett having been re-elected Auditors, the Provincial Grand Master appointed and invested his Officers for the ensuing year, a list of whom we give eleswhere.

The report of the Board of General Purposes announced the continued prosperity of the Order in the Province, and stated that a Warrant for a new Lodge had been granted, the Consecration to take place probably in September. The membership of the Province showed a substantial increase; while financially they were in a fairly sound state, there being a good balance at the bank. A sum of £5 5s had been granted to a needy Brother, twenty guineas to the Benevolent, and ten guineas each to the Boys and Girls Institutions, and five guineas to the South African Masonic Relief Fund. The report was adopted nem. con.

The report of the Suffolk Masonic Charity Association stated that during the past year a total of £823 4s had been subscribed in the Province to the three Institutions. During the past twelve years (for which period the Secretaryship had been in the able hands of Bro. J. M. Harvey, of Ely), thirtyeight aged Masons, four widows, seven girls, and ten boys had been elected to the various Masonic Institutions, with a total poll of 106,167 votes. The amount contributed by the Province in the same period was no less than £10,803 10s.

The Provincial Grand Master cordially thanked Bro. Harvey for the trouble he had always taken, and his

continued interest in the Charities.

The Lodge was then adjourned, while the Brethren marched in procession to St. Mary-le-Tower Church, where a bright musical service had been provided. Bro. the Rev. Coyle read the prayers; the Prov.G.Chaplain Bro. Rev. W. E. Fletcher preached from St. John i 43 to 45, while Bro. Rev. S. J. S. Banks read the lesson. The Prov.G.Organist Bro. James Price presided with his accustomed skill at the organ. An offertory was taken, amounting to £7 10s 2d, for the benefit of the East Suffolk Hospital.

After service, the Brethren returned in procession to the Town Hall, where the business of the Lodge was resumed.

Addressing the Brethren with his wonted geniality
The Provincial Grand Master expressed his pleasure at being present. He regretted that business engagements would compel him to return to town immediately after the Lodge, without staying to the banquet. His Lordship referred to the unfortunate circumstance that both his Deputy and himself at present resided out of the Province, a fact which made it difficult for them to be with the Brethren as often as they could wish. He was, however, delighted to come, whenever his engagements permitted, to the dear old county of Suffolk, where he had lived so long; and he felt that seeing so many Suffolk faces had really done him good. He also alluded to the recent visit to the Isle of Man on the occasion of his installation of Bro. Rev. C. J. Martyn and Bro. Tracy. Concluding, the Provincial Grand Master said he sincerely hoped it would not be long before he should have the pleasure of meeting some of the Suffolk Brethren in the Lodges of the Isle of Man, where they would be sure of a

hearty welcome.

Votes of thanks were accorded to the Prov. G. Chaplain, for his excellent sermon; the Vicar of Tower Church, for the use of the church; to the Mayor and Corporation of Ipswich, for the use of the Town Hall buildings; and to the choir of St. Mary-le-Tower, to whom the Prov. G.M. expressed

his indebtedness, for the delightful treat they had provided.

The Deputy Prov. G.M. congratulated Lord Henniker upon his restoration to health, and also on the distinguished honour conferred upon him by his appointment as Grand Master of the Province of the Isle of Man.

Prov. Grand Lodge having been closed in due form, the Brethren repaired to the Council Chamber, where a wellserved banquet was provided by Bro. Pipe, of the Cornhill Restaurant. In the absence of the Prov. G.M. Bro. Rev. C. J. Martyn presided, and he was supported right and left by Grand Officers, including Bro. Fred. Binckes late Secretary of the Royal Masonic Institution for Boys, who greatly delighted the Brethren by a very fine speech on Masonic Charities.

The customary Masonic toasts were duly honoured, and the harmony of the proceedings was pleasantly sustained by Bros. Dutton, G. Abbott, H. A. Wright, A. Mead, Price, and Stoker; and the Lyceum Orchestra, under the conductorship

of Mr. W. Fletcher Dorling.

ESSEX.

As briefly announced in our last issue the annual meeting of this Provincial Grand Lodge was held on Tuesday, 17th inst., at Clacton-on-Sea, under the presidency of the Earl of Warwick D.G.M. England Provincial Grand Master, who was supported by his Deputy Col. Lockwood, M.P., several Grand Officers, Provincial Grand Officers, and a full attendance of members. attendance of members.

The meeting was held in the Town Hall, which presented a most attractive appearance, having been tastefully decorated by the local Brethren, with the banners of the different Lodges and other insignia, together with a brilliant

decorated by the local Brethren, with the banners of the different Lodges and other insignia, together with a brilliant display of bunting. The meeting was attended by upwards of 300 Brethren.

The minutes of the last annual meeting, held at Tilbury, having been read and confirmed, the Provincial Grand Secretary Bro. T. J. Ralling P.A.G. D.C. England announced the receipt of letters regretting inability to attend from several Provincial Grand Masters, the Lord Mayor of London, and other distinguished members of the Craft, after which the roll of the Lodges of the Province was called, and all of the forty-four were found to be represented.

Bro. J. J. C. Turner P.P.G.W. presented the report of the Board of General Purposes, of which he is the Chairman, and proposed that it be received, adopted, and entered on the minutes. This report stated that during the year there had been 181 initiations, compared with 178 last year; and 78 joining members, compared with 134 last year; 97 resignations, against 81 last year; the losses by death had been 39, whilst 52 Brethren had been struck off the books of their respective Lodges, leaving the present strength of the Province 2,368 members, against 2,297 last year. The Board recommended the following grants:—£21 to the South African Masonic Relief Fund, £10 10s to the Royal Masonic Institution for Boys, £10 10s to the Royal Masonic Benevolent Institution for Boys, £10 10s to the Royal Masonic Institution for Girls, £10 10s to the Royal Masonic Institution for Girls, £10 10s to the Royal Masonic Benevolent Institution, and £5 towards the Clacton-on-Sea Cottage Hospital. The Board also recommended that the portrait in next year's Calendar should be that of Bro. A. J. H. Ward P.M. 650 P.P.S.G.W. The report was unanimously adopted.

The Charity Committee's report, which was also adopted unanimously, was as follows:—"The Charity Committee congratulate the Province on the fact that since the last meeting of Provincial Grand Lodge, one girl, three boys, and two widows have been elected to the benefits of the respective Institutions. At the three Festivals the Province has, as usual, been very liberal in its support, the large sum of £2,042 12s 6d having been contributed in the aggregate. More than half of this was given at the Benevolent Festival, when there were thirty-nine Stewards, of whom those from two of the newest Lodges, the Seven Kings, and the Charles Dickens, raised respectively £346 and £405. At the same Festival the Albert Lucking Lodge also subscribed £153. For the Girls there were sixteen Stewards, who raised £191, and here again the Seven Kings Lodge headed the Essex Lists with £126. At the Boys Festival, a few days since, there were fifteen Stewards, whose contributions reached the total of £470 8s 6d, and in this instance the Brooke Lodge headed the List with £105."

The Provincial Grand Master then, amidst hearty

The Provincial Grand Master then, amidst hearty applause, rose to address the Brethren. He said it was his custom to address a few words at each of their meetings on events of interest to the Province during the past year, and on that occasion there were several things he should like to speak about. At the last meeting he had said that if the Brethren would pay him a visit at Warwick Castle he and the Countess would be very pleased. He regreted he had not been able to see them, as he had hoped to have done. But there had been various difficulties, chief of which was that owing to medical advice he had had to spend a considerable portion of the spring abroad, and almost immediately on his return he, like so many others in these days, had been doing his best to serve his Queen and Country by devoting some extra time to military duties—and had been by devoting some extra time to military duties—and had been under canvas with his troop. He did not see, however, why it should not come off next year. His friend the Provincial Grand Secretary had visited Warwick, Kenilworth, Stratfordon-Avon, and other places of interest in the district, and under his guidance he felt sure a very pleasant trip might be taken, which would include a visit to Warwick Castle, where Lady Warwick and himself would be delighted to welcome them. As regarded Masonry in the Province they had not experienced such an eventful year as the last, when they added five new Lodges to the roll, but allowing for inevitable losses the strength of the Province had increased by 120 losses the strength of the Province had increased by 130

members, which he felt was very satisfactory. Although he was always glad to see new Lodges consecrated it was an equal pleasure to learn that the Lodges already existing were making satisfactory progress. He regretted that since they least most several very progress. last met several very prominent Brethren had been removed from their midst by death. The district around Southend had suffered severely by the deaths of Bros. Glasscock, Edward Bowmaker, and Thomas Hood; the Lodge under whose banner they met that day had to lament the death of one of its foundary in the page of Bros. banner they met that day had to lament the death of one of its founders in the person of Bro. Penfold, who was also one of the pioneers of the charming watering place in which they were meeting; the Epping Lodge had lost Bro. Moore, who for many years was its able Secretary, and they all, he was sure, sympathised with their Provincial Grand Secretary in the loss he sustained in the early part of this year in the awful sudden death of one of his brothers. The South African war had also had its influence upon the county. Essey like war had also had its influence upon the county. Essex, like other parts, had been called upon to find soldiers, and had cheerfully done so. They missed from their meeting that day a Brother who always took a deep interest in Free-masonry, and who now, he regretted to say, was a prisoner of war—he meant Bro. Woodhouse. It might not be generally known what a patriotic spirit had been exhibited by Bro. Woodhouse in this matter. He was a very skilful worker in iron, and had made some most beautiful things, and being anxious to place his talents at the service of his Queen and country, he had joined the colours as a farrier, and it was while exercising his duties in that respect that he was captured. He was informed by Col. Lockwood that Bro. Woodhouse had also been called upon to act as dentist to his troop, which was probably not so pleasant a duty to him as the other. It was, he thought, highly satisfactory that in spite of the calls that had been made upon the country to support the various war funds, the Indian Famine Fund, and others, Masonic benevolence had shown no falling off. He had the pleasure of being present at the Festival of the Boys School a few days back, when it was stated that up to the present this year the three great Institutions of the Craft had received no less than £64,000. Of course as the lists were read out he naturally watched for that from his own Province, and he was delighted to find that Essex was about third on the list of Provinces, including that of the Chairman of the day H.R.H. the Duke of Connaught. Altogether, the Province of Essex had given £2,000 that year to the Charities, while if the amounts given by the county during the past three years were added together, it came up to the very handsome total of £7,500. He thought he should like to congratulate three of the youngest Lodges—the Albert Lucking, the Seven Kings, and the Charles Dickens—on the very substantial help they had given during the year. While on the subject of charity, he should like to allude to the work of the Charity Committee. They had been very successful at the elections in carrying their candidates, but it was only through outside help. Take, for instance, the last election for the Boys School—the Charity Committee only received heart. about 1,400 votes, whereas the number possessed by the Brethren of the Province amount to about 3,000. It had been suggested to him that the collection of votes would be more efficiently carried out if instead of electing a fresh representative each year as was done in so many Lodges, some zealous Brother could be prevailed on to undertake the Office for a series of years; he would get familiar with the work, to the great advantage of the cases which from time to time came to be helped by the Committee. It was very easy for the voting papers to get mislaid, as every post now-a-days brought a large quantity of printed papers, which were apt to be laid aside for the time, whereas if Brethren had a reminder that their votes had not been received many proxies would be rescued and utilised. They could not very well discuss the matter at so large a gathering, but if any Brother had any suggestion to offer and would communicate with the Provincial Grand Secretary it would have every consideration. He felt they ought to do a little better at least than they did, considering the large voting power of the Province. In reference to the local Lodge, he very well remembered coming down to Clacton to consecrate it, when he was very hospitably entertained by its first Master at his most charming house. He had also come down there in other capacities, and was pleased to see the place growing in prosperity and popularity, whilst his wife and children had received great benefits from its salubrious air. Speaking of the appointments to Office he said he feared it was inevitable that there were disappointments on these occasions. The Officers had been selected with great care, and the announcements of their names would no doubt be applauded. He congratulated those who had taken so much trouble to

arrange for their comfort on the present occasion, and in conclusion expressed the hope that the coming Masonic year would be one of prosperity to the Craft in general and the Province in particular.

Four Brethren nominated for election to the Provincial

Board of General Purposes were declared to be elected.

Bro. W. Scott Miller W.M. 2717 proposed the election of Bro. James P. Allen P.M. and Treasurer 2063—under the banner of which Lodge the day's meeting was held—as Provincial Grand Treasurer for the ensuing year. Bro. Allen was one of the founders of the Lodge, a constant supporter of it, and its Treasurer for some time. The nomination was duly seconded, and there being no other proposition the Provincial Grand Master declared Bro. proposition the Provincial Grand Master declared Bro. Allen to be duly elected.

The other Provincial Grand Officers for the year were then appointed, in accordance with the list we published last week, and at the conclusion of the investitures the Provincial Grand Master said he trusted all the Brethren who had been appointed would do their best to support him in the work of Freemasonry in general and of that Province in particular

during the coming year.

The Deputy Prov. G.M. proposed a hearty vote of thanks to the members of the St. Osyth's Priory Lodge, for their hospitality in providing for the entertainment of Provincial Grand Lodge that day. The Lodge was exceedingly fortunate in having such a fine Hall available in which to receive the Brethren, in having such splendid country round about, and in having made such admirable arrangements with the clerk of the weather for the occasion. This was seconded by Bro. Richard Clowes P.G.Std.B., carried with acclamation, and acknowledged by the W.M. of the local

Lodge.

would support him on that occasion.

The Grand Lodge was then closed and an adjournment was made for the banquet, which was served in a marquee in the grounds of the Warwick Castle Hotel, the band of the 2nd Batt. Royal Warwickshire Regiment playing an excellent selection of music and conducing to the enjoyment of the large party, who were excellently catered for by Messrs. Wright Bros., of Colchester, and most liberally entertained by the local Brethren.

Lord Warwick occupied the chair, and at the conclusion of the dinner proceeded with the toasts. The first on the list, he said, was always received with greater enthusiasm than any other among Masons, being that of Her Majesty the Queen. They all regretted that in her old age the Queen had to face the troubles and anxieties of war, but it had proved she took a lively interest in all that concerned the welfare of her people. Indeed, there seemed to be no event that escaped her notice, and no misfortune that did not enlist her escaped her notice, and no misfortune that did not enlist her sympathy.

In proposing the toast of the Grand Master Lord Warwick said there was no one more popular throughout the country than His Royal Highness the Prince of Wales, and as Masons they believed that in him they had an excellent Grand Master. It was indeed very gratifying to Freemasons throughout the Empire to know they had so esteemed a man to preside over them. None of his multifarious duties received more attention than those associated with the Craft,

in which he took a lively personal interest.

The next toast was that of the Pro Grand Master, and the Grand Officers present and past, and in proposing it Lord Warwick said that, owing to the fact that the Grand Master had lately placed him in a somewhat prominent position in Freemasonry, he had had the opportunity of judging how capable a President Lord Amherst was, and how efficient a

body the Craft had in its Grand Officers.

Bro. George Everett P.G.Treas. responded, saying he considered it a very great honour and a great privilege to be called upon to respond to so important a toast, proposed, as it had been, in such felicitous terms. He returned sincere thanks on behalf of the Grand Officers, and felt that the fact of the toast being always so well received at Masonic meetings was a very great compliment to the numerous body of Brethren included in it.

Bro. Richard Clowes, who occupied the place on the right of the President in the absence of the Deputy, who had to leave, proposed the toast of the Provincial Grand Master. He said he had been entrusted with a toast of very great importance, owing to Col. Lockwood being called upon to

return to London. That Brother could have said more in regard to the Provincial Grand Master, but could not have been more sincere in proposing the toast in his honour. He had the privilege of entertaining the first Provincial Grand Lodge over which Lord Warwick presided—at Harwich and he then said Essex had a Provincial Grand Master they hoped to see among them for many years, for the benefit of the Brethren of the district. He ventured to think that prediction had been fulfilled, and he could say that day, as he had said years ago—may they have the honour of meeting him in Essex and elsewhere in Freemasonry for many, many

years yet to come.

The Earl of Warwick met a most enthusiastic reception on rising to respond. He said he used to be a member of Parliament, and used to get a good deal of practice in talking; he felt it very difficult now that he was rusty to say anything really interesting. He appreciated plain speaking, and thought he always meant what he said; this was certainly the case when he said it gave him the greatest pleasure to meet his Essex Brethren, who were oblivious of his shortcomings, and always most hearty in their reception whenever he came among them. The Officers he appointed year by year certainly did their best to work in the interests of Freemasonry. He had seen a great many Lodges spring up among them, and the number of Masons had greatly increased, but the true spirit of Freemasonry had not died out; its great principles were as much to the front as ever. If for this fact alone Freemasonry would be worthy of support, as it brought together a band of Brethren whose aim was to encourage that Brotherly Love which they regarded as the grand principle of the Order. It was very gratifying to know that in spite of the many calls made upon he felt it very difficult now that he was rusty to say anything gratifying to know that in spite of the many calls made upon them during the past year the support of the great Charities of Freemasonry had in no way diminished, but rather that they had been enabled to raise a total of £64,000 during the year on behalf of the three great Charitable Institutions of the Craft. He was beginning to think it was time he made way for some younger Brother, someone who would be better able to look after the Lodges in the Province; and in

Freemasonry would continue to prosper among them. HERTFORDSHIRE.

THE annual meeting of this Provincial Grand Lodge was held at the Town Hall, Hitchin, on Wednesday, 18th inst., under the presidency of Bro. T. F. Halsey, M.P., Prov. G.M., who was supported by his Deputy Bro. F. S. Knyvett, J.P., other Grand Officers, Provincial Officers, and members

of Lodges of the county.

The minutes were confirmed and the roll of Provincial Officers and of the Lodges called, after which the Brethren had to elect a Provincial Grand Treasurer for the ensuing year. Bro. C. E. Keyser P.G.D. proposed Bro. J. R. Cox P.M. of the Hertford Lodge, No. 403, whom he said had already been elected Provincial Grand Treasurer in the Royal Arch. Thereupon a discussion took place as to the desirability of regarding the Provincial Grand Treasurership as a permanent Office. The first speaker on the subject pointed out that there were twenty-four Lodges in the Province, and that consequently it was quite impossible to give an Office to every Lodge each year; therefore to monopolise the popular appointment of Treasurer for the same Brother year after year was unwise and also unfair. He considered the Office should be one in which there was a change each year, and in support of his contention he nominated another Brother for the appointment.

Other speakers followed on similar lines, and the general opinion among those present appeared to be that an annual change in the Office was desirable, the Provincial Grand Master being appealed to in order to secure such a result. A third Brother was nominated for the appointment, but it was afterwards pointed out that this was merely a

"notice of motion" for 1901-1902—inadmissible, as the

Presiding Officer pointed out.

The Provincial Grand Master, in commenting on the discussion, said it was not a question for him at all, as the Brethren of Provincial Grand Lodge had it in their own hands to decide who should be their Treasurer year by year. He had purposely avoided having anything to do with the appointment of the Provincial Treasurer, and previous to coming there that day had no idea who would be proposed to succeed Bro Felix Support Knypett who having held the to succeed Bro. Felix Sumner Knynett who, having held the Office for several years, had lately risen to the more important one of Deputy Provincial Grand Master. Any Brother in Provincial Grand Lodge had the right to propose whoever he chose as Provincial Grand Treasurer, and personally he the Prov.G.M.) had no voice or power in the selection; and even if he had he should be very sorry to exercise it. Whatever had been said in regard to making the appointment limited to one year only must be purely of a suggestive character, as it was quite impossible for the Brethren present that day—or at any meeting of Provincial Grand Lodge—binding others to any particular course of action in this matter. It was a question to be decided year by year and, as he had already said, it was for those present at each successive meeting to decide among themselves as to who should be elected as Treasurer.

Bro. Keyser said no one admitted more than he did the right of the Provincial Grand Lodge to have a new Treasurer year by year and if it was the opinion of the Lodge that a change should be made on every occasion he would cheerfully fall in with that view. He did not wish to dictate to others in this matter, but he might point out that the Brother he had first nominated—Bro. Cox—was an older member of the Province than either of the others, and he felt it would be more in accordance with the principles of Free-masonry if the Brethren assembled in Provincial Lodge refrained from competition on this occasion. He knew what a contest meant (a remark which was fully appreciated by those who knew of our esteemed Brother's experience in parliamentary and other elections), and he felt he was advising them for the best when he urged them to avoid a contest if they possibly could. It seemed to be the opinion of the Brethren of the Province that a change should be made year Brethren of the Province that a change should be made year by year in the future—by all means let that course be carried out, he could assure them he would cheerfully support such a proposal, but he hoped the matter would not be forced

to the ballot on the present occasion.

It was further pointed out that the present presented a favourable opportunity for making a change in the principle that had hitherto prevailed in Hertfordshire. Bro. Knyvett had held the Office of Prov. G. Treasurer for several years, and it would have been a very delicate task to propose his removal; but now that he had given up the keys of the chest for a higher appointment, there could be no such difficulty, and it was well to start the new system-now generally recog-

nised—with the new holder of the appointment.

The proposer of the second candidate, the Brother who had started the discussion, expressed his satisfaction at what had been said. He had no desire to press his candidate, and had been said. He had no desire to press his candidate, and had only put him forward knowing him to be well worthy of the honour, for the purpose of ascertaining the feeling of Prov. Grand Lodge. He felt he had succeeded in his endeavour, and looked upon an annual change in the holder of the Office as virtually agreed upon. He therefore withdrew his nomination, as he had no desire to create a contest or any difference of opinion. The third candidate was also withdrawn, and so the field was cleared for Bro. J. R. Cox as the only Brother nominated, and he was declared duly elected

only Brother nominated, and he was declared duly elected.

The next item on the agenda was the installation of the Deputy Provincial Grand Master. The Prov. G.M. said he did not know if it was necessary for him to say anything special about this Office. As was known to the Brethren during the past year they had lost their Deputy Prov. G.M. Bro. Lake, and he felt it but right to say they had lost a most estimable Officer in him. They need not consider anything as to what had been said or done outside of Freemasonry; they only had to remember him as one who worked zealously with them, and as one who had done much to promote the best traditions of the Craft. He had appointed Bro. Knyvett as his successor and desired the Provincial Grand Secretary to read his Patent of appointment, which having been done, the Prov. G.M. proceeded to obligate and regularly instal his Deputy, after which the Prov. G. Officers for the year were appointed and invested.

On the question of appointing a Provincial Grand Tyler and an Assistant coming before the Lodge, the Prov. G.M. said they had been unconsciously acting in an unconstitutional manner for many years past in appointing an Assistant Grand Tyler, and as the fault had been pointed out to them he fall it right to at a page admit it and takes store to prove the felt it right to at once admit it and take steps to prevent its recurrence. He proposed that in future they should nominate the Tyler of the local Lodge where they met year by year to assist their regular Officer, and award him the gratuity they had been accustomed to give to the Officer they were now

told they had no power to appoint.

The report of the Board of Finance was next considered. The D.P.G.M.—as late Treasurer—said it had been a custom in that Provincial Grand Lodge to invest something from time to time in consols; they had started with an amount of about £100, which had gradually grown, until now they had about £370 so invested, and thus in case of a special call they had a fund from which they could meet it, and at once sell out. They had voted a hundred guineas two years ago on the special occasion of the Centenary of the Boys School, and last year, when their Brother Keyser presided at the Festival of the same Institution, they gave another fifty guineas. Although these two grants had overtaxed their current resources, he had asked permission to finance Provincial Grand Lodge for the time being, with the result that the two amounts had been paid, and other liabilities discharged, without entrenching on their investments, which had been kept intact and, consequently, had not now to be made up as would otherwise have been the case. He hoped there would not ever be any necessity to reduce their invested capital; but should an emergency arise there it was ready to meet it. The Report was received, adopted, and ordered to be entered on the minutes.

Twenty guineas was voted to the Royal Masonic Institution for Girls, and then Bro. James Terry brought forward a motion—standing in his name—that a sum of £10 be voted to the Cecil Lodge towards defraying the expenses of entertaining Provincial Grand Lodge. He said they were in the habit of voting this amount on sufferance year by year, as

they did not know how they were likely to be entertained; but, for all that, he felt pretty sure the vote would be unanimously agreed to, as was the case.

Bro. C. E. Keyser proposed a grant of ten guineas to the North Herts and South Beds Infirmary, explaining it was the custom of the Provincial Grand Lodge to mark their visit year by year by making a grant to one of the more prominent local Charity Funds. He had every confidence in proposing the grant on the present occasion, and it was unanimously agreed to.

The Prov. G. Secretary proposed that the publication of the Provincial Calendar be continued, and suggested that the Lodge Officials should forward the books to the different

members as early as possible on receipt.

The Prov. G. Master said they owed the Provincial Secretary a debt of gratitude, he having been called upon at very short notice to take up the duties of the Office-no light task; and also to arrange for the publication of the Provincial Calendar with but few days in which to prepare it, indeed the latter work was imperative, and had been done in such a way as to deserve their commendation. The motion

to continue the calendar was agreed to.

Bro. C. E. Keyser presented the Report of the Hertfordshire Masonic Charity Committee for the past year. He stated the Province had been very successful in securing the election of a number of candidates to the different Funds, and that being the case it was but fair that large amounts should be contributed year by year towards their support. He found that during the past three years they had sent up considerably over £5,000, but that sum had not been by any means evenly contributed. He thought that each Lodge should send up a Steward for one or other of the Institutions each year, thereby assuring a regular steady flow of contributions. The result this year was not quite up to what it had been in the two previous ones, which was accounted for by the fact that special efforts were made in connection with the celebration of the Centenary of the Boys School, while last year—when he presided at the Festival of the same Institution—Hertfordshire very naturally took a special interest in the work. Now they had come to about their normal position, for during the year there had been thirtyfive Stewards, who took up £1,314 18s, which was very good, but the work had been unevenly divided, for whereas two of their Lodges had sent up Stewards to each of the Festivals

there were some which had not been represented at either. During the year they had secured the election of five candidates to the Institutions, polling over 23,000 votes; it was indeed a great undertaking to get this large number of votes together, and he considered it hardly fair when, a case having been taken up by the Province, neither the recommending Lodge or the friends appeared to take the slighest further interest in its success; in May last a recommending Lodge helped with thirty-four votes, and the candidate herself (an old lady) secured eight—which as they were well aware was very insignificant compared with the large number actually required. For October next there were already two girl candidates approved by the Institution, and it would require great and united efforts to secure their election. Since 1890, when he undertook the position of Charity Secretary of the Province, they had secured the election of twenty-eight candidates, and as theirs was but a small Province he considered it very wonderful they were able to carry their candidates so readily. If they succeeded this year with the two girls already referred to it would mean thirty cases in ten years, and as each pupil elected to one of the Schools meant £300 or £400, and each old Annuitant a very large sum they would see what a great amount Hertfordshire received from the Institutions.

The Provincial Grand Master felt that the thanks of the Province were due to Bro. Keyser for all that he had done. The principles on which the Charity Committee worked were now known throughout the Province, and that in great measure had enabled them to carry all their candidates on the first application, which was a very great thing to boast

The Prov. G. Secretary reported a total of 889 members in the Province; and drew attention to a practice in some of the Lodges of having more than the regulation number of Officers, by the appointment of "Assistants." Especially was this the case in connection with Assistant Directors of Ceremonies, and as this was contrary to the Constitutions of Grand Lodge he suggested that a notice from the Prov. G.M. as to its illegality would be the means of putting an end to the practice.

The Prov. G.M. endorsed what the Secretary had said in this direction, and hoped the Lodges under his rule would

adhere to the regulations of the Craft in the future.

The Grand Lodge was then closed, and a number of the Brethren repaired to the Sun Hotel, where the annual Festival of the Province was celebrated.

NEW HALL AT LEEDS.

HE Deputy Grand Master of England the Earl of Warwick laid the foundation-stone of the new Masonic Hall, in Great George Street, Leeds, on Wednesday, 18th inst., and the event was made the occasion of a Masonic demonstration which is quite out of the common. On only one previous occasion has Leeds been the scene of so impressive a Masonic celebration, and favoured by delightfully fine weather on Wednesday there was a very large attendance.

The proceedings opened with a Provincial Grand Lodge meeting in the Albert Hall, at which the Prov. Grand Master of West Yorkshire the Right Hon. W. L. Jackson, M.P., presided. On the entry of the Grand Officers, who were duly saluted, the Earl of Warwick took the chair, and an illuminated address of welcome was presented to him by the Prov.

Grand Master, on behalf of the Province.

In replying, the Earl of Warwick said he knew how popular Masonry was in the great county of Yorkshire, and how devoted they were to the great Masonic duties and to the principles of charity. During the past twelve months there had been many calls for India and South Africa, yet, he was proud to say, the Masons had subscribed no less than £64,000 towards the three great Masonic Charities, and his presence in Leeds that day was only a small acknowledgment on the part of himself and the Grand Officers of the cordial support which West Yorkshire had always accorded those Institutions.

A procession of the Brethren in their full regalia was

formed, and proceeded to the building.

On arrival at the building in Great George Street, the Grand Officers and others proceeded to a specially erected platform in front of the foundation-stone. A large number of Ladies witnessed the ceremonial, including the Lady Mayoress of Leeds Mrs. John Gordon.
In inviting the Earl of Warwick to lay the foundation-

stone, the Prov. Grand Master said that was a day they had long looked forward to, and the duty his Lordship was to perform would, they hoped, mark yet another stage in the progress of the Order in West Yorkshire.

The stone was then laid with all the interesting form and ceremonial pertaining to Masonry. In a cavity in the stone was deposited a glass bottle containing coins of the realm, copies of the "Yorkshire Post," the "Leeds Mercury," and the "Freemason," together with a copy of the articles of association of the new Hall and Club. These were covered with a plate bearing an inscription, and the Earl of Warwick duly laid the stone, with a trowel presented by the architect and a mallet presented by the builder. Prayers were offered by the Rev. Dr. Smyth.

In declaring the stone laid, the Deputy Grand Master, after applying the plumb-line, affirmed that "the Craftsmen who prepared it are true and trusty." A test with a level was followed by the words:—"I find this stone to be level, and that the Craftsmen have laboured skilfully." Finally the square was applied, and then his Lordship said: "I find this stone to be plumb, level, and square, and I declare it to be properly and duly laid, and that the Craftsmen have worked properly and duly laid, and that the Craftsmen have worked well." The formal proceedings closed with prayer by the Rev. Dr. Smyth, and the pronouncement of the Benediction.

The stone, which is a solid block of Shap granite, was presented by Bro. Tom Atkinson. Upon its surface, with due solemnity, corn, wine, and oil were poured by the Deputy Grand Master, emblematical of plenty, cheerfulness, and peace and contentment.

CHURCH STONE-LAYING.

THE foundation-stone of the new Church of St. Chad, Smethwick, was laid on the 16th inst., in the presence or a large gathering of Brethren and of the general public, by the Earl of Dartmouth, Lord Lieutenant or Staffordshire,

Provincial Grand Master of the county.

The district is one which has developed rapidly of late years, and some time since the little iron chapel, which has done duty for years as a mission church—an offshoot of Smethwick Old Church—proved not only inadequate, but unsafe. A decision was then come to to erect a substantial building upon economical lines, to be known as the Church of St. Chad. Efforts will be made in the future to secure the formation of a separate ecclesiastical parish, with St. Chad's as the parish church. The cost of the new church will be about £4,500, and towards this nearly £2,000 has already been subscribed.

The ceremony, with Masonic rites, was of an interesting

and impressive character.

Lord Dartmouth, in the course of an address, said it was one of the great duties of Freemasons to help in these good works, and he hoped the success of that ceremony would be an augury of the future success of the church. It was very important that in those great centres of population the Church should keep pace with the growth of the district. The great difficulty was the matter of obtaining funds, and although nobody realised more than he did the many calls this year, he hoped they would not neglect the support of

the Church. A collection was made, which realised £00 14s 10½d.

In reply to a vote of thanks, Lord Dartmouth congratulated Smethwick upon its newly acquired municipal honours. He hoped that the progress and advancement which the locality had made in late years would be continued.

THE BEST MASONS.

THE best Masons are those who have the biggest hearts and souls within them. Those who are ready to sacrifice something for the good of the Order. The real power of Freemasonry consists in the amount of heart and soul to be found among its members.

A Mason may have the ritual, and be a valuable member in a Lodge, but if he has not a soul within him, if he is not willing to sacrifice some of his own interest for the benefit of

the Order, he belongs to an inferior grade.

Such a Brother may be a very useful member, but he is not a power in the Order. He may be an excellent ritualist, and possess many qualities whose tendency is to pull down

rather than build up.

Again a Mason may have literary attainments, and may be able to make a good speech, to deliver a finished address, and be a valuable man on dress parade occasions; he may be useful and ornamental, he may exercise considerable influence, but will be ephemeral; there is nothing in it that is a power, because it does not form an essential element of the Institution.

Whenever the ritualist, or jurist, or orator has himself in view, rather than the interest of Masonry, he lacks the soul, the spirit, and does not belong to the class of best Masons.—"Masonic Guide."
