#### A NEW WORK FOR MASONS.

N the occasion of the installation meeting of the St. Maughold Lodge, No. 1075, held at Ramsey, Isle of Man, visiting Brethren from Douglas and other parts of the Island were particularly struck with the unique collection of antiquities which had, for the present, found a home in the Lodge room and the ante rooms. Bro. C. Kermode P.M. has, for years, been the custodian of this treasure, and, as is well known, has been endeavouring to arouse a sluggish public opinion in the Island in favour of providing a proper museum for those Manx antiquities, as also for a large number of other ancient relics, which are drifting about in the hands of private individuals there and on the mainland. His Excellency Lord Henniker, Governor of the Island, who is also its Provincial Grand Master, made a considerable effort on his arrival there to carry out the proposal for a Manx National Museum, but whether it was that the mass of prejudice and inertness was too much for him to contend with, or whether it was that the idea was not put forward on the most feasible lines, the matter fell, and Manxland remains without a proper building in which to place the priceless and fast-disappearing relics of the past. After the Lodge banquet at the Queen's Hotel, in which a numerous company of influential Brethren took part, the subject of a museum for the Island was warmly discussed. It was broached, of course, by Bro. C. Kermode, who urged on his Masonic Brethren to use all the influence which they were able in order to further the establishment of a Manx museum. He was supported by several members present, and it was suggested that some steps might be taken by the Masonic body of the Island to persuade his Excellency the Lieut.-Governor to again move in the matter. The opinion was general that, inasmuch as the Museum is to be a national institution, the proper source of its establishment and maintenance is the Insular Revenue, and that little difficulty ought to be experienced in obtaining the necessary funds.

#### A NEW CLASS LODGE.

In these days of representative Lodges, is it not time that a Lodge, consisting of the members of the Dancing world and its affiliated arts, should exist? We are sure that it would, in a short time, become prosperous and numerous. As so many of the profession are engaged in the winter, it might with advantage be held as a summer Lodge in some sweet sylvan district. It would be almost too much to dream of that it should be held "al fresco," after the manner of our ancient Brethren, as we fear our climate could not be relied upon to respect even our mystic rites. But we feel sure that there is a want of a Lodge, representing the universal arts of dancing, where Fraternal visitors from all quarters of the globe could meet with the sympathy and assistance of the noble Craft. The Lodge might be called "The Terpsichorean." The lady members of the profession could be made participants in some of the pleasures, and by subscribing to the Masonic Charities be invited to the social delights which sometimes follow our work. Here is the suggestion. We shall be glad to hear what the votaries of our art will say upon so interesting a subject.—"Dancing Times.

Liverpool Freemasons naturally took considerable interest in the unique initiation at the Concord Lodge, No. 43, Preston, of three sons of Past Master Stevenson, of Whittingham. The three brothers were, the other evening, all raised to the third degree, their father, who had filled a

part in the two previous ceremonies, on this occasion taking the chief work. This he performed, having a highly retentive memory, most efficiently in the presence of the members and of some forty visiting Brethren, including Grand and Prov. Grand Officers. Another feature of the interesting gathering was the election as honorary member of the Lodge of Bro. A. Beattie, a well known Past Provincial Officer, and long Charity Representative of No. 343, Liverpool.

On Friday evening of last week, at the usual weekly meeting of the Selwyn Lodge of Instruction, No. 1901, held at the Montpelier Hotel, Choumert Road, Peckham, Brother Daniel Channon P.M., a well known and highly respected Mason, who has for many years acted as Deputy Preceptor of the Lodge, was presented with a gold signet ring bearing his initials, "D. C." After the transaction of the regular business the Brethren dined together. The usual Loyal and Masonic toasts having been duly honoured, the presentation was made by Bro. J. M. Wimble P.M. Preceptor, who occupied the chair on the occasion. In a well considered speech he recalled how for many years Bro. Channon had been held in high esteem by the members of the Lodge, and he hoped that the gift would be considered as a token of the high regard and affection in which he was held. Bro. Channon suitably responded.

The ordinary meeting of the St. Bride Lodge, No. 2817, was held a few days since, at the Hotel Cecil, when the Worshipful Master, taking advantage of the presence in the building of H.R.H. the Prince of Wales M.W.G.M. tendered, on behalf of the Lodge, his most respectful and loyal greetings. The act of courtesy was much appreciated by the Prince, who sent for the W.M., and, through his equerry, desired that his thanks might be conveyed to the Lodge, and this was done amid much enthusiasm.

The increase in the minimum initiation fee agreed to by Grand Lodge of Scotland some years ago has had a most beneficial effect on the Craft. The increase then made was understood to be only partial, and that a further addition would be made later. The good results of the increase are now acknowledged even by the opponents to the change when it was proposed, and the present seems most propitious for a further advance, says "The Mallet," in "Glasgow Evening News."

It is not often a Brother presides over three Lodges at one time, but that distinction is enjoyed by Bro. T. Westlake Morgan, who was installed as Worshipful Master of the Royal Leek Lodge, No. 1849, at Bangor, in March last; rose to the dignity of the chair in the Snowdonia Mark Lodge, No. 259, in November; and has now been installed as W.M. of the Anglesey Craft Lodge, No. 1113, Menai Bridge, the Provincial Grand Master Lord Harlech granting the necessary dispensation.

We are glad to hear that Bro. H. T. Brickwell has secured a lease for twenty-one years of the Court Theatre, Sloane Square, S.W. Bro. Brickwell has had considerable experience in matters theatrical, and will doubtless enjoy a continuance of the patronage of playgoers for whom he has so ably catered at the Garrick and Terry's Theatres.

#### CHESHIRE.

HE installation of the Hon. Alan de Tatton Egerton, M.P., Past Grand Warden of England P.P.G.W. of Cheshire as Provincial Grand Master of the Province of Cheshire took place on Monday of last week, in the Town Hall, Chester. There was a great influx of visitors to the city, comprising representatives of the Lodges within the Province and many Officers and Brethren from the neighbouring Provinces of Fast and West Langashire bouring Provinces of East and West Lancashire.

The calling of the roll showed that every Lodge in the Province was represented, the number of Brethren present being calculated at between 600 and 700. The Deputy Prov. Grand Master his Honour Judge Sir Horatio Lloyd P.G.D. England opened the Provincial Grand Lodge, the duties of Deputy being discharged by Bro. Colonel C. S. Dean S.G.D. England, and Brothers J. Fred. May and William Booth occupying respectively the Senior and Junior Wardens' chairs, while Bro. H. Gordon Smith was the Director of Ceremonies, assisted by Brother Frank Richardson P.G.D.

Bro. Letchworth, the Installing Master, was afterwards conducted to the chair. He said he was sure there was no one in that Hall who would not share with him the feeling of disappointment at the absence of their late Provincial Grand Master Earl Egerton. He knew it was the intention of Earl Egerton to be there that day, and he felt they would all regret still more the cause which had deprived them of the pleasure of again welcoming his lordship to the Provincial Grand Lodge. It would be within the recollection of them all that at the Provincial Grand Lodge of Cheshire his lordship informed them of the reasons why, in justice to the Province, he felt compelled to submit to His Royal Highness the Grand Master his resignation of the office, which for the past thirteen years he had filled so well, to the advantage of that Province: It was his (the speaker's) duty to submit that resignation to His Royal Highness, who expressed the deepest regret that the Province should lose the benefit which for so many years it nad derived from the Mastership of Earl Egerton. But he most heartily congratulated the Province on the choice the Grand Master was graciously pleased to make of his successor their Right Worshipful Brother the Honourable Alan de Tatton Egerton, who was well known in that Province and in that county. He was already a ruler in Masonry, and they knew how well he was able to discharge the duties. He ventured to believe that under his able and genial rule the success which had attended that Province for so many years would be maintained, and that the work would be carried out in every way worthy of its great traditions.

The ceremony of installing the Provincial Grand Master was then proceeded with, the patent of appointment by H.R.H. the Prince of Wales M.W. Grand Master being read by the Prov. Grand Registrar Brother Henry Taylor. The Installing Master subsequently invested the Provincial Grand Master with the apron, chain, and jewel of office, and placed him in the chair.

The Provincial Grand Master said he had pleasure in informing the Provincial Grand Lodge that Sir Horatio Lloyd had been pleased to accept the Office of Deputy Prov. Grand Master, and to continue the good work that he had been doing for some many years. He had, therefore, very great pleasure in re-appointing him to the Office.

The Provincial Grand Master moved that a vote of thanks be given to his Worship the Mayor for the use of the Town Hall. On gatherings of that kind, he said, it was very difficult indeed for the Brethren to find a building of sufficient size to accommodate the Masonic world of Cheshire alone, without inviting all those of their neighbouring friends whom they wished to see. Although he would have liked personally that that ceremony should have taken place under the auspices of his Mother Lodge at Altrincham, still he felt that the demands of the Brethren would be such that nothing short of what they recognised as the county town would suffice to find room for all, and he was very pleased indeed that the Mayor and aldermen of Chester had been kind enough to orant them the use of practically the only building that would contain them. He had been at a good many Masonic functions, and he could assure them that with the exception of one at Berlin he had seldom seen any room filled to the extent that that one was, and he thanked them for coming in such large numbers.

The Deputy Provincial Grand Master seconded the vote,

which he said the Mayor deserved the more because he did not belong to the Craft.

The motion having been carried, a collection, which amounted to £30 8s, was taken on behalf of the Benevolent and Masonic Educational Institution of Cheshire, and the Provincial Grand Lodge was shortly afterwards closed.

#### GLOUCESTERSHIRE.

HE annual convocation of this Provincial Grand Chapter was held on Friday Craft (1976) was held on Friday, 21st inst., at the Masonic Hall, Cheltenham. The meeting was originally appointed for the 6th inst., but it was postponed until the latter date in consequence of the summoning of Parliament and the consequent inability of the Provincial Grand Superintendent the Right Hon. Sir Michael Hicks Beach to attend. During the thirteen years since Provincial Grand Chapter was founded the Chancellor of the Exchequer has not missed one of its annual meetings, and it was an evidence of his continued attachment to the Order that at his request arrangements for the postponement were made to enable him to preside over the Chapter. There was a large attendance of Companions.

Provincial Grand Chapter having been opened in due form, routine matters were disposed of. The report of the Prov. Grand Treasurer was of a most satisfactory character, a substantial balance standing to the credit of the Chapter. This report having been adopted, Comp. Jas. Bruton was again re-elected Treasurer and thanked for his services. It was always a pleasure and the most grateful form of relaxation to come amongst his Gloucestershire Brethren and exchange Fraternal greetings with them. Referring to an allusion made to the report of his approaching retirement from office, he said he need hardly say there was no truth in it. He hoped he was not the man to run away from a position because it was an anxious or difficult one.

#### MASONRY ON THE HIGH SEAS.

S EVERAL Brethren who travelled from Australia to England by the "Persic" White Star Line, on her last voyage home formed the idea of holding a bi-weekly Lodge of Instruction, and so beguile the wearisomeness of the journey, and instruct themselves in the practice of the rites and ceremonies of Freemasonry. The master of the ship, Captain Sealby, who belongs to the Craft, kindly placed his room at the disposal of the Brethren though his constant attention to the duties of his responsible office as Captain interfered with his presence at the Lodge meetings. Brethren who met in this Lodge of Instruction on the high seas represented a wide range of Freemasonry. Every quarter of the globe seems to have been in evidence at the Persic Lodge of Instruction. There was a P.M., Bro. H. W. Meggitt, of the E.C. Lincoln, No. 1447; Bro. T. G. Wilson, P.M. of No. 98, New South Wales; Bro. J. H. L. Zellmann, P.M. of No. 35, Kiama Lodge, Kiama, N.S.W., and a number of Master Masons from Lodges in Opensland, New Zealand. of Master Masons from Lodges in Queensland, New Zealand, Victoria, West Australia and Tasmania, not to mention Bro. David J. Davis of Lodge Aconcagua, Valparaiso, Chili, and a Brother from No. 37, Farmington, Washington, U.S.A. Bro. J. Telfer of Lodge Scotia, No. 861, Coolgardie, acted as Secretary, Bro. Wilson P.M. acted as W.M., and Bro. Zellman P.M. as Chaplain, the Offices of Senior and Junior Wardens were fulfilled by Bro. Front Hort of Scot. In Co. Wardens were fulfilled by Bro. Frank Hart of 203, L.C., Liverpool, and Bro. Oscar Kalbfell of No. 5, Pacific, Tas., and the Senior and Junior Deaconships by Brethren as was convenient. Much praise is due to Bro. Telfer for the artistic manner in which he prepared the notices and sum-The last summons issued is in itself a work of art, heading (with Masonic symbols), Persic Lodge of Antient Free and Accepted Masons, then follows names of the three principal Officers. Notice: Dear Sir and Bro., "You are hereby invited to attend a Lodge of Instruction, to be held in the Lodge Room (Officers' dining saloon) this, Saturday evening, at 8.15 p.m. By command of the W.M., John F. Telfer Secretary. Business: 1st Degree, Regalia to be worn." On the back of this paper the owner has secured the signatures of all the Brethren who attended the Lodge meetings. Others he informs us did the same thing. At the close of the voyage, while the vessel was lying outside the mouth of the Thames, waiting for daylight to proceed up the river, the Brethren all waited on the Captain and presented an address of Fraternal farewell, and thanking him for the opportunity which had been placed within their reach of associating Masonically with one another. The captain seemed highly pleased, and expressed the opinion that the good example of the Brethren in holding Lodge meetings of good example of the Brethren in holding Loage meetings of instruction was deserving of being more generally imitated. He said that when he had taken his Third Degree a suggestion was made to him that the opportunity of a lenghtened voyage might often help Brethren to cultivate a more correct acquaintance with the usages of Freemasonry, though he did not suppose that so early in his career as commander of a vessel he would have been able to help in giving practical effect to the idea.—" Masonry.'

#### LODGE OF SORROW.

A SPECIAL Communication of the Grand Lodge of all Scottish Freemasonry in India was held on the death of Bro. James W. Smith Past Grand Master of that Jurisdiction, when Bro. K. R. Cama P.G. Master Depute delivered the following Oration: Brethren,—The G.M. Depute in charge asked me a few days ago to deliver an Oration on the occasion of the holding of the Lodge of Sorrow in memory of the late lamented Past Grand Master of All Scottish Freemasonry in India, Rt. Wor. Bro. James William Smith. I hesitated a little at first because I believed that it would be well to find out another Brother who would be better qualified to do justice to the theme. But when I remembered that I had been connected with Bro. Smith for years together in Freemasonry, I thought that I would be failing in my duty as an old Mason were I to shirk the duty I owed to my late friend. I accordingly complied with the desire expressed by Rt. Wor. Bro. Pollen, and I feel a sort of melancholy pleasure in raising my feeble voice in the commemoration ceremony to-night. Brethren, from the manner in which Grand Lodge has been draped in crape, it

shows that we have not met for any ordinary business tonight, but that we have assembled to mourn the loss of a dear and beloved Brother, who held a high rank in Freemasonry, and who had served in both Constitutions in the highest offices appertaining to the two Grand Lodges working in Bombay. And I am pleased to see that such a large number has gathered together this evening to do honour to the memory of our late Brother. Brethren, as a password and passport to the portals of Freemasonry we are required to affirm the belief that there is only one true and living God. The immortality of the soul is our next belief. Every man is a composite made up of body, soul, and spirit, and when one dies, that is to say when his soul takes wing and flies to the next world to render his last account to the Most High, though he may be dead to those who are living in this world, he is to all intents and purposes leading a better and a faultless and pious life in another world.

The ceremony that we have gone through to-night and similar ceremonies performed in places other than the Lodges of Freemasons, are not calculated to do any good to the dead, but they are meant for the instruction and improvement of the living. There is a tenet in Freemasonry which states that every man receives his reward or punishment after death according to his deeds in this world. Every one works out his salvation during life by his own acts and deeds, and hence no ceremony is performed after his death since it does not avail his soul in any way. But we as frail human creatures require to be reminded every now and then that we are mortals and that our fate will be similar to that of the Brother whose death we mourn, and such ceremonies are performed by way of affording a useful lesson to those left behind by him.

The ceremonial that we have passed through to-night will show that death takes hold of at one time or another every man that is born in this world, and that we should be prepared to meet it when it comes. We have, therefore, to avail ourselves of this opportunity to draw a moral for our own benefit from the life and career of our late lamented Brother. Nobody can venture to say about another that all his deeds and actions are worthy of imitation, because no man is perfect. There is always a mixture of good and evil among men, and it often happens that at times the evil may obtain victory over righteousness, and may lead one to transgress the Divine Will and be sinful; but in such cases it is always deemed best to throw a veil of impenetrable thickness over the failings and foibles of the departed Brother, and only try to benefit ourselves by remembering and recounting only his good acts and deeds worthy of admiration and imitation. The best service one can render to the dead is to follow in his foot-steps and imitate his good example. The Masonic career of our late lamented Brother is indeed worthy of our imitation. I will not go into every detail of his very useful and brilliant Masonic career, because they are too numerous to be enumerated during the short time at my command, but if any Brother is desirous of doing so he might look for them in the "Indian Freemason" of May 1894.

I will, therefore, only confine myself to some of the

most important points in his career of which, I may say without the least hesitation, I have personal experience and knowledge. It will be found from that magazine that the late Bro. Smith was initiated in the mysteries of the Craft so far back as the year 1871, so that at the time of his death he was a Mason of twenty-nine years standing. He came to Bombay in 1877 and soon joined the English Constitution. He was affiliated in Lodge "St. George," the premier Lodge under the English Constitution. He there rose so fast that within the space of two years he was elected to the chair of the Lodge. I had the honour to be present that night, and I am sure there are a few here who were present on the occasion, many of them having gone to that home whence no one can return. There happened something special that night which has not yet been effaced from my memory. Brethren, it may be quite within your experience that when a Brother is raised to the Master's chair, he is expected to be a little nervous in the presence of a large assembly, and be a little nervous in the presence of a large assembly, and becomes diffident as to how he will be able to go through the beautiful ritual. To my great surprise the late Brother Smith without being in the least diffident or nervous appeared to be self-composed. Without betraying the least hesitation he went through the ceremonial with such skill and practical knowledge and coolness and correctness that he won the admiration of all present on the occasion. They all went away

thoroughly impressed with his ability and integrity and it was at that time that they formed an opinion that Brother Smith was destined to attain a high position in Freemasonry.

Lodge after Lodge sought his services, and he was asked to join this and that Lodge which he readily did by way of extending his right hand of fellowship to those who sought it. He was raised from one high position to another, from one branch of Masonry to another until at last we found him under the English Constitution holding the high and exalted rank of the Deputy District Grand Master. He would have been elevated to the rank of the District Grand Master, but for the fact that the office was held, and during his absence from his country, by H.R.H. the Duke of Connaught. To my mind he excelled himself as a Mason when he was appointed Chairman of the Joint Hall Committee. I may mention for the information of the members of the present generation that about a quarter of a century ago the English and the Scotch Constitutions hired halls of their own, and each of them found it difficult to find a suitable place for its location.

It so happened at the time that both the Constitutions had to vacate their premises, and were in search of suitable places for their location. They both agreed that it would be more economical and conducive to strengthen the bonds of Brotherhood if they both met in one common Hall. They found a place in Nesbit Lane called the Nabob's bungalow, and met there, the bungalow being occupied by the different Lodges almost every day of the month. One management did well for both the Constitutions, and in order that no side got the better of the other and that there might be a balance kept on the Board a Joint Hall Committee was formed of a certain number of members from the English as well as the Scotch Constitutions. When they jointly hired a new hall, Rt. Wor. Bro. D. R. Chichgur (Scottish), who has already made his mark and is known to possess talents of a high order for organisation of a general character, was appointed Secretary of the Joint Hall Committee, and it was so arranged to preserve an equilibrium of power that if the Secretary belonged to the Scotch Constitution, the Chairman should belong to the other Constitution. The Deputy Grand Masters (English) presided over the Hall Committee, but it so happened that they resigned their office one after the other, until Bro. Smith was appointed to that office and was called to the chair. He very well knew that as Chairman called to the chair. He very well knew that as Chairman of the Committee he had to deal with conflicting interests, and he was accordingly very cautious and careful in the discharge of his duties as such. He managed the affairs of the Hall Committee in such a business-like and harmonious manner that the two Constitutions thought of having a building of their own from contributions made by the two bodies, and with that view different schemes were discussed which did not at first bear any fruit.

When Lord Sandhurst was appointed the Grand Master of both the Constitutions, the plans and estimates that were formerly made were submitted to him, and a site was granted by his government upon which the present building now stands. The scheme having been thus settled, it was left to Rt. Wor. Bro. Darasha R. Chichgur to secure the necessary sinews of war, which he did with his accustomed energy and zeal for the Craft. The members of the Scotch Lodges having found in Bro. Smith as President of the Hall Committee an energetic and ardent Mason and a sound businesslike man, desired that he should be asked to join the Scotch Constitution, and as he saw the offer made was of a sincere character he agreed to join the Constitution. affiliated to Lodge Caledonia, No. 490, in 1888, and the next year Lodge Perseverance asked him to join in order to place him in the chair, and in 1890, Most Wor. Bro. Sir Henry Morland, the then Grand Master of All Scottish Freemasonry in Ludia appointed Pro-Smith as Count Master Depart in India, appointed Bro. Smith as Grand Master Depute. Most Wor. Bro. Sir Henry Morland fell ill at the latter end of the year and the Scotch Masons then cast their eyes on Bro. Smith as a fit successor to Bro. Sir Henry Morland. The latter soon afterwards rallied and when he was consulted on the point he expressed it as his opinion that there would be no better successor found than in Bro. Smith.

When Bro. Sir Henry Morland died, the nomination of Bro. Smith was supported by different Lodges throughout the country and his name having been recommended from all quarters, Grand Lodge of Scotland sent his commission as the Grand Master of All Scottish Freemasonry in India. He was installed as such on the 23rd January 1892, and as the senior Grand Master Depute I had the privilege and the pleasure of installing him in that chair. In whatever Office

he took, Bro. Smith pledged himself to perform the duties of that Office to the best of his power and ability. He never ran after offices nor did he ever seek honours, but honours sought him out. Bro. Smith was blessed with a cool and quiet temper, so much so that though I came in contact with him for so many years, I never saw him in any angry mood or his temper in the least perturbed. His knowledge of jurisprudence and his keen insight into human nature stood him in good stead, and enabled him to fill the various high offices with credit to himself and satisfaction to the Brethren. His regularity and punctuality were proverbial. To my mind Bro. Smith, taking him all in all, was a Mason worthy of our imitation. During my long Masonic career I have not come in contact with a more even-minded, unbiassed, cool and collected, hard-working, assiduous, diligent and arduous Mason than Bro. Smith. It is indeed a rare thing to find a Brother possessed of all such qualifications. No doubt any Mason would feel proud to possess these acquirements. Let us all pray that his mantle may fall on as many of us as possible, and that by imitating his worthy example we may glorify Freemasonry and glorify the model whom we all desire to imitate.—" Indian Freemason."

#### THE WORSHIPFUL MASTER.

W E have always contended that it is not the number that make a Lodge, but the fraternal warmth and good fellowship of the individuals that comprise it. To obtain this greatly-desired result, a Brother must be "properly made." What we mean by this expression is that he must be taught the beauties of Masonry in a manner so forcible and earnest as to convince him it comes from an honest heart, whose sole desire is "to be serviceable to our fellow creatures." To do this a Worshipful Master must get his life in his work. He must not "play to catch the crowd," by striking attitudes, studied gestures and stage reading, but be circumspect and convince those present that he means and feels what he is doing. He must divest himself of the cold apathy which seems to say, "Because the Brethren have not complimented me by a large turnout, I will just finish this job in a hurry." You have no right to do anything of the kind; you have no right to use your energies for the plaudits of the crowd to the detriment of your duty; you have no right to hold the position unless you give it all the honesty of purpose of your nature; you have no right to slight your work or pout at empty seats.

On all occasions do the best you can and at the conclusion of your work have a "handshaking and a word" with all present. Make them feel glad that they were present, and the next time they will come and bring some one else, and so will the candidate whom you have just "raised."—Bun F. Price.

MR. MAURICE HEWLETT has made for himself a great reputation. Why he has succeeded in doing so is known to most Englishmen of literary competence, none of whom will grudge him his well merited success. That success is due mainly to two qualities by which he is eminently distinguished. He is master of a truly beautiful, poetic prose, and can go back in spirit to a bygone age and realise it with so unerring a vision that he can re-create it with a fidelity to which few writers ever attain. Two of his books have been read on the Continent as few English fictions are—"The Forest Lovers," and "Little Novels of Italy." This volume does in no way belie the promise of his spring! Even readers with vivid memories of the Richard of "Ivanhoe" and "The Talisman" will be delighted with the wonderful creation of Mr. Maurice Hewlett, and will cherish a wish that so able a depicter of the past may try his hand upon other protagonists in the great drama of English History. The many-sided character of Richard the lion-hearted is presented by the writer in a series of romantic adventures well calculated to exercise the creative ingenuity of the most skilful novelist. We are shown his brave and martial spirit chastened, at times, to the temperament of the dove; we are shown his ever resourceful diplomacy, his fiery temper, his powers of endurance, his commanding personality. Here and there we have met a descriptive paragraph so daintily conceived and choicely phrased that it might have been penned by Sidney Colvin or E. A. Freeman. On the whole, if our readers can imagine a story of an historical character written by Mr. Hamilton Drummond in collaboration with Mr. F. Marion Crawford we think they will have a very fair notion of the qualities by which this book by Mr. Hewlett is distinguished. But we hope they will read it for themselves.

AN exciting romance, admirably conceived and fluently written. We have had former opportunities of expressing a high opinion of the ability of Mr. E. Phillips Oppenheim, and are glad to say that in his last work we think he has taken yet another step towards excellence. His style is, indeed, not very original; but what a great number of writers are doing very indifferently Mr. Oppenheim is doing so well that we can hardly expect him to do it better. He is as imaginative as Mr. Richard Marsh; as versatile, and more uniformly correct, than Mr. Guy Boothby; he is as perfect a plotter as Mr. Le Queux. In the volume before us a mining camp in America affords the opening scene, and the doings of Jim Bryan and Myra are so rich in incident and so dramatic in character that the reader finds abundant entertainment to the end of the story. A character at once so noble and self-sacrificing, so refined and so lovable as Myra has not often been sketched of late in English prose fiction. We hope Mr. Oppenheim will give us something more presently, and trust it may equal "The World's Great Snare."

We cannot refrain from noticing the extravagant admiration of the writer for fox-hunting gentry and all that pertains to them. Every man to his tastes. A WONDERFUL copper-mine in the Ural Mountains, a detestable crime, a great hatred, a deal of dialogue of an explanatory nature—these are the more apparent features of Mr. Norman Silver's very readable romance. Two facts stared us persistently in the face when we were reading "Hate, the Destroyer," the fact that Mr. Calvert is in many respects too good a man to be so relentless in search of revenge, even after so great provocation, and the fact that the story is hardly so well knit together as could be wished. We were much pleased with several chapters which, with but little adjustment, would make good short stories. Of these, the chapter in which we are told how "Mr. Morton" engaged the apartments at Mr. Fernyhough's, and how strangely he proceeded to act, is the best. We hope to see Mr. Norman Silver's work on another occasion.

London Memories. Social, Historical, and Topographical. By Charles William Heckethorn (6s).—Chatto and Windus.

Easy reading, as Sheridan once remarked, is very hard writing.

Mr. Heckethorn has written a good book upon old London, in which delightfully easy reading is apparent on almost every page, and doubtless a deal of labour was necessary before such fluent paragraphs could be produced. The work was, we presume, a labour of love, and Mr. Heckethorn has added a valuable contribution to a subject which, in company with our learned Brother Sir Walter Besant, he has studied exhaustively. The chapter on the old religious houses of London could hardly be bettered; whilst professing only to amuse the writer imparts much useful instruction. He has taken the salutary advice of Pope, who has told us that men must be taught as though you taught them not. There is a short chapter of a somewhat lurid character on the savage villany so often prevalent in our great city during the good old days; there is a very long one on the Thames, in which Mr. Heckethorn has woven many an interesting reminiscence of the river-side. "London Memories" should not be opened merely for amusement, for it deserves very careful perusal. The volume is light in the hand, and well printed. There can be no hope for honest literary work if this book does not circulate widely.

### WHAT DOES FREEMASONRY TEACH USP

N interesting address was delivered by Bro. Henry T. Smith P.M. St. Andrew Lodge, No. 16, Toronto, at the last regular meeting of Rehoboam Lodge, No. 05, on the subject of "What Does Freemasonry Yeach us?" of

which the following is a synopsis:

We know that the records of the past are full of instruction. That the pages of bygone history are laden with the rich treasures of other days, which have come down to us along the ages, and it is only necessary that we open the book and read for ourselves what has been accomplished.

What is Freemasonry? is naturally the first question that arises in one's mind when speaking of its teachings. What are its claims to popular approval? What right has it to exist as an Institution or as a system? As a matter of fact, despite the calumnies of its enemies, and the exaggerated claims of its friends, it has in the moral world a held, as an educating force, and serenely, silently and non-ostentatiously it holds the even tenor of its way by its teachings.

Permit me, in the first place, to point out that Freemasonry is not primarily an alms-giving society, nor a death benefit association. Many outside, and not a few within the Fraternity, appear to entertain the idea that these are its principal functions. It is true we are taught to contribute to the relief of the distressed, so far as our ability will permit, without material injury to ourselves or to our families, but this is not the principal aim or the purpose of the Institution. An examination of the Ancient Charges of a Freemason makes it appear that anciently the giving of alms was a personal matter purely, which addressed itself to the judgment and conscience of the individual Brother, and it was not the custom to vote appropriations of the common funds of the Lodge for the relief of the destitute and indigent.

I desire also to point out that Freemasonry is not a co-operative benefit association. Many organisations have been formed in which from a certain tribute laid upon all the members of the Order, regardless of individual ability to pay, a common fund is raised to be paid as benefits, as a matter of right in certain contingencies, whether the parties to whom the payments are made are in need of financial succour or not. To relieve the distressed is a duty incumbent on all men, but particularly on Masons, who are linked together by an indissoluble chain of sincere affection. 10 soothe the unhappy, to sympathise with their misfortune, to compassionate their miseries, and to restore peace to their troubled minds, is the great aim we have in view. On this basis we form our friendships and establish our connections.

Then Freemasonry is not a religion. It is, to my mind, a grave mistake to regard it as a religion, and nothing can result therefrom but harm. But Freemasonry regards truth as a divine attribute and the foundation of every virtue. be good and true is the first lesson we are taught in Freemasonry. On this theme we contemplate, and by its dictates endeavour to regulate our conduct. Hence, so long as we are influenced by this principle, hypocrisy and deceit are unknown among us; sincerity and plain dealing distinguish us, and the heart and the tongue join in promoting one another's welfare and rejoicing in one another's prosperity.

We find nothing in the teachings of Freemasonry opposed to any Church. What they ought to do, is to lead us into the acceptance of the broader and more comprehensive truths of religion, or, in other words, to respect the good to be found among all classes of people, all civilised races of men, and in all religious creeds. Permit me to interject here that one of the greatest factors, in my opinion, during the past hundred years in the civilisation of the world has been the dissemination of the teachings of Freemasonry. Brethren, on the threshhold of the Lodge every Brother should lay down and even forget every vain titie of worldly pomp and sectarianism by which he may be distinguished in the outer world, for the teachings of Freemasonry are comprised in the words, "Liberty, Equality, and Fraternity," as well as "Knowledge, Morality, and Labour."

Now the teachings of Freemasonry do not contemplate anything political in character. A Mason is taught to conform to the law of the land under the protection of which he lives, and to never lose sight of the allegiance due to his country, but so far from teaching anything political in a partisan sense, it is in accordance with the scheme and plan of Freemasonry that it should constitute a middle state or common rallying ground for men of every shade of political

opinion, and make friends of those who might otherwise have remained at a perpetual distance from each other.

Then in Freemasonry we are taught patriotism, that holy love of country which is inherent in all races and keeps the world moving, which thrills the pulse and fires the heart and nerves the arm. What man in the whole land is a more ardent patriot than the Mason? He is taught to be true to his God, his country, his neighbour and himself. Patriotism is one of the landmarks of the Craftsman. Thus in everything which goes to make up the true man, the Mason finds its counterpart in the Lodge room. The things which make for peace are diligently pursued by him in the Lodge room. But should the country call her sons to arms to fight for God and right, none responds to that cry for sacrifice more promptly than the Mason. We have recently witnessed promptly than the Mason. that, for when our sons and Brothers were contending on battlefields red with their blood did they not display patriotism? And when in all appearance the Empire, of which we form a part, may find herself in worse straits than the South African difficulty has proved to be, do we need to defend our noble Order in its teachings of patriotism? I answer that interrogation by saying: No, not when we had such noble men and Masons in the past as Bros. the Duke of Wellington and Lord Nelson, and in the present day as Bros. Lord Roberts, General Kitchener, the hero of Ladysmith, General White, the hero of Mafeking, General Baden-Powell, Colonel Otter, Captain Barker, and hosts of others ready to sacrifice life, if need be, to lead our brave British or Colonial soldiers to victory.

Freemasonry does not purport to give its members either social or financial standing in the community, and its

teachings are strongly against such a view.

What motive, my Brethren, actuated each one of you to become a Mason? Was it its teachings? The motives that actuate men in uniting with the Fraternity are various. Some are attracted by its great age, and the halo of antiquity that surrounds it. They imagine that from its mystical past there comes a troop of wonderful, weird and solemn mysticisms which are calculated to strike terror to the timid. Their curiosity is aroused, and they seek the darkened chambers of the unrevealed, only to be disappointed. Some look upon the extent of the Brotherhood, encircling as it does the very globe, as affording a means of extensive acquaintance, and they are proud of the distinction of being members of the most widely diffused organisation in the world. They imagine they can find "a friend in need" in any quarter of the globe; for, like the possessions of Great Britain, the sun never sets upon Freemasonry. It has, perhaps, the only universal language among men; for whether in Europe, Asia, or Africa, in America, India, or the far-away islands of the sea, under the frigid skies of the Arctic, or the burning sun of the equator, its peculiar tongue is spoken and its teachings promulgated for the benefit of the human race. It is certainly commendable in a man to desire to be one of such an universal Brotherhood, but he should seek to become a member of the Fraternity "uninfluenced by mercenary or other unworthy motives," and then he is able to grasp intelligently the very spirit of its teachings.

Then Freemasonry has never pretended to be, nor is it, as a matter of fact, an asylum for wrong doers or transgressors of law. Those who imagine that the members of the Institution are taught under any circumstances to condone his transgressions or whitewash his unlawful conduct are mistaken. If a man calling himself a Mason chooses to do wrong, to persist in error and to violate law, he does what he can find no warrant for in the teachings of Masonry, and he will be disappointed if he expects the members of the Institution to apologise for his wrong doing, or uphold him

in his errors. What is Freemasonry then? It is a system of education. It appeals to the intellect and the conscience. It develops man intellectually and morally and is calculated to give him a higher conception of his duty to God, his fellowman and himself. It is a course of hierogyphic moral instruction taught agreeably to ancient usages, by types, emblems and allegorical figures. In other words it is an ancient system of object teaching. "Tools and implements of architecture have been selected by the Fraternity to imprint on the memory wise and serious truths and thus through a succession of ages are transmitted unimpaired the most excellent tenets of our Institution." The Mason is taught that it is his duty as well as his privilege to cultivate a knowledge of the liberal arts and sciences.

If I might designate what to my mind may be termed the leading characteristics of him who has learned aright the lesson inculcated by Freemasonry, I would call them liberality, equality, and Fraternity. Liberality not merely in his dealings in temporal matters, but more especially in his ideas and thoughts. He who has learned aright the lessons inculcated by Masonry is free from bigotry and intolerance, and in forming his estimate of his neighbours is large-minded, candid, tolerant, generous and impartial. He concedes to his neighbour the utmost freedom of ideas and conduct, and grants him the full exercise of every right and prerogative which he claims for himself. My Brother, you tenaciously cling to and cherish the right to entertain whatever opinions you please, and within limits fixed by law and right to pursue whatever line of conduct meets your approbation, but have you learned to exercise that degree of liberality which concedes to every man under the sun the same prerogative? If not, one of the most important lessons taught by Free-

masonry has been lost upon you.

When we speak of equalty in our Masonic Lodges we do not have reference to wordly wealth or honours, to ability or mental endowments, nor to social distinction. Equality in any of these respects is impossible, and is, perhaps, not

desirable.

But when we speak of equality as taught in Freemasonry, we mean that we are all descended from one common stock, partake of the same nature and share the same hope. Distinctions among men are necessary in order to preserve subordination, yet no eminence of station should make us forget that we are Brethren, and that a time is rapidly approaching when every distinction save that of goodness shall cease, and death, the final leveller, reduce us to the same state.

The teachings of Freemasonry can be likened to an intellectual ocean, whose waves touch the shores of thought, within which the sunlight of content and love burst forth with a radiance beautiful to behold. Then what does it teach us? To cultivate that friendship which Addison said:
"Is a strong and habitual inclination in two persons to promote the good and happiness of each other." And that which Cicero has declared: "Improves happiness and abates misery by doubling our joy and dividing our grief." And that which Southey likened to: "The shadows of the evening which strengthen with the setting sun of life." We have plenty of friends (so-called) when we are in prosperity, but adversity sometimes turns the tide. Brethren, in carrying out the teachings of Freemasonry, let us cultivate that friendship which can be found in these words: "Do unto

others that which we would like to have done unto ourselves."

Now, to recapitulate, Freemasonry is at the close of this 19th century no mere childish and contemptible medium for the display of finery and empty pomp. It is no machinery for the encouragement of disloyalty, either to God or man. no substitute for the religion of home or Church. It is a system of morality veiled in allegory and illustrated by symbols. It inculcates the highest and deepest moral lessons. Its universality denotes its hold on the needs of mankind. It seeks no notoriety. It canvasses for no membership. It goes quietly on in its beneficent way. It neither exploits nor conceals its noble and helpful ambitions. Its aid is given without ostentation, and without hypocrisy. The needs of the widow and the fatherless, of the wanderer and the outcast, are met, if found worthy, with a generosity and Brotherly open-heartedness which neither craves nor allows recognition. It lets not its left hand know what its right hand does.

And yet it has been assailed with a virulence which is often as bitter as it is unaccountable. It has been proscribed with a ban and attacked with anathema. It has been ridiculed in pulpit and press. It has been beset with the open assault, and scourged with the covert sneer. It has been the opprobrium of the narrow-minded and the butt of the bigot.

Yet, amidst it all, Freemasonry still glides smoothly on, as it were, accomplishing its great object and proclaiming to the world by its teachings the same messages which heralded the coming of that wonderful man upon the plains of Bethlehem nineteen hundred years ago: "Peace on earth, good will to men."

Brethren of Rehoboam Lodge, in promulgating the teachings of Freemasonry within the portals of your Lodge, I would judge by the number of Brethren on your membership roll that the ashlars upon which you have worked have been gradually smoothed and prepared without too rude a

blow, producing an unseemly fracture—may it ever be thus with you—may those kindly feelings and that amicable conduct which you have extended, I trust, one to the other, be continued. May the G.A.O.T.U. continue to support your Lodge by cementing and adorning it with every moral, social, and religious virtue. And my earnest wish to the Brethren of Rehoboam Lodge is, "That length of days may be in her right hand, and in her left riches and honour-may her ways be ways of pleasantness and all her paths be peace." "Masonic Sun."

#### THE LOOKOUT COMMITTE.

O NE of the most difficult problems, one of the most universal, and one of the longest standing, is how to secure the regular attendance of members at Loage meetings. Masters have resorted to various methods to arouse an interest on the part of indifferent members. They have made personal visits to them and urged them to attend. They have written letters, setting forth the needs of the Lodge, and appealing to them to renew their interest and encourage the Officers and those who are active in its affairs. Attractive notices have been sent out, giving in detail the work of the Lodge, reminding the members of their duty

and soliciting their co-operation.

The first two methods have in some instances resulted in good, and have led some members to attend the meetings and take an interest in the work of the Lodge. They are good as far as they go, but the ordinary Master cannot spare the time to make repeated visits that are sometimes necessary in order to secure an interview, and sometimes when he does see the Brother he finds him uninterested, and with one excuse or another dismisses the matter from his mind. He receives the Master courteously, listens to what he has to say, makes a half way promise, with a mental After the reservation, to be present at the next meeting. interview, he concludes that the Master is ambitious to make a good record, and his motive in visiting the members is a selfish one, and he does not consider it a Masonic duty to encourage selfishness, so the meeting night comes and goes but he is not present.

The letter is read, laid aside, or "filed for future reference." In the "multitude of business cares" it is forgotten, and the good intention that may have been framed in his mind is not carried out. The "attractive" notice is received by the persistenly absent member and in many instances finds its way into the waste basket unopened. In others it is simply glanced at and not wholly read. Some complain at the "squandering of money" on printer's ink.

And so it goes.

The great trouble in most Lodges is the failure to look after and develop those who are brought in. More attention is paid to bringing new men into the Lodge than to retaining and educating those already in. A candidate is raised, signs the bye-laws, and is then turned adrift to "paddle his own canoe" and look out for himself. If he chances to sail into smooth waters all right, but if he strikes upon shoals he must get along as best he can. It is of vastly more importance to the health, strength and vigour of the Lodge to develop the old members, to look after them, and help them to retain the enthusiasm of their Masonic youth, than

to confer degrees upon new men.

Bro. Charles A. Alden, Senior Warden of Washington Lodge, made a suggestion at the last meeting of that body which strikes us most favourably. It was to appoint a "Lookout Committee," whose duty should be to visit the absentees and urge them to attend the meetings, and to look out for them when they do come to the Lodge, extend to them the warm grasp of Brotherly love, and lead them to catch some of the enthusiasm which is found in others. If the absentees fail to respond after one visit, call again, and follow up the work in a kind and Brotherly way. The work of this Committee must be careful, persistent and continuous. The members of it must be on the lookout for an opportunity to meet some who need cultivation and impress them with the importance of their presence at the Lodge, and tell them of the pleasant and profitable meetings that are held. This, followed up day by day, cannot fail to

result in good to the Lodge.

There is much other good work that this Lookout Committee can do which will suggest itself to the thoughtful Mason.

#### NEW PROV.G.M. ANTRIM.

ONE of the most interesting ceremonies ever seen in Belrast will take place on the 15th January, when the Earl of Shaftesbury will be installed as Provincial Grand Master of the Province of Antrim. The last ceremonial of a similar kind in the city was the installation of the Most Honourable the Marquis of Hertford as Provincial Grand Master, in the month of October 1889, on which occasion a grand banquet was given by the members of the Masonic body in the Ulster Hall. The gitt of the dignity of Provincial Grand Master is the especial prerogative of his Grace the Duke of Abercorn M.W. Grand Master of Ireland, and the lot has fallen most worthily upon the Earl of Shaftesbury, who resides in the district and who promises to become exceedingly popular among the Brethren of the important Province.

A special communication of the Provincial Grand Lodge will be convened on the 15th proximo in the Exhibition Hall, Botanic Avenue, at 4 p.m. At this meeting the Duke of Abercorn will preside, and he will be attended by the Deputy Grand Master Sir James Creed Meredith, LL.D., and the Officers of the Grand Lodge of Ireland. The newly appointed Provincial Grand Master will then be formally installed with the customary ceremonials and honours of Masonry by the Duke of Abercorn, and having been duly saluted, the Prov.

Grand Lodge will be closed.

Subsequently, a grand banquet will be given in the Ulster Hall, under the auspices of the Deputy Provincial Grand Master Bro. R. J. Hilton, J.P., and the Officers and members of the Prov. G. Lodge of Antrim, in honour of the installation of the Earl of Shaftesbury, and at this banquet the Duke of Abercorn will preside. The Hall will be gaily and handsomely decorated for the occasion, and the arrangements of the tables will be similar to that of the banquet recently given to General Sir George White. The balcony has been specially reserved for the ladies, who will be supplied with refreshments in the Ulster Minor Hall during the evening. Arrangements have also been made for the orchestral band to be in attendance, and a choice vocal musical programme has been prepared to enliven the intervals between the various toasts. The members of the Order will appear at the banquet in full Masonic costume, representing the various degrees of Freemasonry.

#### NEW HALL AT NEWBURY.

A T a meeting of Brethren held in the early part of last week the arrangements for the dedication of the Masonic Hall were discussed and settled. The ceremony will be performed on the afternoon of Friday, 4th January, by the Dearthy Brownsial Grand Master of Berkshire Brown I. T. Deputy Provincial Grand Master of Berkshire Bro. J. T. Morland, Mayor of Abingdon, Past G. Deacon of England, assisted by the Provincial Grand Wardens and other Officers. Following this will come the installation of Bro. John Rolfe as Worshipful Master of the Loval Berkshire Lodge of Honor as Worshipful Master of the Loyal Berkshire Lodge of Hope for the ensuing year. In the evening there will be a banquet in the Council Chamber. It is hoped that the Provincial Grand Master Lord Wantage V.C. will be able to honour the gathering with his presence. The Mayor of Reading Bro. A. H. Bull and other representatives of Lodges in the Province, as well as distinguished Brethren from the Grand Lodge of England, are expected to be present.

The premises which have been converted for the purpose of providing a commodious Masonic Hall and ante-rooms are well adapted for such a use, being spacious, and on a convenient site within a few yards of Northbrook Street, one of the main thoroughfares. For a considerable period prior to the opening of the Municipal Buildings and the police-court, the house was the scene of the sittings of the Justices for the Newbury division, and also used as the Town Clerk's office during the lifetime of the late Mr. H. B. Godwin. The interior is notable on account of a quantity of oak panelling,

which has been carefully preserved.

The Masonic Hall, which is upstairs, is a handsome apartment, 40ft 6in by 17ft 6in, and the basement has been fitted up to meet the various requirements of the Brethren who will from time to time assemble within the walls in connection with the Royal Arch Chapter and the Craft and Mark Lodges. The entire work has been carried out most satisfactorily by Messrs. G. Elms and Sons, of Newbury and Marsh Benham, from plans prepared by Bro. W. Ravenscroft, Architect, of Reading.

Lyric.—Miss Kate Phillips has so charming a personality, and is so capable an actress in her special line of character, that we cannot but regret her selection of Mr. Robert Ganthony's farcial comedy "The Ring Mistress" for her first essay as a manageress. The very title is a misnomer, as there is not even a suspicion of the scent of the sawdust in the piece, the humour of which consists of a man committing bigamy with his own wife. Miss Phillips represents Mrs. Van Brown, who is designated as "a retired circus proprietress," but her husband is a photographer, who, finding the bonds of matrimony too galling, advertises for another wife. Mrs. Van Brown, by some occult means, finds this out, and answers the advertisement herself, with the result that the pair are re-married at an adjacent registrar's office. An appointment is made for the next day at Southampton, whither another couple, Alderman Grinstead and the Countess Mobrais, proceed for their honeymoon. The Countess wears a dress similar to that of Mrs. Van Brown and is mistaken by the peccant husband for his inamorata, but the fun that ensues is very forced and entirely improbable. After believing himself to be the murderer of his wife, Mr. Van Brown returns repentant to the studio, where explanations are made and the farce ends. Miss Phillips is vivacious enough as the jealous wife, but Mr. Robb Harwood is somewhat too heavy for the part of Van Brown. Two pretty characters, Ada Grinstead and Lawrence Mobrais are introduced, and are capitally played by Miss Victoria Addison, who makes her first appearance; and Mr. Michael Dure. Admirable assistance is also rendered by Mr. Webb Darleigh and Miss Beatrice Lamb, as the Alderman and Countess; by Mr. Chas. Garth as a Detective; and Mr. M. Clifton as Willie Wank. The piece requires to be played with greater briskness both in action and dialogue, but we cannot predict an overwhelming success.

Shelton, Tyler, Willes. and Norrie ably sustain the minor characters. The play is beautifully staged, and the incidental music, by Edward Jones, is clever and appropriate.
