FESTIVAL OF THE GIRLS SCHOOL.

THE one hundred and thirteenth Anniversary Festival of the Royal Masonic Institution for Girls, to be celebrated on Wednesday next, under the presidency of the Pro Grand Master of England the Earl Amherst, is looked forward to with considerable interest in different parts of the kingdom, but more especially so in Kent, where his lordship has been beloved and respected for many years as Masonic ruler of the Province; and we anticipate the Brethren under Earl Amherst's rule there will particularly distinguish themselves as a proof of loyalty and esteem for their worthy chief.

The task Earl Amherst has set himself, of advocating the claims of one of the Masonic Institutions, is not a new one to his lordship, and we can only hope that the result of his previous efforts in this direction may not only be equalled on the present occasion, but that such a total may be collected as will convince his lordship that he is more popular than ever, and that the love of the Craft for the Institutions of the Order is even stronger than it has shown itself to be in years gone by. We think we are justified in saying such a result is probable, in view of the number of Stewards working in behalf of the Festival, the only matter for regret in this connection being the absence of a really representative Board of Metropolitan representatives, little more than a fourth of the London Lodges being represented.

The Royal Masonic Institution for Girls is doing a good work, and the efforts of the Stewards of the year, and others working in connection with the coming celebration, may well be directed toward the continuance and even the extension of that work. There are at the present time 264 girls being educated, clothed and maintained by the Institution, and that too in such a manner as to fully qualify them for any position they may rise to in years to come. While rigid economy is practised on every side nothing is neglected likely to add to the comfort or improvement of the children, for whose future welfare the greatest concern is evinced by those who have the management of the Institution; indeed, the only complaints of which even whispers have been heard in recent years, is as to whether the work is not being done "too well."

The Craft has answered this question in the past, by yearly subscribing the funds necessary to carry on the work. and even to allow of a huge surp'us being invested; and great as are the needs of the Charity for the coming year, we have not the least doubt but that the outcome of Wednesday's Festival will be such as to allow of the work being continued, with the same high standard of excellence and, it may be, permit of a substantial addition being made to the invested capital of the Institution.

While on the subject of this accumulation we should like to ask the supporters of the Charity what good they imagine is likely to accrue if this surplus is allowed to go on increasing year by year as it has done in the last decade? We do not wish to ignore the possibilities of the proverbial "rainy day" coming to upset the affairs of this Charity, as it has done other equally good Institutions; but there is surely a limit even to prudence and forethough, when there are so many worthy objects around us on which to spend some of the

annual surplus. We think a sort of "sliding scale" arrangement might be introduced, providing for a half, or some other proportion, of each year's surplus income being spent on outside Scholarships, or in some equally advantageous manner; or even better still, commence the erection of a Junior or Senior School, on some eligible outside site, and so arrange for the permanent enlargement of the work of the Institution, without increasing the buildings at Chapham Junction, a course which we believe is regarded as being most undesirable, if not even impracticable in view of the crowded state of the locality.

The Province of Kent will, without a doubt, give a very good account of itself next Wednesday; and as a result of the coming Festival we shall not be at all surprised if the Committee find themselves in possession of a very handsome sum over and above what will be required for the year's work of the Institution. Could there be any better recognition of such a contingency than by the purchase of a Kentish estate—doubtless there are many most desirable sites which might be acquired—as the first step towards the removal of the School from London, a necessity which is becoming more and more marked year by year. But until the change is really found to be necessary the secondary School we have just referred to should alone be proceded

THE annual visit of Stewards to the Institution, and distribution of prizes to the successful pupils, will take place on Monday, the proceedings commencing at 4 o'clock, with the singing of the National Anthem, after which there will be the usual displays of calisthenics and marching, part songs and pianoforte selections by the pupils, followed by the distribution of prizes by the Countess Amherst. Tea and refreshments will be served at 5 o'clock, after which visitors will have an opportunity of inspecting the Institution. o'clock there will be a musical selection, the whole concluding with the singing of the National Anthem, at 7 o'clock.

***** DURHAM.

A LARGELY attended meeting of the Masters, Wardens, and Past Masters of the Sunderland Lodges has just been held, to consider the arrangements for the visit of the Provincial Grand Lodge of Durham to Sunderland in September. Bro. J. D. Todd was voted to the chair.

It was unanimously resolved, on the motion of Bro. J. C. Moor, seconded by Bro. E. G. Watson:—"That the Masters, Past Masters, and Wardens of the several Lodges meeting in Sunderland, having learnt with much satisfaction that Lord Barnard Provincial Grand Master-designate has expressed a desire to hold his first Provincial Grand Lodge meeting in Sunderland, hereby assures his lordship that every effort will be made to give his lordship and members of the vincial Grand Lodge a fitting reception.

It was also agreed, on the motion of Bro. T. James, seconded by Bro. D. D. Smith, that a copy of this resolution be forwarded to Lord Barnard, and to the Provincial Grand

Secretary Bro. R. Hudson.

It was agreed, on the motion of Bro. H. T. Halfpenny, seconded by Bro. F. Forster, that the Mayor (Bro. J. G. Kirtley) be asked to take the Chairmanship of the General Committee, consisting of the Masters, Wardens, and Past Masters of the Lodges in the town. His worship has consented to accept the Chairmanship, and will do his utmost to make the visit successful.

The following Officers were also appointed:—Vice-chairman, Bro. J. D. Todd; Secretaries, Bros. E. J. Willis and T. Harrison; Treasurer, Bro. Richard Todd. Sub-committees were also appointed. Brother Thos. Robinson P.P.S.G.D. represents the Provincial Grand Secretary on the Committee.

It was also agreed that a suitable memento of the event, in the form of an illuminated address in album form be presented to Lord Barnard on the occasion of his visit, this matter being placed in the hands of Bro. T. Robinson P.M.

HEREFORDSHIRE.

IT seems peculiarly fitting that the first Provincial Grand Lodge of Herefordshire to be held in the reign of King Edward VII., as Protector of the Craft, should, in the rotation of anniversaries, visit Leominster, in order to take place under the banner of the Royal Edward Lodge, because it is the memory of one of his Majesty's predecessors of ancient renown which is thus perpetuated in the local title. Interesting accounts of the Lodge and its possessions have already been published; suffice it to say, that Bro. J. B. Dowding Worshipful Master upheld the dignity of the Lodge and of the Craft generally in right royal manner on Monday, 22nd ult., in his reception of those who wear the purple. Although the Lodge is at present, we believe, not by any means the largest in the Province—but it would not be surprising to find it so very soon under its new Master-the assembly on Monday probably ranks among the biggest numerically of the last few years, the total being upwards of seventy. It was certainly one of the most enjoyable gatherings in the history of the Provincial Lodge, the Officers of the Royal Edward, as if put on their mettle, having made such arrangements as will furnish some of the happiest recollections of a life-time. The Town Hall was engaged and adapted for the occasion, the large plain room, in which Judge Lea and the magistrates ordinarily sit to adjudicate, being transformed into a splendid Grand Lodge by the Tyler of the Royal Edward Brother W. Baxter, with the proper Masonic furniture, and a profusion of banners and other decorative material; while Bro. W. Bradford, mine host at the Royal Oak Hotel, not only arranged the catering in first-class style, but induced several of his old Masonic friends in the musical world to come down from Westminster Abbey and other places to assist him in what is commonly called the harmony. Inasmuch as Leominster, and the Masonic Lodge especially, is rich in musical men, what with them and the visiting Brethren, the glorious old Masonic songs, as well as modern compositions, were heard to perfection. All this reflected honour on the W.M. and his circle of Officers. The only cause for regret was the inability of the Grand Master of the Province Lord Glanusk to be present. He had fully intended preciding as usual but lets. present. He had fully intended presiding, as usual, but late on the morning of Monday a telegram arrived saying that his medical adviser had ordered him south to the sea owing to the state of his health. However, Bro. H. C. Beddoe Deputy Provincial Grand Master proved an ideal substitute, his wide experience and spirited geniality ensuring a smooth and pleasant continuance of the programme.

After lunch at the Royal Oak Hotel, the Brethren proceeded to the Town Hall where, after formalities, the reports of the Lodges in the Province were handed in, and indicated a decided increase in the membership and a satisfactory financial condition.

Bro. W. W. Robinson, of Hereford, who had undertaken the Office of Secretary of the Herefordshire Masonic Charity Association on the retirement of Bro. T. Smith two years ago, presented his report in conformity with bye-law 20, pointing out that the individual subscription of a guinea a year for five years, or of several individual guinea subscriptions, constituted desirable amalgamations for using the votes. His report was as follows:—"Since this Association was formed, in August 1878, it has collected and remitted to the Masonic Institutions the following sums: To the Boys School, £504, to the Girls School £294, to the Royal Masonic Benevolent Institution (male fund) £173 5s, (female fund) £152 5s, total £1,123 10s. The Committee beg to remark that, as the Province of Herefordshire, through its successful candidates, has so largely benefitted by the funds of the

Masonic Institutions, it ought to subscribe more to those funds than it has hitherto done. In conclusion, the Committee have much pleasure in stating that this Association for the purpose of using the votes, has, by the kind permission of the Provincial Grand Master, been amalgamated with the Midland Masonic Provinces Association, which comprises Staffordshire, Shropshire, North Wales, and Herefordshire; also that the D.P.G.M. Brother H. C. Beddoe has consented to act as one of the Committee, together with the Hon. Secretary of this Association, Bro. W. W. Robinson P.Prov. S.G.D. It was added that the Midland Masonic Provinces Association had elected Bros. Beddoe and Robinson to represent Herefordshire on their Committee.

Still another very useful subsidiary organisation appeared in the form of the Herefordshire Local Charity Association, of which the seventh annual report was presented by Bro. Hewett, of Ross. It showed that the amount received during the year 1900 was £150 198 6d. The payments amounted to £128, so that the balance in hand had been increased during the year by £22 198 6d. The total amount granted since the formation of the Association had been £558, an average of £80 per annum, while the total receipts had been £893 148 7d. The Committee trust that the Brethren of the Province will continue the support which they have so generously given since the Association was established, and that it may continue to prosper and to help the needs of those who are really in want of assistance.

The D.P.G.M. said he had not received any notification from Lord Glanusk as to where the next Provincial Grand Lodge would be held. It was usual at this juncture to announce the place, and he assumed that Royal Arrow Lodge came next in rotation, but the Brethren would receive notice in due course.

SUSSEX.

THE "West Sussex Gazette" gives the following interesting particulars respecting the new chief of this important Province. The Earl of March comes of a family which has been long identified with the Masonic Fraternity. His grandfather, the fifth Duke of Richmond, was Provincial Grand Master of Sussex from 1823 to 1860. The fourth Duke also held the Office from 1814 to 1819. Another Duke of Richmond was in 1695 appointed Grand Master of England, he then being Master of the Lodge at Chichester; and he had, as Deputy Grand Master, Sir Christopher Wren, who was then engaged in the building of St. Paul's Cathedral. Lord March's Masonic career began in 1877, when he was initiated in the Lodge of Union, No. 38, at Chichester. Five years later he was Worshipful Master of this Lodge and also Senior Grand Warden of England. His brothers, Lords Algernon and Walter Gordon-Lennox, have also been Masters of the Lodge at Chichester. Lord March has also been First Principal of the Royal Arch Chapter in the same city.

NORTHUMBERLAND and DURHAM.

A SPECIAL meeting of the Provincial Grand Lodge has been convened by Brother Canon Tristram Provincial Grand Mark Master, to be held in the Central Masonic Hall, Newcastle, on the 16th inst, for the Consecration of two Mark Lodges for which Charters were recently granted.

The new Lodges are the Hartford, No. 546, which will hold its meetings in the Masonic Hall, Bedlington, and the Blagdon, No. 547, which will be held in the Masonic Hall, Beaconsfield Street, Blyth. The ceremony of Consecration will be performed by the Most Worshipful Pro Grand Master the Earl of Euston, assisted by Bro. C. F. Matier P.G.W. Grand Secretary, and other Grand Officers who have consented to visit the Provincial Grand Lodge on this interesting occasion.

The first principal Officers of the Hartford Lodge are Bros. Augustus E. Burdon Worshipful Master, Robt. Weddell Senior Warden, and James Treble Junior Warden; and of the Blagdon Lodge Bros. Adam Dodds Worshipful Master, John Tweedy Senior Warden, and Edward Forster Junior

Warden.

Amongst the Founders of the Blagdon Lodge are the names of many well-known Mark Masons, including Viscount Ridley Past Grand Warden of England. At the close of the Consecration ceremony a banquet will be held in the same Hall.

THE annual meeting of this Provincial Grand Lodge of Mark Masters will shortly be held at Sunderland, under the banner of the Union Lodge, No. 124. The local Brethren are making arrangements to accord a fitting entertainment on the occasion.

FREEMASONS IN ROME.

THE Freemasons have moved their quarters to the Giustiniani Palace from the Borghese. The latter was built some years ago by the Borghese Pope, and had always been the centre for rigid Catholicism. Then the family fell on evil days, and the palace passed into the hands of creditors, who rented the "piano nobile" to the Freemasons. Protest was vain, and the Masons remained until the Borgheses, by a rich marriage, regained their own. The Giustiniani Palace was built in 1580, in part with stones from Nero's bath. In 1170 an epidemic broke out in the city, and the whole Giustiniani family died with the exception of Niccolo, a monk. He at once, by a Papal Bull, left his monastery, married and raised twelve children. Having accomplished this duty to humanity and his house, he went tranquilly back, and died—a monk!—" Pall Mall Gazette" own Correspondent. ************

CUBAN MILITARY LODGE.

THERE is contained in a recent number of "La Gran Logia," of Cuba, printed in Spanish, an interesting account of the Cuban military Lodge, Independencia, and of its founder, Carlos M. de Cespides, President of the Cuban Bro. Cespides was an enthusiastic Mason and the Master of the Lodge at Manzanillo. He was a great student and owned the most complete Masonic library in the island of Cuba. He was a fine linguist, speaking English, French, Italian, German, and Portuguese, besides his native tongue. He was a strict ritualist and excelled as a presiding Officer.

Finding himself surrounded by Masons during the Cuban revolution he founded a Military Lodge in Guaimaro, and called it "Independencia." At first the Lodge met and worked in the various edifices which opportunity afforded, and when these were no longer available the Brethren erected spacious huts constructed from mud or palms and in these rustic structures the sessions of the Military Lodge were held. Those charged with building a "hall" on removal to a new place prepared their own materials.

The meetings held conformed as strictly to ceremonial and proper form as if the Lodge were meeting under ordinary conditions. There was continual work. The meetings were never interrupted, and many initiates, after receiving the first degree, came from a great distance to be passed and raised. General Ramon Cespides took the symbolic degrees in this Lodge and was one of its most ardent supporters. Francisco Aguilero, Francisco Maceo, Salvador Cisneros, Ignacio Mora, and others, distinguished in the Cuban war, met at these sessions and assisted in the work of the Lodge. The Offices of Master, Orator, and Secretary were held by the same Brothers throughout the life of the Lodge; the other positions

were filled by various Brethren.

Other Lodges might have had more luxurious quarters, more room, more perfectly arranged details, but none, could have had more seriousness or earnestness than prevailed in this Lodge. All the implements of the Craft were at hand, even to the ballot-box. All the Lodge furniture was carried from place to place on the back of a mule, which was appropriately called "The Mason." The columns were made of stones, which fitted to each other, marked with the B. and J. Once during an attack by the enemy the mule was turned loose, but the load was not securely fastened and in his flight many articles of the Lodge fell to the ground and were captured. The ballot box and a section of the B. column are now said to be on exhibition in the Museum of Artillery at Madrid, among other relics of batterfields.

The rigours of the campaign finally demanded the suspension of the Lodge and it was never resuscitated.— "American Tyler."

The King, Grand Patron of the Order, has been graciously pleased to accept a copy of the H. F. Beaumont manuscript, an ancient parchment roll containing the regulations of the Craft. The reprint has been edited by Bro. W. Watson, of Leeds, P.Prov.G. Warden and Hon. Librarian of the Provincial Grand Lodge of West Yorkshire, a wellknown writer on subjects relating to Freemasonry. The manuscript, which is ascribed to a date previous to 1690, was thought to have been lost, but was discovered at Whitley Beaumont, the residence of Mr. H. F. Beaumont, near Huddersfield, during last year. The roll was purchased from Mr. Beaumont by the Prov. Grand Lodge for the Library of the Province, which is now among the richest in early Masonic manuscripts of any library of a similar kind in the world, principally through the exertions of Bro. Watson. The manuscript is of great interest to members of the Order.

We tender hearty congratulations to Bro. T. F. Strutt P.M. 2664 W.M. 1679 on his appointment as Chief Sanitary Inspector to the Westminster City Council. Bro. Strutt is a highly-qualified officer, of very considerable experience in the Strand district. His unfailing courtesy to everyone with whom his duties brought him in touch, long ago secured for him a host of friends and well-wishers; he does not, happily, possess that peculiar trait so often noticed in public officers, of more or less importance, and nowadays dubbed "side," and appears to have won the same respect and esteem in the outside world as have marked his career in Freemasonry. Though Bro. Strutt's name was not that recommended by the Committee considering the applications for the appointment in the first instance, he obtained a large majority on a show of hands, and was ultimately elected by thirty-nine votes to twenty-two given in favour of his most formidable rival for the appointment.

Most intelligent Masons know that non-affiliation is not a crime, and that a Grand Lodge cannot make it a crime. It is equally true—though not so generally understood—that no Grand Lodge has any legislative jurisdiction over a nonaffiliate, and no Lodge can lawfully try a Mason for disobedience to a mere Grand Lodge regulation of a jurisdiction to which he does not belong. The non-affiliate is subject to the general laws of the Masonic Institution, but not to those of any Lodge or Grand Lodge. In the face of such travesties on Masonic law and common sense, a certain school of writers keep on reiterating the nonsensical assertion that when so august a body as a Grand Lodge "determines" any matter, its utterances are "absolutely binding" on all the world—whether it had any jurisdiction to "determine" the matter or not.—Wm. H. Upton, Washington.

Capitular Masonry is permeated with religion. At every step of its unfolding it points to Jehovah and to his blessed rule throughout the great universe of which He is the Creator. It presents itself in this character at every advancing step, and because of this profound religiousness—this aim of moral teaching; this call to faith, trust, and righteousness of life—it has abiding strength.—H. 

IN connection with the Irish Masonic Charities, a most interesting meeting was recently held in Belfast, which took the form of a social gathering. VALUE OF FREEMASONRY.

w E do not desire to startle the reader by any remarks that might be justly characterised as unduly laudatory, but we do wish to do justice to Freemasonry, and if in so doing we go beyond the views of some, we trust they will fairly weigh our remarks before they assume to cast them over

among the rubbish. The Masonic Fraternity is a wonderful one in whatever aspect it is viewed, the most wonderful that has come down to mankind through the ages. It is an elect society, and in numbers the elect are a great army. They could do anything they would; they choose to do only that which is for the highest and best advantage of themselves, and at the same time, and only in a less degree, for the advantage of their fellow-men; for whatsoever lifts up, morally and mentally, any class of men, indirectly benefits every other class. It is an ancient society. No one can locate, in time or place, its beginning. It has existed since a time beyond which the memory of man runneth not to the contrary. find evident landmarks of its existence back through the ages, even where little else is found. There is a charm to many minds in searching for evidences of its material works, and its labours of love. They feel that they are en route to an "undiscovered country," from which the traveller may return. They are encouraged by frequent "finds," and they thus go on, enlarging the boundaries of knowledge, and completing the history of the Craft. It is a charitable society, charitable in its best sense. It does not merely dole out pecuniary aid; the world can do that, and often does it. Whenever it gives it gives feelingly, fraternally. giving to a Brother, it feels that it is giving to itself. that it has belongs to the Brotherhood, and from its members in distress it can withhold none of its possessions. charity of Freemasonry is merely incident to its Brotherly Love. It is a moral society. Its morality is that of the First Great Light. All of its symbols and working tools are instrumental in teaching its "beautiful system of morality." It does not supplant the Church; it assumes only to be the "handmaid of religion." But it is a powerful ally. Its teaching is always and everywhere for good morals. It is an intellectual society. everywhere for good morals. It is an intellectual society. The philosophic system of Freemasonry, in its principles and teachings, is to the thoughtful observer its most remarkable characteristic. There seems practically to be no end to the beauty, force and variety of its philosophic system. Men of the largest culture and the profoundest thought find pleasure and profit in its studies. No one can give it attention without having the field of his reflections enlarged, and deriving intellectual pleasure of the highest character. The many may be satisfied with the spectacular exhibition of what is termed the "work of the floor." Even this they may see without comprehending more than its merest surfacemeaning. In doing so they throw away opportunities for the most satisfying and delightful instruction. Indeed, it is scarcely too much to say that they gather the husk and throw away the corn. This is owing, in part, to the Officers of Lodges, and other Masonic bodies, themselves. They do not explain, they do not illustrate. But this knowledge, which the Brethren cannot at times gather within the tyled doors, is not all contraband. Some of it, at least, nay, much of it, may be found in the acknowledged literature of the Craft. Freemasonry now has a literature of which it may justly be proud. The proceedings of its different Grand Bodies, and the Reports on Foreign Correspondence therein contained, are replete with instruction. The published works of such Brethren as Mackey, Fort, Lyon, Woodford, Hughan and Gould are worthy of the most careful reading. They give facts and principles that are truly Masonic. They are logical, accurate and entertaining. The Brother who has them in his Masonic library has an unfailing source of literary pleasure. He may know all of Freemasonry, and thereby become a complete Freemason. He becomes also, as a consequence complete Freemason. He becomes also, as a consequence, practically more regular and punctual in his attendance on his Masonic bodies, and more useful as a member. He is an intelligent member. He advises wisely, and acts promptly. He not only knows the work, but he understands its mean-He comprehends the entire scope of Freemasonry. him it is no longer a mystery. It should not be a mystery to any of its members. Yet alas, how many Master Masons are there in name, that are only Entered Apprentices in fact. They have been "brought to light," but afterwards have wandered into darkness. You must remain in the light, and

use that light, if you would receive its proffered advantages. Welcome the day when initiates shall no longer play Masonry, but fairly and earnestly work it. It is not a plaything. It is not a show. It is a Fraternity with unlimited capacities for enlarging the understanding, purifying the heart, and elevating the character of its Brethren, while at the same time it ministers to the healthy development of their social and convivial propensities. Whoever forgets this, or neglects it voluntarily resigns a part of his public heritage as neglects it, voluntarily resigns a part of his noble heritage as a Craftsman.—"Keystone."

We have stood and must still stand for great forward movements in the world of thought and faith. Masonry has at times been charged with being anti-religious, anti-Christian, anti-church. Never this. But when religion has sunk to superstition and Christianity to a rigid system, and the church to a priest or creed-ridden set or sect, then Masonry has entered her protest and plead for liberty. THE THEOLOGICAL LADDER.

An oration by Brother E. Hamilton, delivered publicly at the Court House, Wagoner (Indian Territory), in the presence of the members of the Grand Lodge and a large number of ladies and gentlemen—citizens of the City of Wagoner—15th August 1900.

THE religion of humanity through all the ages has never varied in its basic principles. In matters of detail divisions have arisen, controversy has flourished round doctrine, in questions of interpretation a multitude of leaders and would-be leaders have endeavoured to torce their views upon mankind. But under every form of belief the principles have ever remained the same. In the Babel of languages, in the conflict of races it would seem that the prevailing law was "Many men, many minds," and the common opinion was emphatically expressed in that most infelicitous of all terms, the word "Protestant," one who protests against everybody else's belief. On the surface the history of human opinion is a story of excess purposes it is a bettle ground at opinion is a story of cross purposes, it is a battle ground at once discordant and disgraceful. Men pursue shadows, forgetting realities; principles are ignored and details of no importance made paramount. Truth is in eclipse, and around its varied names are ranged the children of darkness, ready to battle and if need be to die for their Shibboleth. The Chinese Boxer is the present day representative of Torque-mada, the Dominician priest, and the "foreign devils" in the Middle Kingdom are the objects of hate of an Oriental Holy Office of the Inquisition. History repeats itself. The legations at Pekin remind us of the shambles of St. Bartholomew and the Sicilian Vespers; machine guns and Mauser rifles have taken the place of the amphitheatre and the Numidian lions; modern death-dealing instruments have superseded frying on gridirons, boiling in oil, the thumb screw, and the rack; and the hapless minority is done to death as in the times of Diocletian the Tyrant. In the strite of tongues, the clash of opinions and the changing of creeds, Masonry, the elemental religion, stands calmly looking on. In the great work of Humanity's reconciliation, Masonry assembles the sons of Light around a common and universal altar, and enforces a common and universal duty. Outside is the fierce and inhuman strife of competition, politics and religions, with its uncertainties, its doubts and its will-o'-thewisp chasing; around the altar of Masonry are perfect calm, peace and love of mankind through faith in God. This system of morality, veiled in allegory and illustrated by symbols, is a religion in the true sense. Religion is a bond of union, not an element of discord; religion binds men together as a band of brothers, and cannot and ought not to separate the children of men. Religion being universal, as well suited to proclaim righteousness to the wandering Arab of the desert as to the cultured product of civilisation, should therefore have in it no element that will appeal to one race and not to another, to one age and not to the next. Among the many symbols of the ancient Craft that teach Among the many symbols of the ancient Craft that teach morality, the primæval religion, the Theological Ladder is the clearest in conception, and the most perfect in its development of truth. Clear in conception, for the simplest mind may grasp it in its fulness, perfect in its development of truth, for it holds the key to the problems that men in all ages of history have endeavoured to solve. Let me quote: "Heaven, where all good Masons hope at last to arrive by the aid of that Theological Ladder that Jacob in his vision saw ascending from Ladder that Jacob in his vision saw ascending from earth to Heaven, the three principal rungs of are Faith, Hope and Charity, and which admonish us to have faith in God, hope in immortality and charity to all mankind. Faith may be lost in sight, hope ends in fruition, but charity extends beyond the grave to the boundless realms of eternity." The three greatest moral forces, says Bro. Albert Pike, "are Faith, which is the only true wisdom and the foundation of all government; Hope, which is strength and insures success: and Charity which is beauty. strength and insures success; and Charity, which is beauty and alone makes animated united effort possible." The first invocation pronounced at the initiation of a candidate for Masonry, appeals to the Almighty Father of the Universe. The Deity is not hailed as the God of the Saxon, the Latin or the Mongolian; He is not invoked as being attentive to one race and careless of the other. He is the All-Father, the Almighty Father of all the children of men. The prayer may fall on unheeding ears, its breadth of vision, its comprehensiveness may be lost on the audience, but it is a summary of Masonic belief.

"Father of all—in every age, In every clime adored, By saint, by savage, and by sage, Jehovah, Jove or Lord."

I do not wish to be understood as implying that the idea of God is the same everywhere and to all men, but I do insist that the faith in God which is the foundation of Masonry is not a belief in a restricted God, in a limited God, in a circumscribed God. Faith too frequently is a profession in a being who loves a sect, who is bolstered up by a creed, who is delighted by a certain hedged-in ceremonial faith, is too often understood as implying acceptance of one race and the rejection of the other, and still too frequently as the arraying of one class of men against their Brethren as good and as honest as they. The history of human faith is a record of blood. Hate has been the animating principle instead of love, and men speak of religion only to abuse each other. Faith, in the common understanding of it, is responsible for the majority of the wars that have devasted the world. From the murder of Cain to the assassination of Christian Chinese, from the earliest pages of human history to the newspaper annals of to-day, faith in a God has been the paramount issue productive of human suffering, bloodshed, and death. So Masonry assembles the sons of Light around a common altar, where controversy can never find entrance, where differences of opinion are silenced, where creeds are dumb, where all tongues, and races, and classes, where all the ages can worship, and cries out:—" Almighty Father of the Universe—we do not invoke Thee because Thou lovest us and hatest Thy other children, because Thou hast revealed Thyself to us and not to others; but realising that the greater the knowledge the greater the responsibility, the greater the light the greater the positive duty, we assemble here, and call Thee Father, the Father of all the children of · men.'

"To Him on high, no great, no small, He fills, He bounds, connects, and equals all."

It was this faith that led Abraham from Ur of the Chaldees, that made Moses the deliverer of the enslaved makers of bricks without straw; it was this faith in the Ali-Father that has animated the reformers, the prophets, the Saviour of mankind. This faith is the only true wisdom. I have no desire to enter into the question of the evidences of the Divine existence, for I am addressing a body of men who believe in rim, to every one of whom it has been said on their confession of Him: "Your trust being in God, your faith is well founded," but I wish to consider the human side of this great truth. And this leads me to the second rung of the Theological Ladder—Hope—which has been defined as an anchor sure and steadfast that enters within the Veil of the Holy Place. Hope is another Faith—taith in self by reason of faith in God—from wisdom comes strength. The Supreme Architect of the Universe, the Uncreated Wisdom, has left nothing to chance. His purposes are from everlasting and His plans are devised of old. "Are not two sparrows sold for a farthing, yet not one of them shall fall without your Father knowing it. The hairs of your head are numbered. If God so clothe the grass which to-day is and to-morrow is cast into the oven, how much more will he clothe ye? Ye are of more value than many sparrows."

This is the language of the Great Light in Masonry, telling us of the great care and love of the Almighty Father, and it makes men strong. Have faith in yourself, my Brother, because God lives. You have been taught that you are a man and a Mason, and given in charge ever strictly to walk as such towards the great destiny of immortality that awaits you. "No one," says Richter, "is so much alone in the world as a denier of God." To this statement I would add another: No one is so much alone in the world as a denier of man. Man, the heir of all the ages, if he know himself, his destiny, his power, his opportunities, if to this knowledge are added the activity, the resolution, the courage, the hope that springs therefrom, man is a ruler, the master. But if he ignores all this—if life be but a struggle for physical existence and comparative comfort, a ship without a rudder or compass on an unknown sea, drifting in the darkness to an unknown shore—the very creation is in league against him to make him unhappy. No man can succeed in life who does not believe in himself. I can say this in no spirit of Pharasaism, but in the hope of setting forth an exact truth. We are what we think; we act according to our own estimate of the greatness or littleness of life. This is the key to success or failure. A man

who thinks himself of little consequence will act in keeping with his views; while the man who knows and who wills can take the material, the mental, and the very spiritual things of existence and make them do his bidding. When the kings and nobility of Europe attempted to throttle civil liberty and enslave the masses, there were men of the people who said: Trace your genealogy back, if you wish, to some conqueror or tyrant of yesterday, and by it prove that your blood is blue and ours is simply red, and by reason of that you have a divine right to govern wrong, but we can trace our genealogy back to the very origin of the race, and there we find in God's doomsday books our names inscribed as His very children. So they arose in the might of their splendid manhood, and on many a hard fought battlefield the cry of God and liberty rang out in glad accents of glorious victory. When at the buth of this nation the glorious victory. patriots insisted that all government is based on the consent of the governed, they simply gave expression to the faith they had in themselves, that they were able to manage their own affairs and work out their own destiny, not only without the assistance of king, prince, or potentate, but in spite of them. As it is in the larger sphere of national affairs, so it is in the more limited sphere of individual life. Character cannot exist without faith in oneself, and the stronger the character the stronger the faith. I take it then, that hope is the adapting of faith in God to one's own personal life, having a high estimate of our own nature elevated and refined by the processes of religious development and civilisation, and I insist that no man who has a mean opinion of himself, in the invidious sense of that term, can ever be anything but a mean, contemptible man. How life is glorified by this faith in oneself; how difficulties are overcome by

"The mighty hopes that make us men."

Great men, says a prominent socialist, are great only because we are on our knees; let us arise in our manhood and we will find ourselves as great as they; on what meat, says Brutus, has this our Cæsar fed that he had become so great; all expressive of the same thought. Masonry makes us meet on the level of equality, but that level is a high ideal of true worth and manhood, no longer in darkness, but brought to the light of its possibilities, its powers, its grand destiny. Hence the second rung of the theological ladder. Hope, which springs from faith in God, or true wisdom, is productive of strength. Strong hearts are more than coronets, and simple faith than Norman blood, says Tennyson. The greatest of these is Charity. Let us place our feet on the third rung of the symbolical ladder, that charity that extends beyond the grave to the boundless realms of eternity, which cannot exist without faith and hope, inasmuch as it is a logical consequence of them. Faith in God, faith in oneself by reason of that faith in God, and faith in our fellow-men because God hath of one blood made all the nations of men that dwell on the face of the earth. Faith not simply in our own nation or race, but faith in all men. This faith in our fellow-men is the grandest and most sublime of all Masonic teaching, and without its exemplification there is not nor can there be any true religion. This confidence in man is clearly inculcated in every degree of Ancient Craft Masonry. Moses had faith in the ignorant and semi-savage Israelites in Egyptian bondage, or he would never had led them out to become a great nation, and legislate for all nations to the end of time. Captain Phillips at Santiago had faith in his blue jackets, when he said, "Don't cheer, the poor devils are This Government had faith in its citizens when it dying." initiated a struggle with Spain to remove the unutterable cruelty of its rule from the island of Cuba. The great powers have faith in civilisation in attempting to force their views of righteousness upon the yellow race. This duty of faith in one's fellow-men has been called in national life "The White Man's Burden," and whatever mistakes are made, and there are and will be many, yet the ultimate outcome will be harmony, equilibrium, beauty. It was in some such sense that the Psalmist cried out: Worship the Lord in the beauty of holiness, of help of charity of faith in one's fellows. There is no hope for the progress of any race of men, or for any individual of the race without faith in them-faith often betrayed, faith made use of by the recipient to injure, but faith undimmed, charity cloudless nevertheless. This has an ennobling influence on our own lives. If we have no faith in our fellows, or charity for them, we are small, suspicious, resentful, coveteous; if we look on them as men,

with all the possibilities of manly development and progress, how we enlarge our own character, and ennoble our own nature. We shall frequently be misunderstood, often imposed upon, the unworthy will misconstrue our motives and take advantage of our faith, but what of that? Confidence begets confidence, and faith produces faith. The bewilderment of the defeated tribes of the desert, who do not understand the trend of civilisation, is aptly set forth by Rudyard Kipling, who depicts one of them saying in his amazement:

"Allah created the English mad, the maddest of all mankind.

They do not consider the meaning of things, they consult neither creed or clan;

For behold they clap the slave on the back, and behold he becometh a man.

They terribly carpet the earth with dead, and before their cannon cool

They walk unarmed by twos and threes, and call the living to school."

In the light of the teaching of the symbolical ladder, all governmental, national and racial problems can be solved, and in no other can there be a correct and righteous solution. This is the primitive religion, of which all teaching is either a development or an explanation; this is the religion of humanity through all the ages, never varying in its grand and elevating principles:

Faith, Hope, Charity; Wisdom, Strength, Beauty.
The holding up of which and the exemplification of which if persevered in will bring to pass: The Parliament of Man the Federation of the World.—"Masonry.

I think it may be stated without qualification that any body of men and women organised upon right principles, and for a good purpose, though primarily calculated to benefit only its own members, does nevertheless, exert a potent influence far outrunning its immediate object and aim. Masonry, therefore, though established upon the idea that it is a Brotherhood limited by its membership, must, and does, help toward the consummation of universal Brotherhood. In this respect, and in many others, it very nearly approaches the idea of the family and the home, and as the recognition of the family tie, and the mutual interest of the members of the family, constitute the very basis of our civilisation, so the recognition of Masonic ties and the sentiment of mutual helpfulness tend to uplift civilisation as a whole.—Orville H. Platt, Connecticut.

Charity does not consist solely in furnishing financial aid to the needy (though that is a duty not to be disregarded); but where there is one opportunity for action in this direction, there are a score where our duty is just as plain: to assist and sustain a falling Brother; to whisper good counsel; to vindicate his character; to keep a tongue of good report; to judge not. Who can measure the power for good of these duties well done? Misfortune may come to you, friends forsake you. Slander may smirch your good name.
