BERKSHIRE.

THE annual Provincial Grand Lodge was held in the Guildhall, Windsor, on Tuesday, 29th inst. The Deputy Provincial Grand Master in charge Brother John Morland presided, and many members of the Grand Lodge of England as well as of the Berkshire and other Provinces attended. A resolution was adopted recording the sorrow of the Brethren at the loss the Province had sustained by the deaths of the Grand Master Lord Wantage, the Grand Chaplain the Rev. E. Adams, and the Grand Treasurer Bro. Charles Stephens, and condolence with their respective families was unanimously agreed upon.

****** WEST YORKSHIRE.

THE half-yearly meeting of this Provincial Grand Lodge was held on Wednesday afternoon at the Church Institute, bradford. Bro. R. Wilson Deputy Prov. Grand Master presided, and there was a large attendance of mem-

bers, only six Lodges being unrepresented.

The Deputy Prov. Grand Master, in addressing those present, dealt with the history of the Craft in Bradford. He remarked that the first authentic record related to the holding of a meeting in the town by the old Lodge from York in 1713. The Hope Lodge was formed in 1794, and was followed by others, until now there were eight Lodges in the city. While in other large centres of industry in the Province there had been sprinklings of failures during the past century Bradford stood out exceptionally strong, every Lodge having gone forward and prospered. Just fifty years ago the Most Worshipful Grand Master of England the late Lord Zetland, accompanied by the Grand Lodge, visited Bradford to lay the foundation stone of the St. George's Hall. Speaking of recent events he mentioned that on the 8th October the new premises of the St. Laurence Lodge, at Pudsey, were opened, and on the 22nd the

Regent Lodge at Barnsley was consecrated.

Bro. H. S. Childe (Vice-Chairman of the Charity Committee), in presenting the report of the Committee, stated that in April they elected nine cases from West Yorkshire to the Masonic Institutions in London, and one was presented under the Heaton testimonial. A fortnight ago the Committee elected two boys and one girl. He urged the Brethren to qualify for Stewardships for the Royal Masonic Institution for Boys during the coming year, and intimated that there were already twelve candidates for the elections, which would take place next April and May—a larger number than they had ever before at one time. The report

was adopted.

The Deputy Prov. Grand Master then presented and invested Bro. H. G. E. Green Provincial Grand Secretary, on his appointment as Past Grand Sword Bearer in the Crast and Past Assist. Grand Director of Ceremonies in the Arch, with his Grand Lodge clothing, which had been subscribed for as a mark of affection by the eighty-one Lodges of the Province. In doing so Bro. Wilson spoke of the eminent services of Bro. Green to the Province, and added that he regarded the appointments not only as an honour to Bro. Green, but to the Province.

Bro. Green, in thanking the Brethren, pointed to the progress Freemasonry had made in the Province during the sixteen years he had held office as Secretary. The number of members was now 4,339, and during the sixteen years there had been a complete change in the membership of the Province. Upwards of £75,000 had been collected and sent to London for the Masonic Central Charities, and £70,000 of that had passed through his bands. In the same £70,000 of that had passed through his hands. In the same period they had elected 178 candidates to the Charities,

which had necessitated the collection and manipulation of 457,000 votes.

The Hon. Librarian Bro. W. Watson thanked the

Brethren for their support of the library.

Bro. J. T. Last moved a resolution with respect to the method of election of the Grand Treasurer of England, arguing that the present method of personally tendering votes was unsatisfactory, and entailed great inconvenience and expense upon the Brethren in the Provinces. Bro. Major Bolton seconded the motion, which, however, was ruled out of order, and was dropped.

The proceedings shortly afterwards terminated. dinner was held in the Masonic Hall, Rawson Square, and

was well attended.

NORTHUMBERLAND.

THE annual convocation of this Provincial Grand Chapter was held on Monday afternoon, 28th ult., at the Masonic Hall, Grainger Street West, Newcastle, the Provincial Grand Superintendent the Right Hon. the Viscount Ridley presiding over a large attendance.

It was arranged that the next meeting be held under the Berwick-on-Tweed Chapter at Eerwick. In the evening a banquet took place at the Central Station Hotel, a large

number of Companions being present.

****** MARK MASONRY.

-: 0: SOMERSETSHIRE.

THE annual meeting of the Provincial Grand Lodge of Mark Master Masons of Somersetshire was held on the afternoon of the 25th ult., at Yeovil, under the banner of the William de Irwin Lodge, No. 162, and the presidency of the Provincial Grand Mark Master Bro. R. C. Else.

The Prov.G. Secretary Bro. T. F. Elworthy first called the roll of Lodges, and every Lodge throughout the Province

was found to be represented.

Bro. Watts Prov. G. Treasurer presented the accounts for the year, showing a balance from last year of £80 19s 11d, and that the cash in banker's hands at the present time was £60 IIs 7d, the reduction in amount being explained by the fact that a donation of £21 had been sent to the South African Masonic Relief Fund. The accounts were adopted, and Bro. Watts was re-elected Prov. G. Treasurer, and heartily thanked for his past services.

The Prov. G.M. proposed that a sum of fifteen guineas be granted from the funds of the Prov. G. Mark Lodge to the Mark Benevolent Fund, and placed upon the list of the Brother who undertakes the Office of Steward at the 1902 Festival. Bro. Watts seconded the proposition, which was

agreed to.

Bro. Else Prov. G.M. expressed his regret at the absence of Bro. Colonel Long D.P.G.M. who, he remarked, was now entering on his third year's active service in South Africa. For some time after he got there, Colonel Long wrote stating that he rather liked the climate and got on very well, but unfortunately lately he had suffered from the heat, and his health did not seem to be as good as it was. His son too has been seriously wounded, and was now in Netley Hospital, and under those circumstances Colonel Long would no doubt be glad to return home at no distant period. They all sincerely hoped he would soon be able to do so, and that they might once more have the pleasure of shaking him by the hand. He had very great pleasure in again nominating Bro. Colonel Long as his Deputy for the ensuing year.

The Prov. G.M. next proceeded to appoint and invest

the Officers.

Bro. Else said for the third time in succession at the Prov. G. Lodge he had to bring before them a motion for the appointment of another Prov.G.M. (Cries of "No.") He thought it almost a disreputable thing for the grand old Province of Somerset that it should continue to be represented by such a "lame duck" as himself—(renewed cries of "No")—as he was so feeble on his legs that he could not get about with any comfort, and he really felt that the time had now come when he should stand aside in favour of one who could devote more constant personal attention to the duties. He hoped, therefore, they would now accept his nomination for the ensuing three years of Colonel Long, who had served them so well and faithfully as Deputy Prov. G.M. He would invite his esteemed Bro. the Prov. G. Chaplain, as a matter of form, to second his proposition.

Bro. R. Frazer Frizell Prov. G. Chaplain said it was

with great reluctance that he rose to disobey the command of the Prov. G.M., and instead he would respectfully submit that in having already nominated Bro. Colonel Long as his Deputy the Prov. G.M. had precluded them from accepting the proposition he had made. Although he had called himself a "lame duck" Bro. Else had again shown that day that his faculties were unimpaired, and that he would still continue to discharge very efficiently and satisfactorily all the duties appertaining to the high and honourable Office he filled at the present time, and which they were all so

desirous he should continue to retain.

Bro. Else expressed his great appreciation of all the kindness shown him, but hoped that some Brother would favour him by seconding the nomination of Colonel Long.

Bro. G. T. Dunsford P.P.S.M.O. remarked that as an

old P.M. of Bro. Else's Mother Lodge he had much pleasure in seconding the observations of the Prov. G. Chaplain, and he was confident that he was giving expression to the feelings of the Brethren generally throughout the Province when he asserted that Bro. Else's severance of his long and valued connection with them would be deeply deplored by one and all of them, and regarded as nothing less than a calamity. They all trusted most earnestly and fervently that he would be able to see his way clear to retain the Office of Prov. G.M. for at least another term.

The Prov.G.M. thanked the speakers for their kind

expressions, and said he presumed the nomination must go

up without a seconder.

The Prov. G. Chaplain formally proposed that Bro. Else's nomination of a successor be not accepted, and this was seconded by Brother Dunsford, and agreed to with acclamation.

The customary banquet afterwards took place at the Mermaid Hotel.—"Western Daily Press."

SERVICE AT STALYBRIDGE,

THE corner-stone of the new infant schools connected with Christ Church, Stalybridge, were laid on Saturday afternoon, 19th ult. The occasion was made memorable by afternoon, 19th ult. The occasion was made memorable by the presence of the Provincial Grand Lodge of Cheshire, the chief corner-stone being laid by the Hon. Alan de Tatton Egerton, M.P., Provincial Grand Master, assisted by many

members of the Craft. Prior to the ceremony a procession took place through the streets of Stalybridge.

The new schools are intended to accommodate about 240 children, and are designed to further the useful work hitherto carried on at the Christ Church Schools. The Hon. Alan de Tatton Egerton, in declaring the principal stone well and truly laid, spoke of the connection between Masonry and education, and especially of education which had for its object the teaching of Church principles. masons, he said, looked upon work of that kind as one of the great promoters of their Masonic science, because in teaching the youth of this country the great principles of Churchmanship they were laying the foundation of a Masonic

The Provincial Grand Master afterwards declared the stone to be well and truly laid, after which Mr. Platt-Higgins, M.P., expressed on behalf of those present their grateful

thanks for the presence of members of the Order.

At a later stage the Hon. M. White-Ridley, M.P., laid another corner stone. The hon, member was presented with a trowel by Alderman Fentem. In the course of his speech, the hon, member said there seemed to be an idea that education was to be developed by cramming, but they in Stalybridge knew that under the direction of the Rev. J Grant Bird that was not the aim of those who taught the children who attended Christ Church Schools.—" Manchester Courier.' ********

LIVERPOOL MASONIC HALL.

UNDER the chairmanship of Bro. E. R. Latham P.P.G. Treasurer, a numerously attended meeting of the Masonic Hall Committee was held on the 25th ult. at headquarters in Hope Street. It appeared from the minutes of the House Committee that Bro. J. S. Willis had been appointed hall porter in succession to the late Bro. Glass.

On the motion of Bro. Captain J. Macnab P.P.G.J.W., seconded by Bro. J. Scott P.P.G.S.B., and supported by several Brethren, the subjoined resolution was passed, with only one dissentient:—"That from the 1st January 1902, the Masonic Hall Committee shall at its own cost provide and maintain for the use of the Lodges and Chapters meeting in the building all furniture, such as chairs, pedestals, tables, and banners of the R.A. degree; that all Lodges and Chapters be invited to lend their existing furniture, as above specified, to the Hall Committee for the purpose, and instruct their Tylers to co-operate with the Committee's servants in the care and preservation of the same; and that a written document be given to each of the Lodges as to its ownership of the property thus entrusted to the keeping of the Committee." *******

PROPOSED NEW LODGES.

ARRANGEMENTS for the formation of a Bethnal Green Borough Council Lodge are, in the able and energetic hands of Councillor Read, making good progress. It will, the "Eastern Post" hears, start with twenty Founders, while a number of well-known gentlemen are expected to become initiates. Contrary to what has been stated, the Lodge will not be exclusively confined to members of the Council. It would, manifestly, be impossible to form a Lodge from among the members of the Council alone, observes our contemporary.

A P.M. has addressed the following letter to the Editor of the "Southend Echo": "Knowing the interest you take in local Masonry, I shall esteem it a favour if you will allow me through the medium of your columns to make a suggestion to the Brethren who are located at this, the West-end of the town, and that is that the time has now arrived for the founding of a Lodge identified with this district, as the phenomenal growth of Westcliff has been the means of attracting and retaining as residents a large number of Brethren who for various reasons have not associated themselves with local Masonry, but who would doubtless be glad of an opportunity of joining a Lodge in this district, with its many social advantages. I need not remind you, Sir, of the excellent accommodation we have in our midst in the Queen's Hotel, and I feel sure that Bro. Wagstaff and Mr. Goring would do all in their power to make Brethren comfortable, and the Lodge a success; and whilst I should be very sorry to advise taking any steps that would prove hurtful to the prospects of the Masonic Club, it appears to me that the new Lodge in the Borough would indirectly benefit the Club, as the bulk of the joining or new members would feel it their duty to support an institution that has been so very useful to Southend and visiting Brethren. Should you think this idea worthy of a thought, or better still, should any of your Masonic readers write you on the subject, I should be pleased to hear from you with a view to a preliminary meeting or such other steps as may, in your wisdom, be considered best."

It is announced that another medical Lodge, on the same lines as the Rahere (St. Bartholomew's) and London Hospital Lodges, will be consecrated on Monday next, in the Governors' Hall of St. Thomas's Hospital and that the Duke of Connaught M.W. Grand Master will himself undertake a most important portion of the ceremony. The Lodge, which will be numbered 2870 on the roll of the Grand Lodge of England, will be called the "Cheselden," after the name of the great anatomist and surgeon of St. Thomas's who introduced the operation of lateral lithotomy. The Officers named in the Warrant are Bros. Thomas Wakley jun., L.C.R.C.P. Lond., W.M., H. H. Clutt, F.R.C.S. Eng., S.W., and G. J. Crawford Thomson, M.D. Durham, Junior Warden.

It is proposed to mark the jubilee in Masonry of Sir Horatio Lloyd Deputy Prov. G.M. of Cheshire, by the Prov. Grand Officers and Brethren in December next, with some appropriate memento of such an interesting occasion. The exact form the presentation will take has not yet been arrived at, but we have no doubt the response of the Brethren will be a most loyal and Masonic one. This reminds us that, according to Bro. John Armstrong's "History of Cheshire Freemasonry," Bro. Richard Newhouse, the veteran Prov. Grand Secretary, will celebrate his jubilee as a Mason in 1902. Bro. Armstrong, while praising a long series of D.Prov.G. Masters and Provincial Grand Secretaries for the manner in which they kept the minutes, awards the palm to Bro. Newhouse. "His minutes," says Bro. Armstrong, "are illuminated throughout, and are splendid examples of penmanship, to be handed down from generation to generation as specimens worthy of emulation."—"Manchester Courier."

Bro. F. A. Philbrick, K.C., Past Grand Warden responded to the toast of the Grand Officers at the installation banquet of the Horsa Lodge, No. 2208, held at Bournemouth last week. He remarked that for seventeen years he served as Deputy G. Master of the Province (Essex) over which the Earl of Warwick Deputy Grand Master of England presided, and a more popular ruler and more agreeable man never lived. Selected by the King as his Deputy, Lord Warwick was a typical Mason, and he claimed for the Grand Officers that they were wisely selected and worked well. Bro. Philbrick also proposed the health of the W.M., reminding the Brethren that the Master was an Initiate of their Lodge, and had risen step by step to the proud position he now held. They as Masons adhered closely to the ancient landmarks of the Order, and elected a new Master every year.

Sir Augustus Webster, who has just been appointed Grand Master of the Hampshire Masons, is one of the cleverest amateur banjoists in the kingdom. Before he married and retired from the Guards, in order to look after the family estates and Provincial Masonry in Hampshire, he was regarded in the brigade as a "cert" for any kind of entertainment whether got up for the amusement of the officers' friends or the charitable and benevolent funds of the Guards in general. He was one of the prime movers in the famous Guards' burlesques of some ten years ago, and in company with Mr., now Captain, Nugent took principal parts in singing, acting, dancing, and banjoing. His retirement was much regretted by the regiment, not only on account of personal popularity, but also as a severe loss to the regimental "company."—"Tatler."

A dinner was given to Bro. Alfred J. Thomas a few days ago by a few of his friends to congratulate him on his recent appointment as P.A.G.D.C. The dinner took place at Oddenino's Imperial Restaurant, Regent Street, and was of a most enjoyable character. The chair was taken by Bro. Thomas Fraser W.M. of the Eccentric Lodge, one of the Lodges to which Bro. Alfred Thomas belongs, and there were present: Bro. Alderman Vaughan Morgan, Colonel Probyn, L.C.C., J.P., Under-Sheriff Langton, H. J. Gardiner, J. Morrison McLeod, Carl Hentschel, W. J. W. Beard, and M. R. Sewill. In proposing the health of the guest of the evening, Bro. Fraser expressed the pleasure that was felt by all Bro. Thomas's friends at his receiving Grand honours. To the toast of the Grand Officers Bros. Alderman Vaughan Morgan and McLeod replied.

It is not often we hear of a Lodge Secretary being voted direct to the chair, although it seems to us to be a ready means of recognising faithful service on the part of a Brother who may not happen to be Past Master of the

Lodge in which he fills the onerous position of "recorder." This was the view taken by the members of the Orpheus Lodge, No. 1706, who unanimously elected Bro. R. J. Hennings P.M. 2508 P.P.G.D. Essex as W.M., in recognition of the indefatigable discharge of Secretarial duties, the other Officers foregoing promotion for a year as a testimony to the value of Bro. Hennings's work. He was duly installed last Saturday.

We were particularly pleased to meet a very old friend the other night in the person of Bro. Egbert Roberts P.M. P.Z., and still better pleased to hear him in splendid voice. "The Veteran, as he likes to be called, assured us he was singing as well now as ever, and after hearing him we quite agreed. Bro. Roberts is open to provide artistes for installations and banquets, and when a quartette is not required Bro. Roberts can bring one artiste with him—a Brother or a Lady vocalist. "A SPRIG OF ACACIA."

One of the most widely known members of the English Craft, and a fellow worker with ourselves for many years past in the field of Masonic journalism, was called to his rest on Saturday last. Bro. George Kenning died suddenly at his residence at Sydenham, at the age of sixty-five. Our deceased Brother was the founder of the "Freemason" and the "Masonic Magazine," and issued many other works in connection with Freemasonry, and his death will be greatly regretted in many quarters. He was one of the leading members of the Lion and Lamb Lodge, and took a lively interest in many other Masonic bodies; was a Past Provincial Officer of Middlesex, and a warm supporter of all of the Masonic Charitable Institutions. We tender our sympathy with the members of his family in their great bereavement.

THE death took place at Newport, Mon., on Sunday, at the age of 52, of Bro. Richard Alexander Forsyth, rails inspector and engineer of the Indian States Railways, who had twice been W.M. of the Isca Lodge, and was its Treasurer at the time of his death. He was P.Z. of the St. Woolos Chapter, was Scribe E. of the Provincial Grand Chapter, E.P. of the Gwent Preceptory of the Knights Templars, and R.W.S. of the Ivor Hael Chapter of the Rose Croix

AN exceedingly wide circle of friends and acquaintances will regret to learn the death of Bro. W. Coulter, of Cotehele, Calstock, which took place on Monday. Deceased had been many years in the Earl of Mount Edgcumbe's service as steward. He was seventy-one years of age. A zealous Freemason, he had been W.M. of Cotehele Lodge, and Prov. G. Pursuivant, the latter being an appointment made by the noble Earl as Provincial Grand Master of Cornwall.

THE funeral of Bro. Dr. Alfred Aplin, medical superintendent of the Notts. County Lunatic Asylum, who died on Monday of last week, took place on the 24th ult. at the Church Cemetery, in the presence of a large number of mourners. The members of the Craft present included the Provincial Grand Secretary and members of the Royal Sussex Lodge, of which deceased was a Past Master.

THE death is announced of Bro. Philip Rowland, of Swansea and Neath, who was the "father" of the Cambrian Lodge, No. 364, which meets in the latter town.

CIRENCESTER JUBILEE,

AT Cirencester on Wednesday evening, 16th ult., an interesting celebration took place: the Cotteswold Lodge, numbered 592 on the roll of Grand Lodge, celebrating on that evening the fiftieth year of its existence. As a fact, the commemoration was intended to have taken place in January last, but the sudden death then of one of the Lodge's oldest Past Masters the Rev. C. J. Martyn Past Grand Chaplain of England, and the subsequent national mourning, led to its

postponement.

The Lodge was constituted in 1851, chiefly through the exertions of the late Bro. Newmarch, who was afterwards Deputy Prov.G.Master of Gloucestershire. Up to the date stated, the Cotswold capital had been without a Lodge for many years, but it is interesting to note that it was the birthplace of the Royal Union Lodge, No. 246, now meeting in Cheltenham. The Warrant for that Lodge was issued in July 1813, under the Grand Mastership of the fourth Duke of Athole, and the Lodge was known as an "Athole" or "Ancients" Lodge until a few months later, when "Ancients" and "Moderns" united under the rule of HPH the Duke united under the rule of H.R.H. the Duke " Moderns ' of Sussex, and Grand Lodge was constituted as it now continues. It is a singular fact that in the same year a second Warrant, originally given to a Lodge meeting at the White Lion Hotel, Bristol, was transferred to Cirencester, and both the Royal Union and the Royal York Lodge (the second Lodge referred to) were warranted as meeting in Cirencester, at the King's Head Hotel, for some years after 1813. Neither of them could have been, however, in a flourishing condition, for in 1820 the Royal York Lodge died of inanition, and was erased from the roll of Grand Lodge, and in the following year the Royal Union Lodge was transferred to Cheltenham, on the purchase of its Warrant, regalia and jewels by Freemasons in that town who deemed the creation of a second Lodge necessary. Cirencester was thus without the "light of Masonry" from the year 1821 until the date of the foundation of the Cotteswold Lodge in 1851. Its old Warrant had, however, remained in active and prosperous working in Cheltenham, where the paraphernalia which it handed over with the Warrant in 1821 is still in regular use. At the constitution of the Cotteswold Lodge two Brethren at least of those who were members of the Royal Union thirty years previously took part: Bros. R. Anderson and Bowly, both names well known to Cirencester, and a descendant of the former is now a Past Master of the Lodge.

The Lodge met at 6.15 under the presidency of the W.M. Bro. C. Mackinson, Bro. the Right Hon. the Earl of Bathurst being Senior Warden.

The Lodge was honoured by the presence of the Right Hon. Sir Michael Hicks Beach, Bart., Prov. Grand Master of Gloucestershire, and Bro. Bevir Prov. G. Secretary Wilts P.G.D.C. Eng. Chairman of the Masonic Boys School. The first-named distinguished Brother is the oldest surviving Past Master of the Lodge, and it was a notable incident of the evening's proceedings that Bro. M. H. Hicks Beach, a son of the Prov.G. Master, was elected a joining member of the Lodge, he having been initiated into Masonry in St. Helena, in which island Freemasonry has a flourishing growth, during his recent service there with the

4th Gloucestershire Regiment.

At a banquet after Lodge, over forty Brethren sat down, presided over by the W.M. during the earlier part of the proceedings and subsequently, when a professional emergency called him away, by Bro. Harmer I.P.M.

In proposing the health of the Prov. Grand Master and Prov. Grand Lodge, the W.M. recalled the fact that Sir Michael became a member of the Lodge in 1856, only five years after its foundation, and that he occupied the Master's

chair exactly forty years ago.

The Prov. Grand Master, who was received with the utmost enthusiasm, said it was true he was "father" of two bodies of great importance: one was the House of Commons and the other was the Cotteswold Lodge. He would not attempt to gauge the relative importance of those two bodies on that occasion, but speaking at Cirencester he was inclined to think that the Cotteswold Lodge was the more important, and to assert, even in the presence of Bro. Norman, that the town in which it met was the "hub of the universe." In spite of the distant dates to which the W.M. In spite of the distant dates to which the W.M. had referred, he did not feel quite worn out yet, and he was endeavouring still to do his duty as their Provincial Grand Master; but it was a matter of some pain to him to look round those tables and to think that he was addressing so

many present whose fathers were among his dearest friends. Still, he hoped he might make friends with the sons as he did with the fathers, and he felt sure that the younger generation was doing its best for Masonry in everything connected with the Cotteswold Lodge, of which they were now celebrating the fiftieth anniversary. He referred with satisfaction to the fund that he understood was being raised, and with considerable success, to suitably celebrate that event, and offered the suggestion that it might be applied to the

provision of a Masonic Hall for the Lodge meetings.

Later in the toast list "Visiting Brethren" was proposed by Bro. the Hon. Ben. Bathurst, M.P., P.M. and P.Prov. S.G.W., and acknowledged by Bros. Norman and Pettit (Mayors of Cheltenham and Wallingford respectively), and Bro. Wood S.W. of the Hicks Beach Lodge, Stroud. Bro. Norman, in his reply, said that he readily acquiesced in any proposition Sir Michael laid down, and he did not therefore challenge his estimate of the relative importance of the two institutions of which he was "father, or the position of Cirencester in the universe. Indeed, he might claim for Cirencester additional distinction in the fact that, though it was celebrating the jubilee of its Lodge that night, the more ancient Lodge to which he belonged had its birth nearly a century ago among Cirencester Masons. He had in his possession probably the only copy extant of the Bye-laws governing the Lodge in its old Cotswold days. They were quaint and amusing: one made provision for the treatment of any member who attended "disguised in liquor." Though the fact that that bye-law seemed to have been found unnecessary when the Lodge moved to the vale need not be quoted to the detriment of Cirencester, he thought it might fairly be instanced as a token of the change that had taken place not only in Masonic Lodges but in the habits of the people during the past century.

Among other toasts, the Masonic Charities was pro-posed by the Prov. Grand Master, and Bro. C. Tudway P.P.G.Reg., in responding, showed that since 1878 the Cotteswold Lodge had contributed no less a sum than within a few shillings of £2,500 to the three Masonic Charities, a record which Sir Michael said he believed could be equalled by few Lodges of like numbers.—" Cheltenham Examiner."

************ NEW HALL AT COLCHESTER.

VARIOUS projects for building a Hall for the Angel Lodge, No. 51, have fallen through, but at last the members of the Lodge, having acquired a site in Abbeygate Street, Colchester, have commenced the erection of a Masonic Hall from plans prepared by Mr. Charles E. Butcher, architect. The builders are Messrs. Henry Everett and Son. The accommodation includes a Lodge Room, 26ft. by 45ft. on the first floor, and a room of like dimensions on the ground floor. There are in addition various rooms and offices. first contract is over £2,000. It is proposed to heat the building with hot-water pipes, and to light it by electricity. The Lodge Room proper will be kept for Masonic purposes, but the other parts of the building will, it is expected, be largely used for meetings and entertainments.

At 1130 on Thursday morning of last week Lodge was opened at the Cups Hotel. By special dispensation from the Prov. G.M. the Brethren wore Craft clothing during the procession to the site of the Hall immediately after the opening of the Lodge. First came the Tyler with drawn sword, followed by the members of the Lodge, the juniors being in front. Next came the Architect with the plans, followed by the J.D. bearing the trowel, and the S.D. with the mallet, the Secretary with the Book of Constitutions, and the Treasurer, who bore the phial which later was deposited in the stone. The visiting Brethren came next, and were followed by the J.W. with the plumb rule, and the S.W. with the level. The Chaplain, bearing the Volume of the Sacred Law, immediately preceded the W.M. bearing the square, and after him came the Mayor Bro. Claude E. Egerton-Green P.M. 51 P.P.S.G.W. and P.P.G. Treasurer. Members of the Town Council brought up the rear of the procession.

The head of the procession having arrived at the site, the Brethren opened out to the right and left to allow the Mayor and officiating Brethren to proceed to their places on a platform specially erected near the south-east corner of the intended building.

The D.C. having proclaimed silence, the Mayor gave a brief address. He said that Freemasons were true and faithful to the laws of their country, and engaged in solemn

obligations to erect buildings to be serviceable to the Brethren, and to fear God, the Great Architect of the Universe. They had secrets, but they were honourable, and not repugnant to the law of God or man. They had been entrusted in peace and honour to Masons of ancient times, and having here lawfully transmitted to the present generation of Free been lawfully transmitted to the present generation of Freemasons, it was their duty to convey them unimpaired to the latest posterity. If those secrets had not been honourable, the Masons would not have lasted for so many centuries, nor would so many illustrious Brethren have joined the Order. They were assembled that day to erect a house to the honour and glory of the Most High, and wherin local Freemasons might practice their Craft.

The Chaplain Brother Rev. Pierrepont Edwards then offered prayer, at the conclusion of which the Mayor called upon the Secretary Brother T. J. Ralling P.M. P.G.A.D.C. Provincial Grand Secretary Essex to read the inscription on the stone. The inscription was as follows:—"This corner stone was laid with Masonic ceremonial by Claude E. Egerton-Green, Esq., M.A., J.P., D.L., Mayor of Colchester, P.P.S.G.W. and P.P.G. Treas. Essex, October 24th, 1901."

The phial, containing coins, a copy of a local paper, and programme of the ceremony, having been deposited by the Treasurer Bro. A. S. B. Sparling in the cavity, the J.D. Bro. H. G. Elliott presented an inscribed silver trowel to the Mayor, and requested him to set the stone. An Entered Apprentice presented the cement, which was spread on the upper face of the lower stone. The upper stone was on the upper face of the lower stone. The upper stone was then slowly lowered with three distinct stops, the Mayor standing to the east of the stone, with the W.M. bearing the Square on his right hand, the Wardens going to the west with the Level and Plumb Rule. The Mayor, having proved the "just position and form of the stone by the Plumb Rule, Level, and Square, which were successively handed to him by the J.W., S.W., and W.M., his Worship gave the stone three raps with the mallet, which was delivered to him by the S.D. Bro. J. G. Laver. The Mayor having next inspected the plans, delivered the same to the Architect, together with the plans, delivered the same to the Architect, together with the tools used in proving the position of the stone. At the same time, His Worship desired the Architect to "proceed without loss of time to the completion of the work in conformity with the plans.'

After a hymn the Benediction was pronounced by the Bishop of Barking Bro. Dr. Stevens P.G.C., and the Architect having presented the Mayor with the Trowel, the procession then formed in inverted order, and proceeded to the new Town Hall, in order that the ceremony of unveiling the statue of Queen Victoria, which is situated at the top of the grand staircase, might be performed by the Mayor.
The Director of Ceremonies was Bro. Ives.

The statue, which represents the late Queen seated in her coronation robes, holding the globe and sceptre, is of white marble, and is on a pedestal of red marble. The total height is 7ft. 6 inches. The statue was executed by Messrs. L. J. Watts, Limited, at a cost of some £300. It is the gift to the town of Alderman H. G. Egerton-Green, and is placed at the top of the grand staircase in front of the memorian at the top of the grand staircase, in front of the memoriam window of Mr. William Warwick Hawkins, who was M.P. of the Borough, 1852-57.

After the processionists had taken their places, Councillor Wilson Marriage, Chairman of the New Town Hall Committee, said he was glad to report on behalf of that Committee that the erection of the statue of her late Gracious Majesty Queen Victoria had been completed. Having alluded to the fact that the donor worthily filled the office of Mayor of Colchester during the Jubilee year of the late Queen (1887), and again the year of the Diamond Jubilee (1897), he said it seemed very appropriate that they should receive from his hands this handsome gift in memory of their late Queen. The only this reference that they of their late Queen. The only thing they regretted was that the health of Alderman H. Egerton Green did not permit him to attend. It was a great pleasure to think that the work was completed, so that a member of the family of the donor could unveil it before the conclusion of his year of office. It was an added gratification to the inhabitants of Colchester to know that the whole work had been carried out by Colchester people.

The Mayor, previous to performing the unveiling ceremony, said he had received a letter from Alderman H. Egerton Green, asking him to present the statue on his behalf. It also stated that he originally meant it to commemorate the Diamond Jubilee, but now he wished to dedicate it to the pious memory of the best Queen England

or the world had ever seen. His Worship then expressed the pleasure he felt at performing the ceremony on behalf of his uncle. He alluded to the very serious illness which prevented his uncle from attending. He then curtain aside, and "God save the King" was sung. He then drew the

Continuing, his Worship said that, as Mayor, it gave him the greatest pleasure to receive that very handsome addition to the decoration of their Town Hall. Putting aside the personal element, he thought that everybody in the town would recognise that it was one more instance of the Alderman's generosity, and his desire to do all he could for the borough. He congratulated Colchester and Messrs. L. J. Watts, Limited, on the production of such a work of art.

This was the first occasion on which Masonic clothing had been worn in public in the town since the members of the Angel Lodge laid the foundation stone of St. Mary Magdalene Church, in 1853.

******* NEW HALL FOR MARYHILL.

A NEW hall erected in Wyndford Street, Maryhill, for the use of the Maryhill Lodge, No. 510 (S.C.), was consecrated and formally opened on Wednesday, 23rd ult., by Bro. John Graham of Broadstone Prov.G.M.

In the course of the evening Bros. Graham and Campbell Prov.G.Sec. were each presented with a gold mounted umbrella, in recognition of the services rendered to the Brethren of Maryhill in securing a suitable place of meeting. The new Hall is constructed to hold 300, in addition to which there are ante-rooms and other necessary accommodation. *******

IS HE QUALIFIED?

MEN sometimes gain access to Masonic Lodges and become influential members therein, who are so narrow-minded, so indifferent to the true intent of Masonry and so utterly selfish in working only for the advancement of their own interests, that they use the power their position gives them to prevent the admission of others, against whom they may have a personal grudge.

Nothing can be more despicable than such conduct as this, and the individual who exhibits such spleen has not in his composition the material out of which to build a genuine Mason, at least on short notice. To oppose the candidacy of a good citizen—a kind husband and father, a man generous in thought and act, and confessedly clean in his relations with society—simply because one has, for some reason perhaps impossible to rationally explain or justify, conceived a dislike to such individual, is totally indefensible, and one who does it is wholly out of his sphere in the Masonic Lodge room. We may honestly dislike the man personally, and find neither enjoyment nor benefit in his company; he may not belong to our church, or believe as we do about baptism or transubstantiation; he may not vote with our party; he may be an unreasonable democrat, an unreflecting republican or an unphilosophical populist; he may not be a member of our club or set or take his daily plunge in our social bathing hole; he may eschew what we revere and champion what we loath and flaunt the flag of arrogant independence and universal heterodoxy in our face at every turn, and yet, strange as it often seems, be a good man after all and as justly entitled to a seat in the New Jerusalem as ourself, and hence as fully entitled to all the privileges and honours of Masonry. In spite of his being out of affinity with us he may pay his debts, love his wife and children, have beating in his bosom a kind heart and really desire the betterment of mankind. Personal predilection for or against should not govern us in our yes or no when the admission of a member is under consideration. The only proper action is for us to weigh the candidate as to character and qualification for Masonry. If he meets the requirements bar not his way, though he may be your aldermanic competitor, while if when put on the scales he be found wanting, you should stop his Masonic advancement though he were your political campaign manager.—"Indian Freemason."

WE have heard some pretty tall stories of high degree Masonry in the United States of America, but our cousins across "the herring pond" will have to look to their laurels, if there is any foundation for the following, which we extract from the "Manx Sun," and which would seem to point to a society having a membership of about seven millions, or so:

The Sheikh was first received into the Order twentyone years ago. *******

MASONRY AT THE FRONT.

AMONG the Boers there are scores of Freemasons, and

"It is a well-known fact out here," writes an "Answers" reader from Middelburg, that if a soldier who is a Mason

happens to be made prisoner by the Boers he is treated much better than his non-Masonic confrères."

"One particular instance, he says, was of an officer of the Imperial Vocasaria" of the Imperial Yeomanry who was captured in the Orange River Colony. GOVERNMENT BY FREEMASONRY.

A REMARKABLE PROTEST FROM TAMWORTH.
THE municipal elections at Tamworth appear to be turning in a singular fashion upon the question of Free-masonry in the Town Council. An appeal has been issued to the electors by the Tamworth and District Ratepayers' Association, in which the hope is expressed "that they will unite not only in resisting the importation of any further Freemasonry into the authority and Council, but that stringent efforts will be made to expel this undesirable element from the public life of the town, as the first step towards the promotion of its higher interests."

Along with the appeal there is printed a long letter from Councillor Frederick Alldritt, J.P., showing the extent to which the Tamworth Council is permeated and dominated by members of the Masonic Fraternity. Mr. Alldritt declares that from 1888 down to the present year every Mayor of Tamworth, with one exception, has been a Freemason. With a single exception likewise,

ALL THE ALDERMEN HAVE BEEN FREEMASONS,

and are so to-day. "Until the County Court Judge, Mr. H. W. Sadler, and myself were placed on the Commission of the Peace the Bench consisted of four Freemasons and four others, with a Freemason always in the chair." The Borough Council, according to Mr. Alldritt, contains six Freemasons out of a total membership of sixteen, and they hold the chairmanships of the Estate, Lighting, General Purposes, Fire Brigade, Castle, and Waterworks Committees. "All Committees," the writer says, "have been carefully constituted so as to afford the Freemasons and their unswerving supportors as to afford the Freemasons and their unswerving supporters power to swamp and monopolise the whole of the Council's proceedings," and he adds that the Town Clerk, the Surveyor, and the Medical Officer are also Freemasons. The charges pressed against the Masonic Fraternity by Mr. Alldritt are that "on any and every question, almost invariably, the Freemasons always act together on any matter introduced by or affecting the interests, directly or indirectly, of a Freemason," and that "every piece of extravagant or unreasonable expenditure, during my connection with the Council, has emanated from, or been supported and carried out by the aid of Freemasons."—" Birmingham Daily Argus."

SIR,—I observe in your issue of to-night that Mr. Alldritt has carried a domestic squabble from this borough to your columns, so as, I suppose, to obtain a wider publicity than he can obtain here. We in Tamworth are all familiar with Mr. Alldritt's catalogue of insinuations, innuendoes, and baseless assertions in respect to public work in our borough, and we value them at their true worth. But since he has obtained by your paper a medium for further

spreading his absurd statements, I trust in all fairness you will permit me a reply on behalf of a large number of ratepayers. First, let me say that in the early part of this year Mr. Alldritt made similar assertions against the Tamworth Rural District Council, but the members of that authority quickly brought him to book, and when Mr. Alldritt was asked to substantiate without any evasion his assertions ne was totally unable to do so, with the result that the District Council unanimously passed a vote of censure upon him. Since then the Rural District Council has heard no more of Mr. Alldritt. At the present moment this gentleman, who airogantly assumes to himself all the honesty and fair mindedness of the borough, has launched a series of charges directed against the Borough Surveyor, who has discharged his duties honestly for the last twelve years. Not one of these charges has Mr. Alldritt been able to substantiate, despite the fact that he has access as chairman of the Finance Committee to every detail of information.

Now as to the particular charge he brings against Free-

he has access as chairman of the Finance Committee to every detail of information.

Now as to the particular charge he brings against Freemasonry, that also is baseless, as can be easily proved. He says, first of all, that from 1888 down to the present time every Mayor has been a Freemason. The facts are that in each of the following years, namely, 1890, 1891, 1894, 1895, 1896, 1897, and part of 1898, the Mayoral chair was occupied by gentlemen who were not Masons. The Town Clerk was appointed several years before he became a Mason. Mr. Alldritt says that, with a single exception, all aldermen have been Masons. There are only four aldermen in the Council, and until quite recently these were not Masons. He also says that a Freemason has always been in the magisterial chair. That is also incorrect. The senior magistrate is not a Mason, and, again, the Mayor of the borough is chief magistrate and always takes the chair by virtue of his office, and it follows, therefore, that during the years I have stated above the magisterial chair was not occupied by a Mason. Mr. Alldritt further says that out of sixteen members of the Council, six are Masons. He is correct there, but he fails to remember that the election of the Mayor and of the Aldermen is made by the Council, so that if the Masons had been such a bad lot as he says they are, they could not, of course, of themselves have elected a single alderman, so that Mr. Alldritt's shaft in this respect fails to hit the mark.

Further, the same remark applies to the election of the chairmen of the various committees, but as a matter of fact every chairman was elected unanimously. Mr. Alldritt says that the Masons have always acted together and that "every piece of extravagance or unreasonable expenditure has emanated from and been supported and carried by the aid of the Masons. But the thing is absolutely absurd. The Masons according to Mr. Alldritt's has no substantial basis, and if certain members of the corporation and certain officials would only do the bidding of Mr.

The majority of Tamworth people feel that the good name of the town is, as you fairly observe with regard to your own City Council, "being dragged in the mire by unscrupulous zealots, who have no respect either for age, character, or life-long service."

It is a notable fact that almost the whole of the £4,000 required to purchase our Castle for the public enjoyment has been secured by a Mason in the Council, and of that money £300 has been subscribed by one Mason, who also some years ago erected a public baths and institute for the town, as well as a Cottage Hospital for the district, which has been a great boon. You might search from now to Doomsday to find a record of the subscriptions to the Castle Purchase Fund of Mr. Alldritt's principal supporters.
