Ir is officially announced that the list of contributions to the testimonial proposed to be given to Miss DAVIS, in recognition of her valuable services, as Head Governess, during the last twenty-five years, of the Royal Masonic Institution for Girls, will be closed on the 15th prox. We have no doubt the results will be in all respects satisfactory, and that the testimonial, when complete, will be worthy alike of Miss DAVIS's acceptance, and the Craft's bestowal. But it is just as well to give prominence to this announcement, as there are, probably, brethren who would be much aggrieved if their amounts did not arrive in time to be included in the general total.

THE Mark Grand Lodge appears bent on following the same line of conduct, in respect of its Grand Treasurership, as the Craft Grand Lodge, by annually electing a fresh man to the office, instead of, as heretofore, reelecting the same man annually. At all events, there are already two candidates in the field, who will be nominated at the winter half-yearly communication on Tuesday, the 30th November, namely, Bro. J. L. MATHER, Vice-President of the Board of General Purposes, and Bro. EDGAR BOWYER, a Past G. Std. Br. (Craft) of England. Both are good men, and both have had large experience in the conduct of Masonic affairs, Bro. MATHER being already a member of the General Board of the Mark Degree. It has been even whispered that Bro. CAMA, the present Craft Grand Treasurer of England, may allow his name to be put forward. But, be this as it may, we know there are the two candidates we have mentioned in the field, and if the contest lies between them ultimately, we have no doubt if will be a close one, for both these brethren are calculated to confer honour by their election to such an office, though it is, of course, impossible that both of them can be elected for service in one and the same year.

BRO. BURDETT-COUTTS, M.P., spoke to very good purpose the other day at the meeting of the Abbey Lodge, Westminster, when he insisted on the importance of accurate working in our lodge ceremonies, and brethren who aspire to be lodge rulers will do well to take his advice to heart. A Master is paying a very poor compliment to the lodge which has elected him to its chair, when he performs his duties in a slovenly and perfunctory manner, or when, in absolute ignorance of the most important of those duties, he is obliged to call upon some brother to perform them for him. We are not all gifted with the same power of committing things to memory, and one man may succeed in knowing his part more perfectly than another, just as of two whose knowledge is about equal, one may be able to carry it out more impressively than the other. But it is well known there are many brethren among us who are incompetent to work either of the Three Degrees or even to open or close the lodge without some one being at hand to help them through the task. Yet they are elected W.M.'s, and at the close of their term of office are presented with the usual jewel in recognition of their valuable services. It is quite possible, of course, that they may have rendered such services, but they have also done the lodge the disservice of setting to the members an example of laxity in work which cannot be otherwise than prejudicial. If a brother intends offering himself as candidate for any office, let him follow the example of Bro. BURDETT-COUTTS, and obtain a knowledge of the duties that he will be called upon to perform. If he cannot make up his mind to undertake this small amount of trouble, then let him stand aside for others who, while they regard office as an honour that is worth aspiring to, are not unwilling to discharge its duties in a creditable or passable manner.

### PROVINCIAL GRAND LODGE OF DEVONSHIRE.

### WEDDING GIFT TO LORD EBRINGTON.

WEDDING GIFT TO LORD EBRINGTON.

The Provincial Grand Lodge of Devonshire held its annual meeting on the 20th inst., in the Town Hall, Devonport, under the banner of Friendship, the oldest lodge in the borough. The meeting was very largely attended, about 500 brethren from all parts of the province being present. The R.W. Prov. G.M., Viscount Ebrington, presided, and was supported by Bros. Rogers, D.P.G.M.; Brewer, Secretary; John Dodge, Treasurer; the Rev. W. Whittley, of London; Gover, Frederick Binckes, P.G. Stwd. of Eng.; and W. J. Hughan, of Torquay, Past G.S.D. Bro. W. Derry was in his place as P.G.S.W., and nearly all the other officers of Prov. Grand Lodge were present. Among the brethren signing the book were the following Past Provincial Officers:—

The Secretary reported the number of members in the province to be 2604, against 2564, showing an increase of 40 on the year. Lodges 70, 250, and 954 had each subscribed ten guineas, which, by the regulations, had to be supplemented by equal sums from the Prov. Grand Lodge Funds, in order to entitle those lodges to become Life Governors of the Charities. Lodges 70 and 250 were, by seniority, entitled to the grants, and 954 would have to wait for awhile.

The TREASURER reported a balance in hand of £84.

The Deputy Prov. Grand Master presented the report of the Fortescue Annuity Fund, which showed that during the past year £750 had been invested in Exeter Asylum Bonds, and £150 distributed in annuities. The balance in hand was £42 18s. Sd., and the capital account showed a total

of £2432. Bro. Gover read the report of the Committee of Petitions, which stated that the province was now drawing from the Charities no less a sum than £1154 per annum, whilst its average donations and subscriptions only reached the sum of £376. The province had been for some time largely dependent on the assistance of other provinces in order to elect Devon candidates whose cases were urgent, and it was still largely indebted to them for valuable assistance. The Committee recorded their especial thanks to Bro. S. G. Homfrey, of Newport, Mon., for his ready assistance, and especially on a late occasion when there was urgent necessity for electing an esteemed member of the province. The Committee felt that they would be ungrateful if they did not put on record an expression of their deep sorrow and regret at the loss sustained by the death of Bro. Charles Godtschalk-(hear, hear)who for so many years transacted their business in London so wisely and zealously. The fact of his having had 124 votes annually in his own right for the great London Charities will cause his memory to be revered. The report of Bro. Whittley, as the London representative of the province, pro tem., had been received and adopted. A vote of thanks was given to him, and he was appointed the representative in London, with power to arrange the votes of the province. (Applause.) The Committee referred with regret to the increasing number of applications for relief, constituting a heavy strain on the limited resources of the Provincial Grand Lodge. The various claims had been carefully considered, and they recommended the following sums be granted:  $-\pounds_5$  to a brother of Lodge 106. Exmouth; £5 to a brother of 248; £10 to a member of Lodge 223, Plymouth; £5 to a brother of 1550, Plymouth; £5 to a widow of a late brother of 282, £10 to a brother of 39, Exeter; £5 to a widow of a late brother of 666, Princetown; £5 to a widow of a brother of 1099, Stoke; £5 to a daughter of a late brother of 1125, Tiverton; and £10 to a widow of a late brother of 700 Tothes. 710, Totnes.

On the motion of the Rev. W. WHITTLEY, who met with a very cordial

reception, the report was adopted.

Bro. E. T. FULFORD, of Exeter, proposed that the London representative be requested to inform the Prov. Grand Master the amount required to relieve the province of its liabilities in respect of 3000 votes owed to other provinces, and that when the amount was known an appeal should be issued to every lodge in the province to subscribe towards it.

This, seconded by Bro. Andrews, was carried unanimously, the feeling of the meeting being in favour of a special effort to relieve the province of its liability, rather than to postpone the election of its candidates to the great

The Prov. G.M., accepting the gift, assured the brethren that he felt he had done very little to deserve so beautiful a present. The duties he had performed as Prov. G.M. during the last seven years had not been heavy, and he had always been assisted most readily by Present and Past Provincial Grand Officers, and by none more so than by Bros. Rogers and Brewer, whom he might call his permanent staff. His aim always had been to administer the province with impartiality and justice, and though conscious of many failings, he gladly regarded their handsome gift as an appreciation of his efforts, and as an expression of their opinion that the welfare of the Craft had not suffered at his hands. (Loud applause.) His marriage had brought him a great deal of happiness, much of it in consequence of the goodwill it had evoked from all classes with whom he had been brought into contact, and which had culminated in that present from an ancient and honourable Society, in which all classes and all interests were represented. (Applause.) This was not the first present his family had received from the Masons of Devonshire. Years ago his grandfather, who ruled over the province, was presented with a beautiful centre-piece, which had been bequeathed to the family as an heirloom of the Castle Hill estate. (Applause.) He (Lord Ebrington) hoped to do the same with their beautiful gift, and he was sure they would all join him in the hope that his wife, who was the daughter of the Provincial Grand Master of North Wales— (applause)—would be spared to wear it for many years, and that their friendship might be as bright and as durable as the gems of which it was composed. (Loud applause.)

In answer to a BROTHER the Prov. G.M. said he should be happy to do whatever the Craft in general, with the Devonshire Province in particular, thought was the best way of celebrating the jubilee of the Queen, to whose

family Masonry owed so much. (Applause.)
The lodge was closed in due form.

In the evening about 120 brethren attended a banquet at Bro. Rogers's, Newmarket Hotel, Plymouth. Lord Ebrington presided, and was supported by Bros. A. Brickwood Hutchings, Mayor of Devonport; W. Derry, Rev. H. G. Morse, Rev. W. Whittley, and D. Cross. The gathering was the inauguration of the handsome new dining-room which Bro. Rogers has recently added to the hotel. It is 40 feet long and 26 feet wide, with a handsome covered ceiling and a spacious skylight. The walls of the room were draped with flags, and the effect was heightened by evergreen decorations. The approaches to the hall were also draped, and were lit with handsome coloured lanterns. A capital banquet of seven courses was served on elegantly laid tables.

After the banquet the Prov. Grand Master gave "The Queen and Craft," referring to the approach of her Majesty's jubilee, and to the aid Masonry had received from the members of her family.

The fees received from Provincial Grand Officers amounted to £31 8s.; fees and contributions from lodges for the Charity Fund, £164 2s.; Provincial Grand Lodge Fund, £245 15s. 3d.; and Fund of Benevolence, £245 15s. 3d.—total, £655 12s. 6d. The total expenditure of Prov. Grand Lodge for the year amounted to £1356 5s. 10d., leaving a balance to be carried over of £1900 16s. 8d. Of this £21 1s. 10d. stands to the credit of the Charity Fund, against £66 19s. 10d. last year; £115 19s. 6d. to the credit of the Provincial Grand Lodge Fund, against £510 4s. 4d. last year, and £1763 15s. 4d. to the credit of the Fund of Benevolence, against £1928 18s. 7d. The expenditure during the year included grants of £105 each out of the Charity Fund to the Hamer Benevolent Institution and the Royal Masonic Institution for Girls; and grants of £290 from the Fund of read, were passed. The receipts for the year amounted to £3257 2s. 6d., each out of the Charity Fund to the Hamer Benevolent Institution and the Royal Masonic Institution for Girls; and grants of £290 from the Fund of Benevolence to 15 widows of deceased Masons and four distressed brethren, whilst £210 was granted from the Provincial Grand Lodge Fund to the West Lancashire Educational Institution. The other items of expenditure comprised £100 salary of the Prov. Grand Secretary, and £84 8s. 11d., Prov. Grand Secretary's travelling expenses.

Bro. GOODACRE, P.G. Sec., in his usual annual report, stated that the condition of Freemasonry in the province was very satisfactory, During the past year three new lodges had been consecrated. The initiations during the same period numbered 573, against 506 in the previous year, and the number of subscribing members was now 4790, as compared with 4608. He would remind the brethren of the desirability of exercising the greatest care against the admission of unworthy men into the Order, as the character of the candidates conduced to the real welfare of Masonry much more than mere numbers. He further referred in terms of congratulation to the fact that proficiency in the working of the various lodges had been maintained, and, with the view of still further enhancing the value of their ritual, he, with the Prov. Grand Master's consent, would arrange to have meetings in different centres for instruction, thus assisting in bringing about uniformity in all essentials. Referring to the Provincial Grand Lodge of Benevolence, he said that a Committee, consisting of all the present Prov. Grand Officers and a representative from each lodge, was last year entrusted with the arrangement of that fund. As a result of the work of that Committee, 15 petitioners had been assisted since the last meeting of the Provincial Grand Lodge, involving an expenditure of £215. The local Masonic Charities were in a prosperous condition. The Educational Institution of the province and the Hamer Fund had both an income conditional excess of the state of the stat former years, and the Alpass Benevolent Fund had been successful beyond the most sanguine anticipations. These Institutions were all engaged in the highest Masonic work-that of dispensing assistance to indigent brethren, bereaved widows, and helpless orphans. The Educational Institution had 168 boys and girls participating in its benefits, at a cost of £1344 per annum. The Hamer Fund had paid £32 in annuities to distressed brethren; whilst the Alpass Institution, at its first election on the 15th inst.,

had placed three annuitants on its foundation, at an annual cost of £66. The province had now on the foundation of the Royal Masonic Benevolent Institution, in London, five old men and four widows receiving annuities amounting to £328. In the Royal Masonic Institution for Boys at Woodgreen there were ten boys from the province, costing  $\pounds_{450}$  a year, and eight girls at Croydon involving an expenditure of  $\pounds_{208}$ . The Stewards from the province at the Charity Festivals in London had contributed  $\pounds_{509}$ 

during the year.

The PROV. GRAND MASTER said he was extremely pleased at the very satisfactory report which the P.G.S. had given as to the state of the province. From what he had seen, he was convinced that when he appointed Bro. Goodacre to the very important office of Grand Secretary of the province he did right. (Hear, hear, and applause.) Bro. Goodacre, in his report, had given some very interesting statistics, which had not, he thought, been brought before the province before, and he hoped that when the report came into the hands of the brethren they would study it and see what they were doing in the way of Charity. (Hear, hear.) They all knew pretty well what they were doing with their own local Charities; but he thought it was hidden from them that the amount they were receiving from the London Charities represented the large sum of £1058 per annum, expended on their old men and women and children in London. They had spent on their own local education £1324 during the past year; they paid £32 more in annuities to distressed brethren, and had placed three annuitants on the foundation of the Orphans' Institution. They were thus receiving a very near equivalent from the London Charities. (Hear, hear.) The report showed that they were doing their duty by themselves, and also by the other great Charities in London—supporting them as they helped the provinces. (Hear, hear.) There was only one other word he had to say with regard to the suggestions made by the P.G.S. about arranging meetings in different centres for the purpose of working Degrees and installation ceremonies, and in that way purpose of working Degrees and installation ceremonies, and in that way bringing about uniformity in all essentials. He only hoped it would be taken up, and that they would by degrees bring all the province into one uniform mode of work. (Hear, hear.) He was extremely obliged for the admirable report that had been read. (Hear, hear, and applause.)

On the motion of Bro. J. Kellett Smith, P.P.G.R., seconded by Bro. E. Pierpoint, P.P.G.J.W., it was resolved "That the allowance to the P.G. Secretary be increased to £250 per annum, include travelling expenses which may be incurred in visiting the lodges of the province."

It was proposed by Bro. T. Forrester, P.P.G.D., seconded by Bro. Pierpoint, and unanimously resolved, "That the sum of 200 guineas be voted from the Provincial Grand Lodge Fund of Benevolence in aid of the West Lancashire Alpass Benevolent Institution for Widows of Freemasons

West Lancashire Alpass Benevolent Institution for Widows of Freemasons of the Province."

It was also unanimously agreed, on the motion of Bro. J. HOULDING, P.P.G.R., seconded by Bro. T. H. W. WALKER, P.M. 1675, that 200 guineas should be voted in aid of the Hamer Benevolent Fund out of the

Provincial Grand Lodge Charity funds.

The sum of 200 guineas was also voted to the West Lancashire Masonic Educational Institution, on the motion of Bro. R. MARTIN; and a similar sum, on the proposition of Bro. R. WYLIE, P.P.G.S.W., seconded by Bro PIERPOINT, was granted to the Widows' Fund of the Royal Benevolent Institution in London.

Charity jewels having been given by the P.G.M. to Bros. E. Pierpoint, P.P.G.W.; T. H. W. Walker, P.M. 1675; J. P. M'Arthur, P.P.G.J.W.; J. Slyman, and H. Marshall, and the 13th annual report of the Hamer Benevolent Fund, submitted by Bro. H. H. SMITH and adopted, the Provincial Grand Lodge was closed.

The former, after referring at some length to the revised code of bye-laws of Provincial Grand Lodge, which had been adopted during the past year, and which had been highly spoken of in various quarters, and in particular as being selected to form the basis of a proposed revision of the bye-laws of a District Grand Lodge in South Africa, called special attention to the practice of initiating candidates who do not reside in the place where the lodge is held, which appeared to be on the increase. The Committee pointed out that it was incumbent on the Masters of lodges in all such cases to exercise great caution and to cause minute enquiries to be made as to the reasons for a candidate thus presenting himself in a place where he does not reside, for which purpose Provincial Grand Lodge had provided printed forms of letters of enquiry for use in the province. The report, after speaking favourably of the position and progress of Freemasonry in the province, and also dealing with some topics of local interest, concluded with suitable notice of the losses sustained by the province by the deaths of several brethren who had held office in Provincial Grand Lodge. The Charity Com-

mittee reported that at the last April election of the Girls' School their candidate, Edith M. Hood, was elected eighth on the successful list of 24, this being her first application, and, on account of her age, her only chance. To ensure this success the Committee had to borrow votes to some extent, To ensure this success the Committee had to borrow votes to some extent, but with regard to the other Institutions there were still a considerable number of votes to the good. The Committee called attention to the successful efforts of Bro. Dr. T. Macaulay, P.P.G.S.W., who represented the province at the last festival of the Royal Masonic Institution for Boys, and whose list amounted to £267 15s. That brother was thanked for his services, as was also Bro. Kelly, P.P.G.M., who went up as Steward at the last Girls' Festival. In concluding their report the Committee stated that in the ensuing year it would be the turn of the Royal Masonic Benevolent Institution to receive the support of the province, and they nominated lent Institution to receive the support of the province, and they nominated Bro. ### PROVINCIAL GRAND MARK LODGE OF KENT.

The annual meeting of the above Provincial Grand Lodge took place on Wednesday, the 20th inst., under the auspices of the Royal Naval College Lodge, No. 294, at the Ship Hotel, Greenwich, and was well attended by the brethren of the Degree from most of the lodges in the province. The R.W. Bro. Rev. T. Robinson, M.A., Prov. G.M., was in attendance early, and, a procession of Present and Past Grand Officers having been formed, he was received and saluted with grand honours. The same honours were he was received and saluted with grand honours. accorded Bro. C. F. Matier, Past G.S.W.

The minutes of the previous annual Provincial Grand Lodge meeting at Canterbury, and of an emergency meeting at Gravesend, having been passed, the roll of Mark lodges was called, when it was found that every lodge in the province was represented. The Prov. G. Officers present having answered to their names, a very pleasing episode occurred in the presentation of a handsome sword to Provincial Grand Lodge by Bro. Horatio Ward,

P.M. 262, G.S.W., and G.D. England.

The Prov. Grand Master said that before they proceeded any further with the business he should take the opportunity of making an announcement that, he felt sure, would be very gratifying to the brethren. Some two months previously he received a letter from a very excellent brother, who occupied not only a distinguished position in Provincial Grand Lodge, but who had been honoured by receiving the purple in Grand Lodge, requesting him (Bro. Robinson) to receive a deputation, who desired to present to him a sword for Provincial Grand Lodge purposes. He was extremely pleased at receiving such a letter; but thought it would be better, instead of

receiving the sword so generously given by Bro. Ward in private, to receive it in open Prov. G. Lodge assembled. He felt that it would give that brother an opportunity of making the presentation himself, and so receive, as they must all agree that he deserved, the united thanks of Prov. Grand Lodge

for his thoughtful and handsome present. (Cheers.)

Bro. WARD, in making the presentation, said that some time since he had noticed the want of a proper sword in Provincial Grand Lodge, one that, in his opinion, would enhance the dignity of its meetings; and having had the honour conferred upon him of a Grand Deacon by H.R.H. the Prince of Wales, G.M.M. of England, he thought he would mark his appreciation of that honour by presenting the Provincial Grand Mark Lodge of Kent with a sword. He then formally handed the sword to Bro. Robinson, and wished that distinguished brother many years of life

and health to preside over them as their Prov. G. Master. (Loud cheers.)

The Prov. Grand Master expressed his pleasure at receiving the sword, and said he should anticipate what would be sure to follow later on, by at once moving- "That a cordial vote of thanks be presented to Bro. Ward, and inscribed on the minutes of Prov. Grand Lodge," which was

carried by acclamation.

Bro. the Rev. H. CUMMINGS, M.A., P.M. 322, D.P.G.M., and P.G.C. England, having briefly seconded the proposition, it was carried by acclaim, and the G.S.W. returned thanks suitably.

The report of the Committee of General Purposes and Treasurer's

accounts having been passed,

The Prov. Grand Master announced to his great regret that Bro. George Page had written him a letter declining re-election as Treasurer, in consequence of failing health; and Bro. James S. Eastes, P.G.S.O. England, and P.P.G.S.W. Kent, proposed Bro. Briggs, P.G.I. of Works, Kent, as Provincial Grand Treasurer for the ensuing year, and the proposition having been seconded, Bro. Briggs was declared duly elected, but, owing to his absence, his collar was received by proxy.

brethren adjourned to banquet.

The Grand Master having given the usual loyal and Grand Mark Lodge toasts, which were honoured with enthusiasm,

Bro. Sweny proposed that of "The D.G.M., Bro. Lord Egerton of Tatton, and the rest of the Grand Officers, Past and Present," and having paid many and just compliments to those dignitaries, concluded by coupling with it the names of Bros. Miller and Ward, the two Grand Deacons of Grand Lodge.

Both Bros. MILLER and WARD responded, the former stating he considered the honour conferred upon him was a greater honour to his (the Naval) lodge; and the latter that he should always do all in his power to increase the prosperity and prestige of the Degree in the Province of Kent.

The Der. Prov. G. Master then submitted the toast of "The R.W. the P.G.M. of the Province of Kent, Bro. Robinson," and in doing so Bro. Cumings said it was a great honour to belong to such a province; it stood the highest upon the roll of the Grand Lodge of England, it had made great strides during the past few years; and to whom might they attribute its high position and its progress but to that eminent Mason and good brother under whose rule they were content, aye delighted, to be governed? It was the wise, fatherly, and kind ruling of their esteemed and beloved Prov. Grand Master that made them so united, and the work so harmonious. He reigned and ruled in their hearts as well as in their lodges, and they were pleased to see him with them that day, better in health, and stronger to carry on the work, and that T.G.O.O.T.U. might spare him to them for many years to come was the desire of all their hearts, so that he might receive at their hands the hearty, loving, fraternal good wishes of every brother in the province.

The Prov. Grand Master, who was received with prolonged applause, in response said he knew not how to answer such a toast so eloquently and kindly put, and so heartily and touchingly received. All that he could do was to say how much he felt their kindness, and how gratifying it was to him to receive such tokens of their good will and appreciation of his endeavours to promote the prosperity of the Mark Degree. When he took over the office of Prov. Grand Master, some seven years ago, there were six lodges in the province, now there were sixteen, and he thought there would be at least two more added to the roll during the coming year. It was a great pleasure to him to see so goodly a number assembled that day, and it was especially cheering to their hearts to hear what they had done in the cause of Charity, and before next year closed he hoped they should hear,

not only that the province had surpassed even its last year's contributions, and so kept at the top of the tree with its subscription as it had done for the last two years. Bro. Cotterell would at the forthcoming Mark Benevolent Festival represent the province, and in his hands the work would go on until his list surpassed that of his predecessor, Bro. Cummings, who took up the handsome sum of one hundred guineas. (Loud cheers.) As to the statistics of the province, he should leave that in the hands of the Deputy Prov. Grand Master. They all knew what Bro. Cummings had done for Charity, and how assiduously he had visited the lodges in the province. Bro. Cummings threw his heart into the work, and went straight at it, and in so gentlemanly a manner that wherever he went he was heartily welcomed, and they felt sure that whatever he did he did right. After adverting in kindly terms to Bros. Podson and Snowdon, P.P.D.G. Masters, he asked them to drink Bro.

Cummings's health with all the cordiality it deserved.

The Deputy Prov. Grand Master, in response, said as their Prov. Grand Master had referred to him in urging the cause of Charity, he would take that matter first. That, he took it, was a representative meeting, and he felt that everything that was said there would be circulated among every one of the sixteen lodges in the province, and under the banner of their esteemed Prov. G. Master. He felt sure it would interest them, and that they would cordially assist in making Bro. Cotterell's list worthy of the province and the cause. With regard to the Mark Benevolent Fund, it would be a grand thing if every lodge in the province was represented at the next Festival. He knew that it was not always convenient to stand as Steward, but he thought that it might be possible for, say, two lodges to join together, and send up a Steward between them, so that, in fact, every lodge might be represented. There was no earthly reason why not only a representative from a lodge should go up, but also any and every brother who chose to do The Steward's fee was two guineas, for which not only a dinner was provided, but a jewel was presented, and if the brother who went chose to give five guineas he not only did good at the time, but laid up honour for himself in the future. There was another incentive, although he knew the brethren did not want other incentives than the sacred cause of Charity, yet he could tell them that upon the next Festival every Steward would receive a special jewel from H.R.H. the Grand Mark Master of England. He would further suggest that a Committee of Stewards should be formed, so that they might meet and discuss their progress or otherwise, and so keep themselves up to their work. With regard to the province, he regretted that he had not been able to visit every lodge in it, but he had most of them. He was glad to find that there was good progress made in most of them, and great mprovement in all. Then, as to numbers, as their P.G.M. had told them, they had 16 lodges, and he, Bro. Cummings, could tell them, that notwithstanding withdrawals, deaths, and other causes, they had over 400 members good on the books of Prov. G. Lodge, showing an increase of over 63 members during the past year. There was not only strength in their numbers, but the calibre was good, and that, he was proud to say, was a characteristic of the Province of Kent. He asked the brethren of the lodge to send him invitations when there was work to be done, and concluded a lengthy and brilliant address by thanking them for the toast, and hoped that it might be long before they were severed, but that they might work together in the future, as they had in the past, with love and unity.

The Prov. Grand Master then proposed the toast of "The Provincial Grand Officers," coupled with the name of the P.G.S.W., Bro. MASTER-MAN, who cordially thanked the brethren, and assured the Prov. G.M. that the Prov. G. Officers highly prized the honour conferred upon them,

and that they would do all they could for the prosperity of the Degree.

The toast of "The Visitors," was coupled with the name of Bro. Por-

PLETON, who returned thanks.

The Prov. Grand Master then proposed "The Worshipful Master and Brethren of the Entertaining Lodge," coupled with the names of the W.M., Bro. Masterman, and Bro. Miller, who both responded.

The D.P.G.M. proposed the toast of "Bro. Matier," in connection with the Master Benevalent Fundament

with the Mark Benevolent Fund, and

Bro. MATIER said he would, in the first place, thank Bro. Cummings and all the other Stewards for their valuable assistance, and then say a few words about the grand Charities of the Craft. They had been charged with taking away money that had better be given for the support of the aged and the education of the young. (No, no.) Now, they were not so doing; they were supplementing the good work carried on by the Craft, and he, as one of the Committee of the Aged Freemason's Benevolent Institution, was exceedingly sorry to tell them that at the present moment there were no less than 130 candidates for the benefits of that Institution, and still more sorry to say that there was not a single vacancy for one of them, either as an inmate or as an annuitant. As they got on in years, their sympathies were drawn strongly to the aged and destitute, and therefore, he thought that a kind word on behalf of the poor old people, the good old Mason, who had borne the heat and burden of the day, and the lonely old widow, who had no help except such as they might give her, awoke their deepest sympathies, and he could not let the occasion pass without strongly recommending those excellent Institutions to their charitable consideration. Now with regard to their own Charities. Those who had done so well in that province would be pleased to know that the amount paid in Benevolence in 1885 was nearly £400. At the present time there were 21 children receiving education, at a cost of £200; and it had been determined to add the sum of five guineas to the cost of each child for the purchase of clothing, so that the child might attend the local grammar or high school in garments suitable to the class it joined with. Then, as to the annuities, they had had none hitherto, but it was decided to grant annuities of £20 each to two old Mark Masters, and £16 to the same number of old women; and if they went on in the future as well as they had lately, they intended to increase the number of annuitants to six. And now, how could he thank the Province of Kent for what it had done? For two years it had been at the head of the list for its contributions, and he felt sure that under the presidency of Earl Amherst (who was a P.G.M.M. of England) at the next Festival they would exceed anything done in the past, and win the thanks of every Mark Mason under the rule of Grand Lodge. When they remembered that under the presidency of Earl Amherst, the beloved P.G.M. of Craft Masonry in Kent, the Boys' School Festival, in 1883, produced the handsome sum of £,23,500, a sum never before or since reached, it was an augury for the success of the next Mark Benevolent Festival, for the same noble earl and good brother would preside over that Festival. He earnestly urged them to work for its success, and concluded by trusting that next year they might meet under the banner of their esteemed P.G.M.M. as mutually pleased and district the success. pleased and delighted with one another as they were upon the present occasion.

The Tyler's toast concluded the proceedings.

ticulars respecting herself and her parents:—In his (Bro. Kelly's) "Sketch of the History of Freemasonry in Leicestershire," printed in 1870, but which had been out of print for some time, particulars were given of a Craft lodge and a Rose Croix chapter being opened by the French officers, prisoners of war on parole, at Ashby-de-la-Zouch, about the year 1810, "under the immediate protection of Lord Moira (afterwards' the great' Marquis of Hastings) the acting Grand Master of England. A little traditional incident strikingly illustrative of the gallantry of the French towards the fair sex, had been told him a few days ago by this poor lady, namely, that when the new lodge (called the "Vrais Amis de L'ordre") was opened, the French officers celebrated it by a ball, and presented to each of their fair guests two pairs of white kid gloves—one pair long and the other short, and that those worn on the French officers celebrated it by a ball, and presented to each of their fair guests two pairs of white kid gloves—one pair long and the other short, and that those worn on the occasion by her mother were years afterwards given to her. Among the French officers initiated (for none but their own countrymen were admitted) was a "Sous Lieutenant," named Louis Jean, a native of Rouen, as appears from his Craft and Rose Croix certificates—still in his daughter's possession—which are printed at length in the "Sketch" before mentioned, and have also been photographed by Messrs. J. and T. Spencer, of the Market-place. Louis Jean, who, it appears, was a member of a respectable family of landed preprietors at Rouen, fell passionately in love with, and married at the parish church of Ashby-dela-Zouch, a young lady of that town. He was one of the first of the prisoners to be exchanged, and went with his young wife to his native city, where they lived until peace was declared, when his wife strongly importuned him to go back with her to Ashby, which at length he consented to do, greatly, as it proved, to their pecuniary loss. He converted the proceeds of his property into diamonds, on the sale of which, at London, he had to make a heavy sacrifice, thus greatly injuring their position. At Ashby they lived for some years, Louis Jean being greatly esteemed, and being treated on terms of triendship by our late chief, Lord Howe, and the Marquis of Hastings, as well as by Messrs. John and Edward Mammatt, and others. There a daughter was born—the poor lady in question, in whom, and in her mother, the Lady Edith Hastings (the late Marchioness of Loudoun), took a warm personal interest. Later on they returned to Rouen, where, after twenty-two years, Louis Jean died, leaving his widow and daughter in greatly reduced Loudoun), took a warm personal interest. Later on they re-turned to Rouen, where, after twenty-two years, Louis Jean died, leaving his widow and daughter in greatly reduced circumstances, owing to his mother, during his absence as a prisoner of war, believing he was dead, having left the whole of her family property to her daughter, who, dying young, bequeathed the whole to her affianced lover! Louis Jean's daughter not long before her father's death had married a young man named Hinton, an Englishman by birth, but brought up in France. He soon died leaving his widow with brought up in France. He soon died leaving his widow with three young children. The two widows and the children leaving France took up their abode in Leicester, where Mrs. Hinton did her best to keep them all by teaching French and by fine needle-work. He (Bro. Kelly) had only just learned that on the death of Mrs. Jean in 1867, she had been childish and helpless for seven years, having had three apoplectic fits; yet so sensitive and retiring has been the nature of this poor lady that she never sought for assistance in her sad condition, but struggled on, toiling day by day to maintain the family. Had she but sought the aid of day to maintain the family. Had she but sought the aid of the brethren of St. John's Lodge, it would have been readily granted to her. Now, however, through the kindness of the Mayor, she is provided with, at least, a roof to cover her for the rest of her days, together with the not very extravagant pension of five shillings a week."

AN HISTORIC RELIC.

A fine specimen of Leeds ware has come into my possession which may interest some of your readers. As I purchased it in order to secure, rather than keep it myself (having no collection of this class of Masonic curios) it is thaving no collection of this class of Masonic curios) it is for sale price £2. The article referred to is a jug, formerly the Master's "loving-cup" of the Alfred Lodge, No. 433, Wetherby. It bears the name of the first W.M., Bro. George Walker, of No. 4, York, MS. celebrity, and the date 1778, at which period the lodge had already been contemplated. Meetings were held at Bro. Walker's house by a number of Masons, without any warrant; some, like himself, no doubt, initiated in a lodge under the All England Grand Lodge. No coubt Bro. Walker purchased the jug in the first instance for use at these meetings; but it is certain that it was kept at the Swan and Talbot with scrupulous care for years after the Alfred Lodge was warranted to meet there under the Moderns, in 1780. I may add that apart from its Masonic associations and value, it is the finest specimen of old Leeds ware I have ever seen, which, of course, is an additional recommendation. Besides this, it is perfect—quite an uncommon thing in Leeds ware of any age. This relic ought to be kept in Yorkshire. I heard of it first in 1880, but all my efforts to secure it were in vain; since then I have followed it into secure it were in vain; since then I have followed it into Lancashire and back into Yorkshire. In both counties it was purchased as fine old Leeds ware, and it is supposed I did the same. I desire, of course that this historic relic of 18th certain. did the same. Brett) was his Senior Vice-President, and, he might say, his oldest companion, for they had been associated together for very many years. They were made Grand Officers on the same night many years ago (1869) by the late Earl of Zetland; they were the first Senior and Junior Vice-Presidents appointed to the Board of Benevo-lence when it was newly constituted and altered, and they were the two oldest members of the Board. He (Bro. Brett) had been a member since 1857—29 years ago this month—and Bro. Nunn had been a member six and twenty years—and from that time to the time of his death Bro. Nunn had been a constant attendant at the Board. The brethren years—and from that time to the time of inscean Bro. Nunn had been a constant attendant at the Board. The brethren all knew how well and worthily the late President performed the duties of his office. He (Bro. Brett) had hoped that Bro. Nunn would have remained President of the Board at any rate as long as he (Bro. Brett) had the honour of a seat at it; but, as it happened, that was not to be, and the Great Architect of the Universe had called him and the Great Architect of the Universe had called him away. Bro. Nunn was always a gentleman, and although some might consider that in the office of Senior Vice-President he might have been more liberal than he was as President, they would agree that on his appointment as President he seemed more to feel his responsibility—a responsibility which was very great, not only upon the President but upon every member of the Board, because they were entrusted with the disposal of thousands of pounds belonging to the Craft. It was of the more importance on account of the money belonging to others that they on account of the money belonging to others that they should dispense it jealously and carefully than it it were their own.
