THE proposals of the Special Committee appointed to provide The Quarterly Court, Girls' School. for the due celebration of the Centenary Festival of the Girls' School drew a large attendance of Governors and Subscribers at the Quarterly Court, held on Saturday last. There would have been a strong muster under any circumstances, as the regular autumn election was a part of the day's proceedings. But it was known that a series of resolutions, embodying the recommendations of the Special Committee, as adopted by the General Committee, would be submitted, and it was also known that a wrong impression had established itself in the minds of sundry members of the Court as to the nature of those recommendations. There was, therefore, a very natural anxiety on the part of the general body of subscribers as to what would be done, and how any objections that might be raised to the Committee's proposals would be met, and the misapprehensions of sundry members allayed. The report of the Committee was in due course submitted by Bro. Fenn, its Chairman, who moved, in the first place, that Scheme A, which provides, as we explained last week, for the new houses and Lyncombe House being converted into one building and rearranged so as to provide dormitory accommodation for an additional 35 girls, should be at once proceeded with under the direction of the House Committee, and carried out at an expense not to exceed £2000. Bro. FENN then submitted a number of resolutions relating to Scheme B for enlarging and re-arranging the main building and erecting a new Centenary Hall and other necessary premises at an estimated expense of some £20,000, the extent to which these proposals will be carried out being necessarily dependent on the amount of support that may be forthcoming at the Centenary Festival. Resolution No. 4, which provided for the immediate inspection of the windows, with a view to their offering an easy means of escape in the case of fire, was adopted at once, and there was but little discussion as to Resolutions Nos. 5 to 9, which were also adopted. Resolution No. 2, however, which recommended the approval of Scheme B and the raising of the necessary funds, occupied the Committee's attention for a considerable length of time, in the course of which Bro. Fenn fully and most minutely explained the various parts of the Scheme, and so closely indicated the actions of the Scheme, and so clearly indicated the nature and extent of the alterations and additions which it proposed, and the sums they would severally cost, that we are satisfied the evident misapprehensions of the Provincial Grand Master of West Yorkshire and others must have been set at rest, and that he and they fully understand that the Committee are not going to pull down property which cost £63,000 nor do they propose to erect buildings which will require a subsidy of £30,000. To us it seems hardly in doubt that Bro. Tew must have added the estimated cost of Schemes B and C together, instead of noting that it was only the former which the Committee recommended for adoption, and that Scheme C, for the manifold and satisfactory reasons which were offered, had been absolutely and entirely rejected. At all events, the ample and lucid exposition of Bro. Fenn set the whole of the proposal before the Court in such a manner, that with a slight addition as to the time when it should be brought to the notice of the Quarterly Court, Resolution No. 2 was carried, and Scheme B was approved as the plan for commemorating the Centenary Festival of the Institution. It is now manifest that the extent to which it will be possible to carry out this scheme depends entirely on the Craft, on whose contributions the Committee rely for the necessary ways and means. If the requisite funds are forthcoming our Girls' School will be a fine building, as it is already a fine educational Institution, but if less than the amount stated is raised, the Committee must content themselves with such alterations and additions as will be possible with a lesser sum. It is as well, however, to point out that the fulfilment of any part of the Committee's plans now rests with the general body of the Craft, and we need hardly, therefore, remind the brethren that the services of Stewards are anxiously desired by the Secretary.

THERE is little doubt that, when due allowance has been made The Girls' School Election, Election result of the Girls' School Election at the Quarterly Court on Saturday is about as satisfactory as it could have been under any circumstances short of the election of the whole body of applicants. There were 30 candidates and only 16 vacancies. It was inevitable, therefore, that 14 of the former must fail in obtaining places. However, it is gratifying to know that the hope which we expressed last week, and which was endorsed by the Chairman of the Court, Bro. H. B. MARSHALL, Past Grand Treasurer, that the four children who had but the one and only chance of election would prove successful, has been realised, and that no girl's chance of admission into the School has been utterly and irrevocably extinguished. The whole of the 14 who failed, and who are, naturally enough, downcast by the result of last Saturday's poll, have the consolation of knowing that at least one more chance of success awaits them in April next, while several of them will remain eligible for further ballots, should their then efforts prove as unavailing as on this occasion. As regards the polling, the contest appears to have been keen and well managed. No. 1, a London girl, obtained 1958 votes, and Managed an and No. 16-IDA WILKINSON, of Northumberland-1637 votes, or only 321

votes below No. 1, the highest unsuccessful candidates being LILY MARTIN, of Kent, with 1619 votes, and M. M. FREEMAN, of London, with 1605 votes. Of the remaining 12, only one-the Colonial candidate-obtained an appreciable amount of support; but such support as they did obtain will of course be available for the next and, if need be, for future trials. As we have pointed out already. London succeeded in placing one of its candidates at the head of the poll, and two of its remaining six stood ninth and fitteenth respectively. Hertfordshire stood second with 1940 votes, and the West Yorkshire girl was third with 1939 votes. Wiltshire came next with 1918 votes, and then Cornwall with 1895 votes. One of the two girls from the Western Division of South Wales secured the sixth place, and the other the eleventh. The Suffolk and Sussex candidates were next in order with 1826 and 1816 votes respectively, while two of the four hailing from Devonshire obtained the tenth and thirteenth places, No. 10 polling 1781 votes, and No. 13, 1736 votes, the Hants and Isle of Wight girl coming between them, as No. 12, with 1738 votes. One of the two Dorsetshire girls stood fourteenth on the list, with 1725 votes, and the Northumberland girl brought up the rear with 1637 votes. Of the 14 unsuccessful candidates, four hailed from London, two from Devonshire, and one from each of the following, namely, Cambridgeshire, Cumberland and Westmorland, Dorsetshire, Essex, Kent, Nortolkand London, Somersetshire, and Victoria. According to the official return, 42,131 votes were issued for the election; but the votes polied and accepted amounted only to 36,024, so that the unpolled and rejected—the latter constituting a very insignificant proportion—amounted together to as many as 6007 votes.

It is greatly to be regretted that at the Boys' School Election on Monday more strenuous endeavours were not made to secure the return of all those children who, by the operation of Law 53, had only that one chance of being admitted into the Institution. Six of the candidates were placed in this predicament, and of these only two obtained places, so that the names of the remaining four will now be removed from the list. With only 12 vacancies to be filled and 54 applicants to fill them, we can well imagine the difficulty of carrying the whole six successfully through the ordeal, and we getner from the particulars in the published list that in the case of three out of the four rejected boys, the provinces from which they severally hailed must have pretty well exhausted their efforts in securing the election of their candidates at the Girls' School election on the previous Saturday. But where of two approved candidates, be they boys or girls, it is found that one has two chances of being elected and the other only one, we think the electors should do all in their power to help forward the return of the latter. Were this rule followed, then no boy or girl, whose claims to admission into our Schools have been recognised and approved, would be rejected. Past Grand Treasurer MARSHALL set an excellent example on Saturday last by announcing his intention of placing his votes at the disposal of those girls who had but that one chance of success, in the event of their needing help, and we have little doubt in our own minds that Bro. MARSHALL'S announcement had much to do with securing the return of the four "last cases" among the five girls at the top of the poll. Nor does it detract from the merit of Bio. MARSHALL's conduct that in the earlier days of the Girls' School it was constantly the practice of the Committee to call the Subscribers' attention to the fact that it certain candidates were unsuccessful at an approaching Election, they would become ineligible by superannuation. Had such a custom prevailed at these Elections, it is possible the name of the lad Cannon, who was No. 1 candidate on Monday, would not have been placed on the list and remained there for three and a half years in vain. But to return to the Election. With so many candidates and so small a proportion of vacancies it will be understood that the contest on Monday was very keen, no less than three candidates who polled over 2000 votes, and one who obtained upwards of 1900, failing to win places, while five others had 1100 votes and upwards. The highest successful candidate was MORGAN, from Monmouthshire, for whom 3368 votes were cast, BOULTER, of Somersetshire, being second with 3151 votes. Mason, from Warwickshire, who, as well as Boulter, was a "last case," was third with 2981 votes, HIRD and Tolson, of W. Yorkshire, being next with 2973 votes and 2916 votes respectively. The next five on the list hailed from London, PAYNE obtaining 2856 votes, BARKER 2626 votes, ALBERY, 2607 votes, BROAD 2441 votes, and PITT, who had 700 votes, Therefore, 2007 Votes, 2397 votes. Kelly, of Chesnire, stood eleventh with 2336 votes, and a second Somersetshire lad named EDWARDS last with 2229 votes, the four highest unsuccessful candidates being Mossop (Cumberland and Westmoreland), who had 2145 votes, CHEEK (London), 2129 votes, CABLE (Surrey), 2089 votes, and Brown (Durham), 1914 votes. We notice further that London, which supplied 18, or exactly one-third of the candidates, was successful in five cases, while West Yorkshire, which sent up four candidates, carried two; Som ersetshire two out of its three candidates; Warwickshire one of its two candidates; and Cheshire and Monmouthshire each its only candidate. As regards the votes brought forward and polled, we find on reckoning up the figures that the former were 6351, and the latter 53,400, the number issued for this election being announced as 58,703, so that the number of unpolled and spoilt votes was 5303, which is a smaller proportion than in the case of the Girls' School, both actually and relatively to the number issued.

The Provincial Grand Lodge of Durham, of which we gave a full report last week, appears to have been a great success, both as regards its proceedings and the number of brethren who attended it. The Prov. G.M., R.W. Bro. Sir Hedworth Williamson, Bart., presided in person, and was well supported by his Deputy, Bro. the Rev. Canon Tristram,

Past G. Chap. of England, his Grand Officers, both Present and Past, and the representatives of the subordinate lodges. The financial and statistical reports were satisfactory, that of the Prov. Grand Treasurer in particular, showing in respect of the capital account a total of upwards of £2393. The address of the Prov. Grand Master must have been equally gratifying, both to the distinguished brother who delivered it, and who, during his brief tenure of office, has proved himself so worthy of the honour conferred upon him, and to the brethren who formed his audience. The events to which it referred were for the most part of an agreeable character, the solitary exception being the death of Bro. E. D. Davis, of Newcastle, who at the time of his demise was one of the Grand Standard Bearers of England, and to whose memory Bro. Sir H. WILLIAMSON paid a well-conceived tribute of respect. Indeed, it must be evident to all who know anything of the Craft in Durham that Freemasonry in this early province is in a most flourishing condition, and we have no doubt that under the auspices of its present popular ruler its future will be to the full as prosperous as its past and present. We must not miss this opportunity of congratulating Bro. ROBERT HUDSON, who for some years past has been the Grand Secretary of the Province, on the honour paid him by his brethren in presenting him with a full suit of Grand Lodge clothing on his appointment by the M.W. Grand Master at the recent Masonic Jubilee gathering to the brevet rank of Past Grand Sword Bearer of England. Bro. Hudson has successfully performed the many and often arduous duties with which he has been entrusted during his Masonic career of a quarter of a century, and he is now reaping the reward of his labours. May he be spared many years to enjoy the honours which he so fully deserves!

That application be made for permission to wear the Stewards' Badge as a Centenary jewel in perpetuity, and that it be of a special design selected for the cccasion, to be submitted to the G.D. of C., and approved of by the M.W. The

Bro. Thomas Fenn, in rising to move the adoption of No. 2, above given, said, as he was given to understand that there might be, he would not say, opposition to, but, some discussion relating to the third proposition, he would propose all the others first and separately, and leave No. 3 for discussion after the others had been disposed of. With reference to No. 2, he thought all the brethren present would agree with him, that having purchased the two extra buildings adjoining Lyncombe House they would be tultifying the mealure alternation in the Lyncombe House they would be stultifying themselves altogether if they did not avail themselves of these two houses and put them in a condition which would enable the Committee to extend the Junior School and make, in fact, a proper use of the purchase.

The moderate expense of £2000 would greatly add to the accommodation of the School; 35 more children could by this means be accommodated, and the alteration would very vastly increase the convenience of the building

in other respects.

Bro. Robert Grey seconded the motion.

The motion was carried.

Bro. Fenn, in moving the adoption of No. 4, said he did not anticipate any objection to that. On the examination of the building necessary for the purposes of the Committee it was discovered that the windows having iron frames were perfectly unable to be opened to an extent even to admit of the egress of a child. He thought no one would object to this being seen to at once.

Bro. Robert Grey seconded this motion also, which was then put and

Bro. FENN then proposed, and Bro. FRANK RICHARDSON seconded, the

adoption of No. 5.

Clause 1, Law 24, having been read by the SECRETARY, at the request of Bro. Money, Bro. Money said he did not agree with this proposed reso. lution, because he did not think it fair to the old subscribers of ten guineas and five guineas. He would suggest that every one who served for the first time on this centenary occasion should first qualify himself as a previous donor; otherwise he would be put on a level with old subscribers, though he had never before done anything for the Charities. The votes were really going a great deal too cheaply, and some restriction ought to be imposed. He would move as an amendment "That no one who has not already qualified as a Life Governor by the donation of ten guineas shall be allowed these extra votes.

Bro. GEORGE BOLTON seconded the amendment.

The CHAIRMAN said he should like to inform the brethren with reference to the last Boys' election that subscribers received double votes, and those who were wise enough qualified before hand, and had four times the votes. That was not proposed by this Committee, but every one who was wise would put his name for ten guineas.

Bro. FENN said the object of the Committee was to get as many new

Stewards as possible.

The amendment was lost and the original proposition carried.

Motion No. 6 was moved, seconded, put, and carried. Bro. FENN moved, and Bro. GREY seconded No. 7.

Bro. C. F. HOGARD hardly saw the necessity of putting in the words "at intervals of not less than 12 months."

Bro. Fenn said this was a misprint; it should have been "not more than 12 months."

The correction was made in the motion, and the motion as altered was carried.

Nos. 8 and 9 were also moved, seconded, and carried "nem. con." Bro. Fenn then recurred to No. 3, but before asking the Chairman to put the resolution to the meeting he would like a letter read which had been written by Bro. Tew, Prov. G.M. of West Yorkshire, to the Secretary in his official capacity. He thought Bro. Tew could have no objection to its being read. His (Bro. Fenn's) name was mentioned in the letter, and a certain imputation was cast upon the Committee, of which he (Bro, Fenn) was Chairman, and he thought it should be read and answered. There were certain misconceptions in that letter, so extraordinary that if the brethren in the provinces misconstrued them in the same manner the Committee would have to give the scheme up altogether, for they could not do without the assistance of the provinces. The misconceptions were marvellous

and should be explained. The CHAIRMAN said this was a very important letter, and he thought it

should be read.

Bro. J. A. BIRCH protested. It would be establishing a very inconvenient practice if letters were to be read at these Courts from brethren who happened to be distant, and who did not attend. It would take up a long time. If a brother had strong views to represent he should attend. If he could not attend he should have sufficient confidence in those who did attend to leave them to settle the question. He believed it would be the initiation of a most inconvenient practice. He moved "That the letter be not read."

Bro. FENN quite agreed with Bro. Birch as to the inconvenience of the course he proposed, if it were generally adopted. But Bro. Tew represented brethren of one of the largest provinces in England, and his remarks were of very great importance, and if the misconceptions of Bro. Tew were shared by other members in the provinces, he thought it was right they should be removed. It was quite an exceptional case. The reading of the letter would not take long.

Bro. C. F. HOGARD thought the difficulty of Bro. Birch was that Bro. Tew, the Prov. G.M. for West Yorkshire, was not present. He would remind him that the D.P.G.M. was present, and he could adopt the letter

of Bro. Tew.

Bro. Fenn said perhaps it would remove the difficulty if the letter were not read in its entirety, and if he referred to the misconceptions of Bro. Tew as he went on. Bro. Tew and he were old personal friends, and he had great respect for Bro. Tew, having known him well for many years. But Bro. Tew said, mentioning his (Bro. Fenn's) name—"I ask you to present this my protest to Bro. Fenn and to the Court against the haste with which this scheme is to be pushed through the Court and upon the Craft generally." Now, he (Bro. Fenn) protested against this assumption that the Committee desired to push the report through the Court. Committee, of which he had the honour to be Chairman, had to perform certain duties which they were asked to undertake by the General Committee. They did so, and as quickly as they could, and made their report on the first available opportunity. They could do no more, and in the discharge of their duty they could do no less. It was not the fault of the General Committee or the Quarterly Court that the General Committee met about one week before the Quarterly General Court. The Committee could not publish their report before it was made to the General Committee, and the Secretary had a number of them printed and in the hands of the General Committee, and they were sent out the next day to the Provincial Grand Secretaries. There was no desire on the part of any one to force it through the Court. The proposition he had to bring under their notice meant very little; it did not commit the Court to spend £20,000; the matter must come before another Quarterly Court, and therefore the haste of which Bro. Tew complained did not exist, and there was no necessity for haste. Bro. Tew wrote of the great cost of the buildings which were proposed to be pulled down wholesale—£63,000 (with the land). What were they proposing to pull down? The north-west wing, which cost some £1400. They also proposed to pull down the kitchen and some useless sculleries and store rooms. The kitchen was becoming of very little service, because it was built for 68 children, and it had now to provide for over 200 and a proportionate staff. That cost perhaps another £1400, because the kitchen was only of one storey. There was no building over it, and instead of this cost of £63,000, if Bro. Then Bro. Tew said the new buildings were to cost £30,000. There was nothing in the report to justify that assumption. The sum mentioned was £20,000. As he went through the proposition of the Sub-Committee he would mention the various items which made up this £20,000. Bro. Tew said there would be £12,000 extra. He (Bro. Fenn) did not know where Bro. Tew got his £12,000. That was in connection with C scheme, which the Committee did not recommend. The first part of the recommendation of the Sub-Committee was that new kitchen offices, with matron's room, cooking class room, house dining room, and servants' bed rooms be built on the site of the new

piece of ground lately purchased by the Institution, and bounded by the public road. It was necessary for him to state that part of the recommendations was the conversion of the drill room into a dining room, and therefore the position of the kitchen near the dining room was the best place for it. The estimated cost of this would be £7000. This was not only the kitchen, but the Matron's room, cooking class rooms, and bed rooms for all the servants, which would be a very extensive building. The next proposition was for converting the present large Schoolroom in the Alexandra Wing into a Dining Hall. That cost nothing. 3.—Converting the present Dining Hall and Cooking Class-room into one large Schoolroom, by removing the intermediate wall, and thus enlarging the Dormitory over, and gaining space for eight more beds. 4.—Building a new large Schoolroom about 76 feet by 22 feet adjoining the last with—5.—Large Dormitories over, capable of affording sleeping accommodation (with 45 feet superficial area to each) for 76 children, with the necessary Lavatories, &c., &c. The estimated cost of all that was £5000. Then covering the present asphalte court with wide and airy passages, day lavatories, latrines, and boot-room. That would be a very great advantage, affording a covered connection with all parts of the building. That would cost £1400. The building of the Centenary Hall, under scheme B, would cost £5000. If the Committee had adopted scheme C, it would cost £7000, because the building would stand by itself and there would be certain architectural requirements which would add very considerably to the expense. He would now allude to the Medical Officer's Report, the principal part of which was in the hands of the brethren, and it showed the absolute necessity that something should be done. Now that the Report had been put before the Committee, it threw a vast responsibility upon them. The School was overcrowded; and if an epidemic should break out there, the Committee would be responsible after this notice had been given them. This School was crowded far more than any building under the direction of Government Officers, and of those who had the superintendence of those buildings. The Committee felt it was a great responsibility. It was therefore absolutely necessary to make the alterations, for unless they carried them out they would have to stop any more children coming into the school until they came down to such a number as to be within the requirements of the Medical Officers. These alterations amounted altogether to £19,000, so that they would see that Bro. Tew was far begond the mark in his apprehensions. Bro. Tew also said the expense of £30,000 was to be incurred for an additional 75 girls; but this was another misleading statement, because it was really for over 100 children, which was reduced to 75 if you took 30 off to give the requisite space to be allowed to each child.

Bro. J. A. BIRCH said it was £19,000, in addition to the £2000 for the

Junior School.

Bro. Fenn said that was so. He might say that although this scheme proposed the addition of bed-rooms and dormitories, it was not imperative on the Committee that these should be filled directly; it was only necessary that they should be filled as occasion might require. But having the future before them, and judging of it by the past, it seemed requisite to provide for extending the usefulness of the School as Masonry increased. It would be folly, while they were about it and had the means of increasing the dormitory accommodation, that they should neglect that opportunity. Of course they could do without the new dormitories proposed to be built over the schoolroom, and where the kitchen was. But as it stood between the great hall and the other part of the building, the expense was so small that, as he said before, it would be folly in them not to avail themselves of the opportunity of building these two rooms. Just one more remark. He had heard some say that it would be a great deal better to remove the School further out into the country, than to go to this expense at once. He hoped that no such suggestion would be made. He had been a member of this House Committee a short time, but long enough to know how ably it conducted the affairs of the School, how devoted the members of the Committee were to the Institution's interest, running down on all occasions, when wanted, or not wanted-(laughter)-on week days or Sundays; whenever they found a convenient moment they would go down there and see what was going on. The Chairman of the month was almost always there; he was at the beck and call of the matron, and Miss Davis, the head governess, and everyone else. Now it would be impossible to do this if the building were 20 miles away from London. Now, all the subscribers had the greatest security for the proper conduct of this School in the constant supervision of the House Committee—(hear, hear); moreover, why should the Institution go to the country? It was at present in the most healthy part of London; they could not have a more healthy place; it could not be enclosed any more than it was now, and there was plenty of room for the School even in its expanded form. If it would meet the objection which had been made or shadowed forth by Bro. Tew, he and others might possibly feel more assured that the Committee were not rushing this report through the Quarterly Court if he stated he had no objection to add to his motion, the rider "subject to any modification which often due are identified in the control of the state of the control of the which after due consideration may be deemed desirable by a future Quarterly Court," so that no money might be spent without the consent of a future Quarterly Court, which could make any alteration in this scheme at a future date. It was brought on now because it was necessary at once to come before the Craft with some proposition for celebrating the Centenary of the Institution.

Bro. C. F. HOGARD asked Bro. Fennwhether he would repeat the figures. Bro. HENRY SMITH, Deputy Prov. G.M. West Yorks, submitted that it was for want of full information that the misconception which had been alluded to had arisen in the provinces. Bro. Tew, like any other brother who could not come to the meeting, wrote a letter for information. He (Bro. H. Smith) did not come there to complain; on the contrary, he came to support the Committee in every possible way. The report was practically read because all items were referred to by Bro. Fenny But it was impossible to understand the plan which was annexed to the report. He knew that the beds in the dormitories for years had been overcrowded, and that at least 30 ought to have come out. Therefore it was a very wise thing at this time when there was a chance of getting extra funds to take advantage of the opportunity to bring the present state of things into a satisfactory condition. The desire of the Committee should be to make the Institution equal if not superior to any other institution in the country. The subscribers did not want them to waste money, but only to see that the Institution was second to none. A plan which could be more easily understood which would, give a proper distribution of the rooms, and on a larger scale, should be sent out, and the sooner it was sent out the better. There was nothing would disabuse the minds of people who had not been associated with the Committee of any misapprehension so much as a proper plan, and then making them fully acquainted with the whole circumstances. Eventually, however much that

money might increase from time to time, at present it was not intended to

exceed the amount asked.

Bro. FENN said Bro. Hogard had asked him to explain the figures of which the £19,000 was composed. They were new kitchens, £7000, corridors, £600, new schoolroom and two dormitories, £5000, lavatories, passages,

&c., £1400, large hall, £5000, making £19,000.

Bro. Frank Richardson, P.G.D., in rising to second the proposition of Bro. Fenn, said after the able manner in which that brother had put it very few remarks were necessary from him. This was no sudden scheme: Those members of the House Committee whom the brethren had from time to time elected to govern the Institution had seen the disadvantages under which they were labouring, and it had been a matter of consideration with them from week to week how those disadvantages were to be cured, not only in the domestic offices, but in the teaching department, because the number of the children had been continually increased without the establishment being increased concurrently with them. At the time the Institution was increased it was only sufficient for the time being. Now there were so many children there that it was inadequate for the proper teaching of them. Therefore, it was felt by the House Committee that they must see how the difficulty could be remedied. The different matters affecting the School had not been the subject of consideration by one or two meetings, but 20 or The scheme propounded they thought was one that would not only ensure the present requirements, but enable the subscribers to deal with enlargements of the Institution at a future date. Something must be done. If this scheme was not accepted by, and acceptable to, the general body of the subscribers, some other scheme must be propounded, because it was an impossibility that the establishment could really be carried on as it was. (Applause.)

Bro. Russell (Kent) entirely approved of the scheme, yet wished to make a few remarks. The very hard line that Bro. Fenn had drawn between the £30,000 and the £20,000 or £19,000 caused him to ask which sum they proposed to spend. Unless the brethren and their Committee in their corporate capacity were more fortunate than individuals in their private capacity, they knew they would not complete the scheme for the sum mentioned. There was always something cropping up. What he wished to do was to place on record that day a remark on this subject, because he thought it would be extremely valuable at a future day. He did not wish them to cross the river, and then burn their boats. It might happen at a future day they would be told that when they asked for £19,000 they said they did not want £30,000, and the question might be asked which was right and which was wrong. (Hear, hear.) He thought they should bear in mind that if they asked for £20,000 they might want £25,000, and then they would be in a much better position now than if they started on the hypothesis of wanting £30,000. He did not think that the brethren who were going to act as Stewards would want any spur to induce them to make the collections. They were all going to start on that endeavour, and he would say it was probable that something more than £20,000 would be wanted.

Bro. Robert Grey thought a time should be fixed in this motion.

Bro. FENN said the Committee would undertake to bring it before a Quarterly Court.

Bro. J. A. BIRCH asked whether the Quarterly Court in April would not

be soon enough?

Bro. FENN said the Festival would not have been held so soon, and they would not know then what money the Festival would produce.

Bro. BIRCH said the modifications, if any, which might be made in the

propositions at the April Court need not be final.

Bro. Fenn said he would name the Quarterly Court in April.

The motion with the rider was then put, and carried unanimously, Bro. FRANK RICHARDSON moved that an additional child should be elected, in consequence of the death of Florence Weber. There was a bed vacant, and he knew it was against the wish of the subscribers that there should be any bed vacant.

The motion was seconded and carried.

The CHAIRMAN then stated that there were four last applications on the list, one of which he was told was safe. He should divide his 400 votes among the other three.

The Scrutineers were appointed, and the election of 16 girls out of a list of 30 candidates was proceeded with. At the declaration of the poll the following was the result :-Successful.

Fenn, President of the Board of General Purposes. The resolution of Grand Lodge, when your Provincial Grand Master, as Grand Master, had the honour, on the 7th September, of occupying the chair of Grand Lodge, embodying the thanks of the Craft towards these distinguished brethien for their admirable labours, were well and richly merited. I hope also, to day, that this Provincial Grand Lodge will move an analagous resolution, expressive of our gratitude to Lord Zetland, and the Provincial Grand Lodge of North and East Yorkshire; to the Dean of York, and to the York Lodge, No. 235, for the Jubilee meeting at York, whereby many brethren who could not attend the greater demonstration in London, did avail themselves of this opportunity to attend the Masonic Jubilee Service in York Minster. I awaken your memories to these events to thank every lodge and every brother in West Yorkshire for the generous manner in which you, one and all, supported your Prov. Grand Master and officers on these memorable occasions. So far as West Yorkshire records tell us 60 lodges were represented in London, and 208 orethren. At the York Jubilee meeting, 61 lodges were present from West Yorkshire, represented by 359 brethren, of whom 72 were Present and Past Prov. Grand Officers of this province. Then, again, the occurrence of the Boys' Festival, at the Crystal Palace, on the day immediately following the Albert Hall gathering, you supported me generously as the President of that Festival, at which £11,764 ing, you supported me generously as the President of that Festival, at which £11,764 was raised, West Yorkshire contributing the handsome sum of £671, and taking the lead of every other province in the amount of its contributions, and this, too, when we had raised for the Girls £374, and had further pledged ourselves to £2100, as a special Jubilee offering to the "Royal Masonic Benevolent Institution," and a further sum of £826 at its regular February Festival. Bro. Terry is here to-day, and we shall listen to nim with attention. I may be allowed to say that, if ever a Chairman of a Festival was entitled to support and indulgence, it was myself on the occasion of the Boys' Festival. because I was called upon suddenly and unexpectedly to ful that delicate and onerous office. Truly did the Most Worshipful the Giand Master say, in the Albert Hall, that "Brotherly love and Charity" are two of the principal tenets of our Order. The former you have exemplified largely towards this office I hold, and the latter to the Charities. Further, I had the honour of transmitting through the Grand Secretary, towards the Prince of Wales' scheme for the "Imperial and Colonial Institute," the sum of £150, and which, I believe, will be considerably augmented before the close of the year from this province. It affords me much pleasure to announce to you that on the 13th June, the M.W. the Grand Master conferred the rank of Past Grand Deacon of England upon Bro. Henry Smith, Deputy Prov. Grand Master of this Province, and that of Past Grand Sword Bearer upon Bro. William H. Brittain, who have both done so much for Freeemasoniy and for the Chanties in this province. This lodge, whose warrant was signed by Bro. John Co. Ington, on the 15th June, 1786, was opened at the Sutling House Marine Barracks, Devon, August 22nd, 1786, when

James George Power was elected, sworn, and invested the first Worshipful Master. It was established as a Military and Naval Lodge, for the officers of both services, "Land was established as a Military and Naval Lodge, for the officers of both services, "Land and Water." It appears from the minutes to have been of frequent occurence, if a person were what is called a "transient" man (permanently on active service) to ballot for, initiate, pass, and raise him on the same evening. Hence, the name of the Lodge Amphibious. As a Yorkshire Lodge, the Amphibious date only from 2nd May, 1803. I had hoped to day to celebrate here the 100th year, or the Centenary of the working of this old lodge, but nothing can be done until the year 1903, it being evident from the lodge minute books, and the Grand Lodge registers, that Amphibious ceased to exist in 1702, and that previous to, or in 1803, some Yorkshire brethren got hold of the books and G.L. warrant and started what was virtually a new lodge, with an entirely new set of members. Provincial Grand Lodge of West Yorkshire met on the 2nd May, 1803, to consecrate and dedicate this lodge at the lodge room, at the Shear's Inn, Hightown, when Bro. John Binns was the Worshipful Master. Grand Lodge books go back to about 1740, and show No. 258 from the year 1786 to 1792 only, and from 1803 to 1887 as a new lodge. Amphibious finally settled in its present place of meeting on 27th March, 1850, and the last time Prov. Grand Lodge visited this place was on the 2nd January 1861. I mention these facts to show the importance and the necessity of lodges carefully pre-1850, and the last time Prov. Grand Lodge visited this place was on the 2nd January. 1861. I mention these facts to show the importance and the necessity of lodges carefully preserving their minute books and ancient documentary records. This is the sixth time that Amphibious Lodge has received this Provincial Grand Lodge. It has 61 members on its roll, 24 of whom are P.M.'s, only two other lodges in this province exceeding this number. We cordially acknowledge therefore the labours of the W.M., Bro. A. Macauley, and his officers for the preparation they have made for the conduct of the business of this Prov. Grand Lodge to-day. We wish this lodge a continuation of prosperity and perpetuity, both on "land and water," and fervently trust that in 1903 it may enjoy its centenary from an unbroken continuity of working since 1803, and give proof of its uninterrupted existence for one hundred years, in accordance with the Book proof of its uninterrupted existence for one hundred years, in accordance with the Book of Constitution.

Having referred to the meeting of the Charity Committee of the Province held at Halifax on the 24th September, and having quoted "ex parte" certain important statistics compiled by Bro. Col. Clerke, showing the progress made by our several Charitable Institutions from their foundation till the present time, the Prov. G. Master continued his

address as follows:

With this financial and numerical increase in our Charities, the number of lodges have also multiplied by 1565 during the same Jubilee period and since the year 1875, when his Royal Highness the Prince of Wales became Grand Master of the Craft, 682 lodges have been established, being nearly 40 more than Master of the Craft, 682 lodges have been established, being nearly 40 more than existed altogether at the accession of her Most Gracious Majesty, in 1837. These figures illustrate in some degree the loyalty, the brotherly love, and Charity of Freemasons, and I hope the next 50 years will exhibit, in these respects, a corresponding progression in magnitude of the Freemasons of England, and that of West Yorkshire will be in the van with its sympathies for the Charities, and its generosity and loyalty, as it has shown itself during this past brilliant period of our Gracious Sovereign Queen Victoria's glorious reign. Briefly, brethren, I have awakened in your memories Masonic progress in this country. It is representative of the "loyalty and Charity" of our Order. It is for us to work out the perfection of Masonry "when wars shall cease, and art shall prosper, and science thrive," and when trade and manufactures and agriculture, represented by personal activity, shall reach their triumphant consummation by turning the "whole human race into one vast lodge, and made every man a brother." And may this gracious lady who sits upon the throne of England gracious lady who sits upon the throne of England-

"Through all this tract of years,
Wearing the white flower of a blameless life
In that fierco light which beats upon a throne."

Who has witnessed so many changes, without lessening the esteem and affection of her subjects, long continue to govern a united, prosperous, and contented people, is the fervent aspiration to-day of every brother in this large gathering of the Craft, forming the Provincial Grand Lodge of the Province of West Yorkshire, so

Until the heavens envying the Earth's good-hap,
Add an immortal title to your Crown,"

is the prayer of your Provincial Grand Master.

CENTENARY OF THE GRAND LODGE OF MARYLAND.

BY BRO. W. J. HUGHAN.

We are well used to Centennials and even Sesqui-Centennials, Masonically speaking, in this country, but though such Assemblies and Commentorations are not strangers to us, each one as it arises appears to have some peculiar History of its own, which renders the observance of the event a matter for congratulation, and sometimes for enduring memorials being

One of the most important of late years has been the celebration, in 1886, of the 150th Anniversary of the formation of the Grand Lodge of Scotland. and in this country several lodges have taken the opportunity of observing similar anniversaries, such as No. 37, Bolton, in 1882, No. 41, Bath, and No. 43, Birmingham, in 1883, &c. The Sesqui-Centennial of the Grand Lodge of England, in 1867, appears to have passed away without any commemoration whatever! Such an oversight would not occur in the United States, as High Festivals suitable to the special circumstances of each event would be sure to receive general sympathy and hearty support.

The latest of these celebrations, held in May, 1887, of the Centennial of the Grand Lodge of Maryland, has been duly described, first of all, in a capital volume devoted to an account of the Proceedings on May 12th, and another volume dealing with the "Semi-Annual Communication" of the Grand Lodge, on that day, and the 10th and 11th immediately preceding; advance sheets of which have reached me, through the kind attentions of General T. J. Shryock, M.W.G.M.

I should like to give my brethren in this country some idea of the character and extent of the proceedings, so fitly portrayed in the two handsomely printed books before me, and especially so, because the Grand Master and moving spirit of the great Celebration has so recently been on a visit, and also the honoured tuest of the "Anglo-American Lodge," London, the "Eboracum Lodge," No. 1611, York, and other Masonic Bodies, who are always to the fore when distinguished brethren from "across the Big Pond" desire to see a little, at least, of English Lodge life whilst sojourners in this country. To my mind, the truly Masonic action of the "Anglo-American Lodge" and the York Lodges in so warmly welcoming our American Visitors, from time to time, is a prominent feature of late years, which is deserving of special recognition by our Masonic authorities, and neither should the more private, but none the less hospitable, receptions tendered under similar circumstances by Brothers George Kenning and Colonel MacLiver be allowed to pass unrecorded.

One thing, at all events, is clear, that the Craft in the Old Country will fail in its duty unless suitable opportunities are embraced to practically illustrate the fact of the oneness of Freemasonry, the cosmopolitan character of our Society, and particularly the bond that exists between the Englishspeaking Grand Lodges throughout the world.

On May 10th, 1887, the Grand Lodge of Maryland held its 201st stated communication, having met semi-annually during the past hundred years. General Shryock, M.W.G.M., delivered a stirring address of welcome, in which he remarked that-

Our existence began April 17th, 1787. It is our privilege to celebrate this crowning anniversary of 1887. One hundred years! What a contrast since a few earnest men come together to organise this Grand Lodge. What a contrast between the two assembles the small and homely meeting of that day, and the great assemblage here to night! What a difference between the quaint little lodge room in a country to in, one hundred years ago, to the splendid temple of to-day—erected to God and dedicated to universal beneficence! What a difference in the surrou idings—a sparsely sit led State, which had not recovered from the exhaustion of war then, to a Commonwealth teening with commerce, industry, and wealth now. The ceremonials that we follow at this communication, bridging the vast chasm of one hundred years to honour the nien had not recovered from the exhaustion of war then, to a Commonwealth teeming with commerce, industry, and wealth now. . . . The ceremonials that we follow at this communication, bridging the vast chasm of one hundred years to honour the nen who started this Grand Lodge, wil be repeated one hundred years hence by good men and true in commemoration of our display. Like a benediction over our graves will they search down through the century to us, as we search through the century gone to the memories behind us. . . . All has been changed save the vernal landmarks that point to the Fatherhood of God and the Brotherhood of Man. These are eternal, and will accomplay the new ventures before us, as the have come through the cenand will go on through the new centuries before us, as they have come through the century back. It is for us to do our present duty in transmitting them from the one to the other, with gratitude to Atmighty God for the inestimable privilege of being present at this glorious epoch, and being the honoured participants in this notable anniversary,

A characteristic letter from our esteemed Masonic veteran, Bro. Brackstone Baker (who is the accredited Representative of the Grand Lodge of Maryland-as also some 15 others!), was read by the Grand Secretary, in which our good brother the present W.M. of the Anglo-Am rican Lodge wrote most appreciatively of the magnificent style of the patent of his appointment, which, however, he considered was "exceeded" by the sentiment of ment, which, however, he considered was "exceeded" by the sentiment of Brotherhood and of interchange of fraternal good feelings, of which the document is the evidence.

The Grand Master's racy and most Statesmanlike account of his Stewardship left nothing to be desired in that respect, and we may beassured that his numerous official visitations in all parts of the State have been the means of increasing the interest of the members of the lodges thus tayoured in the prosperity of their Grand Lodge. In America there are no Provincial Grand Masters, with Provincial Grand Louges such as we have in England, so that unless when the period has arrived for inspection by their Deputy District Grand Masters-who hold no District or Provincial Grand Lodges such as in this country -tue numerous louges grouped within Districts have little practical knowledge of the dignity and character of the Grand Lodge Officers, save and except when Grand Masters do their duty by going in largely for official visitations. A great deal of the narrative of the Grand Master's doings reads quite strangely to our ears, but it must not be lorgotten that in the United States the Grand Master is practically the President and the "Boa d of General Purposes," and in like manner the "Colonial Board," besides doing the work of the Grand Registra! His decisions are reviewed by the Grand Lodge, it is true, but, as a matter of fact, all the questions which come before our two Boards, and are dealt with by a number of responsible brethren, are in the States entirely attended to and decided upon by the Grand Masters, between the Grand Lodge Meetings.

Mention was made by the Grand Secretary of his receipt from Colonel Clerke, "by command of H.R.H. the Prince of Wales, of a most be untitul gold jewel, with the request that Grand Master Suryock be properly invested with the same, as the badge of his office." I have seen the jewel, and consider it both artistically and Masonically a work of art, and I know that the Grand Master is proud to wear the decoration as Representative in Maryo land from the Grand Lodge of England.

to the forthcoming analysis of the Girls' and Boys') I can only say that I must have put my letter together very badly for him to have so misconstrued it. Let us see if I can put it in plainer language. Granted, that the rich provinces it in plainer language. Granted, that the rich provinces should help the poorer, that Masonry is not a benefit Society in the usual acceptation of the term, and that its Charities are as they should be, universal; my contention is that a province which supports kindred Institutions of its own, must have the necessary funds which should first of all be utilised in meeting the obligations it is already to the patent Institutions, and that it is most unfair to ignore its own responsibilities by throwing them on the mercy of other provinces; that such provinces should be "just before they are generous at the expense of others," "they should be off with the old love before they are on with the new." Our Institutions are open to all duly qualified claimants under the English Constitution, whether at home or abroad, under the English Constitution, whether at home or abroad, and their doors are wide open to help those who cannot help themselves. And the true Mason will never begrudge their assistance, but when provinces who prove their ability by their other actions, persistently refuse year after year, to aid and assist, then I say it is an unfair tax on the generosity of the sister provinces. Nine months ago I suggested to some brethren, in a town of one of the poorest of provinces, which is yearly receiving large benefits from the parent Institutions and give little or nothing in return the parent Institutions and give little or nothing in return, that they should start an association, which they have done, at sixpence per week, and the result is already some £50 at skepence per week, and the result is already some £50 or £60 to the Institutions, thereby showing their willingness to contribute, and I believe it only requires this example to be followed all over the kingdom to increase largely the power and means of doing good. Having written this without "Zeta's" letter before me, and only from memory, I cannot answer his criticism so carefully as I could wish, but have done my best to true and explain the meaning of but have done my best to try and explain the meaning of my former letter.—Yours fraternally, J. 174.

Is it really a fact that all the charters issued for country lodges from 1725 to 1731 have all disappeared, just as the lodges have? If so, it is a surprising fact, for on looking over Bro. John Lane's great work—"Masonic Records"—I find that very many were started in one city and another, of which no trace scarcely seems to be left. We are all much indebted to Bro. John Lane for such a magnificent volume, and now we want another tome to contain copies of all the old warrants?

LODGE DEACONS.

When did Deacons first take their duties as such, and be appointed in lodges under the "Moderns?" According to Bro. Gould, the Masonic Historian, that office was peculiar to the "Ancients," being "unknown to the older Grand Lodge of England until the union." The title is met with in the "Atholl" Records so early as 1752-3, and still earlier in Ireland and Scotland. Evidently, however, the custom of appointing Deacons was not confined to the "Ancients" until the union was consummated, as it will be found that "Modern" lodges followed the same plan late last century at all events. Take, for instance, the Lodge of "Fidelity," Leeds. On 1st October, 1792 (so Bro. Scarth, W.M. 289, tells me) there were present the Master and other officers duly named, including the "S.D." and "J.D.," and I know this minute is not the only one of the kind of that period. Who knows of earlier instances? ENQUIRER.

MALTA.

Bro. Speth's note is valuable and interesting. It proves the great importance of careful examination of all that comes to hand. In reference to the place of meeting of the lodge, designated in the Englist lists "St. John's Lodge ot Secrecy and Harmony," Bro. A. M. Broadley's "History of Freemasonry in the District of Malta" gives an extract from a statement by Bro. Waller Rodwell Wright, the P.G.M. of Malta, written about 1817, in which, after stating that the warrant of the Lodge No. 539 was then in his possession, he says: "The meetings of the lodge were not openly avowed, but were held without any precaution for concealment at a place called Sa Maison," and Bro. Broadley adds: "Bro. Wright goes on to say that the rooms at Sa Maison bear no traces of their use for Masonic purposes." Does not this imply the existence of a distinct building bearing this peculiar designation: and as such it is evidently referred to in Muir's "Masonic Almanac for Malta" (1849), quoted by Bro. Broadley, who further says "The locality of Sa Maison is indicated as the site of this lodge." I think it probable that Sa Maison (although in its general interpretation meaning "his house") must have been used to denote some definite building, well known locally under that name. Perhaps some brother at Malta could throw more light on the subject.

I am informed, on excellent authority, that in my note 742 I have libelled the Grand Secretary of 1788, who was in this instance most correct in his statements. I will not attempt to excuse myself, but make the amende honorable attempt to excuse myself, but make the amende honorable by quoting from my correspondent's letter. He says: "Sa Maison is the name—still existing—for a well-known house and grounds, situated (to the best of my recollection) a little outside the main fortifications, and just beyond the Florianna outworks and barracks, and overlooking the quarantine harbour. Before the Florianna works were built it must have been a very quiet and seeluded place for the lodge to meet at quite out of sight of and more than built it must have been a very quite and sectioned place for the lodge to meet at, quite out of sight of, and more than a mile from, the palace of the Grand Masters, and nearly as far from any of the Auberges of the Knights."

Passing to the second part of his subject, "What is Freemasonry?" Bro. Mason spoke as follows—The Dean of York, when addressing the brethren of the North and East and West Ridings of Yorkshire in the Cathedral, at York, on the 14th July, 1887, stated: "I believe that Freemasonry represents an almost primeval craving for relief from that which human selfishness had made intolerable—a craving to draw together, man to man, and heart to heart, for mutual sympathy, mutual friendand heart to heart, for mutual sympathy, mutual friend-ship, in a word—Brotherhood. That each should look at his fellow not as his enemy, his rival, his tool; but his brother-one with him in common interests and common aims, in mutual protection and advancement, of which the individual welfare of each was the best promoted and secured." Were I to attempt to answer fully and catesecured." Were I to attempt to answer fully and categorically this question—"What is Freemasonry?"—it would take more time than we have at our disposal this afternoon, and I must therefore only attempt to do it in part, in outline that is to say. If I asked any brother in this room, "What is Freemasonry?" I should have the prompt reply, "A beautiful system of morality, veiled in allegory and illustrated by symbols." True, but it is evident that this condensed description of Freemasonry, though dent that this condensed description of Freemasonry, though suitable enough for a short examination, does not profess to give (nor does it in effect give) a full solution of the query, "What is Freemasonry?" Freemasonry is best and most fitly described as a world-wide Guild, Fraternity, or Brotherhood, bound together by certain leading principles, and fixed on an immutable basis, so that it is able to outlive the passing away of kingdoms and dynasties, "to survive the wreck of mighty empires, and resist the destroying hand of time." Its abstract or foundation principles may be said to be fraternity, human sympathy, love of truth: while its to be fraternity, human sympathy, love of truth; while its concrete or active development is to be found in its respect for law and order, its toleration, its reverence for religion, its illimitable Charity or brotherly love. In its fraternity it seeks to enrol a phalanx of persons of different countries, sects, opinions, and colours, in one firm bond of living union and concord, for the great aim of "being happy and communicating happiness to others;" all permeated and influfor the children of the dust, mutual respect, mutual confidence, mutual support, practical brotherhood. Such a confederation has been objected to on various grounds. The Roman Catholic Church has formally excommunicated not only Roman Catholic Freemasons, but all Freemasons, on the ground that by thus obliterating the limits of different denominations and ignoring sectional distinctions, a sort of natural religion is set up. Such is the idea and scope of the famous Bull of Clement in 1738, and such is the teach-ing of the Church of Rome to-day. There are others, of various bodies, who see in the non-use of Christian prayers, as in England, what they term a mere Theistic avowal. | Masons, we need have no fear for the future of our

But such is not the case. In Scotland and Ireland Christian prayers are used. There is no law to prevent a Chaplain using a Christian prayer. But since 1730, and notably since 1813, universal prayers have been undoubtedly used, which, as we use them, are perfectly sound, enlightened, rational, reverential, and charitable. There is, therefore, no valid objection to the basis on which Freemasonry rests; a band of good men and true, of different countries and denominations, all acknowledging, however, a Divine Creator, united in the noble cause of increasing the happiness, "relieving the distresses, soothing the afflictions," and succouring the necessities of one another. In its expressions of human necessities of one another. In its expressions of human sympathy it would enforce what is really the great aim of life, as John Wesley puts it, "to leave the world better than we found it," by infusing in all around, and extending on every side of us, those kindly and engaging sympathies of the human heart and affection which always seem to remind us of a Divine Original, and which, when duly cultivated and religiously directed, tend more than anything else to the harminess of society, the welfare of anything else to the happiness of society, the welfare of our race, and the civilisation of mankind. In Love of Truth, Freemasonry proclaims the solemn reality-that there is such a thing as Truth; and that, whether in its more dogmatic form or in its practical development by us, by a hatred of hypocrisy, of insincerity, of treachery, it is one of the noblest characteristics of the human mind and conduct. When we come to the concrete virtues or graces which Freemasonry professes to recommend to its votaries, time fails me, on the present occasion, to enlarge upon them fully. In its respect for Law and Order, Freemasonry in our favoured land declares loyalty to our Sovereign the first duty of every citizen and Freemason; forbids all participation in revolutionary societies (the enemies of true liberty), and while it enjoins obedience to the laws of our own country, enlightened and admirable as they are, it also enjoins us to obey the laws of any land "which for a time may become the place of our residence or afford us its protection," as peaceful citizens, travellers or sojourners. In its toleration, it knows nothing of the controversies or the divergencies of the human mind, the often angry utterances of bitter partizans, or those unhappy divisions which seem to separate brother from brother. It bids all its members meet as brethren, work as brethren, be social as brethren, part as brethren, and to forget for a few peace-ful hours all those inevitable and inherited severances, which in the world without often seem to divide us into contending hosts. Freemasonry, though not a religion in itself, is ever most reverent in respect of the undoubted claims of religion on man's best feelings, and ever ready to assist in all that tends to illuminate the minds, satisfy the needs, and extend the benefits of culture and civilizing influences in all directions and among all classes. It may be remembered, to its praise, that it never begins or closes its work without prayer, and that the Bible, the "great light of Freemasonry," is ever open in our midst. All its utterances breathe a spirit of reverential piety and true morality, and are alike beautiful in precept, in purity, and religious feeling. Some of us remember those words spoken by the Marquis of Ripon, when Grand Master, in Grand Lodge, on the 4th of March, 1874, "Remember, the strength of our Order lies not in the number of our lodges, or in the increasing roll of our members, but in the fraternal spirit by which the members are animated, and which lives and breathes in our lodges." And what shall I say about its Charity? It is illimitable, in that, expanding year by year, it has become a marvellous reality, a living proof of the true spirit which adorns, and we may truly say consecrates, Free-masonry. It does good in countless ways. For instance, take its great Charitable Institutions, with an income of more than £50,000—the interest on a million of money at 5 per cent.—whereby it educates, clothes, and feeds 258 boys and 240 girls, and succours the aged and infirm, by granting annuities to 405 old men and widows. Take again our own local Charity in Leeds, which, though so recently own local charty in Leeds, which, though so recently established, has been the means of educating 39 orphan children, who otherwise would have been debarred the benefit of a sound education. These and countless other deeds may truly be considered those distinguishing badges which do honour to its own professions, and best charac-terise its useful and beneficent existence. "Freemasonry terise its useful and beneficent existence. is an Institution founded upon and growing out of the necessities of men, as social, as intellectual, and as re-ligious beings. It has demonstrated its capacity for adapting itself to these wants in all ages of human experience. Amid the rivalries and antagonisms of active life there is a longing of the soul for union and brotherly love, and for such relations as will satisfy the necessities of our social nature. It is upon this principle that our Order is founded, hence it cannot fail to exist; it must grow and prosper necessarily with the growth and development of man's better sentiments. It is not aggressive, it is not obtrusive. It makes no issues, it sets up no rivalries with other Institu-tions, but, gathering up the ages, it recognises the inner cravings of the soul and the universal brotherhood of man, forgetting all else in its devotion to his higher and better deeds." The writer of the article on "Freemasonry" in the Encyclopædia Britannica, in his concluding paragraph, uses these words, "As regards the future of Freemasonry, it is impossible, at least for outsiders, to say much. The celebration of the universal brotherhood of man and the celebration of universal goodwill in the abstract seem rather indefinite objects for any Society in this imaginative age." The Dean of Christ Church, Oxford, when addresssing the Mayor and Corporation and people of Oxford on their Jubilee Festival the other day, used these words: "The great lesson, after all, to lay to heart is, that the future is very much what we individually shall make it, and if we do not play our parts amiss, the results we may in faith leave to God." And so may we say of the future of Freemasonry, if we make it a living reality; if we perform our duties aright, act up to the great principles of our Order, fusive Charity; by constancy and sincerity in our friendships, and by a uniform good, kind, and virtuous deportment," "prove to the world the happy and beneficial effects your ancient and truly honourable Society," "so that when a man is said to be a Mason the world may know him to be one to whom the burdened heart may pour forth its sorrows; to whom distress may prefer its suit; whose hand is guided by justice, and whose heart is expanded by benevolence."
