THE CRAFT IN SUFFOLK.

Our brethren in Suffolk have had a most successful year, and therefore the rejoicing which was so conspicuous a feature at the annual meeting of their Provincial Grand Lodge at Bury St. Edmunds on the 18th ult. under the banner of the Royal St. Edmunds Lodge, No. 1008, and the presidency of Lord HENNIKER, P.G.M., is not to be wondered at. As we pointed out in our analysis of the Boys' School Festival Returns, the Province has contributed upwards of £600 amongst our Charitable Institutions during the present year, and that, too, after a succession of three heavy years in which the amount obtained from the same source amounted to close on £2950. Then it was announced that a petition for a new lodge to be located at Felixstowe had been sent in, an announcement which was greeted with all the more enthusiasm from the fact that eight years have elapsed since the present junior lodge on the Provincial roll was consecrated. In other respects also the Province appears to have substantially improved its position. The number of its subscribing members is in excess of 900, showing an advance of nearly 40 brethren as compared with the previous year, while as regards the sinews necessary to carry on the peaceful pursuits of Masonry, the Treasurer was in a position to report the existence of a handsome balance on the right side of his account, and likewise considerably in excess of the balance stated in his previous year's report. These facts, which redound so largely to the credit of the lodges and brethren in Suffolk, very naturally created a large amount of satisfaction, nor is it possible for us to notice them without tendering to the Province our most hearty congratulations, both on its present prosperous condition and the equal or even greater measure of prosperity which apparently awaits it in the future. There was also one very sound practical recommendation by the Committee of the Suffolk Masonic Charity Association to which, in these days of keen competition for places among the successful candidates at our annual elections, deserves especial prominence. It was pointed out that when a lodge voted five guineas from its funds towards the Benevolent Institution it only secured a vote for 15 years, and that if it were not supplemented by a further five guineas within two years, the privilege expired on the completion of the period arranged. As regards the Schools also, it was shown that a donation of five guineas secured no vote whatever, while one of twice that amount would secure one vote in perpetuity at every election. These are points that are worthy of consideration, not only by Suffolk, but by all lodges throughout the country. It often happens that a lodge makes a donation annually of five guineas, which is effective for voting purposes during the year in which it is given, but useless afterwards, whereas 10 guineas given in alternate years secure a vote for ever. However, the matter is so clear that we need not discuss it further. All we need add is that a Province whose interests are so well looked after by its Provincial Grand Master and his officers, as well as by the Committee of its Charitable Association, deserves, as it is evident that in this particular instance it has experienced, a measure of prosperity that is full and overflowing. May our reports from Suffolk be always as bright and cheerful as the one we have so much pleasure in recording in another part of our columns!

THE PROVINCE OF SOMERSETSHIRE AND ITS LATE PROV. G.M.

There was a numerous attendance at the Special Provincial Grand Lodge of Somersetshire, which was held in the Town Hall, Highbridge, on the 15th ult., under the presidency of Bro. R. C. Else, Past GD. of England and Deputy P.G.M., while the emblems of mourning which were visible in all parts of the lodge room were as the outward and visible sign of the deep grief which pervaded the minds of all present. No ordinary business was appointed to be done, the Provincial Grand Lodge having been specially summoned for the sole purpose of expressing and

recording in appropriate language the sincere sympathy of the brethren of Somersetshire with the widowed Countess of CAR-NARVON and the children of her late husband in the recent terrible bereavement with which it has pleased the Great Architect of the Universe to visit them. The grief of the Craft generally at the death of so distinguished and courteous a Mason as the late PRO GRAND MASTER OF ENGLAND has found free and full expression in all parts of the country, nor in all probability has there been held, since his lordship's death became known, a single Masonic meeting at which the great loss thereby sustained by English Freemasonry has not been more or less pointedly referred to. But in Somersetshire, in the province over which his lordship had presided for the last 21 years with so much urbanity and kindness, in whose welfare he had taken so deep an interest, and for whose benefit he had laboured so assiduously and successfully, it is no more than natural that, as the blow has been felt more severely and immediately, so should the grief for its occurrence be the more poignant. Others may have known his lordship through being officially associated with him in Masonic duty, or from listening to his eloquent speeches in Grand Lodge, and witnessing the ability with which he presided in that assembly. But our Somersetshire brethren were still more intimately bound to him. They regarded him not merely as their ruler, but even as one of themselves, as one who took a deep and kindly interest in the success and prosperity of their lodges, and who never lost an opportunity of promoting that success and prosperity. Thus, by his lordship's death they have lost not only a respected chief, but likewise their truest and best friend, in whose unvarying kindness they had the most implicit confidence; and we may be sure their sorrow is commensurate with their loss, and that the memory of him who is gone from their midst will be affectionately cherished and respected while there is a single lodge and even but a single brother in the Province to cherish and respect it. This, indeed, was well exemplified at the recent special meeting of their Provincial Grand Lodge. Bro. ELSE, Dep. Prov. G.M., who presided and proposed the resolution of condolence with the widow and children of the late Earl, was eloquent, but not more eloquent than just, in his tribute of praise to one who had distinguished himself so highly as a Statesman, in literature, and in Freemasonry, and who, above all things, had shown in all the various parts he had played that he was the very beau ideal of a courteous English gentleman. STOTHERT'S address, which, in consequence of a passing infirmity of speech, was read for him by a brother present, was equally appreciative, while the few words added by Bro. E. WHITE, who had witnessed his lordship's initiation in the Westminster and Keystone Lodge in February, 1856, were equally emphatic and to the purpose. It is indeed impossible that more fitting testimony could have been borne to any man of equal or even of greater distinction, and we sincerely congratulate our Somersetshire brethren on having acquitted themselves so gracefully and, at the same time, so feelingly, in the performance of a most mournful duty.

DISTRICT GRAND LODGE OF BOMBAY.

The Report of the Proceedings at the Fifty-seventh Half-yearly Communication of the District Grand Lodge of Bombay on the 31st March last demonstrates clearly enough that during the period H.R.H. the Duke of CONNAUGHT was actively engaged in the performance of his duties as District Grand Master, the Craft made very considerable progress, and thereby materially strengthened a position which was also already strong. It is well known that his Royal Highness evinced a deep interest in the lodges in this district, and that whenever the exigencies of military duty permitted, he was both ready and anxious to do all in his power to promote the welfare of the Craft generally. The result of his efforts will be apparent to those who read this Report. Thus the District Grand Treasurer's accounts show that at the close of the year ended 31st December,

1889, the District Grand Lodge held at credit in cash over 11,716 rupees, of which some 10,581 rupees belonged to the Fund of Benevolence, while there was also a sum of 33,132 rupees to the credit of the Bombay Masonic Association. These figures, as the Deputy District Grand Master, who presided on this occasion, pointed out in his address to the brethren, indicate that during the year 1889 there was an increase in the Fund of Benevolence amounting to 1288 rupees, and in the fund of the Bombay Masonic Association of 2758 rupees. Again, as regards the Hall Account, the Report of the Joint Hall Committee shows the revenue for the past year to have exceeded the expenditure by 1047 rupees, the credit balance carried forward to the current year being only a fraction short of 6226 rupees. Add to this that the official visitations to sundry lodges, the deputations from sundry other lodges to his Royal Highness, and the reports of the District Grand Secretary, &c., all tend in the same gratifying direction, and our readers will be in a position to form some idea of the beneficial results of the Duke of CONNAUGHT'S rule as Dist. G. Master of Bombay. He appears also to have been equally popular with the brethren of the Scotch as well as of the English Constitutions, his policy having been to bind and strengthen the ties by which the brethren of the two Constitutions were knit together. The only regret we have reason to feel after perusing this Report is that we must henceforth speak of Bro. HAROLD KING, Past Grand Deacon of England, not as Deputy District Grand Master, but as Past Deputy, of Bombay. Bro. KING has retired from an important and responsible office, which he had held for five years with credit to himself and to the very great advantage of the Craft, and we trust that his successor, Bro. H. W. BARROW, who has been appointed to the vacant office by his Royal Highness the District Grand Master, will be as successful in the performance of his duties as Bro. KING.

The dinner was awfully nice, and in the middle of it we had a sorbet, with a mayonnaise of lobster after. At our table we managed to have champagne all the way through, but it was decanted, and Mr. B. (you know who I mean) said it was toast-

and-water. I wonder why?

After dinner came the toasts, with music in between.

Clara Samuell sang her songs divinely, and Ethel Bevans had a great difficulty in avoiding an encore for a song called "A Summer Night." Bernard Law gave us "I'll sing thee Songs of Araby," and so sweetly. With the dessert Mr. Cordeux-Rhys gave us each a box of delicious sweets, all made like little squares and compasses and things; Fred told me he thought they must have been made specially for us. KNIGHTS TEMPLARS.

In Bro. Richard Wolfe's (formerly Woof, deceased) sketch of the Knights Templars, 1865, particulars are given of what may be termed the French branch of the Templars, which it is asserted has maintained "a complete succession from the early Templars." In Mill's "History of Chivalry," and in a "Manual of the Order," it is declared that Jacques de Molay "foreseeing the evils which threatened the fraternity, appointed as his successor Brother John Mark Larmenius, of Jerusalem, who, in 1324, executed a Charter, by which the Grand Mastership was transmitted, and which has continued to be signed by each successive Grand Master down to the present time." (P. 18, Woof.)

In this document the Scottish Templars are styled "Deserters of the Order, and cast off with an anathema." Likewise the supposed Grand Master says: "I have appointed signs, unknown to and out of the reach of the false brethren (which reads more like eighteenth century style), the date (?) of this curious epistle being 13th February, 1324. The lamented author of the sketch considers it to be "a genuine record of antiquity," and that the doubts of its authenticity were due to the communications made by an expelled member this century to M. Clavel. Admiral Sir Wm. Sidney Smith was Regent in 1838, and the Duke of Sussex (who was Grand Prior of England), and many other English noblemen, were members; the badge, as the decoration, consisting of a gold cross of eight points, enamelled white, charged with a cross pattee of red enamel, and surmounted by the Grand Master's crown.

There was a "Metropolitan Convent in London, of which the 7th Duke of Beaufort, the 3rd Marquis of Donegal, the 1st Earl of Durham (entitled Grand Prior of Scotland), Colonel Kemeys-Tynte, the 3rd Duke of Leinster (G.P. of Ireland), the 4th Earl of Milltown, WilliamWilliams, M.P., and others, were members. Eight were mentioned as living in 1865.

Quite a number of brethren in India are noted as belonging to the Order, under the local rule of the Chevalier Burnes.

There was also a "Convent" at Liverpool, meeting in a building called the "Templars' Hall," and numbering about thirty. The names of some 25 are recorded by Brother Woof; H. Stewart De Lancaster being the Baillie, in 1836.

The same authority mentions the name of Henry Lucas, as the Secrétaire, but evidently was not aware of the name of the convent. That I am able to supply from the title-page to a very rare work entitled-

Manual of the Knights of the Order of the Temple [Coat of Arms, V.D.S.A.], Translated (from the Paris Edition of 707—1825 by authority. By the Chevalier Guyot, printer to the Militia of the Temple) by Fra. Henry Lucas, for the Priory of Jacques de Molay, Liverpool, 1830.—Printed by David Marples, No. 71, Lord-street, Liverpool.

At page 11 it is stated "The Charter of Transmission [A.D. 1324] is preserved, with other writings not less precious, &c., in the treasure of the Order of the Temple;" and at pages 12-13 we read "The different Orders of Masonry are, without doubt, only counterfeits of the Order of the Temple."

The anniversary of the martyr was celebrated on the last day of every lunar year, and his relics, bones, sword, spurs, &c., are

still preserved.

The statutes are all printed in this handsome 32mo volume (pp. 324), and are of a most elaborate character. There is likewise a Bibliography of the Temple.

Bro. Tracy, P.G. Sec., read the report of the Board of General Purposes, which stated that a great improvement had been manifested during the last year in the province. By last year's report there was a total of 870, whilst this year it is 909—a gain of 39. The initiations had been 67, as compared with 55; joinings 909—a gain of 39. The initiations had been 67, as compared with 55; joinings 26, as against 21. This improvement, however, was rather decreased by losses from death and various causes—62, as against 51 last year. The balance in favour of the province, after providing for the discharge of all liabilities, was £62 15s. 10d., as compared with £44 2s. 6d. In continuation of the improvement mattered the Board potential with pleasure that a patition had been presented ment mentioned, the Board noted with pleasure that a petition had been presented to the M.W.G.M. for a lodge at Felixstowe. The Board recommended that £13 be voted towards the decoration of the Centenary Hall of the Girls' School; 10 guineas to each of the Boys' and Girls' School; and 10 guineas to each of the Male and Female Funds of the Benevolent Institution.

The report was adopted.

Bro. TRACY, P.G. Sec., proposed, and Bro. the Rev. C. J. MARTYN, D.P.G.M., seconded, that a sum of 10 guineas be given to the Binckes Indemnity Fund. Bro. the Rev. E. GRIFFITHS, P.P.G.C., supported the motion, which was unani-

mously carried.

The report of the Suffolk Masonic Charity Association stated that the total contributions to the three Institutions of Masonry from the province of Suffolk during the past year amounted to £645. The Committee desired to impress upon the brethren that when a lodge gave only five guineas to the Benevolent Institution, it only secured voting power for 15 years, and if not supplemented by another five guineas within two years the vote expired, and they strongly recommended that all lodge votes should be made perpetual. With regard to the Girls' and Boys' Institutions, when a lodge gave five guineas it did not qualify for a vote. Every 25 guineas the Steward received entitled him to a vote, and when the lodge sent another five guineas it then obtained a vote, and not till then.

The report was adopted.

The PROV. GRAND MASTER, in a brief address, thanked the Bury brethren for the reception which they had accorded the Prov. Grand Lodge that day, and, referring to the new Masonic Hall, he said it looked as though Masonry was flourishing in Bury. Indeed, he thought all would join him in satisfaction at the progress Masonry was making in the province over which he had the honour to preside, and mentioned, as an indication, the fact of a new lodge being soon formed at Felixstowe, and which he believed would be a prosperous one. He alluded to the death of the Earl of Carnarvon, Pro Grand Master, of whose gentle, good, kind, and generous qualities he spoke in feeling terms. In conclusion, the Provincial Grand Master invited the lodge to honour him with their presence at Thornham next year—an invitation which was cordially accepted in behalf of the brethren by Bro. Rev. C. J. MARTYN, D.P.G.M., who proposed a vote of thanks to his lord-

ship for the invitation, which was carried.

The Prov. Grand Lodge then closed, and the brethren proceeded in procession

to St. Mary's Church, where a special choral service was held.

Provincial Grand Lodge having been closed, the brethren proceeded to church, and at the conclusion of the service sat down to banquet at the Angel Hotel, Bro. West again presiding.

Bro. John O'Connell, P.M., Prov. Grand Organist, presided at the organ, and as the brethren entered the church played "The War March of the Priests" (Mendelssohn). The service was fully choral, and included a processional and recessional hymn, as well as the very appropriate anthem, "Behold, how good and joyful a thing it is, brethren, to dwell together in unity." Before proposing the usual toasts, Bro. West said he considered the fine day they were enjoying was a good augury for the fortunes of the Provincial Grand Lodge of Surrey. He felt he ought not to take up too much of the splendid day in speaking to the usual toasts, and therefore should be very brief in his remarks. He would first ask them to drink to "The Health of the Queen and to the Prosperity of the Craft," which having been done, the toast of "The Prince of Wales,

the M.W.G.M.," was submitted.

The next toast, Bro. WEST said, was another always familiar at Masonic gatherings—"The Deputy Grand Master and the rest of the Grand Officers, Present and Past." The brethren would have discovered by their proceedings in Prov. Grand Lodge that day that they had lost a distinguished Craftsman, even if they were not already aware of the severe loss sustained by the death of the Earl of Carnarvon, Pro Grand Master of England. He was a Mason respected by every member of the Order, and he (Bro. West) felt sure each Surrey Mason would join in expressing regret at his death, and would also add a word of sympathy to those members of his family left to mourn his death. With the toast was coupled the name of Bro. Dumas, who, the Chairman said, was a distinguished P.G. Officer of England almost, if not quite, senior of the long array of brethren who comprised the Past Grand Deacons of England.

Bro. Dumas had the greatest satisfaction in replying to the toast and acknow-

ledging the hearty reception that had been accorded it by the brethren present. It was indeed a proud day to him, as he had had the pleasure of witnessing the investiture of his own son as Junior Grand Warden of the Province. He hoped he would give satisfaction in that position. Bro. Dumas then proposed the toast of the "Acting Provincial Grand Master." If it were mere gratitude to the brother whose toast he had to propose he felt sure the reception would be a hearty one, but there was in addition a kindliness of feeling and true fraternal spirit to be acknowledged which would ensure a true welcome to the toast. Of Bro. West it might be said, his ambition is worthy of the objects to which he devotes it, while the objects are also worthy of the distinguished brother who has now the honour of presiding over the province. The attendance that day was proof that the brethren of the district not only approved his appointment, but also approved of him personally. They appeared to look upon him as a true and good Master in charge, and he felt he might say the Masons of the district were as ready to do their duty towards Bro. West as he appeared anxious to perform his.

In reply, Bro. West said he hardly knew how to express himself in proper acknowledgment of the splendid gathering that day, and of the hearty reception given to him as officer in charge of the Province of Surrey. Presiding over a province such as theirs, as he had virtually done for the past three years, was no easy task. The brethren who attended the meetings of Provincial Grand Lodge might imagine theirs was a bed of roses, as they happily never saw the hard side of the Masonry of the district. There were brethren in Freemasonry just as there were lodges where troubles occurred, but those grievances, happily, seldom saw the light of day, at least in public. He should always endeavour to prevent anything that might appear to show a non-Masonic spirit, and which came under the notice of the provincial rulers, from securing general publicity, and felt that in that respect he and others at the head of affairs were justified in exercising the authority

with which they were invested.

The next toast was that of "The Visitors." Bro. West said he considered that no province, no lodge, or other body of men could get on without the presence of friends and guests who could advise, criticise, or sympathise with them. That day they had a large number of visitors, and they were always ready in Surrey to give them as hearty a welcome as would, he was sure, be accorded them that day. With the toast he had the pleasure of coupling the name of Bro. Fairchild, P.M. of several lodges, and one who took a great interest in Freemasonry and the Charitable Institutions connected with the Order.

He felt he would do all in his power to secure the success of his new position. As regarded their new Prov. J.G.W., he felt they need have no fear. CONSECRATION OF THE COVENT GARDEN CHAPTER, No. 1614.

On Friday, the 25th ult., a new Royal Arch chapter was consecrated at the Criterion Restaurant, Piccadilly, by Comp. Col. Shadwell H. Clerke, Grand Scribe E., who was assisted in the ceremony by Comps. W. George Lemon, as H.; the Rev. J. Studholme Brownrigg, as J.; R. Turtle Pigott, D.C.L., as S.N.; and Frank Richardson, P.G.S., as Director of Ceremonies. There was a large attendance of companions on the occasion, many of whom are members of the Covent Garden Lodge, No. 1614, to which the new chapter is attached.

Clerke addressed the companions on the object of the meeting, and on the importance of the Royal Arch Degree, and expressed his earnest hope that the new chapter which he was about to consecrate would be successful in its career and add

many worthy, good, and sincere brethren to the roll of the Royal Arch.

Comp. the Rev. J. Studholme Brownrigg afterwards delivered the following

Companions,—We welcome heartily a new Royal Arch chapter, especially because the daily growing interest taken in our Order is directing attention to many other Degrees, which, though not formally recognised, are still most justly respected and countenanced by the rulers of our Craft. Whilst fully admitting the right of other legitimate Masonic jurisdictions to gather from the field before them an abundant and satisfactory harvest, it is much to be desired that this harvest the valid not be recorded to the desired that the legitimate of Povel Arch much to be desired that this harvest should not be reaped at the expense of Royal Arch Masonry. I am sure they do not desire this, but I am sure also that there is some danger lest the numbers of Royal Arch Masons in England should in its proportion to the Craft fail always to hold its own. A practical question it certainly is as to what line a new Royal Arch chapter should take in order to commend itself to the Craft at large and to the partial or before with which it is connected. the particular lodge with which it is connected. And, first of all, let me notice one too common misfortune. It is by no means an uncommon thing to find a zealous and competent Master of a Craft lodge develope into an inefficient Principal. I am aware of the temptations. Comparatively speaking the chapter meets so seldom and the ceremonies are so rare, that it is hardly worth while to perfect oneself in work which one may never be called upon to do. The result is that when there is work to do it is either badly done, be called upon to do. The result is that when there is work to do it is either badly done, or done over again by one or two companions of the chapter, and the whole tone and character of the chapter suffers. But further, the work is difficult—it needs, as does all other Masonic work, something more than mere verbal accuracy. In this Degree more, perhaps, than in any other Degree—the modulation of the voice, most accurate punctuation, distinct pronunciation, and a easy, natural, unaffected address is essential. Companions need instruction not merely what to say, but how to say it. There are little tricks of the trade which Principals ought to teach their successors. One more caution and I have done. The impression conveyed upon the candidate and upon the companions depends immensely upon their not being wearied. It is quite as sinful to waste time in chapter as anywhere else. A good First Principal begins punctually, goes straight on with his work, keeping others up to their work, and so saves at least twenty-five per cent. of time. The ceremony should not be hurried, but it should not be spoiled by unnecessary pauses. Pardon these suggestions, and be assured that I have every confidence that your chapter will be a credit to yourselves and an ornament to the Craft. The ceremony of consecration followed, after which Comp. Col. Shadwell H.

The ceremony of consecration followed, after which Comp. Col. Shadwell H. Clerke conferred the secrets of the J., H., and Z. chairs on Comp. Samuel Hewett, and of the J. chair on Comp. Frederick Kedge, and placed Comp. Simeon Jacobs, P.Z., in the H. chair. Comp. Col. Shadwell H. Clerke was in splendid form, and executed all the lengthy and intricate ceremonies in a manner which afforded an intellectual treat to admirers of perfect working. The officers of the chapter below the three Principals' chairs were subsequently invested as follows: Comps. George Reynolds, S.E.; J. Skinner, S.N.; Charles O. Burgess, Treas.; Walter Hancock, P.S.; George Coleman, 1st A.S.; Wm. Clarke, 2nd A.S.; John Jacobs, D.C.; C. W. Frommholz, Stwd.; and Robert F. Potter, Janitor. Comp. Coltart, at the request of the M.E.Z., agreed to act as I.P.Z. for the first year of the chapter.

Comp. Reynolds proposed, and Comp. Cox seconded, that Comps. Col. Shadwell H. Clerke, W. G. Lemon, Rev. J. Studholme Brownrigg, and Dr. R. Turtle Pigott, D.C.L., be elected as honorary members of the chapter.

The motion was carried unanimously, and the M.E.Z. thanked those companions for the services they had rendered that day in consecrating the chapter.

Founders' jewels were presented to the Consecrating Officers, and Comp. Col. SHADWELL H. CLERKE responded to the compliment which had been passed.

A Committee for framing the by-laws was appointed, and the names of 28 candidates for exaltation were then proposed.

The chapter was thereafter closed, and the companions adjourned to an elegant banquet, served under the personal superintendence of Bro. G. P. Bertini assisted by Mr. Olivier.

The usual Royal Arch and loyal toasts followed, the music, which was interspersed, being under the direction of Comp. Herbert Schartau, assisted by

Comps. Egbert Roberts and Henry Guy.
Comp. Col. MARMADUKE RAMSAY, Dist. G. Supt. Malta, responded to the toast which included the Grand Officers, and after a passing reference to the song "Will o' the Wisp," expressed the pleasure he personally felt at attending the inauguration of a new chapter, more especially one which started under such happy auspices as the Covent Garden Chapter. He trusted to be often able to attend and see the chapter working and pursuing a prosperous course in propagating Royal Arch Masonry.

The M.E.Z. proposed "The Consecrating Officer and the Grand Officers who assisted him." All the companions would agree with him when he said they owed the Consecrating Officers a deep debt of gratitude. The only way they could show their gratitude was by a strict adherence to those excellent precepts which were so strongly impressed on the companions to make the chapter second to none, so that when they might have the honour of another visit from the Grand Officers-which he hoped they very often would-those companions would have

no occasion to regret the part they took in launching the chapter.

Comp. Col. Shadwell H. Clerke, in reply, said as Consecrating Principal on that occasion he felt personally a very great pleasure in recognising the kind expressions of the M.E.Z., which he was always ready to give to those who were ready to do their duty in Masonry. All the Consecrating Officers attended with a great deal of pleasure, of satisfaction to themselves to try and assist in any way possible to start a new chapter on the right road. They believed they had started it thus, and that in its future career it would achieve that high position they all desired it should attain to. Comp. Col. Ramsay seemed rather to like to be called "Will of the Wisp": it might be that in his district be might be in the healt of "Will o' the Wisp"; it might be that in his district he might be in the habit of flying about over fens and morasses; but he (Comp. Col. Clerke) confessed that the song which came after "Will o' the Wisp" was a little hard upon himself personally and his companions in the consecration, who were called "Stars of the summer night." As far as his memory served him the ceremonies of consecration which Comp. Richardson and himself were so continually engaged in were by no means confined to summer nights. He had a distinct recollection of some 10 years ago being engaged in a consecration—in January, 1881, when there was an awful storm of snow, and they had to go through ten feet of snow to get to their dwellings. The event was accentuated, as Comp. Richardson would not have forgotten, inasmuch as the lodge that was consecrated was at Kensington, by some arrangement the dinner was sent to Clapham. With ten feet of snow on the ground it was delightful to turn out at eleven o'clock p.m. It was, therefore, a little hard that the Grand Officers were set down on the programme as "Stars of the summer night." However, he knew that, whether winter or summer, all those brethren who assisted him so heartily and enthusiastically, were always ready to go whether to Clapham or elsewhere to do their best to further the interest of Freemasonry, to give a leverage to a lodge or chapter, to start it on its road, and to wish it God-speed. Passing away from this episode, he would go on to the toast of "The M.E.Z.," and he would couple with it the toast "Prosperity to the Covent Garden Chapter." He had not the honour of consecrating the Covent Garden Lodge; that honour fell to the hands of his late lamented predecessor, John Hervey; but it was consecrated some 16 years ago, and it had had since then a very prosperous, useful, and distinguished career. Therefore he was glad its members had gone in for a chapter to complete the Masonic superstructure, and he was personally very glad indeed and pleased to be allowed to come that night, and in the position he held, to consecrate it in the name and on behalf of the Grand Master and Grand First Principal. The companions had made a good selection of officers to fill the chairs, and the First Principal designate was selected no doubt to a great extent because he was W.M. of the mother lodge, which of course gave him a special position in the chair. He thought the companions did right in selecting him to take the first position in the new body. Masonic Motes.

The meeting of the General Committee of the Royal Masonic Institution for Boys, which is fixed for to-morrow (Saturday) at Freemasons' Hall, will be of a purely formal character, and the business which under ordinary circumstances would be transacted will be deferred till Saturday, the 9th inst., on which day the newly-elected Secretary, Bro. J. Morrison McLeod, will enter upon the duties of his office.

The Queen has been pleased to appoint Bro. the Earl of Jersey to the Governorship of New South Wales, which will be vacant at an early date by the retirement of Bro. Lord Carrington, who is expected to return to this country in November next. As our readers are aware, Bro. Lord Carrington is M.W. Grand Master of the United Grand Lodge of New South Wales, but will doubtless resign his office on leaving the colony. They are also no doubt aware that Bro. the Earl of Jersey is a Past Senior Grand Warden of England and Prov. Grand Master of Oxfordshire, so that in the event of our New South Wales brethren being anxious for a continuance of the connection now existing between them and the United Grand Lodge of England, and provided, of course, that their Governor nominate, like the well known Mr. Barkis, "is willin'," they will have the opportunity of electing the Earl of Jersey as successor to their present chief.

It would certainly not be a bad move on the part of the New South Wales Grand Lodge if it were to act in accordance with the suggestion we have thrown out. It is reasonable to suppose that the union of the various Masonic Constitutions formerly existing in this important colony was more easily and more effectually cemented by the appointment as Grand Master of Bro. Lord Carrington, who, both as the representative of the Queen and by his high social and Masonic position, would necessarily and has since proved himself to be above the slightest suspicion of a predilection in favour of any one of the separate Constitutions existing in the colony at the time of his lordship's installation as Governor. And the same idea must hold good in the case of the Earl of Jersey, who, politically and socially, will stand on precisely the same footing towards the colony as his noble predecessor, while as regards his connection with Freemasonry, it has been both of longer duration and more varied, his lordship having for some years occupied the same positions in English Mark Masonry as he has held, or now holds, in our English

Bro. Massey, Charles Frederick Hogard, and F. Binckes.

After the reading and confirmation of the minutes of the Quarterly Court of April last, Bro. BINCKES read a letter from the family of the late Bro. Raynham W. Stewart, P.G.D., thanking the Court for the vote of sympathy with them in their bereavement. He also read a letter from Bro. W. W. B. Beach, Prov. G.M. of Hants and the Isle of Wight, accepting the office of Trustee of the Institution, to which he was elected at the April Court, and thanking the brethren for the honour conferred upon him.

The brethren then proceeded to discuss a resolution of the General Committee of Saturday, 7th June, 1890, referring to this Court an appeal from the Province of Cumberland and Westmorland for the admission to the Institution of James Carruthers, unsuccessful on the last application for which he was eligible, with 1768 votes, at the election in April last. A letter was read from Bro. George J. Mackay, the Secretary of the province, appealing to the brethren on behalf of Carruthers, and trusting that the large support which the province had given to the Charity would be taken

Bro. J. S. CUMBERLAND said it was a very disagreeable office to oppose anything of this kind. Bro. Mackay was very unfortunate in not getting his candidate elected, but he was afraid no exception to the established rule could be made in his interest. If they opened the door in one case they would have to do so in exceptional cases in the future. They must not strain the laws of the Institution. Bro. Mackay's fault at the election was that he was polling a sufficient number of votes. Under the circumstances he (Bro. Cumberland) could only move that the child be refused.

Bro. A. C. SPAULL said no doubt they would all be very glad to take a boy into the Institution if they possibly could do so.

Bro. J. E. LE FEUVRE did not see what else they could do in this case but refuse the boy. The Institution had its laws, and the Court and Committee were bound to abide by them. His own province was in the same position as Cumberland and Westmorland with a widow. They thought 100 votes were polled more than had been polled, and the poor woman was the highest unsuccessful. But the province had not applied to the Benevolent Institution to take that candidate in. She was only out by seven votes.

Bro. BOURNE said the Province of Cumberland and

Westmorland did not exchange votes with neighbouring provinces. All that they could exchange up in London they exchanged.

The petition was then rejected.

He only threw it out as a hint, because hitherto the rules of the two Institutions had been the same, mutatis mutandis. Now, the Boys' School were going to make great alterations in their rules, and he thought it would only be justice and courtesy to the other Institutions that this Institution should, to a certain extent, take them into their confidence. An approach should be made towards them in some shape or form.

Bro. BINCKES said there were certain points of difference in the rules of the respective Institutions. Bro. HOGARD observed that there could be no harm in sending to the Committee of the Girls' School a

copy of the new laws of the Boys' School. Bro. J. S. CUMBERLAND thought it would be advisable; it could do no harm, if it did no good.

Bro. ATTENBOROUGH observed that the object was to have the draft laws as altered placed in the hands of the General Committee for deliberation on the 9th of

Bro. J. S. CUMBERLAND remarked that he had been told that it was not intended to send the new rules out to the Provincial Secretaries.

Bro. Attenborough said that on the 9th of August the by-laws would be presented to the General Committee, and the Secretaries of the provinces could attend that meeting. The new laws were not to be passed at the meeting of the 9th of August, they were only to be presented to the General Committee, and the General Committee were to have from that day till the Quarterly Court in October to consider them; that would give them two months.

Bro. HOGARD said that for the meeting in

October a notice could be given under Law 34.

Bro. J. S. CUMBERLAND thereupon moved that a copy of these by-laws be sent to each Provincial Grand Secretary. Let them be sent out at once; they could not be sent too soon.

Bro. Spaull said it would be quite soon enough to

make this motion at the meeting of the 9th of August. The by-laws were not ready yet. He did not think it would be courteous to send them out to the provinces before they came before the Committee. The whole

constituency was from Sooo to 9000.

The subject then dropped, and a vote of thanks to the Chairman closed the proceedings.

THE JAMES TERRY LODGE.

The M.W. Grand Master, H.R.H. the Prince of Wales, has granted a warrant for a new lodge to be held at the Public Hall, Crossbrook-street, Cheshunt. The ceremony of consecration will be performed by the Prov. Grand Master, Bro. T. F. Halsey, M.P., about the middle of September, the number is to be 2372, and, named after its first Worshipful Master, it will be called the James Terry Lodge. Bro. James Terry has done much for the cause of Masonry generally, but for the Province of Hertfordshire most particularly, and in consequence of the increased and overflowing number of members of one lodge in the province and the desire of several Masons of the vicinity not members of a lodge near their residence, it was requisite that a new lodge should be formed, and unanimously (but without that brother's knowledge) it was decided to hand down to posterity the name of Bro. James Terry as a mark of the high estimation and respect with which he is held in the province. Upwards of 20 years he has been a Grand Officer of the Province of Hertfordshire, viz., Prov. Grand Director of Ceremonies, and has also served as Prov. Grand Warden of Herts, Prov. Senior Grand Warden of Northants and Hunts; he is Past Master of many lodges, Vice-President of all the Masonic Charities, has for many years been the indefatigable Secretary of the Royal Masonic Benevolent Institution for Aged Freemasons and Widows of Freemasons, and occupies the proud position of Past Grand Sword Bearer of England, having been elevated and invested to that high office by H.R.H. the Prince of Wales himself in 1887, on the occasion of the great meeting of Freemasons at the Albert Hall to commemorate the Queen's Jubilee.

The founders unanimously requested their Secretary to ask the permission of Bro. Terry for his name to be used, and, as a still further favour, that he would become the first Worshipful Master. It was not, however, until Bro. Terry was assured of the unanimity of the brethren on these points that he modestly consented to their request. The new lodge will have a fair start with about 20 founders, also a list to be submitted at the first meeting of joining members and of proposals for initiation.

Obituary.

BRO. W. H. PERRYMAN, P.G.P.

We deeply regret that it should devolve on us to announce the death, on Wednesday, after a severe and protracted illness, of Bro. W. H. Perryman, Past G. Purst. of the United Grand Lodge. Our deceased brother had been a very active member from the time of his initiation in November, 1871, till very recently. He first saw the light in the Lodge of Fidelity, No. 3, and less than four years later had the honour of being present as its J.W. at the installation of the Prince of Wales as M.W.G. Master, in the Royal Albert Hall, South Kensington, in April, 1875. In 1877 he was elected and installed its W. Master, and on vacating the chair was warmly thanked and congratulated by the members on the success of his presidency. He joined the St. Clement Danes Lodge, No. 1351, and having successively filled the various offices, was ultimately elected into the chair. In 1876 he was exalted into the R.A. Degree, in the Ebury Chapter, No. 1348, and rose in due course to be M.E.Z. In 1886 he was appointed Asst. G. Purst. of Grand Lodge, and the year following was advanced to the higher position of G. Purst. For many consecutive years past ne was elected one of the Past Masters to serve on the Board of General Purposes, and had been a member of the Committee of General Purposes of Supreme Grand Chapter. He was always ready to undertake any duty that might be assigned to him, and the work he did and the manner in which it was done, were generally appreciated. Lastly, he was a Life Governor of both our Masonic Schools, and had given his services as Festival Steward for both those Institutions. We respectfully tender our sincere sympathy to the relatives and numerous body of friends who are now mourning for the decease of so worthy and respected a brother.

The marriage of Miss Morell Mackenzie with Mr. Theodore M'Kenna has been arranged to take place at the parish church, Marylebone, on Wednesday next, at haif-past two o'clock.

Bro. Lord and Lady Tweedmouth and Bro. Lord Brassey were among the guests at the dinner party given by the Right Hon. W. E. and Mrs. Gladstone at 10, St. James's-square, on Monday evening.

Bro. Lord Mayor Sir H. A. Isaacs and the Lady Mayoress received at luncheon on the 24th ult. a number of French Senators and Deputies on a visit to London in connection with the Inter-Parliamentary Arbitration Conference.

The Common Council of the City of London held a special Court on Monday, when a heavy business paper was successfully gone through, the Chief Commissioner at the close of the proceedings wishing Bro. the Lord Mayor, Sir H. A. Isaacs, a pleasant holiday and renewed health. The compliment was warmly reciprocated, and the Court then rose till the middle of September.

The Provincial Grand Lodge of Hampshire and the Isle of Wight was held on Monday, the 28th ult., at the Town Hall, Ryde, Isle of Wight, under the presidency of Bro. W. W. B. Beach, M.P., Prov. Grand Master. There was a most exceptionally large attendance of brethren from the province, and, after the usual business, a large number sat down to a banquet. A full report will appear in our next issue.

A deputation, including Bros. Major F. W. Allan, Ex-Provost Christie, of Stirling, and several Edinburgh brethren from the Grand Lodge of Scotland, visited Manchester on the 11th ult., and were most cordially received and hospitably entertained by the Manchester Provincial Grand Lodge of the Royal Order. During the afternoon the members of the deputation performed the ceremony of advancing and promoting two brethren who had been approved by the Council. The members and visitors afterwards dined in the Victoria Hotel.

From the August number of the "Life-boat Journal" we learn that this Institution has now 206 life-boats under its charge, and last year it granted rewards for saving 627 lives from shipwrecks on our coast. A large and permanent annual income is indispensable to enable the society to maintain its great life-saving fleet in a state of thorough efficiency. At the present time pecuniary aid is peculiarly needed, on account of the special outlay that is being incurred by the Committee in replacing a considerable number of their life-boats by boats of the newest type and possessing the latest improvements.

The arrangements for the visit of the Emperor William II. of Germany to the Queen are virtually complete. His Imperial Majesty will arrive off Dover on Sunday evening next, but will remain on board his yacht—the Hohenzollern—till the following morning, when he will proceed on his journey to the Isle of Wight, with the German Ambassador in attendance. On arriving in the Solent he will be met by the Prince of Wales on board the Osborne, and the Duke of Edinburgh on board the Alberta, and will be received on landing by the Duke of Connaught. The Queen will meet his Majesty at Osborne House, where he will reside during his visit. The Emperor will leave Osborne on his return to Germany on Thursday evening next.

THE UNEMPLOYED IN EAST LONDON.—At a time when much thought is being given to this matter, a practical suggestion may be of service. Last year more than £300,000 worth of foreign matches were purchased by inconsiderate consumers in this country, to the great injury of our own working people, so true is it that "evil is wrought by want of thought, as well as want of heart." Bro. the Earl and Countess of Airlie have left London for their seat in Scotland, where they expect to be joined by the Duke of Clarence and Avondale for grouse shooting on the 12th instant.

The Benchers of Gray's Inn have again resolved that during August and September children (boys over 10 years of age excepted) be admitted to the gardens without orders between 6 p.m. and 8 p.m., wet days excepted.

During the month 72 persons were rescued from drowning out of 76 cases reported to the Royal Humane Society, which has awarded two silver medals, 19 bronze medals, and a large number of testimonials recording the thanks of the society to the other salvors.

Bro. Alderman Sir Reginald Hanson, Bart., has received an intimation from the Greek Minister in London that his Majesty the King of the Hellenes has been pleased to confer upon him the rank of Commander of the Order of the Saviour of Greece.

In the Saloon of the Mansion House on the 24th ult. Bro. Earl Granville distributed the prizes, scholarships, and cerficates to the successful competitors in connection with the first examination held under a Scheme of Commercial Education under the London Chamber of Commerce.

On Thursday, the 24th ult., the Duchess of Albany distributed the prizes to the successful competitors at the annual exhibition held under the auspices of the Esher Cottage Garden Society, by her Royal Highness's permission, at Claremont.

The Prince and Princess of Wales dined with Lord Alington at his lordship's residence in South Audley-street, on the 24th ult., among those invited to meet their Royal Highnesses being Bros. the Marquis of Hartington, the Earl of Hardwicke, and Lord Frederick Hamilton. A ball followed.

The Princess of Wales has become President of the Cheyne Hospital for Sick and Incurable Children at Cheynewalk, Chelsea, and has forwarded a donation of 25 guineas to the funds of the Institution. Her Royal Highness has also given £25 to the Children's Country Holiday Fund, of which she is patroness.

The entire proceeds of the Beverly benefit matinée, at the Haymarket Theatre on Wednesday last, will be placed at the disposal of Mrs. Beverly's trustees, free of all deductions for expenses, by Mrs. Oscar Beringer and Mr. C. W. Somerset, joint owners of the new comedy, "That Girl," by Henry Hamilton and Mrs. Beringer.

Messrs. Woodhouse and Rawson, the well-known electric engineers, have recently purchased the business of electric and steam launch builders, formerly carried on by Messrs. W. Sargeant and Co., at Strand Works, Chiswick, W. Mr. Sargeant has been retained as branch manager. Special attention is intended to be paid to the building of electric launches and charging stations; and arrangements can also be made for the hire of either steam or electric launches by the day, week, month, or season.

The Prince of Wales, who is Hon. Colonel of the 12th Middlesex (Civil Service) Rifle Volunteers, has signified his intention of contributing 100 guineas to the fund for the establishment of a new head-quarters for that corps. The Governor and directors of the Bank of England have promised 100 guineas, and Viscount Bury, the lieutenant-colonel commanding, £100. In addition to these donations subscriptions have been received or promised to the amount of £2000 out of the £3000 which will be required.

Mr. Wilson Barrett, only just returned to London from his American tour, is already hard at work on the details of his provincial campaign and the opening of his new theatre. On the former enterprise he will start very soon, still accompanied by Miss Eastlake as his "leading lady." He hopes to make his entrée at the New Olympic towards the end of October. He says he is in splendid health, and the fact will be agreeable to his many friends and admirers, in and out of London.

On Friday, the 25th ult., the members of the Square and Compass Lodge, with friends to the number of 60, visited Bala. The party started by the 9.26 train. Lunch and tea were provided at the Plascoch Hotel, Bala. Many of the Bala br thren placed their wagonettes and conveyances at the disposal of the party, and Mr. Owen's coach and four conveyed several visitors round the lake. Bro. Wednesday was the annual Speech Day at Christ's Hospital School, the ceremony taking place in the great hall. Bro the Lord Mayor delivered the prizes, and among those present were Sir Henry Peek, Mr. J. R. Diggle, and the Rev. Richard Lee. The programme was composed of Latin, French, and German recitations. The Thompson's Gold Medals for classics and mathematics respectively were awarded to C. L. Hills and A. H. Goddard; the Richards Gold Medal for Latin hexameter verse to F. L. Woodward; the Charles Lamb Medal for an English essay to C. L. Hills; the Tyson Medal for the best scholar in mathematics and astronomy to C. G. Leftwich; the Gilpin Good Conduct Prize for Grecians to R. R. Cummings; the Unknown Governor's Prize for Good Conduct for a Deputy Grecian to S. T. Harmer; for a Royal mathematical boy to A. Brown; and the Vidal Prize to H. H. Hull. R. R. Cumming, who delivered an English oration, referred to the history of the past year, and said that they had come to their last Speech Day under the old regime. He also enumerated some of the features of the new scheme which is to be carried out by the Charity Commissioners. During the proceedings selections of instrumental music were performed.

Last year there were on the foundation of Christ's Hospital about 1100 boys and 90 girls.

The directors of the Bank of England have increased the minimum rate of discount from four per cent., at which it was fixed on June 26, to five per cent.

The second son of the Speaker, Mr. Arthur Peel, has just taken a first class at Oxford. He has been at New College, which boasts of five first-class men in this year's honour list.

Bro. Alderman Gibb, of the London County Council, has written from Caracas, Venezuela, that he has been out there for the past four months. He hopes soon to return home.

Mr. Rolls, of the Hendre, has promised £5000 towards the restoration of St. Saviour's Church, Southwark, the memorial stone of which was laid by the Prince of Wales on Thursday, the 24th ult., in the presence of the Princess of Wales and her daughters.

The Free Exhibition of Pictures on loan at Guildhall will be closed at the end of August. Over 50,000 persons have visited this gallery during the last six weeks; but there must be large numbers who are still unaware of its existence, and who are yet close to it daily. The value of the collection may be gathered from the fact that the pictures are insured for nearly a quarter of a million.

The Grey Friars—a Carmelite Order, which took its popular name from the colours of its robe—came to London for the first time, and established themselves, in Edward I.'s reign, on the north side of what we now call Newgate-street. Here, aided by the citizens, they built first a chapel, and then a church, and then a much larger church, which was completed about 1310. And here they flourished exceedingly.

A recent presentation has been made to the permanent Art Gallery of the Corporation of London, by Mr. Felix Joseph, of Eastbourne, of 26 original drawings by Uwings, Corbould, Burney, Thurston, and Westall. Mr. Felix Joseph has already done much for the towns of Nottingham and Derby in enriching their respective museums by gitts of fine Wedgwood and Crown Derby.

At the second day's sitting of the Institution of Mechanical Engineers on Wednesday at Firth College, Sheffield, three papers were read. The first was by Mr. C. J. Stoddart, on "The Parkgate Iron and Steel Works." Mr. Oakham read a paper on "The Loomis Process of Making Gas for Fuel," claiming that by this system the fuel saving over coal or coke in heating forges for making cutlery, files, and similar work was one third. The third paper was by Mr. Eaton, engineer to the Sheffield Corporation, who described the local waterworks.

She will afterwards take holiday till the Lyceum opens in September.—Miss Dorothy Dene joins Mr. Benson's company at Manchester next week, to play a special engagement in "A Midsummer Night's Dream."—Mr. Henry Neville leaves England for America on the 20th prox.

The new hotel just opened at Brighton, which has been termed the Hôtel Métropole, is the latest addition to the colossal establishments projected and carried on by the Gordon Hotels Company, and is designed to afford visitors to Brighton the same well-ordered entertainment as is already provided at the Hôtels Métropole, Grand, and First Avenue, London.
