### CUMBERLAND AND WESTMORLAND.

There was no great amount of business to be transacted at the recent annual meeting at Penrith of the Provincial Grand Lodge of Cumberland and Westmorland. Nevertheless, there was an excellent attendance of brethren, and what was appointed to be done was done satisfactorily to all present. The reports, especially that of the Provincial Grand Treasurer, were favourable, the only shortcoming which provoked anything in the nature of a complaint from the authorities being the lack of promptitude on the part of Secretaries of lodges in forwarding the necessary returns to the Provincial Grand Secretary. We notice, however, with pleasure that the Province unanimously decided upon establishing an Educational Fund, and that "a Committee of 13, with a Secretary, was appointed to carry out the work without prejudice to the other Charitable Institutions in Masonry, and at all times to be under the government and control of the Provincial Grand Lodge." The establishment of such a Fund will undoubtedly prove a benefit to the Province, while the reservation so judiciously made in favour of the great central Masonic Charities, shows that our Cumberland and Westmorland friends are fully alive to the claims which these have upon their support. This, indeed, was practically demonstrated before the close of the meeting by the success which attended Bro. MCLEOD'S efforts to obtain the services of brethren to act as Stewards at next year's Festival of the Boys' School. The Province is not invariably represented at these anniversary gatherings, but when it does enter an appearance, it generally shows to great advantage. We congratulate our Cumberland and Westmorland brethren on the satisfactory results of their past year's labours and the Provincial authorities, but especially Bro. L. F. B. DYKES, P.G.D. of England, Deputy Provincial Grand Master, who has so often presided of late years at these meetings, and Bro. G. J. McKay, who, during his long tenure of office, has proved himself so able and indefatigable a Provincial Grand Secretary.

4th. From Comps. Joseph Henry Price, as Z.; William Barnes Fendick, as H.; Henry Esling, as J.; and seven others for a chapter to be attached to the Emblematic Lodge, No. 1321, Southwark, to be called the Emblematic Chapter, and to meet at the Criterion, Piccadilly.

The foregoing petitions being in every respect regular, the Committee recommend that the prayers thereof be respectively granted.

The Committee have likewise received memorials, with copies of minutes, for permission to remove the following chapters:

The West Kent Chapter, No. 1297, from the Thicket Hotel, Anerley, to the Crystal Palace, Sydenham.

The Welchpool Chapter, No. 998, from the Railway Station, Welchpool, to the Masonic Temple, Newtown, North Wales.

The Committee recommend that the removal of these chapters be sanctioned.

The Committee have further to report that, in consequence of the formation and recognition of the Grand Lodge of Tasmania, there are no longer English Craft lodges in that colony to which the chapters meeting in Tasmania can be attached, as required by Article 45, Royal Arch Regulations.

The Committee, therefore, recommend that the charters of the Chapters Nos. 536 and 618 be withdrawn and cancelled, and that the chapters be erased from the register of the Grand Chapter.

### PROVINCIAL GRAND LODGE OF OXFORDSHIRE.

The annual Provincial Grand Lodge of this province was held in the Apollo University Lodge, Masonic Hall, Frewin-court, on Monday, the 20th ult., and afforded an opportunity for the brethren to meet their esteemed Provincial Grand Master once more previously to his departure from the shores of England to assume his Viceregal functions in the distant colony of New South Wales, and to bid him "God-speed" in and through all his patriotic work. Provincial Grand Lodge was called for five o'clock, and soon afterwards his lordship entered in procession, preceded by the Provincial Grand Officers for the year escorting him to the throne, Bro. the Rev. H. Sayers taking his position as S.W., and Bro. W. A. Simmons as J.W., Bro. W. R. Bowden acting for the P.G. Organist. After prayer, offered by the Provincial Grand Chaplain, Bro. A. R. Pritchard, the business of the province was commenced, which consisted of the receiving of the reports of the Deputy Provincial Grand Master Bro. Emberlin, who recommended the usual grants to the Masonic Benevolent Institution and to the Radcliffe Infirmary, Medical Dispensary, Sarah Acland Home, Blue Coat Girls' School, and Oxford Benevolent Institution; these grants were adopted. The report of the Provincial Charity Committee was read by the Secretary of the Charity Committee, Bro. F. W. Ansell, and adopted. GRAND MASTER moved that a vote of sympathy and condolence should be given expressing the grief and loss the province had sustained through the death of the Pro Grand Master, the Right Hon. the Earl of Carnarvon.

The Earl of JERSEY spoke of the Masonic zeal and sterling character and ability

of the deceased nobleman, expressing his personal sorrow on his removal.

The motion was seconded by Bro. Rev. H. Adair Pickard, P.G.C. England,

Supt., in the following words: In seconding this resolution, I would ask to be allowed to advert for a few minutes to the high character of the noble brother allowed to advert for a few minutes to the high character of the noble brother whose loss we deeply deplore. A great Statesman, a courteous gentleman, and a devout churchman, he filled with much distinction the high offices of Lord Lieutenant of Ireland in 1885, of Secretary of State for the Colonies in 1866 and in 1874, and of High Steward of this University since 1859, in addition to many other minor offices. But we especially deplore his loss as a Freemason. Initiated in the Westminster and Keystone Lodge, No. 10, then recently resuscitated under the care of Bros. Beach, Portal, and others, to be the foster mother of brethren of the Apollo, who resided, at all events during part of the year, in London; Lord events during par Carnarvon joined the Apollo University Lodge in 1857, when I was W.M. Those were stirring times in Grand Lodge, and the Oxford Masons attended regularly, and fought shoulder to shoulder in defence of the Canadian brothers whose rights and privileges had not been recognised at that time by the permanent officials of Grand Lodge. The eminent ability of our lamented brother brought him prominently before the notice of the rulers of the Craft, and he was appointed Prov. G.M. of Somersetshire in 1868, and Deputy G.M. in 1870. Then in 1874 he had the great honour of installing H.R.H. the Prince of Wales as Grand Master, an event that can never be forgotten by those who witnessed the installation; he was at once appointed to the Pro Grand Mastership, an office which can only be held when a Prince of the Royal blood is Grand Master. In that capacity many of us have seen Lord Carnarvon presiding in Grand Lodge. Indeed, on all occasions when matters of great importance were brought before us, we were quite sure to be favoured by his presence. We noted his wise advice, his just ruling combined with inflexible firmness when any principle was involved. His portrait adorns the walls of our Masonic Temple in London, and I venture to assert that it will be long before the services which he rendered to the Craft will fade from our memory.

Bro. Emberlin was re-elected Prov. G. Treasurer by acclamation. The Prov. G. Tyler was also re-elected. The Provincial Grand Master then proceeded to appoint and invest his officers

Provincial Grand Lodge was then closed.

The annual report of the Charity Committee disclosed that during the year the sum of £256 12s. had been raised by Stewards for the Royal Masonic Benevolent Institution; £81 7s. 6d. for the Girls' School; and £187 19s. for the Boys' School-these independently of separate subscriptions and donations not here reported.

The annual banquet followed, and was held in the Assembly Room at the Clarendon Hotel, which barely afforded accommodation to the large number of brethren assembled. The Earl of Jersey presided, supported on his right by the D.P.G.M., the P.G. Treas. (Bro. W. G. Emberlin), and the Secretary of the Charity Committee (Bro. F. W. Ansell), and on his left by Viscount Valentia, Bros. H. A. Pickard, F. P. Morrell, and other members of P.G. Lodge. The menu was attractive, and the serving as well as other arrangements for the dinner reflected. attractive, and the serving, as well as other arrangements for the dinner, reflected much to the credit of the manager and staff of the establishment. The noble earl was most felicitous in proposing the customary Masonic toasts, which were severally replied to, two or three excellent songs interspersing themselves.

It came to the lot of Bro. Pickard to offer the toast of the evening, that

of "The Provincial Grand Master," which he did in the following terms:—
"When I received, a few days ago, from the D.P.G.M. a request that I should propose the health of our Provincial Grand Master at our banquet to-night, I then shrank from the privilege, conscious of my own inability to do justice to the toast. But greater pressure was brought to bear upon me when Lord Jersey himself said that he would prefer that I should undertake to propose the toast. I therefore cultivated the Masonic virtue of obedience, cast aside all my own wishes, and considered what I should say. Brethren, for some time past our Provincial Grand Master has been hearing addresses Brethren, for and speeches in his honour. I do not know what has happened in Old South Wales, but in Oxfordshire the Druids, the cricketers, the citizens have vied with each other in praising him and lamenting his loss; and I rather think the Magistrates are to have the same opportunity which we have to-night of expressing our regret for his departure, and our good wishes for his prosperity during his absence, and his speedy return. No more popular Provincial Grand Master exists in England, and this popularity is thoroughly deserved. I ask you, brethren, is there anyone who more thoroughly fulfills the distinguishing characteristics of a Freemason than the noble brother whose health I propose to you? Is there one who carries out more fully the characteristics of a ruler in the Craft? in that he who carries out more fully the characteristics of a ruler in the Craft? in that he is trusty, of good report, and held high in estimation among his brethren; in that he is of exemplary character, courteous in demeanour, easy of address, but steady and firm in principle? Is there anyone who exemplifies more fully the three grand principles on which our Order is founded—Brotherly Love, Relief, and Truth? By the practice of these virtues our Prov. G.M. has endeared himself to the hearts of all the brethren, and if we are for a time separated from him we know that our loss is the gain of the colony to which he is going, where, if rumour be true, he may find himself (in succession to Lord Carrington) Dist. G.M. of New South Wales. We hope he may find that as easy a province to rule as this, and that the experience which he will gain at the Antipodes may fit him even still better for his higher duties outside Masonry. I am perhaps prejudiced in thinking that the Grand Master can bestow no higher honour than that of Prov. Grand Master of Oxon and Grand Warden of England, but outside Masonry there are many high dignities to which Lord Jersey may aspire, and if he only fulfils their duties as well as those which have devolved upon him as our ruler in the Craft, we may greatly congratulate those over whose destinies he may be called upon to preside. We are quite sure that, when acting as Pro-Consul in a distant part of our great empire he will not forget us, and he knows that we shall always remember him. Brethren, I give you the health of our Prov. Grand Master, and call upon you to drink it with the utmost enthusiasm.

A heartier response could scarcely be conceived than that which followed Bro. Pickard's interesting speech, and when the noble earl rose to respond he was again greeted with deafening applause. At the close of his reply "Auld Lang Syne" was freely indulged in, and as his lordship left the Assembly Room he was greeted with another equally well-remembered chorus by all the brethren present.

A few remaining toasts being disposed of, this highly representative gathering

# PROVINCIAL GRAND LODGE OF SUSSEX.

On Friday, the 24th ult., the Eastbourne Town Hall was the scene of a gathering scarcely second to any which the building has contained. The past year had been a very successful one so far as the Provincial Grand Lodge of Sussex was concerned. They now numbered 1275 members, an increase of 75 during the past 12 months. The only special occurrence worth mentioning was the fact that the Burrell Lodge had been removed from Shoreham to Brighton, and this because the former town had no suitable room in which they could assemble. He assured them that he should continue to give his best efforts in order to advance the true interests of Freemasonry in the Province of Sussex. He then appointed the following brethren as his Prov. The roll of lodges and of Present and Past Prov. Grand Officers having been called, the minutes of the annual meeting of Prov. Grand Lodge, held at Sheffield, on Wednesday, 16th April, 1890, were presented. It was moved by Bro. C. L. MASON, P.M. 304, P.P.G. Treas., seconded by Bro. Austin Roberts, P.P.G. D. of C., and resolved, "That the minutes be taken as read, and confirmed."

Brethren,—We acknowledge the hearty welcome offered to this Provincial Grand Lodge by Bro. Alfred Robertshaw and the brethren of the Lodge St. James, No. 448, and I also thank you all for the salutations accorded to me, to my Deputy, and to the officers of this province this afternoon. I may remind you that this Lodge of St. James, which now numbers some 80 members, was constituted 17th March, 1838. It celebrated the jubilee of its existence on 23rd October, 1888. Twenty-one years ago, on the 24th November, 1869, Provincial Grand Lodge assembled in this hall for the purpose of its dedication by the Marquess of Ripon. I and my Deputy were present, but many brethren like Bro. Bentley Shaw, who was then the Deputy, have, alas! passed away to their rest. I am happy to think that this noble hall is now free, or almost free, from the obligation of debt. This Lodge of St. James, No. 448, has contributed £712 15s. to the Charities, and possesses 231 votes; but I will not make further allusions to it, because we are looking forward to Bro. Austin Roberts' history, which I am told is in the press, and a copy of which will shortly adorn the Masonic Library at Wakefield. To this lodge, then, as well as to the other lodges of Halifax—Probity, De Warren, and St. John's—Provincial Grand Lodge offers good wishes for their prosperity and success. Like my predecessor, Sir H. Edwards, I am anxious to see all lodges hold their meetings in halls of their own, and with that view it has been a pleasure to me quite recently to sanction plans for new buildings or rooms at Batley, Hebden Bridge, and Castleford. There is to these changes from licensed premises to private halls one great danger, viz., that of being led to keep late hours; and I think that the Act of Parliament regulating the closing of hotels might fairly guide us as to the hour of our departure from our lodges. On lodge and instruction nights the billiard room should be closed, otherwise the attendance in the lodge is With respect to the interval of time between taking Degrees, I call your special attention to Rule 195, Book of Constitutions. At a special meeting of our Charity Committee, held at Leeds on the 23rd June last, the representatives of this province adopted Bro. James Morrison McLeod as the most suitable candidate for the office of Secretary to the Boys' School. The election took place on the 12th July, and Bro. McLeod received 2317 votes, having a majority of 1326 over those polled for Bro. A. C. Greenwood, who was next on the list, thus showing that many other provinces agreed with our selection. At this same meeting the opportunity was taken of presenting to Bro. W. F. Smithson, the Chairman of the Committee, complete sets of clothing and jewels corresponding to the offices conferred upon him by the M.W. Grand Master in Grand Lodge and Grand Chapter. Bro. Smithson has done immense service to the Craft by his labours for the re-organisation of the Boys' School, and earned for himself much credit as our representative in London; and he richly deserves our commendations for the labour and time sentative in London; and he richly deserves our commendations for the labour and time he has devoted to carrying out the views of West Yorkshire in this most difficult matter. The West Yorkshire brethren have provided carpenters' benches and tools for the purpose The West Yorkshire brethren have provided carpenters' benches and tools for the purpose of giving manual, in addition to mental, training to the boys in our School, and this has been augmented by a munificent private donation. A further sum has been given, which has been expended in the purchase of a printing press. This is now in active operation, and a monthly magazine, called the "Masonian," has been established, and is being largely circulated. Having taken a deep interest in the re-organisation of the Boys School, it is now manifestly our duty to give it our hearty support. West Lancashire sets us a noble example, and its Prov. G. Master, Bro. the Right Hon. the Earl of Lathom, has consented to preside at the next Festival of the Institution. With the approval of our Charity Committee, a notice has been placed on the agenda paper, for a grant from this Provincial Grand a notice has been placed on the agenda paper, for a grant from this Provincial Grand Lodge of £151 10s., as our contribution in aid of the 1891 Festival. I and many of my friends shall also add our names as Stewards, and I believe that in making this appeal to your sympathies, I shall have at least 100 who will follow our example. With regard to the Girls' School, my Deputy has recently been there, and has reported to our Charity Committee the progress made at the new buildings. All seems satisfactory. The memorial lights of the large window of the Centenary Hall have thus been appropriated: There are nine lights, and West Yorkshire has taken up seven of them; North and East Yorkshire, one; and the United Northern Counties Lodge, London, the ninth; thus completing the Yorkshire portion of the centenary window. The librarian will give a brief report of the donations of books since April. There is one work I must mention, "The Heraldry of York Minster," by Bro. the Very Rev. A. Purey Cust, Dean of York, and Prov. G. Chap. of England. This work is a monument of graceful learning. The library is thus accumulating most valuable books and curiosities, through the enterprise and energy of Bro. W. Watson, our Honorary Librarian. It would hardly become the loyalty of this Provincial Grand Lodge towards the M.W. the Grand Master of Grand Lodge of England, H.R.H. the Prince of Wales, to pass by with only briefly reading the communication of the Grand Secretary of England, dated the 1st July, 1890, announcing the death of the Right Hon. the Earl of Carnaryon, Pro Grand Master, and Prov. Grand Master of Somerset. This event has filled the heart of every Mason with grief. For upwards of 15 years, during which time he held the position of Pro Grand Master of the Order, his unfailing courtesy, his just rulings, and his matured advice and increasing exertions for, and devotion to, the best interests of the Craft, will ever be recognised as having signally contributed to the high position it now occupies in the world. This Provincial Grand Lodge, therefore, records its grateful appreciated by the 250 13s. 6d. by This church of St. John, Soo years old, was connected with Roche Abbey. The Rev. H. Ellershaw, the vicar, who is with us to-day, gave the Craft a fraternal welcome, and Bro. the Rev. Canon Bullock, vicar of Holy Trinity, Leeds, and Past Prov. Then, when "the silver cord be loosed, and the golden bowl be broken," and our "dust return to the earth as it was," in the Grand Lodge above, may our "spirits return unto God who gave them."

The Deputy Prov. G.M., Bro. HENRY SMITH, after returning thanks for their hearty greeting, congratulated the brethren on the general prosperity of the province, but adverted with great regret to the unusually long death-roll since their last meeting. He also referred to the handsome presents of tools which had been made to the workshops of the Boys' School, and concluded a brief but earnest address by giving sound admonition to Secretaries in relation to change of addresses and lodge returns.

Bro. W. F. Smithson, P.M., Grand Deacon of England, on being called upon by the Prov. G.M., expressed his gratitude to the brethren of West Yorkshire for so completely supporting him in his action in respect to the Boys' School. He

also assured them that he felt proud of the honour conferred upon him by the M.W.G.M., his Royal Highness the Prince of Wales, in making him a Grand Deacon of England, and regarded it less as a personal matter than as an indication of the merits of the Province of West Yorkshire, to which he had the honour to belong. He strongly urged the brethren to examine and dissect the lists of donations to the Charities from time to time, and by their personal efforts endeavour to reach those lodges who names were only too frequently conspicuous by their absence from those lists. Their voting power must be maintained, and no effort must be wanting in this important matter. He also presented and proposed the adoption of a brief report, of which the following is a summary: "Your Executive Committee have satisfaction in reporting that at the April and May elections, West Yorkshire succeeded in placing two boys, one girl, three men, and one widow on the list of participants in the benefits of the Masonic Institutions, that there still remain one boy and four girl candidates, and that it will be necessary to register every vote in the forthcoming struggle at the end of the month in order to meet with any measure of success, as the competition is likely to be exceptionally keen."

The adoption was seconded by the VICE-CHAIRMAN of the Charity Committee,

and carried nem. con.

Bro. W. GAUKROGER, P.M., P.P.G.D., then moved the resolution standing in his name on the notice paper: "That a sum of £151 10s. be voted by this Provincial Grand Lodge to further endow the Prov. G. Master's chair, R.M.I. for Boys." He pointed out that this would raise the amount to 600 guineas. He also took the opportunity of welcoming Bro. Jas. M. McLeod, the newly-appointed Secretary, who was present.

This was seconded by Bro. C. L. MASON, P.M., P.P.G. Treas., who showed that West Yorkshire had a great stake in the Boys' School, and since it had taken a prominent part in the re-organisation of that establishment, and had assisted in placing it upon a sound basis, it was clearly the duty of this province to render it

substantial support.

The resolution was carried unanimously.

Bro. JAS. M. McLEOD, on being called upon by the Prov. G. Master, was most cordially received. He expressed his gratification on being so warmly welcomed by the brethren of West Yorkshire. He was conscious of the active part taken by this province on the occasion of his election, and for that he tendered his He also felt grateful for the money just granted, and for the many indications of renewed enthusiasm for the Institution with which he was so closely connected; and concluded by paying a very high compliment to the Prov. G. Master, his Deputy, and other active Masonic workers in the province, notably Bro. Smithson, a member of the London Provisional Committee.

### CONSECRATION OF THE HILBRE LODGE, No. 2375, AT HOYLAKE,

Several months ago a movement was set on foot for the formation of a lodge at Hoylake, with the result that a warrant for the constitution of a new lodge to be known as the Hilbre Lodge, No. 2375, was granted. The leading promoter of the movement was Bro. J. S. Jolly, who found active and practical support from Bro. Charles Roberts, W.M. 605, the result being that the warrant for the formation of the new lodge was granted, the consecration being fixed for Saturday, the 18th ult. The impressive ceremony, which took place at the Market Hall, now to be known as the Masonic Hall, was the occasion of a very numerous gathering of brethren, not only from the Cheshire province, but the Province of West Lancashire, there being considerably over 100 present, including a large number of Provincial Grand Officers from both sides of the river Mersey. It was hoped that the consecration ceremony would have taken place under the presidency of Bro. Lord Egerton of Tatton, Prov. Grand Master, but his lordship was unable to be present, and his place was admirably filled by Bro. Sir Horatio Lloyd, Deputy Prov. Grand Master, whose popularity among the brethren of the Province of Cheshire is a matter of notoriety in Masonic circles. He was ably supported by Bros. James Salmon, P.S.G.W.; J. Clayton, P.J.G.W.; Lilley Ellis, P.P.S.G.D.; and J. B. Sparks, P.P.S.G.D., who filled the chairs of the Prov. Senior and Junior Grand Wardens and Deacons respectively during the consecration ceremony. A large number of Provincial Grand Officers were present.

The usual consecration ceremony was carried out with appropriate solemnity, in the course of which Bro. the Rev. A. Symons, the junior Provincial Grand Chaplain, delivered an interesting address on the nature and principles of

At the conclusion of the reverend brother's address, which was closely listened At the conclusion of the reverend brother's address, which was closely listened to by the brethren, the consecration ceremony was proceeded with and brought to a close, after which Bro. C. S. Dean, P.P.G.D., was duly installed the first Worshipful Master of the new lodge, the installing ceremony being impressively performed by Bro. J. B. Sparks, P.P.S.G.D. Subsequently the Worshipful Master invested the other officers of the lodge as follows: Bros. Charles Roberts, W.M. 605, S.W.; C. Nigel Stewart, J.W.; J. Morris, Treas.; J. S. Jolly, Sec.; Charles H. Smith, Org.; John Lee, P.P.G.S., S.D.; J. G. Holmes, J.D.; W. H. Martin, I.G.; T. S. Jackson, M. Jolly, and W. J. Gaskell, Stewards; and John Craft, Tvler.

Before the lodge closed the encouraging announcement was made that at the first ordinary meeting of the lodge 14 candidates for initiation would be proposed, and that about the same number of joining members would be submitted for election to the membership of the lodge.

Subsequently the brethren sat down to an excellent banquet provided by Bro.

J. Fairhurst, the well-known Liverpool caterer.

The usual loyal and Masonic toasts were proposed from the chair by the Worshipful Master, including that of "The Deputy Provincial Grand Master." who said that when he first became acquainted with the Craft there were only 27 lodges in the provinces, but now there were no fewer than 46, which in itself was a striking evidence of the growing popularity of the Order.

In the course of the evening the usual collection by means of the Charity box was made on behalf of "poor and distressed Masons," Bro. Thomas M'Cracken announcing his intention of supplementing the sum collected, so as to bring it up to the even value of a Bank of England note, the announcement being, it need hardly be said, received with loud applause.

### Masonic Motes.

We have to remind our readers that the Quarterly General Court of the Royal Masonic Institution for Boys will be held at the Freemasons' Tavern to-day (Friday), when 19 boys will be elected from an approved list of 53 candidates, while at the same time the Bylaws as amended by the Provisional and General Committees will be submitted for approval. We are glad to find that in the advertisements of the meeting prominence has been given to the fact that if five of the boys are unsuccessful at this ballot, their names will be removed from the list under existing Law No. 53. These five are W. J. Atley (Durham), No. 6, who brings forward 604 votes; R. W. Levey (London), No. 10. who has in hand 166 votes; G. F. Bullivant, (Warwickshire), No. 17, with 363 votes; G. L. Woodhams (London), No. 27, with 1058 votes; and C. J. Phipps (Hertfordshire), No. 53, who is a new case. We trust that every effort will be made to secure the success of these five, whose cases have been thoroughly inquired into and approved. The other candidates will have further opportunities of obtaining admission into the Institution, but with these five it is a case of "now or never."

The Quarterly General Court of the Royal Masonic Institution for Girls will be held at Freemasons' Tavern to-morrow (Saturday), but here the only important business will be the election. In consequence of the death of one girl, and the removal of another from the establishment, the number of vacancies, after proposition duly made and carried, will be 16 instead of, as originally, 14, while the number of candidates is 32, or, case No. 14 having been withdrawn, 31. Of these, however, only two are last cases, namely, F. E. Hooke (New Brunswick), standing at No. 3, who brings forward 691 votes, and W. B. Miller (London), at No. 20, who will be a candidate for the first and last time on this occasion. We trust these two children will be found among the 16 successful at the close of the poll. They have been found worthy of admission into the Institution, and no efforts should be spared in order to ensure their success.

A correspondent from abroad, who has held high office in his District Grand Lodge, has written us a long letter, in which he complains of the indecent extent to which the use of rituals in open lodge is carried. We heartily concur with him in condemning the practice, not only for the reasons he adduces, but because rituals are not recognised in any form or under any circumstances by the authorities of Grand Lodge. More than this we are unable to say, as the subject is one which cannot be discussed even in the columns of a Masonic newspaper.

Owing to the heavy accumulation of lodge reports, we have been compelled to hold over an article on "Masonic Minorities," &c., and much other interesting matter.

At the meeting of the Provincial Grand Lodge of Northumberland the retirement of Bro. B. J. Thompson from the office of Provincial Grand Secretary was made the occasion of a warm eulogium of the worthy brother from the Provincial Grand Master, and a cordial and hearty recognition of his long years of service to the province. Bro. Thompson is probably the oldest Pro-

vincial Grand Secretary in England, and he retires full of years and honours, with the best wishes of all who during the 30 or 40 years of his official life have benefited by his knowledge and enjoyed his friendship.

\* \* \*

Our opinion has been asked as to the justice or legality of the course pursued under the following circumstances. A brother having given due notice of his intention to bring forward a certain motion, expressed a desire at the meeting at which it was to come on for consideration that it should be postponed till the following meeting. As an amendment, it was proposed that the motion should be rejected, but as no one seconded this, the amendment fell through, and the brother, in the belief that his wish had been complied with, left the lodge. Later in the same evening the question was revived, and the rejection of the proposal was proposed, seconded, and carried.

Under these circumstances our correspondent is anxious to know if "it is Masonically legal, customary, or just" to re-consider the same question in the course of the same meeting, the amendment that the original proposal should be rejected having already once fallen through for want of a seconder. Assuming the case is as reported by our correspondent, we answer unhesitatingly that the amendment for the rejection of the original proposal having once failed, should not have been put a second time. There is, however, a difficulty in the case. It is by no means clear that the lodge agreed to the brother's request to postpone the consideration of his motion till the next meeting. If it did not agree, then, as far as we can see, there is no reason why his motion should not have been put and rejected. However, the aggrieved brother will have his oportunity of reviving the question when the next meeting is held, and he will be in a position to move the non-confirmation of that portion of the minutes which deals with the rejection of his motion.

The ceremony of laying the foundation-stone of the Eiffel Tower, Douglas Head, Isle of Man, though postponed for a short time, has at length been performed with the usual Masonic rites by Bro. the Earl of Lathom, Deputy Grand Master of England, and Prov. Grand Master of West Lancashire. There were some brethren in the island who raised objection to his lordship assisting in his Masonic capacity in an enterprise which they declared to be of a private character rather than intended to promote the public welfare. It is clear, however, that his lordship, who is a man of judgment, must have satisfied himself that the project was one with which Freemasonry might properly be associated, and, as will be seen from our report elsewhere, the stone was laid on Saturday last in the presence of a large gathering of the Prov. Grand Officers and brethren of the Province of the Isle of Man under their respected chief, Bro. Major Goldie-Taubman, with a numerous and distinguished muster of visitors from the Provinces of West Lancashire and Cheshire. We sincerely hope that an enterprise which has been begun under such favourable auspices will materially promote the welfare and prosperity of the island.

We have been favoured by a Northumbrian brother with a communication which, though it is far too long for insertion in our columns, nevertheless, contains a highly interesting sketch of the arrangements made by the provincial authorities in Northumberland for securing efficiency on the part of the lodges, an impartial distribution of provincial honours, and orderly government of the province by the Provincial-Grand Lodge. Among the points to which our correspondent draws attention, we note with pleasure that every Worshipful Master is expected to read aloud at the annual meeting of Provincial Grand Lodge a full and particular account of what his lodge has done during the year, the account being afterwards handed to the provincial authorities. We note, likewise, that lodges nominate in turn the brethren who are to be invested as Provincial Grand Stewards, the nominations being sent to the Prov. G. Secretary seven days prior to the day appointed for the meeting of Provincial Grand Lodge. These are not the only points which he has enumerated, but they are the most worthy of notice and demonstrate clearly enough the justice of his complimentary remarks as to the zeal, energy, and ability of Bro. Richard Holmes, J.P., P.G.D. England, who is Deputy Prov. G.M., and Bro. B. J. Thompson, who has been for so many years Prov. G. Secretary of Northumberland. We are only too pleased to have this opportunity of endorsing the compliments paid to these distinguished brethren by our worthy correspondent.

### THE DOUGLAS HEAD IMPROVE-MENTS.

### IMPOSING MASONIC CEREMONY.

In the presence of a large assembly of the brethren of the Isle of Man, West Lancashire, East Lancashire, West Yorkshire, and Cheshire, the Right Hon. the Earl of Lathom, Deputy Grand Master, Prov. Grand Master of West Lancashire, assisted by numerous Grand and Provincial Grand Officers, laid the foundation-stone on Friday, the 24th ult., of the approach tower to the Douglas Head Suspension Bridge. The English visitors accompanying his lordship, as the guests of the directors of the Suspension Bridge Company, were conveyed on Thursday from Liverpool on the Snaefell, which was specially chartered for the occasion. During the voyage, which was of the pleasantest description, music was supplied by the band of the 3rd Cheshire Rifle Volunteers.

The morning opened beautifully fine, and from an early hour the Masonic visitors who were to take part in the ceremony at noon were to be seen leaving their hotels and lodgings and proceeding along the Promenade to view the site of the proposed Douglas Eiffel Tower. All the visitors were astonished to hear that eight days ago the site was entirely covered by house property. The necessary land has been acquired for £25,000, and the property to be pulled down thereon is of a class the removal of which will not deprive Douglas of any of its architectural beauties. A space sufficiently large for the accommodation of fourteen or fifteen hundred spectators had been cleared, and this space would have been much larger but for the fact that a portion of the property consisted of Customs-house buildings, and the authorities have not yet acquired new premises. In the centre of the site a square vault about 14 feet deep had been excavated, and it was at the bottom of this that the foundatiod-stone was to be laid by Bro. the Earl of Lathom. Some difficulty had been encountered in preparing the foundations of this base, which will form one of 56 bases upon which the approach tower will rest. The quantity of water which was come to when the excavations were proceeded with was rather more than had been bargained for, and consequently the necessary pumping occasioned considerable delay. However, everything was prepared by Friday morning, for the ceremony of laying the foundation-stone, an immense square block weighing over two tons.

There was a large assembly of Worshipful Masters and Past Masters of lodges in each of the provinces, as well as a numerous and representative gathering of the rank and file of the Masonic brotherhood of

Lancashire, Cheshire, and the Isle of Man. Prov. Grand Lodge having been duly opened, a procession was formed from the Masonic Hall, outside which a vast crowd had assembled, and were being entertained by the music of the 3rd Cheshire Rifle Volunteers' band. A public Masonic ceremonial is quite a redletter day in the island. There has only been a single previous one, and that at Peel a year ago. Since then the brethren have never walked in procession, except once from lodge at Douglas to church, and on that occasion, as the rain was pouring down, they ran rather than walked. Such an unusual sight as that presented by five or six hundred Freemasons attired in full Masonic Craft clothing had been eagerly anticipated, and when shortly after 11 o'clock the rain began to fall great disappointment was occasioned. However, there was not sufficient to spoil either the procession or the ceremony, although the brethren had to resort to a pretty general use of umbrellas from leaving to returning to the lodge rooms. The procession went not along the Promenade, but through Finch-road, Prospect Hill, and Victoria-street, so as to traverse the principal streets of the town. All along the route was lined with spectators, who were much interested in the sight afforded by the brilliant pageant. The military band headed the procession, which was formed in the usual order. The visitors and provincial officers led, all the others following according to rank, the Provincial Grand Master of the Isle of Man, and the Deputy Grand Master bringing up the rear. the entrance to the site the brethren divided to the right and left, forming an avenue, through which the Earl of Lathom and Major Goldie-Taubman passed, the order of procession then being inverted, and the

Grand Officers of England and the Provincial Grand Officers following his lordship into the enclosure. The rank and file of the brethren brought up the rear, the place of the officiating brethren having been assigned while the heralds were announcing the arrival of the Deputy Grand Master by a flourish of trumpets. ceremony was commenced by the singing of the "Old Hundredth." Mr. Thomas Floyd, the engineer, presenting the Earl of Lathom with a handsome silver trowel, which had been manufactured by Bro. George Kenning, requested his lordship to lay the foundation-stone, which was then raised by means of a powerful tripod crane and carefully adjusted. After prayer had been offered by the Grand Chaplain, the Psalm Lord build the house" was sung, Except the and then the Provincial Grand Secretary read the inscription on the brass plate to be affixed to the foundation-stone, and the Prov. Grand Treasurer descended the vault and deposited in the stone a phial containing the usual collection of newspapers and coins. The Deputy Grand Master then laid the stone according to Masonic ritual, strewing thereon the corn contained in the cornucopia, and pouring upon it the wine and oil contained in the ewers, which had also been carried in the procession. "Prosper the Art" having been sung, prayer was offered by the Prov. G. Chaplain, and the engineer then presented the plans of the tower approach to his lordship, who delivered them to the engineer, exhorting him to proceed without loss of time to the completion of the work in conformity with the plans. The Masonic version of the National

Anthem, joined in by the band, brethren, and spec-

tators, concluded the ceremony, and the procession was

then re-formed, and the Provincial Grand Lodge was

duly closed at the Masonic Hall, which was reached by

way of the Promenade. A rumour was freely circulated in Douglas to the effect that the Earl of Lathom

had promised to use his influence with H.R.H. the Prince of Wales to prevail upon the Heir Apparent, as the Grand Master of the Freemasons of England, to open the approach tower when completed.

The proceedings of this most important day in the annals of Manxland were concluded with a banquet at the Castle Mona Hotel, where 200 guests partook of the hospitality of Dr. Abbots, the Chairman, and the directors of the Douglas Head Suspension Bridge Company.

Bro. Major J. S. Goldie-Taubman presided, and was supported by Bros. the Earl of Lathom, W. Goodacre, C. Robinson, Thomas H. Nesbit, and G. Harradon,

At the conclusion of the banquet, the toasts of "The Queen" and "H.R.H. the Prince of Wales, M.W. G. Master," were given and duly honoured, after which

The CHAIRMAN proposed "The Health of the Right Hon. the Earl of Lathom, and the rest of the Grand Officers, Present and Past." The Manx Freemasons, he said, esteemed it a great honour that the Deputy Grand Master of England had consented to come there and lay the foundation-stone of the approach bridge. He hoped that his lordship had formed a good impression of the Manx brethren, and also that the visitors would carry back a good account of

Freemasonry in the Isle of Man.

Bro. the Earl of LATHOM, in replying, said that he had been exceedingly pleased to be able to come over to the island to see the working of that young Provincial Grand Lodge. The lodge was in its childhood, but it was a very lusty childhood, for already in the course of four years the province had actually doubled itself. This showed how thoroughly Freemasonry was prospering in the island. He hoped that that would long go on, and that that province would prove a formidable rival to West Lancashire, just over the border. It was with the greatest pleasure that he came to perform the public function, feeling that the tower and bridge was not only a work which was likely to be a benefit to Douglas and the Isle of Man, but that it was one thoroughly within the bounds of Freemasonry. As he understood that scheme, which he hoped would be carried out in its entirety, it was one which would not only give work to men on the island at a time when work was scarce, but would be of immense advantage to the inhabitants and to the many visitors who came there every year. It would add to the great attractions of the island. His own experience dated back over 19 years, when he first had the pleasure of coming over with Sir Henry Loch. Since then he had been 17 or 18 times, and he need hardly tell them that he admired the island. He considered it a great health resort, so much so that he had sent his then young family every year. Since his last visit, 10 years ago, improvements had been made in the town which had perfectly astonished him. In conclusion, his lordship said: He wished all prosperity to the island, and prosperity to the Freemasons of the island.

Other toasts followed, including those of "The Council and House of Keys of the Isle of Man," "The Town and Trade of Douglas," and "Success to the Douglas Head Suspension Bridge." Responding to the second-named toast, Mr. W. Proctor, Chairman of the Town Commissioners, expressed the entire approval of that body of the scheme which had been that day so

successfully initiated.

Saturday last being the 36th anniversary of the Battle of Balaclava, the surviving officers who took part in the memorable engagement dined together at Limmer's Hotel, under the presidency of General Sir C. C. Shute.

Bro. the Marquis of Hartington, who left Newcastle for Scotland at the end of last week, will deliver a political address at Edinburgh to-day (Friday), and then leave to join Lord and Lady Edward Cavendish at Chatsworth, where it is likely he will remain till Parliament opens on the 25th inst

The Princess of Wales left Sandringham on Saturday last in order to join the Prince of Wales at Marlborough House, and on Monday their Royal Highnesses left town on a visit to the Marquis and Marchioness of Londonderry, at Wynyard Park, Durham.

Bro. H. M. Jackson, M.P., Financial Secretary to the Treasury, left town on Monday to visit Ireland for the third time, his object being to consider the light railways in course of construction, or about to be constructed, in the west, and it is probable he will meet and consult with the Irish Secretary before returning to England.

Good news has been received from Teheran to the effect that the British Minister at the Shah's Court—Bro. Sir H. Drummond Wolff—whose life a short time since was despaired of, has made considerable progress towards recovery, and that he is able to sit up in bed, and take solid food. We trust the improvement will continue.

Bro. Lord Halsbury (Lord Chancellor) was unfortunately prevented by his official duties from being present.

We remind our readers in the Chatham district of the Masonic lecture appointed to be delivered by Bro. James Stevens on Wednesday next, the 5th inst, at the Sun Hotel, Chatham, under the auspices of the Royal Kent Lodge of Antiquity, No. 20. A lodge will be opened prior to the lecture, which will commence at seven o'clock, and occupy two hours in delivery. We are not surprised to learn that a very large attendance of Masons from several lodges in the province is anticipated, and can recommend those who can conveniently attend to do so.

The route of the Civic procession on the 10th instant, when Bro. Lord Mayor Savory will go in state to the Royal Courts of Justice to receive the congratulations of the Bench on his installation in office, will be from the Guildhall through Gresham-street, Wood-street, Fore-street, Moorgate-street, Prince's-street, Cornhill, Leadenhall-street as far as Aldgate Pump, Fenchurch-street, Gracechurch-street, Cannon-street, St. Paul's Churchyard, Ludgate Hill, and Fleet-street. The return route is not yet settled, but it will in all probability be, as usual, along the Strand and the Thames Embankment.

Bro. Alderman Savory, Lord Mayor elect of the City of London, visited the Lord Chancellor, Bro. Lord Halsbury, at the House of Lords, on the 24th ult., in order that the latter might signify her Majesty's approval of the choice by the citizens of their new Chief Magistrate. Among those present were the Recorder of London, Sir Thomas Chambers, Sheriffs Farmer and Bro. Augustus Harris, Bro. Sir J. B. Monckton (Town Clerk), Bro. H. H. Crawford (City Solicitor), &c., &c. Bro. Savory was presented by the Recorder, and in expressing the Queen's approval, the Lord Chancellor spoke in extremely complimentary terms of the Chief Magistrate elect's past career.

Bro. W. S. Hoyte, Organist of All Saints, Margaretstreet, W., Prov. Grand Organist for Surrey, performed some admirable selections at the organ recital of last Saturday at the Bow and Bromley Institute. His repertoire for the evening included an organ duet, sonata in D minor by Merkel, which he played in conjunction with Mr. Butler. The double pedal action rendered the work of the two players difficult, especially in the Fugue movement. The solos were the Introduction to Wagner's "Parsifal" and the lovely "Pilgrim's Chorus" from "Tannhäuser," Grand Prelude and Fugue in C minor, by Krebs, Andantino by C. Franck, Polonaise in C major by Rubenstein, and a brilliant "Festal March," composed by the performer himself. An additional interest is added to this piece, as it was expressly composed to be played on the occasion of his appointment as Prov. Grand Organist for Surrey.

Prince Henry of Battenberg has consented to preside at the 73rd Anniversary Festival of the German Society of Benevolence, to be held at the Hôtel Métropole on the 24th February, 1891.

In future the Government Institution, which is known as the Normal School of Science and Royal School of Mines, will, by command of her Majesty, be known as "The Royal College of Science, London."

Lord Egerton of Tatton has presented his portrait to all the lodges in the Province of Cheshire. The likeness is an excellent one, and presents his lordship in his Masonic clothing as Provincial Grand Master.

The Michaelmas sittings of the Royal Courts of Justice opened on Friday, the 24th ult., when the judges, after breakfasting with Bro. Lord Halsbury at his official residence at the House of Lords, attended in great force.

At the moment of going to press we hear that Bro. S. H. Parkhouse, P.M. 511, 1642, of North Kensington, was presented on Wednesday evening with a testimonal consisting of an illuminated address, a gold watch, and a purse containing a cheque for £150. We shall refer to this more particularly in our next issue.

We regret to hear that the Countess of Jersey caught a slight chill in going to Balmoral the other day, and this has since developed into typhoid fever. The Countess, however, according to the latest accounts, is progressing favourably. In consequence Bro. the Earl of Jersey has been compelled to postpone his departure for Australia.

The British Astronomical Society, which has been formed as a supplement to the Royal Astronomical Society, held its annual general meeting at the Society of Arts on the 24th ult., when, according to the reports presented, it was found that there were 283 members, and that the society had a balance at its bankers of close on £200.

The South Australian Freemason says:—"Excellent as is R. F. Gould's 'History of Freemasonry,' it is doubtful whether it will in any great degree become popular. There is a want of abridgment of it. Such a work will be well received by the Masonic world, and would probably lead many Masons to peruse the greater work and thereby further the growing taste for Masonic study."

Speaking on the word "Freemason," Bro. W. Simpson, of Lodge Quatuor Coronati, says we do not know the exact meaning of the name. Many etymologies have been suggested. All the languages in Europe having been exhausted in attempts, the ancient languages of the East are now being attacked as a solvent in this case. Bro. J. H. Little has dived into the hieroglyphics of Egypt, and has derived the word from that source. He puts it as *Phre*-masson.

The marriage of Bro. G. Loder, the junior M.P. for Brighton, with the Lady Louise de Vere Beauclerk, eldest daughter of Bro. the Duke of St. Albans, was solemnised at St. Peter's, Eaton-square, on Saturday last. The Prince of Wales was present, and among the congregation and at the wedding breakfast were Bro. the Duke and Duchess of St. Albans, the Baroness Burdett-Coutts, Bro. Sir W. Marriott, M.P., and Lady Marriott, and Bro. Sir Raymond and Lady Burrell. In the afternoon the bride and bridegroom left for Beechwood, Herts, for the honeymoon.

The Crystal Palace Dog Show, which was opened on Tuesday and remained open the two following days, was on a larger scale than any that has yetbeen attempted. It was conducted under Kennel Club rules, but was organised by the Palace Company. The exhibits numbered over 1700, and were divided into more than a hundred classes, while the sum distributed in prizes was £1350, irrespective of 175 special prizes. Among the best and most numerously represented heads were the St. Bernard's, the bloodhounds, and pugs, and there were some very fine foreign dogs, in particular a team of Eskimo dogs.

A farewell banquet was given at Sydney on Monday by the leading colonists of New South Wales to Bro. Lord Carrington, on his vacation of the Governorship of the colony. Among the principal guests were Bro. the Earl of Hopetoun, Governor of Victoria; Bro. the Earl of Kintore, Governor of South Australia; and the principal members of the Ministry. The health of his excellency was drunk with the utmost enthusiasm. A grand ball was to be given in his honour on Thursday. To-morrow (Saturday) his lordship will hold his last levée, after which he and Lady Carrington will leave by the overland route for Adelaide, where they will embark for England on board the Orient line steamer Orizaba.

Mr. Edwin Drew will give an elocutionary and musical evening at Exeter Hall, on the 10th inst., this being his first appearance at this celebrated centre.

We learn from a dispatch recently received at Berlin from Zanzibar that Vice-Admiral Fremantle captured Vitu on Tuesday and burned the town to the ground.

Tuesday night's Gazette contained an announcement that the Queen has been pleased to command, on the recommendation of her Majesty's Chapel Royal Commission, that the Chapel Royal, Whitehall, shall be permanently closed.

The Exhibition of the Works in Pottery, Stone, and Glass, to which the prizes annually given by the Turners' Company had been awarded, was opened at the Mansion House on Wednesday.

The state of the eyesight of Bro. Alderman Sir Francis Wyatt Truscott is a cause of anxiety to him. An eminent oculist who has been consulted advises the Alderman that, though he can read the smallest print, he must scrupulously avoid overtaxing the strength of his eyes.

The Dutch States General by a vote of 109 to 5 votes have declared his Majesty the King, on account of the state of his health, to be incapacitated from carrying on the government of the country, and a bill providing for a Regency is expected to be passed in the course of the next fortnight.

Bro. Henry Lorraine, the scholarly Shakesperian tragedian, who has this week been winning high eulogiums by his masterly interpretation of the Ghost in "Hamlet" and Iago in "Othello," at Sadler's Wells Theatre, has been engaged to support Mrs. Langtry in the forthcoming production of "Cleopatra" at the Princess's Theatre.

Bro. Lord Mayor Sir H. A. Isaacs and the Lady Mayoress, accompanied by Sheriffs Farmer and Bro. Augustus Harris, attended the Guildhall School of Music on Wednesday evening for the purpose of distributing the prizes to the successful pupils. The prizes were distributed by the Lady Mayoress, and his lordship acknowledged the vote of thanks for their attendance.

It is the intention of Bro. the Earl of Jersey to leave England for Sydney, N.S.W., as soon as the convalescence of his wife is thoroughly established, and her ladyship will follow him to Australia when she is strong enough to travel. Their children, who had arrived at Brindisi and were stopped by the news of her illness, are expected to return to England the end of the present week.

It is announced that a history of the Craft in Austria and Hungary will shortly appear. The historian is Bro. Louis Argner, and it will be published in German in monthly parts. There was existing in Hungary in the last century a system of Masonry called the system of Count Draskovich, the details of which are promised by Bro. Argner.

The Duke of Clarence and Avondale visited Liverpool on Wednesday, for the purpose of opening the new Royal Infirmary. As may well be imagined, the city was en fête in honour of the event, and the Prince, both in the Town Hall, where he was received by the Mayor and Corporation, and the Infirmary, met with a most hearty reception, an address in a choice gold casket being presented to his Royal Highness in the Town Hall, and a gold key, with which he unlocked the door leading to the main corridor, and declared the new buildings open at the infirmary. A number of ladies presented purses afterwards, the amount thus raised being reported as £4,500. The day's rejoicings concluded with a grand ball, at which the Prince was present.

Mr. Charles E. Mudie, the founder and chief proprietor of the celebrated Select Library, which in all probability will always be distinguished by his name, died at his residence at Hampstead on Tuesday at the ripe age of 72 years. The deceased had been in failing health for a long time, nor had he taken an active part in business for some six or seven years. But though his place in New Oxfordstreet had long ceased to know him, his death will be very generally lamented as that of the founder of the most successful circulating library of this or any other country. "Mudie's," indeed, is an institution, and though all may not have approved of the principles on which it is conducted—as regards the selection of books for circulation—it is generally allowed that the deceased did much to promote the interests of a sound and wholesome literature. It has been said that he was narrow and somewhat bigoted in his views, especially in religious matters, but though some good works may have been excluded from his catalogues, none were ever included that were calculated to exercise a baneful influence on religion and morals.
