## THE BOYS' SCHOOL ELECTION.

The autumn election of children into the Royal Masonic Institution for Boys was held at Freemasons' Tavern on Friday, the 31st ult., when 19 candidates were chosen by ballot to fill up as many vacancies from an approved list of 52, the boy HART, standing at No. 47, and hailing from the Provinces of Bedfordshire and North Wales, having had his name withdrawn by his friends after the issue of the voting papers. The result shows that the poll was a heavy one, and that the voting was close, there being a difference of about 1000 votes only between the boy who headed the poll and the lowest successful candidate. Not far short of 400 votes separated the latter from the highest unsuccessful candidate, between whom and the candidate who obtained the thirtieth place there was a difference of about 1100 votes. The votes cast for the remaining 22 candidates were few in number, but with the exception of two of them, they will all have one or more opportunities afforded them of obtaining admission into the School.

The approved list contained the names of 13 London candidates, two of partly London and partly Provincial origin, and 38 Provincial, since reduced by the withdrawal of HART, as above mentioned, to 37, while the successful comprise seven London boys, one partly London and partly country, and 11 from the Provinces. Thus London has succeeded in carrying more than half its candidates, while the Provinces have failed to carry one-third. London had also the honour of heading the poll, one of its half-dozen new cases, No. 39, polling 3397 votes right off the reel, while the Lincolnshire lad, with 1779 votes from April last, stood second with 3146 votes, thanks to the support vouchsafed it by the Hertfordshire brethren, who, as the widow resides in their Province, adopted the candidate as their own. No. 3, hailing from London and Surrey, and having 1343 votes in hand, scored 1764 additional votes, and thus raised his total to 3107 votes. No. 4, London, with 1697 votes brought forward, increased his total to 3199, and then followed one of the two Warwickshire boys, who polled 3062 votes, of which 363 were brought forward. Had the exertions put forth in behalf of this lad been less considerable, he would have failed altogether, as this was his only remaining chance of obtaining admission into the School. No. 6, standing No. 52 on the list, had the support of Worcestershire and Cheshire, and, thanks to the exertions of his friends, obtained 3055 votes. One of the three Durham boys, who had only this chance left him and but 604 votes in hand, secured the next place with a total of 3044 votes, the Monmouthshire candidate, with still fewer votes (210) to his credit, being close at his heels with 3041, and a West Lancashire lad, who brought forward 489 votes, well up with 3037 votes. Thus between Nos. 1 and 9, the difference in the votes they obtained is only 360. Two boys from London obtained the tenth and eleventh places, the former, who was a last case, and had 1058 votes to his credit, scoring 2931, and the latter, with 1249 votes to the good, 2894. A second West Lancashire boy, who was a candidate for the second time, stood twelfth with 2887 votes, of which 239 were polled in April last; while a Kent boy, with 56 votes brought forward from the same election, secured the thirteenth place with 2733 votes. The East Lancashire candidate, with 2715 votes, was fourteenth in order, the West Yorkshire next with 2692 votes; two more London boys next with 2573 votes and 2525 votes respectively; one of three candidates from Derbyshire, with 1498 votes to his credit, raised his total to 2524 votes; and a seventh London boy brought up the rear with 2368 votes, of which 311 were already in hand.

The highest unsuccessful candidate hailed from London, his total being 1999 votes, of which 1484 were brought forward. Probably had his friends been a little less sanguine, his position would have been higher. The Suffolk boy stood next with 1872 votes, and then came the youth from South America, who carries forward his 1602 votes to the election in April next. The Berks and Bucks boy was twenty-third on the list with 1448 votes, and the Notts boy next with 1374 votes. Then followed a

London boy with 1250 votes; one of the Somersetshire candidates with 1203 votes; one of the three from Kent with 1154 votes; and then three others who each of them scored over 800 votes, and will therefore stand proportionately well for the next election. The remaining 22 candidates did nothing to speak of. The total number of votes issued and brought forward reached 77,500, of which 16,042 were in hand already, while of the 61,458 issued for this election 56,160 were received and passed by the Scrutineers, the number unused or rejected being 5298. Of the five last cases, three succeeded, the two unsuccessful hailing from London and Hertfordshire respectively. It is manifest, however, from the fact of the latter obtaining only eight votes that he never had the remotest chance of winning, and it seems to us that it would have been better, and would certainly have saved trouble, had his case never been submitted for approval. The number of candidates who will go forward to the election in April, 1891, is 31.

## THE GIRLS' SCHOOL ELECTION.

As might have been expected from the more limited number of candidates, the polling on Saturday last for the election of candidates into the Royal Masonic Institution for Girls was indidividually far heavier than at the Boys' Election the day previous. At the latter, the highest individual poll was 3397 votes, and the lowest successful candidate obtained 2368 votes, the highest unsuccessful scoring 1999 votes. On Saturday last the girl returned at the head of the list polled 4212 votes, and No. 16, the lowest successful, 3563 votes, while there were two children who obtained upwards of 3000 votes, and failed to secure places, and a third in a similar position, who obtained upwards of 2300 votes. Taking, however, the aggregate at the two elections, we find that there were more votes passed by the Scrutineers out of a somewhat smaller issue for the Boys' Election than at that of the Girls' School.

The approved list of candidates contained the names of 32 girls, of whom one, however, was withdrawn after the voting papers had been distributed. Of these nine hailed from London and 22 from the Provinces and Districts abroad. London carried four of its candidates, and polled over 3000 votes in the case of two others, while the Provinces placed 12 candidates. The highest successful child hailed from New Brunswick, and starting with 691 votes in her favour, obtained a total of 4212 votes. Of the two girls from Norfolk, one had 2141 votes to her credit, and increased her total to 4073 votes, thereby securing the second place, while a London candidate, who figured in this capacity for the first time, was placed third with 4014 votes. One of two Sussex children stood next with 3957 votes, and a Suffolk girl next with 3832 votes. The candidate from North and East Yorkshire, with 2593 votes to the good, scored 3829, while one of three from the contiguous Province of West Yorkshire, who had 2470 votes in hand, came next with 3771 votes. second Suffolk girl stood eighth with 3760 votes, and the one Hants and Isle of Wight candidate ninth, with 3731 votes, a second West Yorkshire girl, who was only one vote behind No. 9, being next with 3730 votes. No. 11 from London polled 3680 votes, and No. 12 from Durham 3654 votes, of which 908 were brought forward from the April election. Nos. 13 and 14 were from London, and scored 3631 votes and 3630 votes respectively, the former being 1124 votes to the good at starting, and the latter 634 votes. The second Norfolk girl secured the fifteenth vacancy with 3602 votes, of which 2273 votes already stood to her credit, while one of the Devonshire girls obtained the sixteenth place, with a total of 3563 votes, 429 votes being brought forward, and 313.1 votes polled on this The highest unsuccessful candidates were two London girls with 3406 votes and 3062 votes respectively, the former having 1531 votes at starting, and the latter 884, the next child, who brought forward 1517 votes and increased her total to 2339 votes, being from Malta, and the

next with 1343 votes, the second candidate from Sussex. Of the two last cases, one headed the poll, and the other, from London, only obtained 183 votes, and will therefore have her name romoved from the list, so that the number of children who remain eligible will be 14. The votes brought forward from April were 17,689, and the votes issued 61,524, making a total of 79,213, but the total poll was 73,590 votes, so that 5623 votes were either unused or rejected by the Scrutineers.

# THE RIGHTS OF MINORITIES UNDER ARTICLE 219.

It is evident that we have not heard the last of the Grand Registrar's ruling in respect of Law 219, Book of Constitutions, and its applications to the case of lodges which determine by a majority of votes to secede from the English Constitution. It will be remembered that this law provides that "should the majority of any lodge determine to retire from it, the power of assembling remains with the rest of the members, but should the number of members remaining at any time be less than three, the warrant becomes extinct." According to a letter from our Grand Secretary, written after consultation with the Grand Registrar, to the District Grand Secretary of Wellington, N.Z., in November last, it was "officially decided" at the time the new Australian Grand Lodges were being formed, that "the rule contained in Art. 219, Book of Constitutions, which allows three members to hold the warrant, did not apply" to cases in which a majority of the members of any lodge determined on joining a newly-formed local Grand Lodge, or one in course of formation, on the ground that "the majority were not 'retiring' from the lodge, but were merely transferring its allegiance to another Masonic power." To this was added the further information "that it was always ruled in the Australian cases that such a question cannot be discussed in open lodge." To this we objected in the article which appeared in our issue of the 20th September, "that (1) there is nothing in the wording of the Article (219) itself to indicate that the word 'retire' possesses, or is intended to possess, the particular meaning assigned to it by the Grand Registrar in this or any other class of cases; and (2) it is not in the power of a majority of the members of a lodge to 'merely transfer' its allegiance from the Grand Lodge which constituted it to 'another Masonic power.'" We further pointed out that, as "such a question cannot be discussed in open lodge," no lodge, as such, could determine in favour of "merely transferring its allegiance to another Masonic power;" that though the members might meet together as individual Craftsmen, and as such determine by a large or bare majority on transferring their allegiance to another Masonic power, such decision would not, unless otherwise previously arranged, be binding on the minority; and that such minority would therefore retain the right secured to them by Article 219 of assembling as a lodge, provided always that they were not "less than three" in number.

We have more than once referred to this subject, and every now and then we receive intelligence, either through our exchanges or from private sources, which confirms us in our opinion that the Grand Registrar's interpretation of this particular law is not justified either by the language in which the law is expressed, or by any other law in the Book of Constitutions. Very recently we have received a letter from a loyal member of the Cambrian Lodge of Australia, No. 656, Sydney, New South Wales, in which he says, "While freely admitting the right of a majority—when not a packed meeting—in all cases where there is no rule or course laid down in the Book of Constitutions for guidance, we totally disagree with Worshipful Brother Philbrick's opinion in our particular case, and you cannot, Sir, wonder at the widespread dissatisfaction such an opinion has caused. In fact, the leading members of the Craft in the Colonies are perfectly astounded at the manner in which the loyal members of Cambrian Lodge, No. 656, E.C., have been dealt with and Article 219, B.C., rendered void." After expressing a doubt as to whether our Grand Lodge has decided in accordance with the Grand Registrar's ruling, the writer goes on to remark—"That the language of Article 219 admits of only one reading, and that that reading is plain and simple I think you will agree with me, for a third-form boy could not misconstrue the language used in B.C., viz., three members may hold the charter of the lodge." In a postcript the writer adds, "May I ask what would the Grand Registrar say to the casting vote of a partisan Chairman on a proposition to join a Constitution which does not recognise the G.A.O.T.U., if that casting vote were given in favour of joining the new Constitution? Would the majority then have the right to remove a God-recognising lodge to an infidel Constitution?"

As regards intelligence of an official character relating directly or indirectly to this branch of the New Zealand question,

we may state, firstly, that in a letter dated "Auckland, May 8th, 1890," the District Grand Secretary of Auckland, writing by direction of the District Grand Master, informs the Worshipful Masters of lodges in that jurisdiction that "until recognised by the Grand Lodge of England, no intercourse should be held with the so-called 'Grand Lodge of New Zealand,' and its members should not be admitted as visitors or otherwise into our lodges;" and further, that "in the event of his electing to erase or suspend the warrant of any seceding lodge, he (the D.G.M.) intimates that if any members, not less than three in number, and not being connected with the so-called 'Grand Lodge of New Zealand,' are desirous of retaining their lodge warrant, and continuing the working of the lodge, he will be prepared to grant such request upon application." In a circular dated "Christchurch, 20th May, 1890," Bro. P. CUNNINGHAM, District Deputy G. Master in charge of the District Grand Lodge of Canterbury, E.C., after cautioning Masters of lodges in the District against surrendering the warrants of their lodges, except to the authority by which they were granted, writes, "I may state, however, that lodges having a satisfactory number of working members (although a minority of the original members of such lodge) will be granted permission to retain their warrants, names, and numbers, and continue to work under the Grand Lodge of England." But the most important utterances on the subject are contained in a letter addressed under date of "Auckland, 10th May, 1890," by Bro. Sir Frederick Whitaker Attorney General N.Z.), District Grand Master of the North Island, N.Z., under the Scotch Constitution, to the Worshipful Masters of the lodges under his obedience. This distinguished brother says, among other things, (1) "No lodge, whatever number of members are in favour of it, can transfer the allegiance of the lodge as a body, and by the laws of our Constitution it is prescribed that 'should the majority of any lodge retire from it, the power of carrying on the work remains with the minority. Should the number of members of a lodge be reduced to less than three, the charter becomes extinct." "Now, as to the position and duty of the Master and members of your lodge. If the lodge has passed a resolution at a duly constituted meeting to transfer their allegiance, or a resolution in any form inconsistent with their charter and the allegiance they owe to the Grand Lodge of Scotland, any such resolution was ultra vires, and, putting it in the least offensive form, a mistake made under a misapprehension: but if not that, and it was passed deliberately, with a full knowledge and appreciation of the situation, it would not be unduly harsh to characterise the act as a revolt on the part of the lodge, and on the part of the Master, if he concurred therein, a violation of the solemn obligations entered into by him at his installation. A statement of the circumstances is alone, in my judgment, sufficient to demonstrate the absurdity of a contention that a lodge, duly constituted by the Grand Lodge of Scotland, to which, by solemn engagement, it owes allegiance, can possess the power to transfer that allegiance to another body, even if that other body were a duly constituted Masonic body, much less to a body not even recognised by the Grand Lodge of Scotland. At the same time it is, of course, the unquestioned right of any members to duly retire from their lodges, and, if they think fit, to transfer their allegiance as individuals to any other duly constituted and recognised lodge, or indeed to any other body by whatever name it may please to call itself." These, it must be remembered, are the utterances, not of a layman, but of a legal colonial luminary, and deserve, therefore, to be well pondered.

In the meantime, we commend to the notice of the Grand Registrar the following queries:—

(a) How can a majority of the members of a lodge legally transfer its allegiance to another Masonic power, if the question "cannot be discussed in open lodge?"

(b) If a majority of the members agree among themselves, but not in open lodge, to transfer their allegiance, what is that but an act of secession or retirement on their part; and in what way can such an agreement, arrived at outside the lodge, be made legally binding upon the minority who remain loyal, if the latter determine upon availing themselves of "the power of assembling," which is secured to them under Article 219?

(c) If it is in any way possible for a majority of the members

(c) If it is in any way possible for a majority of the members of a lodge to transfer its allegiance to another Masonic power, and by so doing revolt from the authority of that which constituted it, are the minority who decline to have part in such revolt to be punished for remaining loyal by deprivation of the rights secured to them by law?

Though the town of Richmond has received its charter of incorporation, it has not yet succeeded in obtaining a Mayor. It, in the first instance, approached Bro. Alderman Sir J. Whitaker Ellis, who is an ex-Lord Mayor of London, and represents the Richmond Division of Surrey in the House of Commons. The latter, however, did not see his way to accepting the offer, but the Corporation of Richmond have again desired Bro. Sir J. W. Ellis to accept the office, and as he has invited the Members to dine with him at Buccleugh House, on Monday, the result of the second application will, no doubt, shortly be known.

## SUPREME GRAND CHAPTER.

The Quarterly Convocation of Supreme Grand Chapter of Royal Arch Masons of England was holden on Wednesday evening, in the Temple, Freemasons' Hall, when a large number of companions attended.

The minutes of the last Quarterly Convocation having been read and confirmed, the following report of the Committee of General Purposes was, on the motion of Comp. ROBERT GREY, seconded by Comp. FRANK RICHARDSON, taken as read, and received and ordered to be entered on the minutes:

THE REPORT OF THE COMMITTEE OF GENERAL PURPOSES.

To the Supreme Grand Chapter of Royal Arch Masons of England.

The Committee of General Purposes beg to report that they have examined the accounts from the 16th July to the 14th October, 1890, both inclusive, which they find to be as follows:—

The Committee have also to report that they have received the following petitions:—

1st. From Comps. Vero William Taylor, as Z.; Millner Jutsum, as H.; Robert Guy Kellett, as J.; and six others for a chapter to be attached to the Joshua Nunn Lodge, No. 2154, Halstead, to be called the Colne Valley Chapter, and to meet at the George Hotel, Halstead, in the county of Essex.

2nd. From Comps. Captain William Home Chisholme St. Clair, R.N., as Z.; John Brickwood, as H.; William Dart, as J.; and 19 others for a chapter to be attached to the St. Clair Lodge, No. 2074, Landport, to be called the St. Clair Chapter, and to meet at the Freemasons' Hall, Commercial-road, Landport, Hampshire.

3rd. From Comps. John George Dimock, as Z.; the Rev. Oliver Carter Cockrem, as H.; John Walker, as J.; and seven others for a chapter to be attached to the Vernon Lodge, No. 1802, East Retford, to be called the St. Stephen's Chapter, and to meet at the Criterion, Carolgate, East Retford, Nottinghamshire.

4th. From Comps. Joseph Henry Price, as Z.; William Barnes Fendick, as H.; Henry Esling, as J.; and seven others for a chapter to be attached to the Emblematic Lodge, No. 1321, Southwark, to be called the Emblematic Chapter, and to meet at the Criterion, Piccadilly.

The foregoing petitions being in every respect regular, the Committee recommend that the prayers thereof be respectively granted.

The Committee have likewise received memorials, with copies of minutes, for permission to remove the following chapters:—

The West Kent Chapter, No. 1297, from the Thicket Hotel, Anerley, to the Crystal Palace, Sydenham.

The Welchpool Chapter, No. 998, from the Railway Station, Welchpool, to the Masonic Temple, Newtown, North Wales.

The Committee recommend that the removal of these chapters be sanctioned.

The Committee have further to report that, in consequence of the formation and recognition of the Grand Lodge of Tasmania, there are no longer English Craft lodges in that colony to which the chapters meeting in Tasmania can be attached, as required by Article 45, Royal Arch Regulations.

The Committee, therefore, recommend that the charters of the Chapters Nos. 536 and 618 be withdrawn and cancelled, and that the chapters be erased from the register of the Grand Chapter.

The above recommendations having been moved by Comp. ROBERT GREY, and seconded by Comp. FRANK RICHARDSON, were severally agreed to, and Grand Chapter was then closed.

## ROYAL MASONIC INSTITUTION FOR BOYS.

The Quarterly Court of this Institution's Governors and Subscribers was held on Friday, the 31st ult., at Freemasons' Tavern. Bro. W. W. B. Beach, M.P., Prov. Grand Master of Hants and the Isle of Wight, presided. He was supported right and left by Bros. R. Eve, Spaull, Le Feuvre, G. Everett, J. Glass, and S. J. Attenborough.

The minutes having been read and confirmed,

Bro. John Glass moved "That the by-laws as amended by the Provisional Management and General Committees be submitted for approval." In doing so he said that more than 12 months since, in response to an expressed opinion of a large number of the supporters of the Institution, and at the desire of those to whom the management of the Institution had been for a time committed, a Sub-Committee was appointed to revise the by-laws of the Institution. At the first meeting of this Committee it was resolved that lines on which such revision should proceed would be to frame the laws upon broader principles of administration than heretofore, and endeavour to prevent the management of the Institution degenerating into narrow channels and cliques. At the same time care was to be taken that the fundamental

principles of the Institution and its benefits should be in no way impaired. Every member of the Committee expressed in writing his views upon the several points that in his opinion required alteration; in addition to which numerous suggestions were made by many brethren who took a warm interest in the affairs of the Institution, who were well qualified by their experience to offer valuable and important suggestions as to the future adminstration of the Institution. Bro. Philbrick undertook to consolidate all the suggestions, &c., into a formal code of laws, this work requiring a great deal of patient labour and careful detail. The work was accomplished by the eminent brother named, and he was assisted in his task by Bro. J. D. Langton, the Hon. Sec. of the Committee, and to both of these brethren the subscribers were much indebted. A draft of these laws was submitted to the Provisional Committee at a special meeting about last June. The meeting was adjourned from time to time until the whole of the proposed laws had been discussed. The Provisional Committee, being a larger and more important representative body, were undoubtedly in a position to give expression to the requirements of the Craft upon many matters appertaining to the government of the Institution. It was also found that as the Provisional Management Committee had compiled a code of regulations for the guidance of the officers and servants of the Institution, some of the proposed laws were unnecessary; some also which had been framed in accordance with suggestions made to the Sub-Committee as to "last chance" cases, and certain advantages to be given to the children of deceased brothers who had during their lifetime been Life Governors of one or other of the Institutions, were rejected by the Committee, after consideration, upon the grounds that either they were unworkable or unfair. After several meeetings these laws were as amended submitted to the General Committee for consideration. This was a still larger and more important body, with yet wider experience and more expansive views upon the subject. This Committee sat one day for six consecutive hours. There was at that meeting at first considerable divergence of opinion upon some essential points. There was much searching and sifting, and there was, of course, a rich harvest of academical discussion. All the brethren, however, exercised considerable self-denial, and generously met each other upon matters of detail, and the happy result of that meeting was the almost unanimous resolve that these laws as then amended should be submitted to the present Committeethe supreme governing body of the Institution-for approval. After referring to the most important points, Bro. Glass said that although the Committee were aware that the by-laws as submitted were not perfect in the estimation of every brother, the Committee were strongly of opinion that they should be passed in their present form, and given at least a 12 months' trial. It would of course be necessary that they should be confirmed at the next Quarterly Court before they could become operative, and the Committee therefore asked the meeting to approve them that day. Most members of the Committee had had to sacrifice some pet theory upon the altar of expediency, and the Committee asked the brethren who were not quite satisfied with these laws to follow the example set by the Committee. The Committee knew it was not by a code of laws alone that they could rely upon the Institution accomplishing its full and proper mission of charity and love towards the children committed to its care; but they believed that if those laws were administered in the same spirit in which they had been conceived, that School would take high rank amongst similar institutions in the country, and would receive that generous support of the Craft in the future which had been afforded to it in the past. For those reasons the Committee asked for a unanimous vote.

The motion was seconded, and agreed to.

A long discussion then followed on different articles, and some alterations were made. Law 35 was altered from the last Friday to the second Friday in April and October for the elections, it being stated that the Girls' Institution would agree to alter their meeting from the last to the second Saturday. Law 96 was struck out, which authorised the payment of commission on subscriptions collected by local agents in large towns.

As Bro. Beach was obliged to leave before the election, he appointed Bro. R. Eve to take his place, whereupon a vote of thanks to Bro. Beach, proposed by Bro. George Everett, and seconded by Bro. Scurrah, was carried unanimously, and Bro. Beach having replied, the meeting proceeded to elect 19 boys out of an approved list of 53 candidates.

## Masonic Motes.

We are in a position to contradict the statement recently made by an evening contemporary in its Masonic News Column, to the effect that the Executive of the Royal Masonic Institution for Boys contemplate holding the next Anniversary Festival somewhere in the North of England.

We do not think that such a proposal would find favour with any considerable section of the Craft, excepting, of course, those living in the town or city that might be chosen for the celebration, and the province in which it was situated. True, in the case of the Boys' School, the Festival has been held two or three times at Brighton, but that is virtually a part of London, and the provincial brethren attending the festivity were as ready to dine at Brighton as at the Crystal Palace or Freemasons' Tavern. But it strikes us the Executive of the Charity have sufficient on their hands to attend to without going out of their way to increase the additional labour which such a visit would entail on them. At all events, we are able to state that so insane an idea has never at any time been contemplated by any of the officers of the Institution.

However, if there is any desire on the part of the Metropolitan or provincial brethren for a change of locality in connection with the Boys' School Festival next year, we venture-on our own responsibility, be it said-to think it would be difficult to find a more convenient or appropriate place than the Great Hall of the Institution itself at Wood Green. It is large enough to dine some 500 guests, and there would be no difficulty as to the catering, while the celebration would take place within the very walls of the Charity which the Craft were being invited to support. As a rule, we think these gatherings should be held always at some central spot, but if, as we have said, a change be thought desirable, let the School Hall be chosen.

Bro. P. H. Emanuel, W.M. of the Portsmouth Temperance Lodge has set an excellent example, which we hope will be extensively followed. At the last meeting, held on the 27th ult., he made a present to the lodge of some 12 volumes of the Freemason and a set of Gould's "History of Freemasonry," as a nucleus for a lodge library, prefacing the presentation by some apposite remarks on the great advantage to be derived by young Masons from the study of Masonic literature, the variety and merits of which were unknown to a large number of brethren, especially the younger members of the Craft. Other Worshipful Masters please copy!

A cablegram from Toronto reports the arrival of the Grand Master, M.W. Bro. J. Ross Robertson, from his tour in Europe, and gives particulars of his reception at the Masonic Temple on Friday night by upwards of 700 brethren, including 150 Masters and Past Masters. An address of welcome was presented to him, and a lengthy reply by Bro. Robertson was enthusiastically received. In short, the worthy Grand Master was the subject of a great ovation. Eulogistic speeches were made by leading Grand Officers and prominent Craftsmen, and the largest gathering of the kind that ever took place in Canada was a further evidence, if any were needed, of the great esteem and affection in which this popular ruler is held by his brethren.

We heartily congratulate our worthy contemporary, the South African Freemason, on the success which has thus far attended its labours, and we trust it may have before it a long career of usefulness. It entered on its fourth year in October, and to judge from the manner in which it has fulfilled its duties as the organ of the Craft in South Africa, it deserves every encouragement. May good fortune preside over its destinies in the future!

Our Australasian contemporaries, the Victorian Freemason and the Australasian Keystone, have been amalgamated, and while the title of the latter journal will be retained, the interest of the two sections of subscribers will be impartially looked after and promoted. We trust the change will be beneficial to the Craft in the Australasian Colonies, and that it will be our good fortune to peruse the pages of our old friend the Keystone for many years.

According to a return we have received from New Zealand there are only 36 lodges which have given in their adhesion to the so-called Grand Lodge of New Zealand, while 29 lodges are as yet undecided as to whether they shall cast in their lot with the unrecognised body or remain true to their old allegiance. The number of lodges which still work under the Grand Lodges of England, Ireland, and Scotland is 79, or considerably more than half of the lodges in existence at the time the scheme for establishing a new Grand Lodge for the whole colony was launched.

We cannot, of course, hold ourselves responsible for the accuracy of these returns, but if we assume they are approximately true, it is clear that our estimate of the extent to which the secession movement had been successful has been largely in excess of the reality. Our idea, based on the not particularly impartial statements of the New Zealand Craftsman, has been hitherto that rather more than half the lodges supported the Grand Lodge movement, while rather less than one-half were in favour of retaining the status quo. If the figures we have quoted above are trustwortny, it is precisely the other way about, and the desire for a New Zealand Grand Lodge has found even less support than we had supposed. It this is so, the case of those who have knowingly thrown the whole of New Zealand Freemasonry into disorder is by no means an enviable one.

## India.

#### AN "AT HOME" AT POONA.

On Wednesday, the 3rd September, the Masons of Poona held an "At Home" at the Masonic Hall, at which a large number of guests were present. Advantage was taken of the occasion by the members of the fraternity under the English and Scottish Constitutions to present Bro. Captain C. D. Wise with a very handsome gold lever watch and chain, in token of their appreciation of the valuable services he had rendered to the cause of Freemasonry in that station during the many years he had been there. Bro. Captain Wise belongs to the Adjutant-General's Department, and will shortly retire from the service. He has now accepted the office of Grand Secretary of the Scottish lodges in India.

The entire building was thrown open to the guests, several of whom were non-Masons. The rooms were very prettily decorated with Masonic flags and banners, the large banners of the two lodges in Poona—Orion in the West and St. Andrew in the East—being conspicuously shown at the back of the dais. The inner hall had been very nicely arranged as a drawing room, with a number of foliage plants happily disposed here and there, and the refreshment tables were laid in one wing. The front room was given up to dancing. The guests began to arrive at nine o'clock, and were received by Bro. Dr. Fearn, the Secretary, and the members of the Hall Committee.

Dancing, to the strains of the excellent band of the 2nd (P.W.O.) Grenadiers, commenced soon after nine o'clock.

Bro. Dr. Fearn the Secretary of the Hall Committee, and W.M. of St. Andrew's Lodge, presented Captain Wise to Colonel Lloyd, to whom, as President of the Committee, and W.M. of Lodge Orion, was entrusted the pleasing duty of making the presentation.

In doing so, Bro. Col. LLOYD regretted that there were not more Masons present. The principal witnesses of the scene that evening were, he said, ladies, whom they did not recognise in Masonry. However, they were all delighted to see the ladies there on that occasion. The gift had been subscribed for by H.R.H. the Duke of Connaught and all the Masons in the station. Colonel Lloyd hoped that his friend Bro. Capt. Wise might be spared for many years to come to make use of the watch.

Cheers were given for Captain Wise, and all present joined in singing "For he's a jolly good Mason."

Captain Wise, in accepting the gift, said he could hardly find words to express his feelings at that moment, and he felt that he was very unworthy of the honour that had been done him. He had merely endeavoured to do his duty, and he believed that if others had had the same opportunity they would have accomplished what he had done, and perhaps would have done it better. He thought that the gift was due more to the kindness and good feeling of his brethren than to any merit he possessed. He had certainly looked for a reward, but we all do, as it is the "hope of reward that sweetens labour;" but his had been a labour of love, and the only reward he had looked for was the approbation of his brethren. He would value the gift, which would remind him of those Masons in Poona with whom he had long been associated, and with whom he had spent many happy hours. He assured those who were outside the pale that Masonry was something more than a name. In conclusion, he thanked all the brethren for the great honour they had done him.

The following was the inscription on the watch: "Presented to Wor. Bro. Charles D. Wise, Past G.D. Grand Mark Lodge of England, Past Dist. G.D. of Grand Lodge of England, P.D.S.G.W. Grand Lodge of All Scottish Freemasonry in India, by H.R.H. the Duke of Connaught, Dist. Grand Master Bombay, and the members of the English and Scottish lodges in Poona, in token of their brotherly love and esteem for his services of over 17 years' Masonry in Poona, 1889."

The presentation over, dancing was resumed, and the

pleasant gathering broke up shortly after midnight.

He is P.M. of Lodges Nos. 343 (S.C.) and 415 (E.C.); was annually elected Treasurer of No. 415 from 1885 to 1889; P.Z. No. 68 (S.C.), P.M. Arrart Lodge, Royal Ark Mariners (S.C.); P.M. (Mark) No. 134 (E.C.); P.D.S.G.D. Bombay (E.C.), P.D.J.G.W. Bombay (Mark), P.S.G.W, A.S.F.I.; P. Dep. P.Z. of Western India (S.C.), P.S.G.D. England (Mark). He was one of the founders and first T.R.S.T.A. of Morland Chapter, Royal Order of Scotland; is P.G. Sec. Royal Order of Scotland for West India, Sec. St. John's Chapter, 18° (S.C.), and M.P.S. Roman Eagle Conclave, Red Cross of Rome and Constantine: He was Hon. Secretary and Treasurer of the Poona Masonic Hall Committee from 1873 to 1889, and is a Life Governor of the Bombay Masonic Association.

RE-OPENING OF THE MASONIC HALL, BATH.

The brethren of the three Bath lodges-Royal Cumberland (No. 41), Royal Sussex (No. 53), and Lodge of Honour (No. 379)-met on Thursday evening, the 30th ult., at the Masonic Hall, Bath, to celebrate the re-opening on the completion of the alterations to their hall. For a considerable time the Masonic body at Bath have felt it was necessary to spend a very large sum of money in restoring and decorating their present building. It may here be stated that the present building was formerly the old Bath Theatre, but about 75 years ago it was purchased by the Roman Catholic body in Bath, and converted by them into their place of worship, and large numbers of their communion were buried in the vaults underneath the present hall. On their removal to their present handsome structure some 25 years ago the chapel was purchased by the Masonic body in the city and adapted to their wants, but at the present moment underneath the lodge room the remains of many devout Catholics still remain, and on a recent visit to the vaults we found 30 to 40 very handsome memorial tablets on the walls underneath the building. This we should think is almost unique in the history of the Masonic body in this country.

Last year, by the efforts of Bro. Dyer, W.M. of the Royal Sussex Lodge, No. 53, and Bro. Gregory, W.M. of the Royal Cumberland Lodge, No. 41, a joint Committee of the Bath lodges was appointed to take steps to carry out the necessary alterations. Under the superintendence of a Sub-Committee, the work has been accomplished, and, we think, to the satisfaction of the brethren. The lodge room has been entirely re-decorated, and fitted with handsome oak stalls and other Masonic furniture. The ceiling of the anteroom has been raised, and above it has been constructed a large and handsome room for the banquets and suppers of the respective lodges. New lavatories have been formed, and a capital heating and ventilating apparatus placed in the building, which will add greatly to the comfort and convenience of the brethren. The Bath lodges may congratulate themselves on possessing one of the most imposing and complete Masonic buildings in the West of England.

After inspecting the various alterations and improvements, the brethren sat down in their new banqueting room to a very *recherché* supper, provided by Bro. Fortt in his usual Masonic style.

He knew that many of their older Past Masters were anxious to relieve themselves of their superfluous wealth, but he thought that even after their very handsome contributions were received, there would still be room for the many contributions that their younger brethren were so anxious to hand over. He trusted that every brother would consider it his duty to give in proportion to the means the G.A.O.T.U. had endowed him with.

#### 18] BRO. SADLER'S NEW WORK.

I was very pleased to read in Masonic Notes (Oct. 25th) so warm a commendation of Bro. Sadler's decision to do justice to the Masonic career of the R.W. Bro. Thomas Dunckerley, and feel assured that your very favourable estimate of the value of the work will be abundantly confirmed. Had not Bro. Sadler intended to write a history of such an enthusiastic Mason, when time permitted it would not have been left undone, as I should have attended to such a duty myself, if for no other reason than for that already indicated. To my mind Dunckerley has been strangely neglected, though beyond question the most active, industrious, and zealous Craftsman of his time. In fact, it is impossible to write his life, Masonically, without treating of the main characteristics of the two rival Grand Lodges from 1767 to his decease in 1795; the origin and spread of Royal Arch Masonry, and especially of the Knights Templars (in which two bodies he took such an interest), and the inauguration of several Provincial Grand Lodges through his instrumentality. Most of the Provincial Grand Lodges of the latter half of last century owe their origin mainly to Dunckerley, and this is still more so with regard to Provincial Grand Chapters. If Bro. Sadler's work on the "Life, Labours, and Letters of Thomas Dunckerley" is not soon subscribed for, it can only be because the great services of that noble brother on behalf of the Craft are unknown to present-day Freemasons. Of course this would be the reason why its publication is still more needed, but it is to be hoped there will be no delay, at all events, on the part of Masonic students in at once subscribing. Bro. Sadler has sent me three of the illustrations for the volume, being autotype reproductions of old prints. These are very satisfactory in character, and will form an attractive feature of the book. I must not omit to state that Bro. W. H. Rylands, F.S.A., has promised to write a preface, so that there will be no lack of attractions.

## 919] THOMAS DUNCKERLEY'S PORTRAITS.

Replying to Bro. Lamb-Smith's enquiries in the Freemason of the 25th ult., I much regret that at present I am unable to inform him of the whereabouts of the original portrait of Dunckerley, painted by Thomas Beach and engraved by John Jones, which was published in 1789. Both these artists were celebrated in their respective professions, the former having been a pupil of Reynolds and a frequent exhibitor at the Royal Academy. The catalogue of exhibits at that institution about the time the portrait in question was painted contains no reference to it, unless in the guise of "A Portrait of a Gentleman," but this I think is scarcely probable. I have been on the look out for this portrait for some years past and have reluctantly arrived at the conclusion that it is no longer in existence. However, as a reduced fac simile of the engraving will form the frontispiece to "Dunckerley's Life," &c., now in the press, it may possibly be the means of throwing fresh light on the subject. The only original portrait of Dunckerley with which I am acquainted hangs in the Masonic Hall at Poole, and is the property of the Lodge of Amity, No. 137, for which lodge it was painted in 1783, by Philip Vandyke, a comparatively unknown artist, although evidently possessed of considerable talent. This portrait was also engraved in mezzotinto, by Charles West, and published in 1786. The latter engravings are now rarely met with; indeed, I only know of two in existence, one belonging to the Lodge of Unity, No. 132, at Ringwood, and the other to the Governors of the Freemasons' Hall, Bristol.

The inscription inside the watch was as follows: "Presented, together with a purse and illuminated address on vellum, to Samuel Henry Parkhouse, by a few sincere and affectionate friends, on the completion of the 50th year of his age. Oct. 29, 1890."

## Obituary.

BRO. THE REV. J. E. COX, D.D., PAST GRAND CHAPLAIN.

The Craft has sustained a great loss by the death of Bro. the Rev. John Edmund Cox, D.D., Past Grand Chaplain of England. Though for some years past he chaptain of England. I hough for some years past he had taken but little active part in Masonry, our deceased brother had rendered many important services in days gone by. He was Grand Chaplain of England from 1848 to 1857, both inclusive, and was Grand Director of Ceremonies of Supreme Grand Chapter in 1853. We find him described in the same year as a P.M. of the Unity Lodge, No. 71, Lowestoft, and as a Past G. Commander of the Cross of Christ Encampment of Knights Templar. In December, he took the 30° in the Ancient and Accepted Rite system of Masonry, while some months previously he was nominated in Grand Lodge to serve on the Board of General Purposes and the Committee of Management of the Royal Masonic Benevolent Institution. In 1854 he was again elected to serve on the same Board and Committee, and was President of the Board of Stewards at the Festival of the Royal Masonic Institution for Girls. About the same time he was elected a joining member of the Polish National Lodge, No. 534, and on the 22nd of October took a prominent part in the installation of the late Bro. Lord Sherborne as Prov. G. Master of Gloucestershire. He was a Life Governor of all three Institutions, and had served as Festival Steward for the Boys' School and Benevolent Institution, as well as for the Girls' School. His services, however, to the Masonic Schools were not restricted to Stewardship. On several occasions he undertook the responsible duties of Examiner, and was busy in his attendance at the Committees at the time when steps were being taken to improve and extend the scheme of education, which had previously been limited to the English education of the plainest character. Bro. Cox, also, will always be remembered in Masonic literary circles, not only as a frequent and respected contributor to the Masonic periodical press of his more active days, but likewise, and in a more especial degree, as the able and careful editor of a work comprising the several successive editions—from 1723 downwards—of our Book of Constitutions. In short, whether as a contributor to our most important literature, as a supporter and promoter of our Institutions, or as an able and active member for many years of various private lodges and chapters as well as Grand Lodge and Grand Chapter, the memory of our late reverend brother will always be held in the highest esteem and respect. Bro. Cox was even better known outside the Craft than in it. He was for many years connected with Bell's Weekly Messenger, had been musical critic of the Observer, and was author or editor of many works, the most important among which were his "Annals of St. Helen's," of which parish he was vicar for close on the rear which were and the last t 40 years, which was published at the instigation of the Merchant Taylors' Company, the patrons of the living, "A Life of Cranmer," "A Life of Luther," "The Works of Cranmer" (for the Parker Society), and "Musical Recollections of the last Half Century. The late Dr. Cox was born at Norwich in 1812, and was educated at All Saints' College, Oxford, as a Bible clerk. He was ordained by the Bishop of Norwich in 1837, and after labouring for some years in that diocese, moved to London in 1847, where he received, as his first appointment, a curacy in the parish of Stepney, being afterwards appointed to the vicarage of St. Helen's, Bishopsgate. He was a member of the Athenæum Club, served as Chaplain to the late Alderman Sir Thomas Owden during his Mayoralty, and was Chaplain to the Turners' Company, the Royal Society of Musicians, and the British Society of Musicians. His death took place at Richmond, at the ripe age of 78 years, and his remains were interred in Norwood Cemetery on Friday, the 31st ult., the officiating clergy being the Rev. J. A. L. Airey, his successor at St. Helen's, and the Rev. J. D. Donovan, who was present at his death bed, while among those present were his sons, the Rev. J. Bell Cox and Mr. B. Cox, Bro. Turtle Pigott, D.C.L., P.A.G.D.C., and others.



With such a sweet title "Sunlight and Shadow," one might expect a highly interesting play, and Mr. R. C. Carton's new piece at the Avenue is just one unalloyed evening of pleasure. We are reminded strongly of Robertson, Albery, and Pinero, as we at once recalled the delightful hours we spent seeing "Caste," "Two Roses," and "Sweet Lavender." Mr. Carton gives us a touch of the true ring of human nature. We want no Ouida, Zola, or Ibsen's plays adapted or dramatised, and we hope Mr. Carton will go and do something even better than the lovely comedy Mr. Alexander has just produced. There are no striking sensations, no fresh melodramatic points, in fact nothing original, for the story is not even new, but the theme is so well put together and worked out in such a refreshing manner and acted so admirably, that every one must not only be highly delighted, but also be the better for a visit to the Avenue. Its simplicity and sweetness are fascinating. Dr. Latimer has two daughters, both true to nature. Helen, always think-

ing more of others than herself, and Maud, selfish, but not viciously so, merely a feather-brain girl, given to tennis, tea, and dancing. Helen loves Mark Denzil, a man whose life is clouded, for in his youth he married an adventuress, but, believing her to be dead, he woos the doctor's eldest daughter. Just as Helen has given her consent the former wife appears on the scene. George Addis is a very intimate friend of the Latimer family, and he, too, loves Helen, but, being a cripple, is afraid to declare himself. Helen has always looked upon George in the light of a brother or dear friend. Addis comes into a large legacy, and gets Jane Felton, the wife, away, and pays to keep her in London so as not to annoy Denzil or the Latimers. He receives a letter informing him of her death, but he has now ventured to speak of love to Helen, and she agrees to marry him, partly out of pity and partly because her father has had an appointment offered him abroad, which he cannot accept unless he can leave his daughters settled. Denzil comes to bid farewell to Helen, for he, too, is going away for ever. George Addis struggles with imself, for he knows Helen still loves Mark. If he divulges the contents of the letter he can unite two lovers at the bitter cost of his own sacrifice. If he keeps it back Denzil will be out of the way, and he is free to marry Helen. The spirit of self-sacrifice prevails, and he nobly gives her up, gaining happiness in his declining years from the thought that he has put a jewel in the crown of the woman he loves. In our short space it is impossible to indicate the charming detail, the truly human pathos, and the beautiful work with which "Sunlight and Shadow" abounds. It is a play which must be seen to be properly appreciated. We would defy the greatest purist to pick out a flaw. It is really true to nature, every line of it. In most plays the last act is occupied by clearing up the former acts, but in this play the last is the strongest of the three. In it the hero and heroine, Mr. George Alexander and Miss Marion Tourn here their heat Mr. and Miss Marion Terry, have their best scenes. Mr. Alexander's study of the character is singularly delicate, at the same time firm. We do not know whether he is greater in the passionate or the pathetic parts. It is impossible to imagine a more sympathetic creation.

Miss Marion Terry—whom we are all glad to welcome back after her long absence from the stage, seems to combine all the sweetness in her acting of her three sisters, Kate, Florence, and Ellen, and gives a most charming rendering of the part of Helen, a character, by-the-bye, very difficult to play, and we can call to mind no one who could touch it so gently and effectually, and so completely win the sympathy of her audience as does Miss Marion Terry. The merry girl, Maud, is exquisitely rendered by Miss Maude Millett. To her falls many of the smartest lines in the play, and she never misses a point. We have before said Miss Millett is the very best exponent we have on the stage at present of the type of the real, pure English girl, full of mischief and fun, but as gentle and loving as a dove. In fitting the pattern of a dress she has to say "Its a dream, its a poem." This accurately describes her acting in a few words. We have heard a whisper that Miss Millett aims at playing pathetic parts. We are selfish enough to hope that no manager will let her, for she will be a decided loss to comedy. Mr. Ben Webster makes an excellent Mr. Bamfield, Mr. Nutcombe Gould as the father is all that can be desired, and Mr. Yorke Stephens thoroughly grasps the character of Mark Denzil. There is one thing, we hope, Mr. Alexander will alter. The cripple has to say that because of his affliction he is the scorn of God and man. A cripple may be the scorn of men, but he is one of God's creatures, and the Great Architect of the Universe scorns nothing he has made. We trust the allusion to the Deity will be expunged.

Telephonic communication between London and Paris will be opened on January 1.

The Lady Mayoress held her final reception at the Mansion House on Tuesday, between the hours of three and five p.m. The attendance was more than usually numerous.

The Prince of Wales will complete his 49th year on Sunday, having been born on the 9th November, 1841. The Royal tradesmen will celebrate the auspicious event on Monday next.

Her Majesty has been graciously pleased to become Patron of the British Archæological and Architectural Society, which was founded in 1840, and has just completed its jubilee.

Bro. Lord Mayor Sir H. A. Isaacs presided for the last time at the meeting of the Common Council on the 30th ult., when a cordial vote of thanks was passed to him for his geniality and kindness in the chair, and gracefully acknowledged by his lordship.

Bro. Sir Somers Vine, of the Imperial Institute, arrived at Zanzibar from the Mauritius on Saturday last, and after an interview with our Consul-General—Col. Euan Smith—was introduced to the Sultan and a number of Arab and European merchants.

Bro. the Earl and Countess of Crawford and Balcarres and Bro. Davenport-Bromley, M.P., were among the guests invited by the Earl and Countess of Sefton to meet H.R.H. the Duke of Clarence and Avondale during his recent visit to Croxteth Park, Liverpool.

What is known as the Lord Mayor's Show will take place on Monday next, and, from all accounts, will be on a scale of unusual magnificence. We can hardly wonder at this, seeing that Bro. Sheriff Augustus Harris has been taking a very active part in the arrangements.

A new African Exploring Expedition will leave England shortly under the command of Bro. Commander Cameron, R.N., for the West Coast of Africa. The expedition is of a private nature, but the Colonial Office has promised to give it friendly assistance through our representatives.

The Grand Commandery of Iowa held its 27th annual Conclave at Templar Park, near Spirit Lake, on Tuesday, the 19th August last. The meeting proved so agreeable that Templar Park has been chosen as the locality of the annual conclave in 1891. Sir Knight J. A. Grant was elected Grand Commander for the ensuing year, and Sir Knight A. Wingate, Grand Recorder.

The annual Grand Conclave of the Knights Templar body in the State of Ohio, U.S.A., was held at Toledo, on the 21st August. There was a large attendance, and it was agreed by a large majority to vote \$5000 towards the Masonic Home in Ohio. Sir Knight W.B. Melish was elected Grand Commander for the ensuing year, while Sir Knight John N. Bell remains at his post of Grand Recorder. Cincinnati was chosen for the annual meeting in September, 1891.

Bro. John N. Macomb, jun., G.M., presided at the annual session of the Grand Council of Royal and Select Masters of New York, held in the Masonic Hall, New York, on the 9th September last. All the Grand Officers were present, and there was also a large attendance of members. The number of active Councils in the State is 25, and the aggregate membership about 3000. Another was sold for £760, and one or two more for £750, while of the seven lots of a 20th part two were sold for £4500 each.

On Saturday last the Prince and Princess of Wales visited Seaham Harbour, inspecting the works, the coal and shipping offices, the Drill Hall of the Seaham Artillery Volunteers, and afterwards lunching in Seaham Hall. The lodge located there presented a loyal address of welcome, which was graciously acknowledged by his Royal Highness. Lastly the Prince inspected the Volunteers, and then, with the guests who had accompanied the Royal party, returned to Wynyard Hall. Their Royal Highnesses concluded their visit to the Marquis and Marchioness of Londonderry on Monday, on which day, in company with the Duke of Clarence and Avondale, they returned to Marlborough

The Prince of Wales, who was accompanied by the Duke of Clarence and Avondale, the Duke of Westminster, Bro. the Earl of Cork, and other gentlemen, opened the City and South London Electric Railway on Tuesday, Bro. Lord Mayor Sir H. A. Isaacs, Sheriff Farmer, and Bro. Sheriff Augustus Harris, with others officially and financially interested in the success of the enterprise, being likewise present. His Royal Highness was received at the King William-street terminus, and having turned on the electric current, the whole party was conveyed by train to the Oval Station, where a brief stoppage was made, and thence to Stockwell, where a large concourse of people had assembled and gave the Prince a hearty welcome. A luncheon followed, at which, after returning thanks for his health, his Royal Highness proposed the toast of "Success to the City and South London Railway." The proceedings terminated shortly afterwards.

The Prince and Princess of Wales, accompanied by the Duke of Clarence and Avondale and Bro. the Duke and Duchess of Fife, visited the St. James's Theatre on Monday evening.

Bro. Lord Mayor Sir H. A. Isaacs presented the prizes won at the recent Exhibition of the Turners' Company in the Egyptian Hall of the Mansion House on Friday, the 31st ult.

On Wednesday, November 12th, Bro. Terry proposes inaugurating a series of Wednesday *matinées* for the purpose of trying several new plays, and reviving some old ones from his *repértoire*.

An expenditure of  $\mathcal{L}_{2000}$  has been sanctioned by the Court of Common Council for the renewal and decoration of the apartments at the Mansion House in view of the new Mayoralty, which begins on Monday next.

The Indian troopship Serapis arrived at Portsmouth on Monday morning, having on board, among other troops, the 17th Lancers, which has been absent from England for 11 years. The regiment will be quartered for a time at Shorncliffe.

The Queen's Staghounds opened the season with the customary meet at Salt Hill, near Slough. The Master of the Buckhounds was present, as well as a large field, the deer being taken at the close of a good run, near Chalfont St. Giles.

Bro. the Marquis of Hartington, M.P., addressed a large political meeting at Edinburgh on the 31st ult., among the principal personages present on the platform being Bros. Sir Charles Dalrymple, Bart., M.P., the Earl of Stair, the Earl of Haddington, and the Earl of Home.

On and after Wendesday, the 5th instant, the doors of Terry's Theatre will open at 7.30 p.m., and the performance commence at 7.45 with an original play, in one act, by Messrs. Goldsworthy and Norman, entitled "My Friend Jarlet," followed at 8.30 by "Sweet Lavender."

The Craft of the Province of Cumberland and Westmorland cannot but be highly gratified to learn that Bro. Geo. J. The Prince of Wales has consented to become a patron of the Newmarket Stablemen's Institute and Free Reading and Recreation Rooms, and has contributed a donation of five guineas to the funds.

Bro. Sheriff Augustus Harris has kindly promised £5 towards Mr. Charrington's great feed, to be given to the very poor in the Great Assembly Hall, Mile End, on Lord Mayor's Day.

The first meeting after the recess of the Council of the Royal Agricultural Society was held in Hanover-square on Wednesday, among those in attendance being Bros. the Earl of Ravensworth (the President), the Earl of Faversham, and others.

The will, with five codicils, has now been proved of the late Earl of Carnarvon, who died on the 28th June last, aged 59 years. The gross value of the personal estate has been sworn at £313,259 os. 9d., and the net value at £242,419 16s. 9d.

The Duchess of Albany and her children visited the Queen at Balmoral on Wednesday and remained to luncheon, and Major-General Sir J. McNeill and Bro. Sir M. E. Hicks-Beach, Bart., M.P., had the honour of dining with the Royal family.

The annual festival of the Hampshire and Isle of Wight Masonic Educational and Benevolent Institution will be held at Southampton on the 8th prox. under the presidency of the Right Hon. Bro. W. W. B. Beach, M.P., Prov. Grand Master.

The 32nd anniversary banquet of Royal Warrant holders, to be held at the Criterion next Monday, under the presidency of Colonel Howard Vincent, M.P., promises to be of exceptional interest. A large number of representative traders, not only from the West-end, but also from the provinces and even foreign countries, have announced their intention of being present.

Business connected with finance and the Charities of the province will be transacted, and, in accordance with the suggestion thrown out by the Provincial Grand Master at the annual meeting at Burnley, that the Charity Committee should select some Charity for a further donation to be given from Provincial Grand Lodge funds, it will be proposed by the Chariman of the Charity Committee, and seconded by the Vice-Chairman, that the sum of 100 guineas be given to the Royal Masonic Institution for Boys, £52 10s. in the name of the Prov. S.G.W., and £52 10s. in that of the Prov. J.G.W. After Provincial Grand Lodge is closed, there will be a Court of Governors of the Systematic Educational and Benevolent Institution of the province, to receive a report of the financial position and general working of the Institution.
