A REVISED CODE OF LAWS FOR THE ROYAL MASONIC INSTITUTION FOR BOYS.

The laws of the Royal Masonic Institution for Boys have recently undergone a complete revision, and the new code, which was submitted by the Board of Management to the Council in April last, will be brought to the notice of the Quarterly Court, which will be held on the 14th July, and a resolution proposed by Bro. LE FEUVRE for its adoption. The earliest laws remain virtually unaltered. That which relates to the Trustees-Law VII .- has been modified, the Sustentation of Building Fund having been merged in the General Fund, and there being, therefore, no longer any necessity for electing Trustees of the latter. We remark also that the Pro Grand Master and Deputy Grand Master are henceforth to be ex-officio Patrons instead of Vice-Presidents-a change to which we see but one objection. The Patronship of the Institution carries with it the right of 80 votes at every election of Boys, while the Grand Master for the time being, in his capacity of President ex-officio, is allowed 20 votes "in consideration of the sum given annually by the Grand Lodge of England." posed change, therefore, the highest personage in the Craft, the distinguished brother who, in the matter of voting, may be said to impersonate the Grand Lodge, will receive only one-fourth the number of votes bestowed on his alter ergo in the person of the Pro Grand Master may be elected by a Quarterly Court," and, we presume, it is intended that under Law XV., "such Grand Patron," holding honorary rank, shall receive the same voting privileges as those who become Patrons by payment. But, though the present Grand Master, H.R.H. the Prince of WALES, is Grand Patron and President, it does not follow that the two offices should be held as a matter of course by one and the same personage. The Grand Master is ex-officio President of the Institution, and in that capacity is entitled to 20 votes at every election of boys, but he is not ex-officio Grand Patron. The law relating to the Presidency is absolute, but that which concerns the Grand Patron is only permissive. There need not be a Grand Patron at all, and if the Quarterly Court has a mind to elect one, it is not a matter of course that it should elect the Grand Master to such office. In former days, when there were neither Vice-Patrons nor Patrons, much less a Grand Patron, the Grand Master being ex-officio President, had his 20 votes in consideration of the annual grant made by Grand Lodge, while his Pro Grand Master-if he were entitled to appoint such an officer-and Deputy Grand Master, as Vice-President, had their 10 votes at each election. Thus the officer of higher rank had the greater privileges, while those of lower rank had the lesser privileges. It will consequently be as well to make some such alteration in the proposed code as will secure to the Craftsman of highest rank the superiority in rights and privileges over all other members of the Grand Lodge. We see no objection to the bestowal of greater rights and privileges on the Pro Grand Master and Deputy Grand Master, provided always that the position of President, who is the chief officer of the Institution, is correspondingly strengthened.

The laws which define the privileges conferred to the different classes of donors, designated respectively Patrons, Vice-Patrons, and Vice-Presidents, are made far clearer, and are much better arranged than in the existing code, while Patrons have higher privileges conferred on further completed payments of 100 guineas each. Thus the existing law gives two votes for tach additional five guineas contributed by Patrons, Vice-Patrons, and Vice-Presidents indiscriminately; but the new law proposes to give to individual donors who have qualified as Patrons 50 votes for "every further completed sum of One Hundred Guineas, in one or more payments of not less than Five Guineas each," the same number of additional votes being assigned to ladies and lewises on payment of 50 guineas, and to lodges, chapters, societies, on the completed payment of 200 guineas. As regards honorary rank, by existing Law X. the Quarterly Court has Power to elect a brother who has rendered special service to the Institution as Honorary Vice-President, and by Law XV, an Honorary Life Governor with, in each case, the rights and privileges pertaining to the rank, while Proposed Law XV. enacts that "a Brother who has rendered special service to the Institution," may be elected "an Honorary Patron, Vice-Patron, Vice-President, or Life Governor," with the privileges pertaining to the respective ranks. We are glad also to see under the head of "Annual Subscribers," all those who contribute 10 guineas within a period of 10 years become, ipso facto, Life Subscribers, at the same time retaining the privilege as under the existing law of two votes instead of one lor every additional guinea subscribed. The greater the encouragement given to brethren of moderate means to subscribe reguarly the more extensive will become the range of support and the better for the Institution.

Taking the laws which affect the exercise of the privilege of voting, existing Law XXIX., which provides that "in all cases a subscribing lodge, chapter, or society shall, at the time of contribution, direct by what officer or member of the body the privilege of voting is to be exercised." Proposed Law XXIX. makes the same provision, but with this addition—that "in default of any direction the Secretary for the time being shall be entitled to We do not quite see why the privilege should be exercised by this particular officer. We would rather it were conferred upon the W.M. for the time being, and we imagine that in the majority of cases where a lodge omits to specify the particular officer or member by whom the vote or votes which are received in exchange for its contribution shall be exercised, it intends that it shall be so exercised by its Worshipful Master, or chief for the time being. As for proposed Law XXXIII., it strikes us as being good policy to have inserted such a provision, the clauses of which are as follows: (1) "A candidate shall be entitled without proxy to have placed to his credit at each election the number of votes to which his parents, if deceased, would by their donations have been entitled to if living;" and (2) " If either parent be a Life-Governor at the date of the reception of the petition, a candidate shall be entitled without proxy to have 10 votes, and, in case both parents be so qualified, 20 votes placed to his credit at each election." Here again we repeat a wise course has been adopted in conferring such votes on candidates; it cannot fail to encourage people to subscribe when they realise that not only will they have the right to exercise certain powers, but also that in the event of misfortune overtaking them, or their dying without having made satisfactory provision for their children, those children, should they become candidates for Institution, will receive appreciable benefit from their parents' support. We are pleased to see that such a clause has been inserted under this head as that which constitutes the second section of proposed Law XXXIV., and which reads thus-"In any case in which it shall be proved to the satisfaction of the Board of Management that the Election of a Boy has been directly or indirectly promoted by the purchase or sale of the votes of the Subscribers, such Election may be declared void by the Board of Management, and the Boy may be expelled from the Institution." We are well aware it is most unlikely that any such case should occur, but it is just as well to be protected by such a provision against any such irregularity. Some years ago a very serious unpleasantness arose in connection with the voting at one of these elections, and the brother who had committed some irregularity in his capacity of scrutineer-was sentenced to deprivation of his rights as a Mason for a period of 18

No material alterations are proposed in the laws relating to Courts. In Law 38, it is proposed to allow "the ten days' notice" required to be given by advertisement for a Special Court to be holden into a "six days' notice," a similar change being made in Law 45, in which the notice of a motion for a new law, or for suspending or abrogating an existing law, must be advertised six instead of 10 days previously. In Law XLII., the number of members constituting a quorum is reduced from 12 to seven. Nor are there alterations of moment in those which affect the Council, or those relating to the Board of Management under proposed new Law L., instead of brethren for election to represent the Provinces being nominated from time to time by the authority of each Provincial Grand Lodge, these nominations must be made as in the case of the London representatives, at the meeting of the Council in March,; while in Law LIII., relating to extraordinary vacancies occurring among the Provincial members, it is provided that the vacancies shall be filled "by the election of a Brother, who shall be nominated on behalf of any Provincial Grand Lodge not represented on the Board," and at the same time, that "at least fourteen days' notice of the Election shall be given to every Provincial Grand Secretary whose Province is not represented on the Board." Under the existing law, each extraordinary Provincial vacancy is filled "by the election of a Brother whose name shall be on the list of Provincial members nominated by the Provincial Grand Lodges," Under the head of "Finance Committee," posed Law LXV. reduces the quorum from five to three, and there is a new clause added to Law LXVI. to the effect that "All payments to be made by cheques, signed by two members of the Finance Committee, countersigned by the Secretaries."

In the laws which deal with the "Qualification and Admission of Boys," it is proposed in Law LXXI. to alter the time at which petitions must be forwarded from "at least two weeks before the meetings of the Council" to "at least three weeks before" such meetings. Existing Law LXXIII. is extended, so that a boy, who already has a brother in the Institution, shall be eligible for admission not only if "the number of vacancies is in excess of the number of candidates," but also "when at least five children other than the

boy in the Institution are dependent." In Law LXXVII., which defines the educational qualifications of the children who are to be admitted, the subjects in which they will be examined according to age are specified, whereas under the existing law certain Government standards are mentioned which an elected boy must pass before admission, the standard being regulated according to age. In Law LXXXI., in addition to the three grounds already mentioned as justifying the Board of Management in ordering the removal of a boy, a fourth is given, namely, " If they are of opinion that the boy's election has been secured by fradulent or other improper means." notice also with pleasure that a new law is proposed to the following effect: "LXXXII.-In any case, when the Board of Management consider that the encouragement of any peculiar talent evinced by a boy would be of advantage to him in after life, they may afford such means of special instruction as to them seems reasonable." Here we have the renewed idea which actuated the promoters of the "Pupils' Assistance Fund," and to carry out which the Centenary Fund of the Masonic Female Orphan School, Dublin, has been established. That is to say, boys will be eligible to receive further educational advantages at the cost of the Institution if the Board of Management consider such further advantages will be of service to them in after life. We commend the proposal, and trust it will be adopted. The limit of age of 15 years beyond which a boy must not be retained in the School is too low, because, as a rule, boys learn more between 15 and 16 years than during any previous period of their Their minds are developing, and they grasp more easily what they are taught; and if the Quarterly Court sees its way to the adoption of the new rule, it will materially benefit the boys whom the Institution has taken under its charge.

Other additions are to be found in the proposed Code of Laws, but they do not appear to us to contain anything of material importance, and do not need that we should refer to them specially. On the whole, and with the one or two exceptions we have noticed, we consider the proposed code is worthy of adoption, and we trust it will be adopted at the July Court, when Bro. LE FEUVRE's motion to that effect is brought forward.

9. REPORT OF THE BOARD OF GENERAL PURPOSES. To the United Grand Lodge of Ancient Free and Accepted Masons of England.

The Board have to report that they have had before them a complaint by the Board of Benevolence against the St. Leonard's Lodge, No. 1766, for supporting a petition by a recommendation purporting to be signed by the Worshipful Master, Wardens, and a majority of the members present; but which was signed by very considerably less than a majority, and by some brethren who were not members of the lodge or present on the occasion.

The Board, considering such a breach of the law highly reprehensible as tending to mislead the Board of Benevolence, severely reprimanded the Worshipful Master, Wardens, and the other members who had signed the recommendation, and warned them to be more cautious in future.

They have further to report that from the returns made by the Fidelity Lodge. No. 430, Ashton-under-Lyne, it appeared that two brethren who had been initiated on the 20th January, 1892, had been passed on the 15th February following, two days short of the interval of 28 days required by Article 195 of the Constitutions.

The Board ordered that the brethren thus irregularly advanced be re-obligated in the Second and Third Degrees before a certificate can be granted, and that the lodge be cautioned to observe strictly the law in future.

It having come to the knowledge of the Board that the members of the St. Ambrose Lodge, No. 1891, had appeared in Masonic clothing at a banquet of their lodge where ladies and non-Masons were present, without previously obtaining a dispensation, and had moreover in such presence given the usual toasts in Masonic form, the Worshipful Master, Wardens, and brethren were summoned to attend the Board and produce the warrant and books of the lodge.

The Worshipful Master having admitted the facts, and promised that the offence should not be repeated, the Board, although considering that such proceedings were not only contrary to the written law, but also a serious breach of No. 4 of the Ancient Charges, after some discussion resolved on a more lenient penalty than the case seemed to deserve, they, therefore, severely reprimanded the lodge and warned them to be more cautious in future.

Although no similar case has been brought under the formal notice of the

Board, they regret to say that one of the officers of the St. Ambrose Lodge alleged n justification of their proceedings that the custom obtained in other lodges.

They have, therefore, entered on their minutes a recommendation to their successors to treat any such cases as may be brought before them in future with greater severity.

The Board have also adjudicated upon the following complaints:

By a member of the Ivy Lodge, No. 1441, against the Worshipful Master for permitting the lodge to vote, at a lodge of emergency, a jewel to the late Worshipful Master without notice having been expressed in the summons, contrary to Article 166 of the Book of Constitutions, and for having, notwithstanding his protest, put for confirmation the minute of this irregular vote at the next regular

It also appeared on examination of the minutes that a candidate for initiation was proposed and seconded at this same lodge of emergency, contrary to Article 184, and that he was balloted for, elected, and initiated at the next regular meeting.

The Board ordered that the brother thus irregularly initiated should be reobligated at the next regular meeting, or at a lodge of emergency called for that purpose under the provisions of Article 185.

For these irregularities the Worshipful Master was admonished to be more careful in the discharge of his Masonic duties for the future.

Against the William Shurmur Lodge, No. 2374, Chingford, for having on the 19th May, 1892, in violation of Article 189, elected 17 joining members, none of whom had been previously proposed and seconded at a regular lodge.

The Board ordered that these brethren should be proposed and seconded at the next regular lodge, and balloted for at the regular lodge following.

For this breach of the law the lodge was fined £3 3s., severely reprimanded, and cautioned to be more careful of the strict observance of the laws in future.

A Sub-Committee appointed by the Board in June last year to inquire into the work of the Grand Secretary's office have held numerous meetings during the year, and have been cordially assisted in their inquiries by the Grand Secretary and his staff. They have made many valuable suggestions which the Board have approved and ordered to be adopted.

Arising out of their report the Board have to offer the following recommendations for adoption by Grand Lodge:

- 1. That all appointments in the Grand Secretary's office should in future be by recommendation of the Grand Secretary to the Board of General Purposes, and subject to their approval, and that promotion should not necessarily go by seniority, but on the occasion of a vacancy the appointment should be made by fitness for the particular office vacated.
- 2. That the banking account hitherto kept at the Western Branch of the Bank of England in Burlington-gardens be transferred to the Law Courts Branch, Temple Bar.
- 3. That the Grand Secretary shall have a clerk capable of taking down letters and other matters in shorthand, and that Bro. A. H. Lee (son of Bro. Lee, one of the clerks in the office), who has served some months on probation, be permanently engaged as such clerk at a salary of £120 per annum, dating from Christmas, 1892.
- 4. That Bro. James Hodgins, who was engaged as a temporary clerk in 1887 at two guineas a week, be now placed on the staff, and that his salary be £150 per annum, dating from Christmas, 1892.
- 5. The work of the Grand Secretary's office having materially increased, it is recommended that an additional clerk be engaged at a salary of £100 per annum.

The Board have ordered that in future the report of each Quarterly Communication of Grand Lodge be sent out as nearly as possible within 14 days after the meeting,

The Board recommend that the following alterations be made in the Book of Constitutions, consequent on resolutions of Grand Lodge passed December, 1892, and confirmed March, 1893:

Rule 6.—Below the words "Past Grand Registrar" (16) insert words "Deputy Grand Registrar," and below "Deputy Grand Registrar" the words "Past Deputy Grand Registrars." Below words "Past Grand Sword Bearers" (32) insert words "Deputy Grand Sword Bearer," and below that "Past Deputy Grand Sword Sword

Rule 18.—Below the words "Grand Registrar" insert words "Deputy Grand Registrar," and substitute for the words "Four Grand Deacons" the words "Six Grand Deacons." Before the words "Assistant Grand Director of Ceremonies insert the word "Three," and add "s" to word "Director." Below word "Grand Sword Bearer" insert "Deputy Grand Sword Bearer." Below words

Rule 88.—That the following words be added:

That in Provinces and Districts numbering 40 lodges and upwards the Provincial or District Grand Masters shall be empowered to appoint annually "four Provincial or District Grand Deacons," a "Provincial or District Deputy Grand Director of Ceremonies," and "three Provincial or District Assistant Grand Directors of Ceremonies.

Assistant Grand Directors of Ceremonies.

In Provinces and Districts numbering 70 lodges and upwards the Provincial or District Grand Masters shall be empowered to appoint annually "six Provincial or District Grand Deacons," a "Provincial or District Deputy Grand Director of Ceremonies," and "three Provincial or District Assistant Grand Director of Ceremonies."

In Provinces and Districts numbering 100 lodges and upwards the Provincial or District Grand Masters shall be empowered to appoint a "Provincial or District Deputy Grand Registrar," to take rank immediately after the Provincial or District Grand Registrar, "six Provincial or District Grand Deacons," a "Provincial or District Deputy Grand Director of Ceremonies," three Provincial or District Assistant Grand Directors of Ceremonies," and a "Provincial or District Deputy Grand Sword Bearer." and a "Provincial or District Deputy Grand Sword Bearer."

Rule 311.—Below the words "Grand Registrar, £10 10s.," to insert the words "Deputy Grand Registrar, £10 10s.," and below the words "Grand Sword Bearer, £5 5s.," insert "Deputy Grand Sword Bearer, £5 5s.," and below the words "Grand Secretary, £10 10s.," insert "President of the Board of Benevo. lence, £10 10s.''

At page 137.—Below the words "Past Grand Standard Bearers," insert "Past Deputy Grand Sword Bearers," and below these words "Deputy Grand Swords Bearer," and below the words "President of the Board of General Purposes insert "Past Deputy Grand Registrars," and below these words "Deputy Grand Registrar.

The Board also submit a statement of the Grand Lodge accounts at the last meeting of the Finance Committee, held on Friday, the 12th day of May inst., showing a balance in the Bank of England (Western Branch) of £8629 os. 11d., and balance of annual allowance for library £40 45. 2d., and in the hands of the Grand Secretary for petty cash £100, and for servants' wages £100.

10. REPORT OF THE COLONIAL BOARD.

To the United Grand Lodge of Free and Accepted Masons of England.

The Colonial Board have to report re "The Cambrian Lodge," No. 956, Sidney, New South Wales:

1. In the early part of 1888 a general movement took place in New South Wales, having for its object the union of the various lodges and constitutions in the Colony under the jurisdiction of the newly-formed Grand Lodge of New South Wales.

At this period there were 80 lodges under the English Constitution, of which "The Cambrian" was one.

2. This lodge had made its last return to Grand Lodge for the year 1885, showing a list of 60 members, and since that time 16 initiations had raised the number to 76.

3. In June, 1888, a meeting, privately convened and attended by 23 members, was held to consider whether the brethren would join the newly-formed local Grand Lodge. On taking the vote, 10 were found on each side, three refrained from voting, and the Chairman gave a casting vote in favour of the proposal.

Subsequently other members gave their adherence, including some of those who had at first dissented.

4. At the September meeting of the lodge the Immediate Past Master from the chair stated to the brethren that he and the Wardens had, while still in office, sent the lodge warrant in to the Grand Lodge of New South Wales, in whose possession it then was.

Some of the brethren present verbally protested against this act, and subsequently the dissentients held a meeting, in consequence of which they applied to the Grand Secretary of the local Grand Lodge for a return of the warrant. This was demanded in writing signed by eight brethren.

5. Eighteen brethren signed a declaration that they were desirous of remaining under the Grand Lodge of England. The local Grand Secretary replied he held the warrant for the Grand Lodge of New South Wales, and the request was not complied with.

6. Meantime the movement in favour of the new Grand Lodge had progressed, and become, as Lord Carrington, the District Grand Master, reported to the Grand Master, practically unanimous, and a request for its recognition by the Grand Lodge of England was forwarded to the Grand Master.

7. At the Quarterly Communication held 5th December, 1888, the request was submitted to Grand Lodge, with a strong recommendation from the Grand Master in its favour, and Grand Lodge resolved to recognise the Grand Lodge of New South Wales.

The Grand Master reserved the right to continue any existing lodges in the Colony which did not join the movement, and stipulated that they should be deemed regular lodges notwithstanding the formation of the new body.

8. The Grand Master of New South Wales also requested that the old lodge warrants might be retained by the lodges, and this request was acceded to, on condition that they were marked in the margin to the effect they were no longer in force under the Grand Lodge of England, and that the jurisdiction was henceforth transferred to the Grand Lodge of New South Wales. Authority was sent out to the Grand Master, Lord Carrington, to cause this to be done, and acting thereon he caused a notification complying with the condition to be stamped on the margin of all the warrants. The warrant of the Cambrian Lodge was ultimately handed to the new lodge under his jurisdiction, which took the same name, "The Cambrian Lodge." A similar course appears to have been adopted with the warrants of all the other lodges which joined the new body.

9. Before, however, the matters referred to in the last paragraph had happened the dissentient members had written to the late Grand Secretary, Col. Shadwell H. Clerke, a letter dated the 8th November, 1888, but which arrived after the recognition of the new Grand Lodge by the Grand Lodge of England, stating that the warrant had been handed over, and that they desired to remain under English jurisdiction. They also asked for a duplicate warrant, and prayed advice and assistance to secure their rights.

By enclosures in that letter it appeared there were at that time 63 members, 26 for and 20 against the proposed union, and the rest not declared. The contention was raised that being three or more in number the non-assenting brethren were absolutely entitled to retain the warrant under Article 219.

10. The Grand Secretary replied on 27th March, 1889, that a duplicate warrant could not be granted—that the transfer of the lodge was in accordance with the wishes of a very considerable majority of the members, only 20 not agreeing, and that in the opinion of the Grand Registrar, Article 219 of the Book of Constitutions did not apply to such a case.

11. In October, 1889, five of the dissentient members protested against the ruling of the Grand Registrar, and the Colonial Board, having considered the protest on 9th January, 1890, upheld the ruling as correct, and this was in due course communicated to those who protested.

Various letters were subsequently received from these brethren who protested against the decision of the Colonial Board and complained of the taking and detention of the warrant, and at length a letter of 22nd April, 1891, was received by the late Grand Secretary, signed by Bro. George Robinson, describing himself as Worshipful Master of the Cambrian Lodge, but whose name was not registered in the books of the Grand Lodge of England, and asking if "our appeals from the Grand Registrar's decision and that of the Colonial Board had been heard by Grand Lodge."

- 12. This was followed by several further letters in which it was stated that legal proceedings would be taken in the Colony to recover the warrant and property of the lodge, and it is not known if such steps were adopted, but the warrant still remains in the hands of the new lodge with the cancelling mark above stated.
- 13. In January, 1892, the Board, not being acquainted with the facts as to what had been done with the warrant, and the previous correspondence not being before it, owing to the lamented decease of Col. Shadwell H. Clerke, resolved to recommend the grant of a warrant of confirmation in the event of the original not being returned.
- 14. This resolution was communicated to the applicants, but before the recommendation could be acted upon the full facts above set forth were disclosed, and the Board thereupon rescinded its former resolution, and resolved to take no step in the matter.

15. The Board adheres to the view it took of the scope of Article 219 of the Book of Constitutions, when the ruling of the Grand Registrar was protested against, and is of opinion that its provisions are not intended to deal with cases where the lodge contemplates joining a new Masonic allegiance.

16. It appears to the Board that the warrant was properly cancelled under the direct authority emanating from the M.W. the Grand Master, given at the time of the recognition of the Grand Lodge of New South Wales, and that as it is impossible for the Grand Master to issue a new warrant, no action should be taken.

17. No proper appeal was ever preferred to Grand Lodge as pointed out by the Book of Constitutions, Article 217. It is an entire misuse of terms to style the letters of November, 1888, and October, 1889, "Appeals."

18. The lodge has neglected to make any return or payments since 1885, and has never attempted to comply with the law in this respect until 23rd February, 1892, when a return was signed comprehending 21 names, four not registered in the books of Grand Lodge, and one of a brother since deceased.

That the sum of £70 be given from the Fund of General Purposes; that the money be placed in the hands of the Secretary of the Royal Masonic Benevolent Institution for Aged Freemasons and Widows of Freemasons, to supply the inmates of the Institution at Croydon with coals during the winter season.

13. NOTICE OF MOTION-By V.W. Bro. RICHARD EVE, P.G. Treas.:

That this Grand Lodge declares that the conclusion of the Colonial Board, viz., that Article 219 did not apply to the case of the Cambrian Lodge, No. 656, of Australia, is totally opposed to the uniform practice of Grand Lodge since 1779, and that the correct construction of the law is that laid down by the V.W. Grand Registrar, Bro. Philbrick, and the V.W. the President of the Board of General Purposes, Bro. Fenn, on the 3rd June, 1885, by the late M.W. Pro Giand Master, Lord Carnarvon, on the 5th December, 1888, and by the R.W. Bro. W. W. B. Beach, and by the V.W. Grand Registrar, and the V.W. President of the Board of General Purposes on the 2nd December, 1891, and adopted by Grand Lodge on those dates.

And that the alleged cancellation of the warrant was in direct contravention of the terms on which Grand Lodge granted recognition to the United Grand Lodge of New South Wales.

And that these brethren who adhere to their allegiance to this Grand Lodge are therefore entitled to recognition as the lodge.

14. Appeal—By Bro. Makinson Sanders, late of Lodge No. 1025, Star of the South, Buenos Ayres:

Against a sentence of suspension for six months from all Masonic privileges passed on him by the District Grand Master for writing an un-Masonic letter to a brother of the lodge.

And also an appeal by Bro. M. Sanders against a decision of the District Grand Master in refusing to order Lodge No. 1025 to furnish the appellant with a certificate in accordance with Art. 213 Book of Constitutions.

The Worshipful Master said, in response, if there was a Degree in Preemasonry that he was fond of more than another it was the Mark. He had endeavoured in his short Masonic career of 18 years to find what there was in the various Degrees, and he must say that among the various Degrees the Mark, if properly carried out, was the most interesting. With

regard to his name, he stood there a very humble representative of a glorious name, which floated 1130 years ago in the county of Herts, when Edward the Confessor gave the name of his (Bro. Graveley's) predecessor's name to a borough in that county. He did hope that his officers would endeavour to do their duty. He would not like to see that lodge which bore his name starve for want of new blood and new energy. While he was in the chair he should endeavour to do what he could to work out the ritual in the proper way. He wished to be a severe Master to them all; but, at the same time, he wanted to be a loving Master. No man was a good Master unless he knew how to control the brethren. If he could not control them the sooner he resigned the chair the better. He wanted to love them all, and to be loved in return. He wished to say that he thanked various brethren for presents they had made to the lodge. Bro. Shurmur had presented the whole of the books, and Bro. Holland had presented the pedestals and wicket and other things. At the next meeting he should propose a vote of thanks to be recorded on the minutes to these brethren. He now proposed "The Health of the Consecrating Officers," thanking them for their

Bro. Matier, G.S., in reply said the thanks were not proposed to himself in propria persona alone, but simply as the occupant of the office of Consecrating Officer. It had given him great pleasure to consecrate that lodge, because it bore the honoured name of one who for many years had been one of his most strenuous supporters in Freemasonry and of the Mark Degree, one who had made his mark in the Charities, and in the Mark Benevolent Fund in particular. Secondly, he was glad to do anything for Lord Henniker. He was most happy to be called upon to perform the ceremony, and he had done it to the best of his ability. But how could he have done it as he had done if he had not been so ably assisted by other distinguished brethren. He thanked the brethren for their kind appreciation of his efforts, and he wished the lodge every success and prosperity for years and years to come.

Masonic Motes.

The Quarterly Communication of Grand Lodge will be held on Wednesday next, the 7th instant, when a very formidable agenda will be brought under the notice of the brethren. There will, as usual, be the election of members of the Board of General Purposes and of the Colonial Board; of Grand Lodge Auditor and of brethren to serve on the Committee of Management of the Royal Masonic Benevolent Institution. For the first of these elections-that for the Board of General Purposes-the contest will no doubt be exciting, as there is quite a regiment of W.M.'s and P.M.'s, but especially of the latter, who have been nominated to serve.

As for the reports which will be submitted, that of the Board of Benevolence calls for no remark, but we notice with regret that that of the Board of General Purposes specifies several cases of grave irregularity which had been brought under its notice and dealt with according to their several degrees of demerit. In one of these cases the members of a lodge had appeared in Masonic clothing at one of its banquets when ladies and non-Masons were present, without having previously obtained the necessary dispensation, and, moreover, they had given the usual toasts in Masonic form in the presence of these ladies and non-Masons. For such conduct the lodge was treated with greater leniency than it deserved, and severely reprimanded, and admonished to be more careful in future.

In another case 17 joining members were elected at one of the meetings of a certain lodge, without having been previously proposed and seconded at a regular lodge. For the offence the lodge was fined £3 3s., severely reprimanded, and cautioned to be more careful in future. But can we be surprised that the privileges of Freemasonry are abused when such irregularities as those we have specified are committed. We believe that one of these offending lodges prides itself on its a subject of congratulation, and it were better if it were in a position to pride itself on a strict observance of the laws of Freemasonry. Unfortunately, it seems to have forgotten all about the law in its eagerness to be a numerous lodge.

The report of the Colonial Board is occupied entirely with the case of the Cambrian Lodge, No. 656, Sydney, New South Wales, a considerable minority of which, numbering 20 brethren, declined to throw in their lot with the newly-organised United Grand Lodge of New

the report and therefore we shall content ourselves with stating that the case is governed by Article 219 of the Constitutions, and that notwithstanding the decision which Grand Lodge arrived at on the recommendation of the Grand Registrar, in December, 1891. in the case of certain New Zealand lodges the Board recommends that a duplicate warrant as prayed for by the Cambrians be not issued, it being the Board's opinion that the provisions of the said Article 219 " are not intended to deal with cases where the lodges contemplates joining a new Masonic allegiance."

> * *

Our opinions on the question are so well known that we shall not reiterate them here. It is enough for us to point out that the provisions of Article 219 are laid down absolutely, without the slightest qualification of any kind; that the minority stated in the said Article as being entitled to retain and work under a warrant in the event of a majority of the members resolving to resign the lodge is exceeded in this case of the Cambrian Lodge, No. 656; and that the United Grand Lodge of New South Wales was recognised by our Grand Lodge on the usual condition that the rights of English lodges to remain in allegiance are to be respected. There may be circumstances in this particular case of which we are not fully cognizant, but on the face of it the Colonial Board appears to have made a hash of the business, and in order to extricate itself from the dilemma in which it is placed, proposes that a grave injustice shall be done to certain English Masons who desire to remain in allegiance to our Grand Lodge.

However, Bro. Richard Eve, Past G. Treas., has given notice of a motion to the effect that these Cambrian brethren who adhere to their allegiance to our Grand Lodge are entitled to recognition as the lodge and he rests his motion on the ground that the determination of the Colonial Board-as to Article 219 not applying to the case of this Cambrian Lodge-is totally opposed to the uniform practice of Grand Lodge since 1779, "and that the correct construction of the law was laid down by the Grand Registrar and the President of the Board of General Purposes in June, 1885, by the late Lord Carnarvon, Pro G.M., in December, 1888; and by Bro. W. W. B. Beach, the Grand Registrar, and the President of the Board of General Purposes in December, 1891." We shall be curious to know what answer will be forthcoming from the Colonial Board to the contention of Bro. Eve.

Of the 13 warrants granted by his Royal Highness the M.W.G. Master since the March Communication for the constitution of new lodges, three are for lodges in the London district, four for lodges in the Provinces of Surrey, Staffordshire, Hampshire, and Essex, and six for lodges abroad, namely, for one in Western Australia, one in Bengal, three in the South African Republic, and one in Mashonaland, South Africa.

Hugh OWEN, as the father of Masonry in Bristol, congratulated the P.G.M., not only upon the position in which the Prince had worthily placed him, but also upon attaining his jubilee. In a very graceful speech, he said they were very young together, but as he was a few years the elder he entered Masonry first; in fact he had been 53 years a Mason. He well remembered the meeting at which their P.G.M. was a candidate, introduced by his honoured father, than whom a more worthy brother never entered a Masonic lodge. His son had held the highest offices in the province, and won the confidence of the highest, the noblest, the humblest, and the simplest of brethren.

Bro. JOHN NORTHAM, the newly-installed W.M. of No. 2257, conveyed the congratulations of the lodge which was permitted to bear the honoured name of Powell, and

Bro. W. E. Vowles, P.P.J.G.W., as a Bristol Mason of 35 years standing, added his felicitations.

The Prov. Grand Master, who was received with enthusiastic applause, rose to reply, and said he could not adequately express his thanks for the honour done him by his mother lodge. So long as he lived the beautiful address they had presented to him would be among his most precious Masonic treasures. Bro. Owen had referred to 50 years ago, and very few could expect to see the 50th anniversary of their initiation. But to be a subscribing member to a lodge for 50 years, to have become its W.M., to have held various offices, and at the end of the time to be Grand Master of the province was, he believed, absolutely unique. He could say he had never sought any office, but he could claim one merit for himself, a good feeling for the Craft, a desire to uphold it, to maintain its character, and to do all in his power to help a brother Mason. He was unable now to be as active as he had been in years gone by. In fact had he known the illnesses he should have to undergo he would not have accepted his present position. In conclusion, he wished the W.M. and brethren of every lodge in the province that prosperity, goodwill, and harmony, which Masons ought to possess and had done in a peculiar degree in the Province of Bristol during the whole time he had known it.

THE LATE W. BRO. H. J. WHYMPER, C.I.E., DEPUTY DISTRICT GRAND MASTER OF THE PUNJAB.

We have a melancholy pleasure in giving prominence to this the first communication from India, other than by cable, respecting the decease of the lamented Bro. Whymper. Bro. Capt. Leslie is the W.M. of the Stewart Lodge, and was a close Masonic friend of the Deputy District Grand Master now, alas! no more.

It will be with feelings of the deepest sorrow and regret that the death of W. Bro. H. J. Whymper is heard of, not only in his own district and lodge, but over the whole Masonic world, for it is not too much to say that his collection of works on Freemasonry, and his vast knowledge of its literature, are known to all true lovers of the Masonic art.

He had gone to Bombay to see an old friend off to England, and it was there that he was taken ill. On the 19th April he was admitted to the European General Hospital, where he rapidly sank, and died on the 27th, of dysentery and fever.

He was initiated in Mayo Lodge, No. 1413, at Rawal Pindi, on December the 17th, 1872, took the R.A. Degree in the Rose of Denmark Chapter, No. 975, and in due course became a member of the 32°, a Knight Templar, and a Knight of Malta. He was a member of the Inner Circle of the Quatuor Coronati Lodge, No. 2076, and at the time of his death was Deputy District Grand Master of the Punjab.

To his Lodge-Stewart, No. 1960-of which he was a founder, his loss is irreparable, and in the District of the Punjab he will leave a gap which it will not be possible to fill. Well versed in all branches of Masonic literature, a staunch and generous supporter of all the Masonic and social undertakings of his lodge, ever ready to help and advise, to assist and instruct; his genial face will be missed, his kindly words and actions ever remembered by all Freemasons in the Punjab, but by none more than his sorrowing brethren of the Stewart Lodge.
