THE APPROACHING FESTIVAL OF THE ROYAL MASONIC BENEVOLENT INSTITUTION.

We are now within three weeks of the day appointed for the first of the three great Anniversary Festivals of the year-that of the Royal Masonic Benevolent Institution-which will be held at Freemasons' Tavern on Wednesday, the 22nd inst., under the presidency of Bro. the Right Hon. Lord LLANGATTOCK, Prov. Grand Master of South Wales (E D.), and it strikes us as being desirable to take another look round, with a view to forming some idea of the prospects in store for the Institution on this eventful occasion. Of the requirements of this important Charity there can be, as we have said in former articles, no question whatever. There are 202 male annuitants at £40 each, for which it is necessary to provide the sum of £8080, and 245 widow annuitants at £32 each, who absorb amongst them a further £7840, together with some 28 widow half-annuitants at £20 each, amongstywhom is disbursed £560, the total expended in annuities being only a few pounds short of £16,500. To this must be added some £3000 for expenses of management and maintenance of the Asylum at Croydon, the whole of the expenditure for which provision must be made being, in round figures, £19,500. Towards defraying this large outlay, there are, firstly, the dividends on invested capital, amounting to between £4000 and £4500, and the annual grants by Grand Lodge and Supreme Grand Chapter which together furnish £1750, the total permanent income on which the Institution relies to meet its obligations being from £6000 to £6500, or about one third part of its This leaves a deficit of fully £13,000 towards annual outlay. the obtaining of which we depend almost wholly on the amount of Donations and Subscriptions raised by the Festival Stewards. But this by no means represents the full measure of what is needed on this particular occasion. Last year, as we have pointed out in previous issues, the Festival receipts were not greatly in excess of £9700 or about one half of the total sum required for the year, and had it not been that the sum of £2000 voted in 1897 by Grand Lodge as a special grant in commemoration of the Queen's Diamond Jubilee was paid over to the Institution last year, the income would have fallen short of the expenditure by upwards of £4000. There is, therefore, a diminution of about £2500 to be made good in respect of 1898 in addition to the £13,000 and upwards which is required for the service of the current year.

In other words, in order to restore the average as far as possible to what has been necessarily raised for some years past, the amount that should be subscribed on the 22nd instant, should approximate very closely to £16,000. Whether or no it will be possible for the Stewards to accomplish this is the question which is now exercising the minds of the brethren, and we are glad to say that, as far as the number of those who have volunteered their help is concerned, the outlook is by no means unfavourable. On Tuesday, the 31st ult., the Board which has undertaken to support Lord LLANGATIOCK as Chairman numbered between 330 and 340 ladies and brethren, and there is every likelihood that between now and the appointed day this number will be still further enlarged; and if the Board, when completed, is not quite equal in point of strength to that of 1897, when H.R.H. the Duke of CONNAUGHT occupied the chair, there is reason to hope that it will not fall very far short of the number that gave their services on that occasion. At all events, in this particular respect, the outlook, as we have said, is not unpromising, and if anything like the list average then obtained is repeated at the approaching Festival, the Chairman, the Stewards, and Bro. TERRY will have good reason to be satisfied with the work they will have accomplished.

We appeal, therefore, most carnestly to those lodges and brethren who are as yet unrepresented to lose no time in tendering their services on behalf of our "Old People." Let them bear in mind, in addition to the particulars we have been at the pains of bringing to their notice, that for the annual election in May next there are at the present time as many as 126 candidates, of whom 56 are for the Male Fund and 70 for the Widows' Fund, and that up to the present time there are vacancies on the establishment for only 12 men and 12 widows. To these must be added the three deferred annuities on each Fund, for which a corresponding number of those on the lists will be returned. Thus, as matters now stand, provision is only possible for 30-15 on each Fund, out of the 126 who have been adjudged worthy to receive the benefits dispensed by the Institution. No doubt other annuities will fall vacant between now and the third Friday in May, when the election takes place, but under the most favourable circumstances we cannot hope to see more than about one-third elected, while the remaining twothirds, that is to say, between 80 and 90 old men and widows, will be left to endure all the privations which a state of indigence entails for at least another year. Under these circumstances, we trust that heed will be given to our appeal.

ARS QUATUOR CORONATORUM.*

With this Part III. the 11th Volume of these Transactions is completed, and we have no hesitation in saying that the whole for no one of the most interesting volumes of the series, while the Part itself, to which we are about to direct attention, is not the least instructive of the three. The meetings, whose Transactions are herein recorded, were those of the 7th October, when the W.M., Treasurer, and Tyler for the ensuing year were elected, and the 8th November, when the new Master—Bro. C. PURDON CLARKE—was installed in office, and appointed and invested his officers. The proceedings at the former meeting

include the last of the series of "Hidden Mysteries," contributed by Bro. S. T. KLEIN, now I.P.M., which constituted so important a feature of that brother's Mastership, and which, as they were such admirable essays in themselves, and so entirely outside the class of contributions which are ordinarily made to the Transactions of our great literary lodge, have made his term of office especially memorable. But, in addition to this fifth and last of Bro. KLEIN'S papers, there was presented by Bro. W. H. RYLANDS certain "Notes on Sussex Masonry." These Notes, the author tells us, are the result of two visits he made to Lavant in 1.95 and 1896, supplemented by particulars derived, by permission, from the paper read by Bro. C. DAWSON before the Sussex Archæological Society at its annual meeting in August, 1894, on certain ancient relics found in the caves of Lavant. Particulars are given of the relics found in these caves, but especially of one which was included among a number exhibited by Bro. C. BAMFYLDE WARR at the meeting of the lodge on the 3rd May, 1895, which was found about a yard beneath the débris in the caves. This relic, of which an illustration is given, is described as a "curious copper badge (thought by some to be Masonic or belonging to some trade guild)," and as "rudely executed," "about the thickness of a sixpence and threequarters of an ounce in weight," and as having its edges rubbed smooth. "Down the centre is what appears to be a plumb line reaching to the hole cut in the lower bar." After certain speculations as to the value of this badge as a Masonic relic, Bro. RYLANDS points out that these Lavant caves are situated only a short distance from St. Rook's Hill, where, in some of our earliest lodge lists, a lodge is located, which is said to have met once a year, and to have been constituted in the reign of Julius Cæsar. What follows is unusually interesting, and will be read with pleasure by all who delight in tracing the history of our earliest lodges and the mysteries connected with them. There is also much relating to the Duke of RICHMOND, who was one of the earliest of the chiefs of our Grand Lodge, and to whom we are indebted for the establishment of what is now known as the Fund of Benevolence. The discussion which followed the reading of the Paper was brief but, as might well be imagined, laudatory in the highest degree of Bro. RYLANDS'S successful effort in elucidating the early history of Masonry in Sussex. The feature of the November meeting was the address delivered by Bro. PURDON CLARKE after his installation in the chair of the lodge.

But these by no means exhaust the treasures of this third part of last year's Volume of Transactions. Reviews is one of Bro. HENRY SADLER'S "Masonic Reprints and Historical Revelations." This review is from the pen of Bro. R. F. GOULD, who is not sparing in his praise of the author, but, as might have been expected, gives his chief attention to the Introductory Chapter, in which Bro. CRAWLEY describes the latest of his valuable discoveries on the subject of Irish Free-

There is also a reprint, with comments by Bro. W. J. HUGHAN, of the "John T. Thorp MS.," of the old Constitutions of Masonry, which is certainly very far from being the least valuable of the contents of this part.

The task of editing this part has been fulfilled by Bro. SPETH with his wonted ability, the whole being rendered complete by the necessary index, and an excellent portrait of Bro. SYDNEY T. KLEIN, the W.M. in 1898, which will serve as the frontispiece to Volume XI.

Accompanying this Part III. is the usual "St. John's Card," 27th December, 1898, in which the Worshipful Master conveys his greetings to the two Circles, and to which is appended a complete list of the members of the lodge, as well as of the brethren and lodges that are comprised in the "Correspondence Circle." The Frontispiece is the portrait, from an engraving in Freemasons' Hall, of an unknown brother, which is thus published in the hope that some one may be able to throw light on his name or history. There is also a chart showing the distribution of the Correspondence Circle over the world at the close of last year. A glance at this will suffice to show that the bulk of the members are to be found in the British Empire and the United States, with, however, a fair sprinkling in the north of Europe.

After Grand Chapter had been opened in ancient and solemn form, and the minutes of the Quarterly Convocation of November, 1898, had been read and confirmed,

Earl Amherst said he had to acquaint Grand Chapter that the Most Excellent First Grand Principal had been pleased to appoint him as Pro Grand First Principal, and the Right Hon. the Earl of Warwick as Second Grand Principal.

The report of the Committee of General Purposes, as published in the Freemason last week, was, on the motion of Comp. Sir Geo. D. HARRIS, seconded by Comp. F. RICHARDSON, taken as read, and ordered to be received and entered on the minutes.

THE EARL OF LATHOM, PRO G.M.

The will bears date December 28th, 1897, with a codicil of the same date, and a codicil of the 31st October, 1898, of Edward, first Earl of Lathom, who died on the 19th November last, in his 61st year, leaving personal estate valued at £127,882 4s. 2d., and the gross value of the whole of whose estate is assessed at £147,527 3s. 4d. Lord Lathom bequeathed to devolve as heirlooms with Lathom House, under the settlement of Dec. 14th, 1885, all the paintings in oils at Lathom House, two paintings in his two houses bequeathed by the Earl of Claren. don, the gold watch and chain of William IV., the Queen's shawl and the small brooch given to Lady Lathom by the Queen, the gold snuff boxes presented to him by the Emperor of Austria, the King of the Belgians, and the Shah of Persia, the diamond ornament made from presentation snuff boxes, the aqua marine brooch given to his grandmother, Lady Skelmersdale, by Lord Liverpool, the presentation made to his grandfather by electors of Newcastle-on-Tyne, the gold snuff box given to Sir Thomas Bootle by Frederick Prince of Wales, the goblet and tankards given to Lord Lathom by the Freemasons of Lancashire, and many other articles. The testator bequeathed the remainder of his goods and silver plate, his furniture, and indoor and outdoor effects to his eldest son, and he appointed the balance of £15,000 of a sum of which he had power of appointment to his sons Villiers Richard and Randle Arthur Bootle Wilbraham and his daughters the Ladies Alice Maud, Bertha Maud, and Edith Cecil Bootle Wilbraham, and he bequeathed to his said two sons such sums as will make up their portions to £20,000 each, and the portions of his three unmarried daughters are to be made up to £7000 each, and they are to receive whilst unmarried £400 a year each, and the last remaining unmarried £800. A freehold or leasehold house is also to be bought, or a house to be taken on lease, for Lord Lathom's house is also to be bought, or a house to be taken on lease, for Lord Lathom's unmarried daughters, who are to have certain plate, furniture, and wine. Lord Lathom bequeathed to his daughter Lady Florence Mary Cecil £1000, and upon trusts for her £5000; and he bequeathed to the Earl of Derby and the Earl of Clarendon, executors of his will, £100 each; to his sisters the Hon. Jessy Caroline Bateman and the Hon. Rose Bootle Wilbraham £100 each; to his estate agent at Lathom, Mr. George Roper, £500; to his solicitors, William Melmoth Walters and Richard Mountford Wood, £100 each; to James Heald, clerk in the estate office, £50; Benjamin Ashton, head gardener, Henry Mansell, head coachman, Robert Hartland, Henry Franklin, and Zella Wright, £50 each; to Kate Johnson £20; to other servants of three years' service one year's wages; and to his children's governess, Elizabeth Hans, a life annuity of £50. Under power of settlements of 1st January, 1859, and 16th August, 1850, Lord Lathom appointed a sum of £20,000 to be raised in and of his personal estate, and he left his residuary estate in trust for his eldest son, now second Earl of Lathom. his residuary estate in trust for his eldest son, now second Earl of Lathom.

as will be seen from our report, withdrawn on the understanding that the question, with others of a cognate character, should be referred to the Committee of General Purposes.

A meeting of the General Committee of the West Lancashire Masonic Educational Institution will be held at the Masonic Hall, Liverpool, this (Friday) evening, at 7 p.m., when the applications of 10 children to be placed on the list of candidates for election at the next Court of Governors will be considered. Four of these are for the Educational Fund, three for the Combined Fund, and three for the Advancement Fund.

We have received a letter from an influential brother in the West of England on the subject of the honorarium recently recently voted to the Secretary of the Royal Masonic Institution for Boys by the Quarterly Court of Governors with an earnest request that we should publish it in our correspondence Had the discussion on this subject been still in progress, we should have had no hesitation in complying with his request, but we trust that, on further consideration, he will agree with us as to the undesirability of re-opening a discussion which has The money was voted almost unanibeen closed. mously at the Quarterly Court in October last and the vote was confirmed almost as unanimously at the Quarterly Court last month. Thus, no amount of protest on the part of lodges or brethren can avail to undo what has been done and under these circumstances we feel sure he will excuse us for not complying with his wishes.

One remark we do feel called upon to make, and that is, to express the hope that our correspondent has been misinformed as to the possibility of brethren withholding their subscriptions from the approaching Festival in behalf of the Girls' School in consequence of this gift. It will be exceedingly hard lines for that Institution if such a course is adopted.

A correspondent writes to ask if we can furnish him with the name of any lodge in which the Swedenborgian Rite is practised either in the Midlands or in London. There is no mention of any such lodges in the "Cosmo," nor have we ever heard of there being any in existence in England. Perhaps some of our readers may be able to answer the question.

We have received copies of the proceedings of the Grand Lodge of All Scottish Freemasonry in India at the Quarterly Communication on the 22nd October and the Annual Communication on Wednesday, the 30th November (St. Andrew's Day). Both meetings were held at Freemasons' Hall, Byculla, Bombay, the presiding officer at the earlier being Bro. P. N. Wadia, Grand Master Depute, as Grand Master, and at the later, Bro. J. W. Smith, Past Grand Master. At the quarterly meeting the office-bearers for the ensuing year were elected, and the acting Grand Master, in the brief address he delivered, expressed, by desire, the thanks of his Excellency Lord Sandhurst, M.W. Grand Master, to the retiring office-bearers for the manner in which they had discharged their duties. The presiding officer also passed in review the leading events of the past year, congratulating the brethren on the harmony which, except in one or two cases, had prevailed among the lodges, and the satisfactory state of the funds of Grand Lodge. He also mentioned that considerable progress was being made with the erection of the new Hall in Bombay, which, it was hoped, would be finished within the appointed time.

At the annual meeting on St. Andrew's Day, the new office bearers were obligated and invested. At the conclusion of this portion of the business, Bro. K. R. Cama, acting G. Master Depute, presented B. J. J. W. Smith, Past G. Master, with a very handsome ivory gavel, in recognition of the great services he had rendered to Scottish Freemasonry in India during the five years he had held the office of Grand Master; and Bro. Smith having briefly expressed his acknowledgments for the gift, G. Lodge was closed, and the brethren held their Grand Festival, under the presidency of the acting Grand Master.

The District Grand Lodge of Bombay held its regular half-yearly communication at Freemasons' Hall, Byculla, on Tuesday, the 29th November last. In the unavoidable absence, on official duty, of His Excellency Lord Sandhurst, Pro Dist. G. Master, the chair was occupied by Bro. I. M. Shields, Dep. Dist.

G.M., who was well supported by the Dist. G. Officers, both Present and Past, and the representatives of lodges. The acting Dist. G. Master, as usual, passed in review the events of the preceding six months, there being two or three matters of no little moment to which he felt it to be his duty to call the attention of Dist. Grand Lodge. One circumstance in particular appears to us to be not a little singular.

As our readers are aware, in the great majority, if not in all, the colonies and possessions of the British Crown, the three home G. Lodges exercise-and, in our opinion, rightly exercise-concurrent jurisdiction. Those who quit the mother country in order to settle in a British colony or possession are not English, Scotch, or Irish, but English, Scotch, and Irish indiscriminately, who take with them not only their worldly possessions, but also their Masonry, if they happen to be Masons. As the principles of Masonry are precisely the same under the three Constitutions, it is in the ordinary course of things to find the members of a colonial lodge of all Constitution should prefer its own system of working, three nationalities. But it is also quite natural that each and, accordingly, when there are a sufficient number of Irish or Scottish brethren to form a lodge or lodges of their own, it is usual for the Grand Lodge at home to give its sanction for their establishment. The Colonial Grand Lodges already formed are composed of the English, Irish, and Scottish lodges previously warranted from home, while in South Africa, Queensland, Western Australia, and elsewhere there are lodges of all three Constitutions working harmoniously side by side.

In his address on this occasion, the acting District Grand Master mentioned that in May last it came to his knowledge that an attempt was being made to establish an Irish lodge in Bombay, and that a petition had already been sent to the Grand Lodge of Ireland for a charter. As there are no Irish lodges in Bombay, Bro. Shields may readily be excused for being unaware of this rule of custom as regards concurrence of jurisdiction in our Colonies and possessions. Accordingly, after consulting with the executive of the Grand Lodge of All Scottish Freemasonry, it was agreed that each should address the Grand Secretary of his Constitution on the subject.

This was accordingly done, and the Acting Dist. G. Master received in due time from the G. Secretary of England a communication to the effect that he (the said G. Sec.) had spoken to an "influential officer of the Grand Lodge of Ireland" on the subject, and had received from him an assurance that no warrant for such a lodge would be granted "unless recommended by an existing lodge" in the city of Bombay; and that he (the G. Secretary) agreed with Bro. Shields "as to the undesirability of establishing a lodge in Bombay under a third constitution." Thus, as there is no Irish lodge in Bombay, there is none to recommend the recent or any other petition to the Grand Lodge of Ireland, and we are naturally left to draw for ourselves the inference that no lodge under the Irish Constitution will be warranted by that Grand Lodge. On this point we shall have some observations to make on a future occasion.

Among the other matters to which Bro. Shields, as acting Dist. G. Master, referred are the receipt of a petition for the formation of a new lodge at Rajkot, which has been forwarded to his Royal Highness the M.W.G. Master for his decision, but in respect of which H.E. the Pro Dist. G. Master has for "sufficient reasons" conceived it to be his duty to withhold his recommendation for the present. It is further mentioned that on visiting certain of the up-country lodges, the acting Dist. G.M. observed an altar or pedestal on the floor of the lodge, "on which the Sacred Writings were displayed and at which candidates were obligated." Regarding this as an innovation, and inconsistent with the requirements of our ritual, Bro. Shields communicated with the Grand Secretary and obtained from him a decision as to the practice being irregular,

Bro. Shields, also referred to certain cases in upcountry lodges in which brethren who had previously been members were re-admitted without ballot, and in testimony of this further irregularity gave the official ruling which he had received from the Grand Secretary on the question. He also announced that satisfactory progress was being made with the erection of the new hall, and expressed the hope that the next communication of the Dist. G. Lodge would be held within its walls

FREEMASONS' MANUAL FOR KENT, 1899," (Rochester: W. T. Wildish, "Journal" Offices).—This valuable annual is in its 22nd year of publication, and was originally started by the lamented Bro. T. S. Warne, of Rochester, on the plan adopted by Bro. W. J. Hughan, when Prov. G. Sec. of Cornwall, 1859-70. On Bro. Warne's decease, Bro. Frank Hitchens kindly undertook the editorship, and has continued and amplified the manual on similar lines, until now it is one of the best, largest, and most useful Masonic directories published in England. All the aid rendered to the editor is always most gratefully and appreciatively acknowledged, and for this edition Bro. W. J. Hughan has fraternally presented an article on "Two Old Lodges" (viz., No. 125, Hythe, and No. 133, Faversham) which will be read with much interest in the county. There are 64 lodges in the province (which is the fourth largest in Englan1), returning 4266 subscribing members, or an average of over 66 per lodge. The chapters number 28, and the Mark Lodges 20. There are also four Rose Croix Chapters, three K.T. Preceptories, four Red Cross Conclaves, and other Masonic bodies. All these organisations are duly and carefully represented in the manual; the information being varied, well arranged, and practically exhaustive. The votes in the central Masonic Charities are likewise described and noted under lodges, but not those of the individual brethren. The former amount to considerably over 5000, and it would be helpful also to know the full totals for the province, even if the names cannot be given, as the manual now exceeds 200 pages. Bro. Hitchens has done his work well, and is to be congratulated most heartily thereon, as also the printer and publisher.
